

#### **1971 CAPE FEAR CONFERENCE MINUTES**

#### THURSDAY MORNING SESSION

(November 4, 1971)

The Cape Fear Conference opened its one hundred seventeenth annual session on Thursday morning, November 4, at 10 a.m., with the singing of the hymn, "The Church's One Foundation."

The morning devotional was by Mr. Gene Britt.

Mr. H. T. Hinson graciously welcomed everyone to Lee's Chapel Church. The Rev. Taylor Hill gave the response to the welcome.

The secretary of the Conference, Ray G. Smith, declared the meeting opened for business.

The Rev. Francis Garner, chairman of the Credentials Committee, explained the registration procedures adopted by the one hundred fourteenth session of the Conference as offered by the Resolutions Committee which states as follows:

"Be it resolved, that in all future sessions of the Cape Fear Conference, the Credentials Committee be instructed to issue a badge of identification to all duly registered ministers, delegates, and visitors.

"Be it further resolved, that no person will be allowed to vote who does not properly display said badge. It is understood that visitors shall be granted all rights and privileges except that of voting.

A song and praise time was held with the singing of the hymns, "Praise Him! Praise Him!" and "Sing and Smile and Pray the Clouds Away."

Scripture was read by the Rev. Henry Armstrong. Many testimonies were given praising God for His great love to us.

Offertory prayer was by the Rev. Armstrong.

The benediction was by the Rev. Hubert Burress.

By motion the conference adjourned until Friday.

### FRIDAY MORNING SESSION

At this time the congregation sang the hymn, "He's a Wonderful Saviour to Me"; and the Rev. W. A. Martin, substituting for the Rev. Swade Benson who was sick, brought an inspiring message using the thought "When Should a Christian Go to the Altar."

The Children's Home report was given by the superintendent, the Rev. Cedric D. Pierce Jr. The Rev. Stewart Humphrey moved that the report be adopted and that the conference go on record encouraging each church in the conference to exceed their suggested quota. The motion carried and the report adopted. (See report.)

The worship hour began with the congregation singing "How Firm a Foundation," and the offering for the day was taken with the Rev. Mr. Humphrey praying the offertory prayer.

The Rev. C. M. Coats brought another inspiring message using Scripture taken from St. Mark 2:1-12. The blessing was asked by the Rev. R. W. Allman and the conference adjourned for lunch.

## REPORTS

#### REPORT OF MOUNT OLIVE COLLEGE

Mount Olive College was founded twenty years ago (1951) by the Free Will Baptists of North Carolina for the purpose of providing a distinctive program of Christian higher education for our young people and our church. During these years more than 2,500 students have enrolled, including approximately 100 ministerial students; and in addition the college is rendering a broad range of services to hundred of others through night and extension courses, youth conferences, institutes for ministers, and other special programs. Today Mount Olive College is fully accredited, has an enrollment of 327 students, total assets of nearly \$2.5 million, and is rapidly developing into one of the most respected church-related junior colleges in America. Among the distinctive features of the College are the following:

1. Education for Ministers. Under a "Supervised Work Experience" each ministerial student is afforded the opportunity to work under an experienced pastor or in a denominational enterprise as a part of his educational preparation.

2. Church-College Scholarship. This program is a creative approach toward encouraging more Free Will Baptist students to attend Mount Olive College. If a local church will provide its students a scholarship in the amount of \$250 annually, the college will give the students an equal amount for a total grant of \$500 per student annually under this program. Other financial aid is also available if needed.

3. Educational Program. Through individualized instruction students are enabled to proceed in a course at their own rate of learning without fear of failure The college has a nonfailing grading system under which no "F's" are given; students are given assistance and more time to complete the course.

#### CHURCH-COLLEGE SCHOLARSHIPS

In order to make it possible for more Free Will Baptist students to attend Mount Olive College, the college has inaugurated a special scholarship program which may cover up to \$500 of the tuition a student must pay each academic year. The program is on a voluntary basis for those churches which wish to participate.

To qualify, a student must present at the time of his registration, or the church must send in advance, a check signed by the treasurer with the specification that the check is for a scholarship for the student named. The college will then provide an equal amount, up to \$125 per semester, as a scholarship. Since there are two semesters in an academic year, one beginning in August and another in January, a student may receive up to \$250 from his church and another \$250 from the college for a total of \$500 under this program.

Gifts sent to the college for this purpose will not be listed toward meeting the "challenge" assigned that church for the college, but will be recorded as "Restricted Income for Church-College Scholarships."

It is understood that the college may use its own funds or any funds administered by it in matching the scholarship from the church; and further, that if the student qualifies for a scholarship already provided by the college, that scholarship shall be considered as fulfilling the college's matching responsibility. In addition, it is understood that the college retains the right to determine the student's academic eligibility for admission and/or continuation in college quite apart from the matching scholarship.

It is the hope of the college that this program will encourage and make it possible for more Free Will Baptist students to attend Mount Olive College.

#### PARTIAL REPORT OF THE ORDAINING COUNCIL

Partial report of the Ordaining Council of the Cape Fear Conference of the Original Free Will Baptists, meeting with the Lee's Chapel Free Will Baptist Church, Route 5, Dunn, North Carolina, November 4, 1971.

The council has held (10) ten meetings since the last Conference, interviewing and recommending applicants for license and examining candidates for ordination.

As a result of these meetings the following brethren were recommended to their respective churches for licensing: C. H. Parrish to the Fayetteville Church, Atlas Hogg to the Powhatan Church, Gene Britt to the Riverside Church, and Earl Johnson to the Johnston Union Church. These are to be added to the Conference roll of licensed ministers.

The following brethren were ordained during the year and are to be added to the roll of ordained ministers: O. K. Peedin, Roy Clifton, Cooper Thompson, Sexton Vann, Elmer Thompson, and Billy Nowell.

Brother Charles Parrish passed his examination and will be ordained at the next union meeting.

The following brethren are to be added to the Conference roll having requested membership in the Conference. Letters of transfer have been received for: the Revs. Earl Glenn and Herman Grubbs.

The following ministers were cleared for work in the Conference and continue to hold membership in another conference: Clinton Davis, Central; Jesse Caton, Eastern.

The following ordained ministers are to be dropped from the roll of ordained ministers: Larry Coates, James N. Gay, and James E. Howard. Mr. Howard moved his conference membership to the Eastern Conference; Mr. Gay surrendered his credentials for reasons of his own; and the credentials of Mr. Coates were declared invalid "after repeated efforts to have Mr. Coates give reason for so many unfavorable reports about his character." He refused to meet with the council, therefore, the council took the action it thought in best interest of the Conference and the will of God.

Licensed ministers to be dropped from the roll of licensed ministers are as follows: J. Dwight Gay, Jerome Pope, and those ministers who were ordained during the year. Both Mr. Pope and Mr. Gay allowed their license to expire and neither are any longer affiliated with the Cape Fear Conference.

On October 25, 1971, the Rev. Charles Pittman was "declared out of fellowship and not in good standing with the Conference due to his failure to cooperate with the council. At such time as he reports to the council and gives proper explanation for his reported conduct, his standing will be clarified."

Quotes are from the minutes of the May 24, 1971, meeting of the council (see minutes).

The council recommends the following:

1. That churches become more familiar with the Statement of Faith and Discipline in regards to securing licensed ministers as supply pastors.

2. That men who have completed the ordination examination not be ordained until they receive a call from a church to pastor.

#### REPORT OF SUPERANNUATION BOARD

#### (July 1, 1970—June 30, 1971)

This has been a good year and the Lord has blessed the superannuation program in many ways. We are grateful to God for His blessings and to you for your prayers and support of this work.

Our work is needful. At the present time there are five ministers and twelve ministers' widows receiving over two hundred sixty-nine dollars on an average each month. We have life insurance on sixty of our ministers with an annual premium of over fifty-five hundred dollars; and the board pays two thirds of this premium. This life insurance amounts to more than one hundred ten thousand dollars. There are eighteen ministers' families and fifty-one individual ministers and ministers' wives participating in the group hospital program. The monthly premium is more than eight hundred eighty dollars, paid by those participating. There are seventy-six ministers enrolled in the *Ministerial Retirement System* in the approximate amount of fifty-six hundred dollars. Thus the board is liable for about twenty-eight hundred dollars each year to insure the retirement and death benefits of the retirement program.

We have two primary needs. The first is more funds to increase every

phase of our superannuation work. We need over sixteen hundred fifty dollars in gifts (not premium payments) each month from our churches to reach the budget of twenty thousand dollars adopted by the State Convention. Second, there is a need for more and greater participation on the part of our ministers in the Threefold Superannuation Program. There are almost two hundred ministers associated with the State Convention, but only seventy-six have enrolled in all or a part of this program. You CAN HELP

1. You can and should pray for the work of superannuation and for the members of the Board of Superannuation. You should pray for the ministers of our denomination, and especially for your pastor.

2. You should assist your pastor in preparing for retirement through the Superannuation Program as recommended by the State Convention, either by paying the total premiums or by paying a percentage of the premiums.

3. You can assist your church and pastor in making regular offerings to this most worthy cause. Be sure that this cause is included in the budget of your church in proportion to meet our needs. To insure the benefits we are offering to our ministers, we need the support of every Free Will Baptist.

4. Remember that the State Convention designated October as "Superannuation Month" and the third Sunday in June, Father's Day, as "Superannuation Day." Send your contribution to: North Carolina Board of Superannuation, P. O. Box 474, Ayden, North Carolina 28513.

#### REPORT OF FREE WILL BAPTIST CHILDREN'S HOME

Appreciation: Please accept our most sincere appreciation for your continued valuable support during the past year! Financially, we have had one of the best years in the history of the Children's Home and you have helped make it that way. Thanks, also, for your prayers and moral support. We must continue to have these in order for our ministry of child care to be successful.

Open-Door Visitation Policy: We always appreciate your letters, cards, gifts, contributions, and any other way you may remember our children. However, it means much greater understanding and appreciation if you can visit us in person and know that you have had a part in making their life more meaningful. You have a standing invitation to visit on campus, to observe the operation of the Home, and to discuss any questions which may be of concern to you. Please be assured that you will be given a hearty welcome.

Our Children: To date, the Children's Home has provided care for a total of 603 children since the first were admitted on May 23, 1920. Of this number, we now have 67 children on campus, consisting of 37 boys and 30 girls. In addition, one girl is in the Vocational Rehabilitation Training Program in Kinston, North Carolina, and we are assisting 3 girls in higher education.

Building Program: Construction has begun on the new residence for the director of campus life and family. The work is on schedule and should be completed by early November.

New Director of Campus Life: Mr. James T. Pully began his duties as our new director of campus life on September 15, 1971. He comes to us from the Richard T. Fountain School for Boys, Rocky Mount, North Carolina, where he has served as counselor for the past five years.

November Is Children's Home Month: Again this year, the month of November has been designated as "Children's Home Month" and Sunday, November 21, as "Children's Home Day" by the North Carolina State Convention. We urge each church and other organizations to give at least \$1 per member as a "Special Thanksgiving Gift" to the Home. An honor roll of all organizations who send this amount will be published in *The Free Will Baptist*. Please start making plans now for your church, Sunday school, or other church auxiliaries to be included in this honor roll.

Thanksgiving Day Service: Please don't forget that there will not be a

special Thanksgiving Day Service at the Children's Home this year. It is felt that our children deserve to spend Thanksgiving with their friends and families. We urge you to plan to help us make our Founders' Day in May, 1972, the big event of the year on our campus.

Report of Contributions and Suggested Quotas: Below is a report of the contributions received from this district during last year, compared with those of the year before, and a listing of the suggested quotas for the year 1971-1972. The suggested quotas are based on the suggested conference quotas as approved by the North Carolina State Convention on September 16, 1971. They are based upon our needs for general operating funds in order to meet our budget of \$250,000, which is very much in line with last year's budget. If each church will meet its challenge we will have raised the \$207,000 needed in religious contributions. Please help your church meet this challenge.

The following is a report of gifts received from the Cape Fear Conference for the years 1969-70 and 1970-71, plus the suggested quotas for the year 1971-72. Whereas, there has been a continuing effort to secure liquor-by-the-drink in North Carolina; Whereas, the sale and consumption of alcohol has contributed to increase social and moral problems;

Whereas, the widespread use of illegal drugs has grown at an alarming rate;

Therefore be it resolved that the Cape Fear Conference of Original Free Will Baptists meeting at Lee's Chapel Church, Dunn, North Carolina:

1. Express its appreciation to the Christian Action League of North Carolina and its executive director, to those members of the General Assembly of the State of North Carolina, and others who have worked against the sale and use of alcoholic beverages and for their success in defeating bills that would have legalized the sale of liquor-by-the-drink.

2. Be it further resolved that we encourage individuals and churches in each of our local communities to combat illegal drug traffic and further liberalization of liquor laws.

3. Be it further resolved that we encourage individuals and churches to contribute financially through the Christian Action League of North Carolina as it attempts to combat the increased flow of alcoholic beverages.

4. That we commend the Attorney General's office in our state and the North Carolina State Bureau of Investigation for their intensive efforts to curb the illegal sale and use of drugs in our state.



## CONSTITUTION

#### PREAMBLE

We, the Cape Fear Conference of the Original Free Will Baptist denomination of North Carolina, desiring to be in fellowship in a bond of union, do ordain this constitution.

#### NAME

This shall be the constitution of the Cape Fear Conference of the Original Free Will Baptist Churches of North Carolina.

#### PURPOSE

The object of the Cape Fear Conference shall be to promote Christ's kingdom among men by means in strict conformity to the Holy Scriptures.

#### ARTICLE I. COMPOSITION

This conference shall be composed of affiliated ordained ministers and churches within its bounds, who are in good standing, and of all general officers, and members of standing boards or committees of the conference. It shall operate under the Statement of Faith and Discipline for Original Free Will Baptists of North Carolina. No church corporation whose articles of incorporation or constitution and bylaws conflict with the Statement of Faith and Discipline for Original Free Will Baptists of North Carolina shall be permitted membership in the Cape Fear Conference.

#### ARTICLE II. REPRESENTATION

Each church shall represent with one delegate for each one hundred members or fraction thereof. The delegation from each church shall carry to the conference a letter certifying their appointment, and giving the statistics and financial condition of the church; together with a statement of all funds received and disbursed for denomination and benevolent purposes during the year.

#### ARTICLE III. OFFICERS

The officers shall be a moderator, an assistant moderator, a secretary, an assistant secretary, and a treasurer, who shall be elected for a term of two years, entering upon the duties of said office at the close of the session in which they are elected. Temporary officers, representatives or messengers, may be elected at the option of the conference for whatever purposes deemed essential.

#### ARTICLE IV. STANDING BOARDS AND COMMITTEES

It shall be the policy of this conference to elect as many boards and committees as may be necessary in carrying out its program. These shall keep records of their proceedings and make a report at each annual session of the conference.

A board of trustees, a board of Christian education, a board of missions and church extension, and a board of ordination consisting of five members each shall be elected. The term of office for members of these boards shall be five years, but shall be so adjusted as to terminate the tenure of office of one member annually.

Section 1—Standing boards shall write their own bylaws and administer their respective programs of work, but each shall remain subject to their conference.

Section 2—The executive committee shall be composed of the moderator, assistant moderator, secretary, treasurer, and one member elected by the conference at the time of the official election of officers.

Section 3—Temporary committees shall be appointed at option of the conference for whatever purpose deemed necessary.

#### ARTICLE V. FINANCE

Each church shall contribute to the conference annually according to its membership.

#### ARTICLE VI. ADMISSION OF CHURCHES

Any properly organized church that gives evidence of adherence to the doctrines of Christianity as taught by Original Free Will Baptists of North Carolina and desires to help promote the program and work of the Cape Fear Conference and the North Carolina State Convention, may present its petition to the regular session of the conference. If the petition for membership is approved, the moderator shall extend the hand of fellowship to the delegates.

#### ARTICLE VII. DISMISSION OF CHURCHES

A church may be dismissed from membership in the conference by vote of the conference.

### ARTICLE VIII. VISITORS

The Cape Fear Conference may extend to visiting brethren all the privileges of the body save that of voting and holding office.

#### ARTICLE IX. MEETINGS

The Cape Fear Conference shall meet in annual session on Thursday and Friday before the first Sunday in November. The host church shall be selected by vote of the conference in annual session or by the executive committee. The place of a future meeting thus selected may be changed by an act of the executive committee should such a change become necessary.

#### **BYLAWS**

SECTION 1—The duties of the moderator shall be to preside, according to accepted parliamentary procedure, over the sessions of the Cape Fear Conference; to appoint temporary committees, delegates, and representatives; to serve as ex officio member of all standing boards and committees; and in general, to perform the duties of the office of moderator.

SECTION 2—The duties of the assistant moderator shall be the duties of the moderator when that officer is not present and he shall assist the moderator when called upon. In the event of the resignation or death of the moderator, the assistant moderator shall fill the vacancy until the next session of the conference.

SECTION 3—The secretary shall record the proceedings of all sessions the Cape Fear Conference and preserve an accurate record of said proceedings in a book provided for this purpose. The secretary shall prepare and cause to be published the minutes of the annual sessions of the conference; hold in trust all documents, not otherwise preserved, and surrender same at the direction of the conference; conduct the official correspondence and sign such documents and instruments as require the secretary's signature; and serve as a member of executive board.

SECTION 4—The duties of the assistant secretary shall be the duties of the secretary when that officer is not present, and he shall assist the secretary when called upon. In the event of the resignation or death of the secretary, the assistant secretary shall fill the vacancy until the next session of the conference.

SECTION 5—The treasurer shall hold in trust all money that belongs to the conference and pay out same by order of the conference, the executive committee, or any standing board invested with the authority to authorize the disbursement of funds. He shall keep an accurate account of all funds received and paid out and make an annual report to the conference.

SECTION 6—It shall be the duty of the executive committee to transact the business of the conference when the conference is not in session, and make report at annual conference. The executive committee shall plan the program for the annual session of the conference.

SECTION 7—The board of trustees shall hold in trust all conference and real property, gifts and bequests of the conference, and convey or expend said property or assets as the Cape Fear Conference may direct.

SECTION 8—It shall be the duty of the board of ordination to examine, ordain, and discipline ministers in keeping with the provisions of the Statement of Faith and Discipline for Original Free Will Baptists of North Carolina, along with whatever additional requirements may be made by the conference. The board of ordination shall examine ordained ministers seeking membership in this conference and make recommendations in keeping with their findings.

SECTION 9—It shall be the duty of the board of missions and church extension to cooperate with the churches of the conference to promote the establishment of churches within the bounds of the conference. The board of missions and church extension shall cooperate with the state board of missions to raise money, arrange itineraries, and keep the work of missions before our churches.

SECTION 10—It shall be the duty of the board of Christian education to keep our people informed as to our educational needs, and endeavor to promote the cause of and stimulate interest among our people in the cause of Christian education. The board of Christian education shall cooperate with the educational institutions of our denomination and use all funds for best interest of Christian education.

SECTION 11—The following temporary committees shall be appointed annually by the moderator and shall render reports during the sitting of the conference: credentials, nominating, resolutions, temperance, obituary, and letter digest.

SECTION 12—A board or committee will be recognized as having a quorum when there is a majority of the members present for a meeting, providing all the members of said board or committee have been duly notified concerning the said meeting.

SECTION 13—All reports, resolutions, and recommendations shall be considered properly presented to the conference in written form only.

SECTION 14—Each minister and delegate in good standing shall duly attend each day while the conference is in session or be subject to censure by the conference and reported to his local church.

SECTION 15—If any member, in the judgment of the conference, shall show anger in his discussion on any subject, he shall forfeit his seat in that session

SECTION 16-No member shall be excused from any session of the conference without leave of the moderator.

SECTION 17-The conference shall adjourn by a majority vote.

SECTION 18—Each officer and member of standing committees and boards in good standing shall be entitled to a seat and vote in the conference.

SECTION 19-The conference shall open and close with suitable devotional services.

SECTION 20—This constitution and its bylaws may be altered or amended by a two-thirds favorable vote of the members present, provided that said amendment shall be presented on the first day of the annual session for action on the following day.

## CONSTITUTION

#### power to act for and on the bell HOITRA on meeting between its regular

NAME—This organization shall be known as the Union Meeting of the Cape Fear Conference of Original Free Will Baptists of North Carolina.

#### ARTICLE II

PURPOSE—The purpose of this union meeting is the creation of an effective agency through which the Cape Fear Conference may successfully promote its work. It shall thus be and remain subject to the authority and use of the conference—except in the election of its general officers—as a consistent medium devoted to the advancement of the conference program of evangelism, education, benevolence and church extension.

#### ARTICLE III

COMPOSITION—This union meeting shall be composed of churches affiliated with the Cape Fear Conference, the ordained and licensed ministers who are members of churches that belong to the conference, and all general officers and members of standing committees of both the conference and the union meeting.

## ARTICLE IV

REPRESENTATION—The churches of the Cape Fear Conference shall represent in the quarterly sessions of the union meeting with one delegate for each one hundred members or fraction thereof. Sunday schools, leagues, and auxiliaries shall each represent with one delegate.

#### ARTICLE V

FINANCE—Each church shall send with its delegation to the quarterly sessions of this union meeting one percent of its annual budget exclusive of funds for building and equipment, or a total of four percent of the church budget for the full year of four union meeting sessions. Sunday schools, leagues, and auxiliaries shall represent with whatever amounts they may choose. All funds shall be allocated by the executive board of the conference, but said allocations shall be approved by the union meeting in regular session or by the conference.

#### ARTICLE VI

OFFICERS—The general officers of this union meeting shall be a moderator, an assistant moderator, a secretary, an assistant secretary, and a treasurer, each of whom shall be elected for a term of one year, at the last session of the union meeting before the annual session of the Cape Fear Conference.

### ARTICLE VII

BOARDS AND COMMITTEES-All standing committees and boards created

by the conference shall avail themselves of the advantage of promoting their work through the union meeting.

The general officers of the union meeting shall be added to the executive board of the conference and this composite committee shall constitute the executive committee of the union meeting. This committee shall have power to act for and on the behalf of the union meeting between its regular sessions. It shall also be the duty of the executive committee to prepare and supervise the programs of the union meeting and to allocate all undesignated funds.

#### ARTICLE VIII

MEETINGS—The union meeting shall hold its regular sessions Saturday before each fifth Sunday in the churches of the Cape Fear Conference. The host church shall be selected from time to time, according to the alphabetic succession of the initial letter of the name of each church. This method of selecting the place of meeting may be changed when deemed expedient or necessary, by an act of the union meeting in session or the executive committee.

#### ARTICLE IX

AMENDMENT—This constitution may be amended at any regular session of the Cape Fear Conference by a majority vote of the members present, provided that the proposed amendment be presented in writing by the union meeting.

#### BYLAWS GOVERNING THE BOARD OF EDUCATION

1. The board shall be composed of five members. Their terms of office shall be as provided for in the constitution of the conference.

2. The officers shall be chairman, assistant chairman, recording secretary, assistant recording secretary, and executive secretary, who shall have charge of the promotional work of the board; provided, however, that any two officers may be combined at the option of the board, and provided further, that the executive secretary, may, or may not be, a member of this board.

3. The treasurer of the conference shall, unless otherwise provided for, hold all funds of the board and disburse same on order of the board, or when duly signed by the chairman and secretary of the board. Annual reports of all receipts and disbursements shall be made to the conference in session and interim reports to the executive board when requested.

4. The board shall meet as often as necessary for the proper dispatch of the work assigned to it by conference direction, but must meet at least twice a year.

5. The board shall make, or cause to be made, adequate records of meetings of this board, detail records, reports, etc., of all activities of the board and its officers, and preserve same as permanent records.

6. This board shall be charged with the responsibility of cooperating with our state and national educational institutions in the promotion of general Christian education.

7. The organization, direction, and the training program of Free Will Baptist League shall be under the direction and supervision of this board.

8. The general supervision of the Sunday school promotional activities, organization of new Sunday schools, training program for workers, and any and all other Sunday school promotional programming shall be the responsibility of this board.

9. This board shall be charged with the responsibility of making, or cause to be made emphasis on the Christian family life.

10. This board shall be responsible for conducting area institutes, and conferences, on a conference scale, annually to instruct and help our people when necessary to have a better understanding of our conference, state, or national programs.

11. It shall be the responsibility of this board to direct and supervise all training programs of the conference.

12. The board shall be empowered to make such rules and regulations as it may deem expedient for the proper prosecution of the responsibilities assigned to it, provided, however, that the same shall not be inconsistent with bylaws, nor the constitution of the conference.

13. The board shall be responsible for the promotion and administration of a Student's Loan Fund with which to aid worthy students in security and education.

14. The board shall lend money only upon the following terms and conditions:

a. Students must be adjudged worthy as to character and ability, and must attend an institution of learning approved by this board.

b. A promissory note must be made by the student, with one or more good endorsements, or other good security satisfactory to the board. The rate of interest shall be 1% while the student is in training. After completion of training, a new note shall be made bearing 6% interest with monthly, or quarterly payments to be made until obligations are fully discharged.

15. These bylaws may be amended or revised at any annual session of the conference, provided that such amendments, or revisions, as may be deemed necessary, shall lie on the table at least three hours before a vote is taken, during which time they shall be read twice, and provided further that such amendments or revisions shall require a two-thirds vote.

#### BYLAWS GOVERNING THE BOARD OF MISSIONS

1. The board shall be composed of five members. The first named shall be for a term of one year, the second for two years, the third for three years, the fourth for four years, the fifth for five years and thereafter for a term each of five years.

2. The officers shall be chairman, assistant chairman, recording secretary, and an executive secretary, who shall have general charge of the promotional work of the board; provided, however, that any two officers may be combined at the option of the board, and provided, further, that the executive secretary may, or may not, be a member of the board.

3. The board shall meet as often as may be deemed necessary and attend to all matters pertaining to missions within the territory of the Cape Fear Conference, but must meet at least twice a year.

4. The treasurer of the conference shall hold all funds designated for Cape Fear missions and pay out same on order of the board, or when said order is duly signed by the chairman and the secretary of the board. Annual reports shall be rendered to the conference of all funds received and disbursed.

5. All persons doing work that merit compensation must first apply to the board on approved forms, and receive authorization to do work under regulations of the board before they can be compensated for same with mission funds.

6. Mission points, or stations, may be opened and maintained by the board for such a length of time as may be deemed best, employ evangelists, missionaries, and such field workers as may be deemed necessary for the proper promotion of the mission work.

7. The board shall not make any investment in property, nor promote any investment in property, without first giving due consideration to the safety of the investment, property titles, and other matters relative to the security of any investment.

8. No person shall be at liberty to enter upon any approved mission point without first consulting the board and receiving its approval as to place, plans, and purposes.

9. The board shall render annual reports to the conferences and interim reports to the executive board when requested.

10. The board shall be empowered to make such rules and regulations as it may deem expedient for the proper prosecution of the mission program, provided that same shall not be inconsistent with these bylaws. to define an inclusion of the second s Pastors
