

# **PROCEEDINGS**

# 1974 CAPE FEAR CONFERENCE MINUTES THURSDAY MORNING SESSION

(October 31, 1974)

The Cape Fear Conference opened its one hundred and twentieth session on Thursady morning, October 31, at 10 a.m., with the singing of the hymn, "Come Thou Almighty King."

The opening prayer and Scripture was offered by Alton D. Howard.

The welcome was given by the Rev. Edward C. Taylor, pastor of the host church, Bethel.

Response to the welcome was given by the Rev. Billy R. Nowell, pastor of Pleasant Grove Church.

The session was called to order by the conference secretary, Mr. Ray G. Smith.

The Rev. John David Hill, chairman of the Credentials Committee, explained the registration procedures adopted by the one hundred and four-teenth session of the conference as offered by the Resolutions Committee which stated as follows:

"Be it resolved, that in all future sessions of the Cape Fear Conference, the Credentials Committee be instructed to issue a badge of identification to all duly registered ministers, delegates, and visitors.

"Be it further resolved, that no person will be allowed to vote who does not properly display said badge. It is understood that visitors shall be granted all rights and privileges except that of voting.

"Be it further resolved, that upon the adoption of this resolution, it shall become the duty of the Credentials Committee to explain the registration at the opening of each session of the Cape Fear Conference."

The secretary called the enrollment of officers and standing boards as follows:

Ordaining Council: W. A. Martin, C. Felton Godwin, Edmundo Gonzalez, R. H. Jackson, and Henry Armstrong.

The roll call of churches was made by the secretary. (See listing of churches and delegates.)

Following the moderator's remarks, the Rev. Edmundo G. Gonzalez recognized the visiting ministers present. (See listing of visiting ministers.)

The moderator made the following temporary committee appointments:

Credentials Committee: John David Hill, chairman; J. Walter Stanley, and Gene W. Britt.

Nominating Committee: Henry Armstrong, John Adcox, and W. A. Martin.

Resolutions Committee: R. H. Jackson, Wilson Parker, and Steve Allen.

Obituary Committee: Taylor Hill, Frank Harrison, and A. F. Ballance.

Temperance Committee: Billy R. Nowell, C. M. Coats, and D. M. Matthews.

The hymn, "Blessed Assurance," was sung by the congregation, under the direction of the Song and Praisetime Director, the Rev. Cooper Thompson.

The Rev. John Gilliland, pastor of the West Clinton Church, brought a short sermon.

The Rev. Hubert Burress gave the Church Finance Association report which was received as information. (See report.)

The Children's Home report was given by the superintendent, Mr. Sammy Weeks. The report was received as information. (See report.)

The report of the conference's Executive Committee was read by the secretary. The report was adopted. (See report.)

Following the singing of congregational songs, "He Lives" and "Love Lifted Me," an offertory prayer was prayed by the Rev. Frank R. Harrison.

The sermon was by the moderator, the Rev. Edmundo Gonzalez, in the absence of the Rev. Sexton Vann who was unable to be present.

Before recessing for lunch, prayer and the blessing for the food was offered by the Rev. Earl H. Glenn.

## THURSDAY AFTERNOON

The Thursday afternoon session began with the congregation singing "No Not One."

Scripture and prayer was by the Rev. Edward L. Painter.

A partial report of the Credentials Committee was given by the Rev. John David Hill showing 42 delegates, 10 visiting ministers, 26 ministers, and 14 visitors present.

A report for the Free Will Baptist Press was given by the Rev. Walter Reynolds. The report was received as information. (See report.)

A report of the Board of Superannuation was also given by Brother Reynolds. The report was received as information. (See report.)

A motion was made and carried to ratify the proposed Retirement Homes program for Original Free Will Baptists. (See report.)

The following resolutiton was presented by the Rev. Walter Reynolds and adopted:

"Whereas, we are duplicating ourselves in the printing of our annual minutes and are using some of the Lord's money unnecessarily; and

"Whereas, the cost of printing continues to increase; and

"Whereas, our Free Will Baptist people need some general information not now available;

"Therefore, be it resolved, that instead of annual minutes we seek the cooperation of all Free Will Baptist conventions, conferences, and associations in the printing of an annual Free Will Baptist Yearbook.

"Be it further resolved, that the yearbook include a church directory, minutes of the annual State Convention with the annual reports of the institutions, boards, commissions, and committees; the necessary minutes of the annual conventions, conferences, and associations; and a calendar of denominational activities.

"Be it further resolved, that we seek the cooperation of the Free Will Baptist Press Foundation, Inc. in the publication of this annual Free Will Baptist Yearbook.

"Be it further resolved, that we request the annual conferences and associations to make available to their member churches two or more copies at a reasonable cost to the conference and/or association, and that the Free Will Baptist Press Foundation, Inc. make additional copies available at a reasonable cost to all Free Will Baptists."

A partial report of the Ordaining Council was presented by the Rev. R. H. Jackson. This report was adopted. (See report.)

The report of the Cape Fear Mission Board was also given by Brother Jackson. This report was adopted. (See report.) The amendments presented were laid on the table until Friday. This motion was seconded and carried.

The report of the Cape Fear Ministers' Conference was presented by the Rev. J. C. Hathaway. The report was adopted. (See report.)

The Cape Fear Sunday School Convention report was given by the president, John K. Adcox Jr. The report was adopted. (See report.)

Mr. Milton Wiggs gave the report for the Cape Fear Board of Education. The report was adopted. (See report.)

John K. Adcox Jr. prayed the benediction.

The conference adjourned until 10 a.m. on Friday.

## FRIDAY MORNING SESSION

(November 1, 1974)

The second day's session began with the congregation singing "Lead On, O King Eternal."

Scripture and prayer was by the Rev. Frank Grubbs.

The amendments to the Mission Board report presented during Friday's session were adopted. (See Bylaws governing Board of Missions.)

The report of the Woman's Auxiliary was presented by Mrs. R. H. Jackson, president. The report was adopted. (See report.)

The final report of the Ordaining Council was presented by the Rev. R. H. Jackson. The report was adopted. (See report.)

Petitions from the Victory and Eastwood Missions were presented requesting their sitting during the conference. The petitions were approved.

Following Praisetime, the congregation sang the hymn, "Will Jesus Find Us Watching?"

A short sermon was brought by the Rev. John Rayford Lee.

The Mount Olive College report given by the Rev. Frank R. Harrison was received as information. (See report.)

A report from the Home Missions Department of the North Carolina State Convention of Original Free Will Baptists, given by the Rev. Taylor Hill, was adopted. (See report.)

The Rev. Joseph Ingram presented the report of the Foreign Mission Board and noted that the Rev. and Mrs. Wayne King were preparing themselves to join the Harold Jones family in the work in the Philippines. The report was adopted. (See report.)

The Rev. Taylor Hill spoke on behalf of the State Sunday School Convention, noting the endeavors of the convention for the coming year.

Temporary committee reports included:

The Nominating Committee's report was given by the Rev. W. A. Martin. The report was adopted. (See report.)

The Resolutions Committee's report was given by Steve Allen asking for a standing vote of thanks to the Bethel Church for its hospitality during this one hundred and twentieth session of the conference. The report was accepted by everyone standing. (See report.)

Mr. Allen also submitted an invitation for the 121st session to be held

at Mount Olive College in the new Rogers Chapel.

Since invitations had been accepted during the 119th session for the 1975 session to be held at Palmer Memorial Church and the 1976 session to be held at Yelverton's Grove Church, the Rev. Frank R. Harrison moved that the invitation be extended for the 1977 session or the first open date. The motion carried.

The Temperance Committee's report was given by the Rev. Billy R.

Nowell. The report was adopted. (See report.)

The Rev. Taylor Hill presented the Obituary Committee's report, observing a moment of silent prayer in memory of the Rev. Herman A. Grubbs, with prayer by the Rev. R. H. Jackson. The report was accepted. (See report.)

The treasurer's report was given by Mr. H. T. Hinson. The report was

adopted. (See report.)

The final report of the Credentials Committee showed a total of 52 delegates, 29 ministers, 5 officers, 10 visiting ministers, 6 licensed ministers, and 14 visitors—not including the Bethel people. The report was adopted. (See report.)

The Rev. Earl Glenn brought the eleven o'clock sermon.

The closing congregational song was "At Calvary."

The moderator appointed the following temporary chairmen: Mission Board, Mr. A. F. Ballance; Board of Trustees, Mr. S. D. Allen; Board of Education, Mr. Milton Wiggs; and Ordaining Council, the Rev. C. Felton Godwin.

The Rev. Taylor Hill asked God's blessings upon the noon meal and prayed the benediction.

By motion the conference adjourned.

The Church Finance Association, Inc. has been serving Free Will Baptists since 1940. It is owned and operated for and by Free Will Baptists of North Carolina. All profits are used for the needs of our people.

God has blessed our Association since it was founded in 1940. We thank Him for it. We would like to express our appreciation to each person who has supported our work with his prayers, funds, time; and we are glad for those who have used our services.

Loans made as of August 1, 1974, totaled \$114,000. Total loans since April 20, 1940, were \$1,203,507.73.

Two new endowment funds have been established by the Aspen Grove and Hickory Grove Churches in memory of deceased church members for the benefit of the Free Will Baptist Children's Home. Will your church consider doing this? We will be glad to help any church or any person

establish an endowment for any of our enterprises.

#### REPORT OF FREE WILL BAPTIST CHILDREN'S HOME

#### APPRECIATION

We sincerely appreciate the support you have given us during this past year. Financially and in other ways, we have had one of the best years in the history of the Home. You are responsible for us being able to make such a great claim. We thank you, not only for your financial support; but for your constant prayers. Please continue to remember us and help us throughout the coming year.

#### OPEN-DOOR VISITATION POLICY

We always appreciate your letters, cards, gifts, contributions, and any other way you remember our children. However, it means much greater understanding and appreciation if you can visit us in person and know that you have had a part in making their life more meaningful. You have a standing invitation to visit on campus, to observe the operation of the Home, and to discuss any questions which may be of concern to you. Please be assured that you will be given a hearty welcome.

#### CHILDREN

As of June 30, there were 71 children on our rolls. Three of the 71 are in college this school year. During the past year, there have been thirteen children admitted and twelve were discharged, resulting in an increased membership of one.

#### EMPLOYEES

The success of this Home has been, and will continue to be, dependent upon the faithfulness and dedication of the workers who are here. Working here is more than a job, it is a new way of life, which requires every minute of the day. We are very thankful for our willing, dedicated workers, for many of them have given their whole lives to this missionary effort.

#### RELIGIOUS PROGRAM

The religious program of the Home is planned to meet the spiritual needs of our children in the best possible way. Realizing that many have very difficult problems, there is a great need to restore to each child the feeling that he is loved. This is accomplished by presenting Christ to them as the answer to their problems and by our daily Christian witness. We are having Sunday school and church services each Sunday.

Memorial Chapel is a member in good standing of the Western Conference. Church membership has increased by fifteen members during the

past year.

#### FARM PROGRAM

The farm was operated for the fourth year under the management of Mr. J. B. Patterson. He was assisted in the farm work by our older boys. Together they have worked hard and the Lord has blessed us with good crops, for which we are thankful. The entire farm (120 acres) has been in cultivation this year. Again, the tobacco was leased off the farm, providing additional acres for raising grain, which will be used to feed our livestock.

## FUTURE CHALLENGES—FIVE AVENUES OF SUPPORT

- 1. General Funds: A letter was sent to each church asking each to include "\$6.50 per member per year" into their 1974-75 church budget. Also, an article was printed in THE FREE WILL BAPTIST requesting the same. If each church will respond to this request, then there will be adequate monies to meet the operational costs of the Home. Every possible effort has been, and will continue to be, made to reduce the operational costs of the Home.
- 2. Sponsorship Program: This program consists of providing \$660 a year or \$55 a month for the direct support of a child.
- 3. Special Love Otferings: The months of May and November are reserved by the State Convention as Children's Home months and each church should respond by taking up special love offerings. Also, a special love offering is taken for the Home at the State Convention each year. At the last session our offering exceeded \$17,000. This year, we are planning to hold the annual Thanksgiving Services at the Home. This will be an all-day occasion and will be held on the Saturday before Thanksgiving Day, November 23, 1974. This will be an occasion for our Free Will Baptists to present their gifts to the Home, not just money, but any item which they would like to contribute. We are hoping that many ladies have canned food items this summer and will bring them to us on Thanksgiving Day.
- 4. Memorial Gifts: We have memorial gift envelopes available for anyone who wishes to use them in memory of a friend or loved one who is deceased. We send cards of acknowledgement to the deceased's family.
- 5. Wills or Bequests: Persons may name the Children's Home as a beneficiary on their wills or on their insurance policy. Interested persons should contact the superintendent for detailed information and assistance.

#### EXECUTIVE COMMITTEE MINUTES

Smith to approve the use of monies received by the Cape Fear Conference to renovate the Albemarle No. 2 Cottage to build a new cottage at our Children's Home because approval could not be obtained to remodel the Albemarle No. 2 Cottage.

A motion was made and carried that the conference pay for the deed of the property of Christian Chapel Church, but in the future the churches should be responsible for costs of such deeds.

The committee appointed Mr. Leo Bass to fill the unexpired term of the Rev. Eddie Edwards on the Mission Board. The Rev. Edwards resigned due to his leaving the Cape Fear Conference.

The Executive Committee met October 14, 1974, at the Hopewell Church.

The program for the one hundred and twentieth session of the conference was planned. 'The Revs. John David Hill, J. Walter Stanley, and Gene B. Britt were appointed to serve on the Credentials Committee.

A motion was made and carried to offer the following recommendation at this session of the conference: "That our churches send \$15 per 100 members, or a fraction thereof, to each session of the conference for the support of the conference work.

viduals made during the month of September, especially at the Mission Rally of the State Convention. Your gifts amounted to a record high of \$11,500, with a gift of food items that was estimated at about \$2,000. The attendance was also a record at the service. It was estimated by one person that there were about 1,200 people present for a most rewarding spiritual blessing from God.

Let us share some of the things happening on the field.

Mexico: Under the leadership of Brothers J. E. Timmons and Vance Link, the work continues to be fruitful. We now have six churches organized and members of the convention. These churches and pastors are setting examples for the other workers and soon we will have other missions ready for church organization.

Our Bible Institute continues to be one of the more promising areas of our work. The pasters and students are studying fervently in the Word of God. It is through this institution that we will get new workers for the future. Please pray for the success of this work.

Philippines: Harold and Sandra are now living in the Greater Manilla Area. Harold is in the process of planning for the beginning of a Bible Institute for the work of the Philippines. This institution will be operated similar to the one in Mexico. The new address of Harold and Sandra is: Rev. and Mrs. Harold Jones, P. O. Box 346, Greenhills, Rizal 3113, Philippines. Why not share a note of appreciation with them.

A new worker has been employed for the work in Puerto Princesa. He is supported by the Cabin Free Will Baptist Church, Beulaville, North Carolina, of the Eastern Conference. We will give you more information concerning this as soon as we receive this from Harold.

Your continued support of the foreign missions program is a must. The inflation that we feel here is even worse in Mexico and the Philippines. Shortly Harold will give a series of articles concerning this. He states that cost of food products continue to go up. "Milk is \$.70 per quart and ice cream \$1.50 per half gallon. Beef is so high we don't eat it." In Mexico gasoline is \$.80 per gallon. In the light of these costs, the mission board must give support to cover these living cost. In order for the board to do this, we must look to our churches. All support of foreign mission comes from you. Please continue to increase your support as much as possible.

# REPORT OF MOUNT OLIVE COLLEGE

WHAT MOUNT OLIVE COLLEGE IS DOING FOR FREE WILL BAPTISTS

Mount Olive College does not exist for itself but rather to serve. Our primary mission is to serve the Free Will Baptist Church and to assist our churches in advancing the cause of Jesus Christ. To fulfill this mission:

1. Mount Olive College provides educational opportunity for Free Will Baptists. Through a broad program of scholarships, loans, and part-time employment, every qualified student can be assisted up to the level of his need.

2. Mount Olive College places first emphasis upon being a Christian College. It is not enough to simply get students into a college—what is

more important is what happens to them after they get there. Mount Olive College believes that the most important thing in the life of any person is his relationship with God.

- 3. Mount Olive College provides an educational experience that is based on the development of students as persons. A student is not just a learner he is a child of God who needs to grow spiritually and emotionally as well as intellectually.
- 4. Mount Olive College provides an education of high quality and reputation. Christian education must be good education for God does not call people to do inferior work for Him. Mount Olive is a fully accredited college whose work is recognized and accepted throughout the nation and the
- 5. Mount Olive College provides educational preparation for ministers and church leaders. Approximately ten percent of our students are preparing for the ministry, missions, or other church-related vocations. We ask for your prayers that more of our young people will accept God's call to a specific Christian ministry.
- 6. Mount Olive College provides distinctive services to Free Will Baptists, including pulpit supply, facilities for denominational meetings, counseling services through the office of the Chaplain, Lagles Nest Conference Center for spiritual life retreats and Christian recreation. Students and personnel are available to visit churches with programs of music and testimony, teach Sunday school classes, conduct worship services, and provide other appropriate services.
- 7. Mount Olive College helps provide identity and recognition for Free Will Baptists. The most distinctive feature of Mount Olive College is its relationship with the Free Will Baptists of North Carolina, and to strengthen and develop the college is one of the most important investments our church can make. # CHURCH-COLLEGE ADVANCEMENT COUNCIL

The general purpose of the Church-College Advancement Council will be to facilitate communication and services between the church and the college. It will serve in an advisory and promotional capacity. Members of the council will advise the college on the educational needs and expectations of the church, and in return they will interpret to the church the services and needs of the college.

Each Free Will Baptist church in North Carolina, and each church out of the state which supports Mount Olive College, is invited to designate a lay member to the council. It is recommended that the term of office be for three years with the privilege of additional terms at the will of the church.

Specific duties of members of the council will include:

<sup>(</sup>b) The "challenge" does not include gifts to the Chapel Fund. Gifts to this project go with a separate account.

- 1. To interpret the needs, interests, and expectations of their church to Mount Olive College, and to interpret the needs, services and expectations of the college to their church.
- 2. To attend the annual meeting of the council at Mount Olive College, any called meetings, and county or district meetings.
- 3. To give regular, preferably quarterly, reports to their church and church organizations on the progress, needs, and services of the college. Members are also to inform their church and other organizations that personnel and students of the college are willing to make appearances to churches, church groups, and community organizations.
- 4. To help the college identify persons who have the capability of making special gifts or bequests for the support of Christian education.
- 5. To assist in the admissions program of the college by presenting information on the college to high school students in their church and community and by encouraging these students to visit the campus.
- 6. To serve in other ways that are appropriate to the mutual interest of their church and the college.

In addition to information provided at the annual and other meetings of the council, members will be put on a special mailing list to receive quarterly reports on the college.

# REPORT OF HOME MISSION AND CHURCH EXTENSION DEPARTMENT

First, we wish to thank God and His supporters for the great step forward that has been made in His Home Missions work. There have been four more home mission points added to our list for support within the past year. They are West Hillsborough Mission, Eastwood Mission of Fayetteville, the Charlotte Mission, and the Faith Mission at Leland. This gives us a total of six home missions including the Henderson Mission and the Hope Mills Mission that were established the year before.

The record shows that our contributions have been \$23,993.54 during the past fiscal year and we are indeed grateful; however, there are many ministers and churches who appear to have done nothing to support this work. The record will show that we have not failed to keep our progress and needs before the people.

There are many details that will have to be worked out as we establish a set of rules to govern us, but for the time being we are mostly dealing with problems as they arise. As for financial support to the home mission points, we are leaning toward the support of the missionaries and leaving the purchasing of property to the missions except in cases where we are needed to assist in obtaining loans.

We know without a doubt that Home Missions is a part of our Lord's

Great Commission, and that it is the God-given responsibility of every Free Will Baptist to support the cause for missions at home as well as abroad.

We appeal to all Free Will Baptist for your continued prayers and financial support. We are indeed thankful for the progress that has been shown through those of you who have faith in God and this program.

Because of the lack of funds, we have no paid administrators and most

of our missionaries are paid for their expenses only.

We feel that Home Missions deserves a rightful and equal place among our other Free Will Baptist Enterprises so; therefore, we appeal to this body for the adoption of this report which included the 1974-75 budget of \$75,000.

# Victoria and the Constitution of the Constitut

We, the Cape Fear Conference of the Original Free Will Baptist denomination of North Carolina, desiring to be in fellowship in a bond of union, do ordain this constitution.

This shall be the constitution of the Cape Fear Conference of the Original Free Will Baptist Churches of North Carolina. sal do adigo al ballor.

#### PURPOSE

The object of the Cape Fear Conference shall be to promote Christ's kingdom among men by means in strict conformity to the Holy Scriptures.

# ARTICLE I. COMPOSITION

This conference shall be composed of affiliated ordained ministers and churches within its bounds, who are in good standing, and of all general officers, and members of standing boards or committees of the conference. It shall operate under the Statement of Faith and Discipline for Original Free Will Paptists of North Carolina. No church corporation whose articles of incorporation or constitution and bylaws conflict with the Statement of Faith and Discipline for Original Free Will Baptists of North Carolina shall be permitted membership in the Cape Fear Conference.

#### ARTICLE II. REPRESENTATION

Each church shall represent with one delegate for each one hundred members or fraction thereof. The delegation from each church shall carry to the conference a letter certifying their appointment, and giving the statistics and financial condition of the church; together with a statement of all funds received and disbursed for denomination and benevolent purposes during the year.

# ARTICLE III. OFFICERS

The officers shall be a moderator, an assistant moderator, a secretary, an assistant secretary, and a treasurer, who shall be elected for a term of two years, entering upon the duties of said office at the close of the session in which they are elected. Temporary officers, representatives or messengers, may be elected at the option of the conference for whatever purposes deemed essential.

# ARTICLE IV. STANDING BOARDS AND COMMITTEES

It shall be the policy of this conference to elect as many boards and committees as may be necessary in carrying out its program. These shall keep records of their proceedings and make a report at each annual session of the conference.

A board of trustees, a board of Christian education, a board of missions

and church extension, and a board of ordination consisting of five members each shall be elected. The term of office for members of these boards shall be five years, but shall be so adjusted as to terminate the tenure of office of one member annually.

Section 1—Standing boards shall write their own bylaws and administer their respective programs of work, but each shall remain subject to their conference.

Section 2—The executive committee shall be composed of the moderator, assistant moderator, secretary, treasurer, and one member elected by the conference at the time of the official election of officers.

Section 3—Temporary committees shall be appointed at option of the conference for whatever purpose deemed necessary.

#### ARTICLE V. FINANCE

Each church shall contribute to the conference annually according to its membership.

#### ARTICLE VI. ADMISSION OF CHURCHES

Any properly organized church that gives evidence of adherence to the doctrines of Christianity as taught by Original Free Will Baptists of North Carolina and desires to help promote the program and work of the Cape Fear Conference and the North Carolina State Convention, may present its petition to the regular session of the conference. If the petition for membership is approved, the moderator shall extend the hand of fellowship to the delegates.

#### ARTICLE VII. DISMISSION OF CHURCHES

A church may be dismissed from membership in the conference by vote of the conference.

# ARTICLE VIII. VISITORS

The Cape Fear Conference may extend to visiting brethren all the privileges of the body save that of voting and holding office.

## ARTICLE IX. MEETINGS

The Cape Fear Conference shall meet in annual session on Thursday and Friday before the first Sunday in November. The host church shall be selected by vote of the conference in annual session or by the executive committee. The place of a future meeting thus selected may be changed by an act of the executive committee should such a change become necessary.

Section 1—The duties of the moderator shall be to preside, according to accepted parliamentary procedure, over the sessions of the Cape Fear Conference; to appoint temporary committees, delegates, and representatives; to serve as ex officio member of all standing boards and committees; and in general, to perform the duties of the office of moderator.

Section 2—The duties of the assistant moderator shall be the duties of the moderator when that officer is not present and he shall assist the moderator when called upon. In the event of the resignation or death of the moderator, the assistant moderator shall fill the vacancy until the next session of the conference.

Section 3—The secretary shall record the proceedings of all sessions of the Cape Fear Conference and preserve an accurate record of said proceedings in a book provided for this purpose. The secretary shall prepare and cause to be published the minutes of the annual sessions of the conference; hold in trust all documents, not otherwise preserved, and surrender same at the direction of the conference; conduct the official correspondence and sign such documents and instruments as require the secretary's signature; and serve as a member of executive board.

Section 4—The duties of the assistant secretary shall be the duties of the secretary when that officer is not present, and he shall assist the secretary when called upon. In the event of the resignation or death of the secretary, the assistant secretary shall fill the vacancy until the next session of the conference.

Section 5—The treasurer shall hold in trust all money that belongs to the conference and pay out same by order of the conference, the executive committee, or any standing board invested with the authority to authorize the disbursement of funds. He shall keep an accurate account of all funds received and paid out and make an annual report to the conference.

Section 6—It shall be the duty of the executive committee to transact the business of the conference when the conference is not in session, and make report at annual conference. The executive committee shall plan the program for the annual session of the conference.

SECTION 7—The board of trustees shall hold in trust all conference and real property, gifts and bequests of the conference, and convey or expend said property or assets as the Cape Fear Conference may direct.

Section 8—It shall be the duty of the board of ordination to examine, ordain, and discipline ministers in keeping with the provisions of the Statement of Faith and Discipline for Original Free Will Baptists of North Carolina, along with whatever additional requirements may be made by the conference. The board of ordination shall examine ordained ministers seeking membership in this conference and make recommendations in keeping with their findings.

Section 9—It shall be the duty of the board of missions and church extension to cooperate with the churches of the conference to promote the establishment of churches within the bounds of the conference. The board of missions and church extension shall cooperate with the state board of missions to raise money, arrange itineraries, and keep the work of missions before our churches.

Section 10—It shall be the duty of the board of Christian education to keep our people informed as to our educational needs, and endeavor to

promote the cause of and stimulate interest among our people in the cause of Christian education. The board of Christian education shall cooperate with the educational institutions of our denomination and use all funds for best interest of Christian education.

Section 11—The following temporary committees shall be appointed annually by the moderator and shall render reports during the sitting of the conference: credentials, nominating, resolutions, temperance, obituary, and letter digest.

Section 12—A board or committee will be recognized as having a quorum when there is a majority of the members present for a meeting, providing all the members of said board or committee have been duly notified concerning the said meeting.

Section 13—All reports, resolutions, and recommendations shall be considered properly presented to the conference in written form only.

Section 14—Each minister and delegate in good standing shall duly attend each day while the conference is in session or be subject to censure by the conference and reported to his local church.

Section 15—If any member, in the judgment of the conference, shall show anger in his discussion on any subject, he shall forfeit his seat in that session.

Section 16—No member shall be excused from any session of the conference without leave of the moderator.

Section 17—The conference shall adjourn by a majority vote.

Section 18—Each officer and member of standing committees and boards in good standing shall be entitled to a seat and vote in the conference.

Section 19—The conference shall open and close with suitable devotional services.

Section 20—This constitution and its bylaws may be altered or amended by a two-thirds favorable vote of the members present, provided that said amendment shall be presented on the first day of the annual session for action on the following day.

## CAPE FEAR CONFERENCE OF ORIGINAL FREE WILL BAPTISTS

#### ARTICLE I

Name—This organization shall be known as the Union Meeting of the Cape Fear Conference of Original Free Will Baptists of North Carolina.

#### ARTICLE II

Purpose—The purpose of this union meeting is the creation of an effective agency through which the Cape Fear Conference may successfully promote its work. It shall thus be and remain subject to the authority and use of the conference—except in the election of its general officers—as a consistent medium devoted to the advancement of the conference program of evangelism, education, benevolence and church extension.

#### early with his side in still at ARTICLE III

Composition—This union meeting shall be composed of churches affiliated with the Cape Fear Conference, the ordained and licensed ministers who are members of churches that belong to the conference, and all general officers and members of standing committees of both the conference and the union meeting.

#### ARTICLE IV

REPRESENTATION—The churches of the Cape Fear Conference shall represent in the quarterly sessions of the union meeting with one delegate for each one hundred members or fraction thereof. Sunday schools, leagues, and auxiliaries shall each represent with one delegate.

#### ARTICLE V

Finance—Each church shall send with its delegation to the quarterly sessions of this union meeting one percent of its annual budget exclusive of funds for building and equipment, or a total of four percent of the church budget for the full year of four union meeting sessions. Sunday schools, leagues, and auxiliaries shall represent with whatever amounts they may choose. All funds shall be allocated by the executive board of the conference, but said allocations shall be approved by the union meeting in regular session or by the conference.

#### ARTICLE VI

OFFICERS—The general officers of this union meeting shall be a moderator, an assistant moderator, a secretary, an assistant secretary, and a treasurer, each of whom shall be elected for a term of one year, at the last session of the union meeting before the annual session of the Cape Fear Conference.

#### ARTICLE VII no for the second

BOARDS AND COMMITTEES—All standing committees and boards created

by the conference shall avail themselves of the advantage of promoting their work through the union meeting.

The general officers of the union meeting shall be added to the executive board of the conference and this composite committee shall constitute the executive committee of the union meeting. This committee shall have power to act for and on the behalf of the union meeting between its regular sessions. It shall also be the duty of the executive committee to prepare and supervise the programs of the union meeting and to allocate all undesignated funds.

#### ARTICLE VIII

MEETINGS—The union meeting shall hold its regular sessions Saturday before each fifth Sunday in the churches of the Cape Fear Conference. The host church shall be selected from time to time, according to the alphabetic succession of the initial letter of the name of each church. This method of selecting the place of meeting may be changed when deemed expedient or necessary, by an act of the union meeting in session or the executive committee.

#### ARTICLE IX

AMENDMENT—This constitution may be amended at any regular session of the Cape Fear Conference by a majority vote of the members present, provided that the proposed amendment be presented in writing by the union meeting.

#### BYLAWS GOVERNING THE BOARD OF EDUCATION

- 1. The board shall be composed of five members. Their terms of office shall be as provided for in the constitution of the conference.
- 2. The officers shall be chairman, assistant chairman, recording secretary, assistant recording secretary, and executive secretary, who shall have charge of the promotional work of the board; provided, however, that any two officers may be combined at the option of the board, and provided further, that the executive secretary, may, or may not be, a member of this board.
- 3. The treasurer of the conference shall, unless otherwise provided for, hold all funds of the board and disburse same on order of the board, or when duly signed by the chairman and secretary of the board. Annual reports of all receipts and disbursements shall be made to the conference in session and interim reports to the executive board when requested.
- 4. The board shall meet as often as necessary for the proper dispatch of the work assigned to it by conference direction, but must meet at least twice a year.
- 5. The board shall make, or cause to be made, adequate records of meetings of this board, detail records, reports, etc., of all activities of the board and its officers, and preserve same as permanent records.
- 6. This board shall be charged with the responsibility of cooperating

with our state and national educational institutions in the promotion of general Christian education.

- 7. The organization, direction, and the training program of the Free Will Baptist League shall be under the direction and supervision of this board.
- 8. The general supervision of the Sunday school promotional activities, organization of new Sunday schools, training program for workers, and any and all other Sunday school promotional programming shall be the responsibility of this board.
- 9. This board shall be charged with the responsibility of making, or cause to be made emphasis on the Christian family life.
- 10. This board shall be responsible for conducting area institutes, and conferences, on a conference scale, annually to instruct and help our people when necessary to have a better understanding of our conference, state, or national programs.
- 11. It shall be the responsibility of this board to direct and supervise all training programs of the conference.
- 12. The board shall be empowered to make such rules and regulations as it may deem expedient for the proper prosecution of the responsibilities assigned to it, provided, however, that the same shall not be inconsistent with bylaws, nor the constitution of the conference.
- 13. The board shall be responsible for the promotion and administration of a Student's Loan Fund with which to aid worthy students in securing an education.
- 14. The board shall lend money only upon the following terms and conditions:
- a. Students must be adjudged worthy as to character and ability, and must attend an institution of learning approved by this board.
- b. A promissory note must be made by the student, with one or more good endorsements, or other good security satisfactory to the board. The rate of interest shall be 1% while the student is in training. After completion of training, a new note shall be made bearing 6% interest with monthly, or quarterly payments to be made until obligations are fully discharged.
- 15. These bylaws may be amended or revised at any annual session of the conference, provided that such amendments, or revisions, as may be deemed necessary, shall lie on the table at least three hours before a vote is taken, during which time they shall be read twice, and provided further that such amendments or revisions shall require a two-thirds vote.

### Bylaws Governing the Board of Missions

- 1. The board shall be composed of five members. The first named shall serve for a term of one year, the second for two years, the third for three years, the fourth for four years, the fifth for five years, and thereafter, each for a term of five years.
- 2. The officers shall be chairman, assistant chairman, recording secretary, and an executive secretary, who shall have general charge of the promotional work of the board; provided, however, that any two officers may be combined at the option of the board, and provided, further, that the executive secretary may, or may not, be a member of the board.
- 3. The board shall meet as often as may be deemed necessary to attend to all matters pertaining to missions within the territory of the Cape Fear Conference, and mission points that have been approved for membership in the Cape Fear Conference.
- 4. The treasurer of the conference shall hold all funds designated for Cape Fear missions and pay out same on order of the board, or when said order is duly signed by the chairman and the secretary of the board. Annual reports shall be rendered to the conference of all funds received and disbursed by the treasurer.
- 5. Churches and/or individuals are encouraged to expedite the work of missions in the fulfillment of the Great Commission of our Lord in appropriate communities throughout the conference. No reimbursement, however, shall be made for expenses incurred without the approval of the Board of Missions.
- 6. Mission points, or stations, may be opened and maintained by the board for such a length of time as may be deemed best, employ evangelists, missionaries, and such field workers as may be deemed necessary for the proper promotion of the mission work.
- 7. The board shall not make any investment in property, nor promote any investment in property, without first giving due consideration to the safety of the investment, property titles, and other matters relative to the security of any investment.
- 8. The board shall render annual reports to the conference and interim reports to the executive board when requested.
- 9. The board shall be empowered to make such rules and regulations as it may deem expedient for the proper prosecution of the mission program, provided that same shall not be inconsistent with these bylaws.
