PROCEEDINGS

The Cape Fear Conference opened its one hundred and twentyeighth session on Thursday morning, November 4, 1982, at 9 a.m. with the singing of the hymn "Stand Up for Jesus." The session was held at Lee's Chapel Free Will Baptist Church, Route 5, Dunn, North Carolina, with the Rev. C. Felton Godwin, moderator, presiding.

The opening prayer and Scripture were given by the Rev. Earl Johnson.

The welcome was extended by the host pastor, the Rev. Henry Armstrong.

The response to the welcome was given by Mr. R. Ray Warrick.

The Rev. Philip Wood, chairman of the Credentials Committee, explained the registration procedures adopted by the one hundred and fourteenth session as offered by the Resolutions Committee, which stated the following:

"Be it resolved, that in all future sessions of the Cape Fear Conference, the Credentials Committee be instructed to issue a badge of identification to all duly registered ministers, delegates, and visitors.

"Be it further resolved, that no person will be allowed to vote who does not properly display said badge. It is understood that visitors shall be granted all rights and privileges except that of voting.

"Be it further resolved, that upon the adoption of this resolution, it shall become the duty of the Credentials Committee to explain the registration at the opening of each session of the Cape Fear Conference."

The moderator extended greetings to the visiting ministers and other visitors present.

Following the moderator's remarks of challenge to be stronger Christians, the temporary committee appointments were made by the moderator, with the first person named on the committee to serve as the chairman:

Obituary Committee: Foy C. Futrelle, Mike Scott, and Dewey Boling.

Credentials Committee: Philip Wood, Mike Scott, and Billy R. Nowell.

Nominating Committee: Jeff Scarborough, J. Rayford Lee, and Milton Wiggs.

Ushers for Conference: Tommy Shirley and W. H. Hawley.

Song Leader: Johnny Woodall.

Pianist: Mrs. Alene Elmore.

The Children's Home report was presented to the Conference by Jean Brickhouse. The report was received as information.

The Mount Olive College report was presented by the president, Dr. W. Burkette Raper. The report was received as information and is recorded in the book of reports.

The Retirement Homes report was given by Walter J. Sutton, director. The report was received as information and is recorded in the book of reports.

The State Convention President, the Rev. Gary Bailey, reviewed highlights of the State Convention of which minutes are recorded.

The moderator declared a ten-minute break for a time of fellowship and the Conference resumed with the singing of the hymn, "At the Cross."

Dean Kennedy, promotional assistant for Home Missions, gave the Home Missions report. The report was received as information.

The Foreign Missions report was given by the director, Harold Jones. The report was received as information.

The Cragmont Assembly report was received as information.

The Free Will Baptist Press Foundation report was presented by the Rev. David Charles Hansley. It was noted that the 109th anniversary of the Free Will Baptist Press Foundation was being celebrated. Mr. Hansley also challenged us to keep the Smithfield Bible and Bookstore open and extended appreciation to the ministers and other volunteers in the Smithfield area, assisted by T. C. Farmer, who were volunteering their time in remodeling the new headquarters for the Smithfield store.

The Superannuation report was given by the Rev. Walter Reynolds. The report was received as information.

The Church Finance Association report was also given by the Rev. Walter Reynolds. This report along with all other State Convention reporting information is recorded in the book of reports of the *Year-book*.

Following the morning offering and offertory prayer, special music was rendered by Phyllis Godwin of the host church.

The Rev. Frank Ray Harrison, chaplain of Mount Olive College, preached the morning sermon, using Scripture based on 1 Peter 2:9-11.

Following the sermon, the host pastor made announcements concerning the noon meal. The benediction and blessing on the food were offered by the Rev. Walter Reynolds.

The afternoon session was opened with the singing of the hymn, "Take the Name of Jesus with You."

The Rev. T. C. Farmer was in charge of the opening prayer and Scripture.

The Rev. Charles Crisp, a representative of the Home Missions Board, presented the promotional program of the Board, using keys.

Ruth Allen of the admissions office at Mount Olive College made announcements regarding High School Days on campus.

The moderator called for reports from standing committees:

The Executive Committee's report was presented by the Conference secretary. The report was adopted. (See Reports.)

The Ordaining Council's report was given by the Rev. L. B. Woodall, Jr., secretary to the Council. The report was adopted. (See Reports.)

The Cape Fear Sunday School Convention report was given by the president of the Convention, the Rev. Philip Wood. The report was accepted and is recorded. (See Reports.)

The Rev. Mike Scott presented the Cape Fear Missions Board report. The report was adopted. (See Reports.)

A formal report of the Woman's Auxiliary Convention was not available; however, it was reported that a written report would be made available for printing. (See Reports.)

The Cape Fear Ministers' Conference report was presented by the Rev. Mike Scott. The report was accepted. (See Reports.)

The Board of Education's report was presented by the chairman of the committee, Mr. Nelson Stewart. The report was adopted. (See Reports.)

The moderator called for reports from the appointed temporary committees.

The report of the Temperance Committee was presented by the Rev. Ted Bryant. The report was adopted. (See Reports.)

The Resolutions Committee report was given by the Rev. Jeff Scarborough. A total of three resolutions were presented to the session and each was adopted and recorded. (See Reports.)

The Obituary Committee's report included a memorial service in memory of Brothers J. E. Timmons, Herman Wooten and J. Walter Stanley. Assisting Chairman C. Foy Futrelle were Mike Scott and Dewey C. Boling. (See Reports.) Dean Kennedy sang "Stand Up, Stand Up for Jesus" representative of the three "soldiers" of the Cross.

The Credentials Committee report was given by the chairman of the committee, the Rev. Philip Wood. (See Reports.)

The Rev. Jeff Scarborough gave the report of the Nominating Committee. The report was adopted. (See Reports.)

The moderator opened the business session and asked for any business that should be presented to the session.

The Ordaining Council's report requested that the Conference dispense with Bylaw 3 of the Council just to ordain Mr. Dean Kennedy as a home missionary and pastor to work with and for the Home Missions Board of the State Convention of Original Free Will Baptist Churches of North Carolina. The Secretary of the Council moved that the action go on record. There being several seconds to the motion, the delegation followed with a vote to wish Mr. Kennedy God's blessings and that time and place of ordination be set at his convenience.

Mr. H. T. Hinson, Conference treasurer, presented the financial report which was accepted. (See Reports.)

The Rev. L. B. Woodall Jr. moved that \$100 be contributed to the Christian Action League. The motion was seconded and carried.

An invitation for the one hundred and twenty-ninth (1983) session was extended by Robert's Grove Church.

Tee's Chapel Church extended an invitation for the session in 1984.

There being no further business, the session was declared adjourned by the moderator as the congregation gave the right hand of fellowship to the new ministers who had entered the Conference since the 1981 setting.

The closing prayer was offered by the Rev. David Charles Hansley.

REPORTS

EXECUTIVE COMMITTEE

(December 15, 1981)

The Executive Committee of the Cape Fear Conference met December 15, 1981, at the home of the moderator. The treasurer was absent due to sickness.

Members present were the Revs. C. Felton Godwin, W. A. Martin, Philip Wood, Mrs. Dola Dudley, and Mrs. Ray G. Smith.

Also present were members of the Cape Fear Missions Board including: The Revs. Alton Howard and Mike Scott, and Mr. Leo Bass.

The moderator called the meeting to order.

The Rev. Alton Howard prayed the opening prayer.

The minutes of the 127th session of the Cape Fear Conference were read by the Conference secretary. After minor changes, the Rev. Philip Wood moved that the minutes be accepted as read and forwarded to the press for printing. The motion was seconded and approved.

The Rev. W. A. Martin moved that 120 copies of the *Yearbook* be ordered for distribution with three copies to each church and mission in the Conference to include a copy for the pastor, the church clerk and chairman of the deacon board. The motion was seconded and carried.

Following discussion dealing with finances of the Conference, Mrs. Dola Dudley moved that the Executive Committee recommend to the 128th session of the Conference that a change be made to provide that each church and mission be requested to send to the annual session of the Conference \$25 for each 100 members or fraction thereof and that the Conference secretary notify each church and mission of the recommendation prior to the annual Conference. The motion was seconded and carried.

The moderator read a letter regarding a meeting to be held January 25, 1982, at the Saint Paul Church with a representative of the Rest Home planning committee presenting the proposal of the committee. Each church and mission is requested to send a representative.

Learning that each church represented had received a letter from the committee, no further action was necessary.

The Rev. Alton Howard, chairman of the Cape Fear Missions Board, presented to the Executive Committee questions regarding the bylaws of the Conference Missions Board.

Following a question and answer session, the moderator asked for further business of the committee. There being none, the Rev. Philip Wood prayed the prayer of benediction and the moderator declared the meeting adjourned.

EXECUTIVE COMMITTEE (February 9, 1982)

The Executive Committee of the Cape Fear Conference met February 9, 1982, at the home of the moderator, the Rev. C. Felton Godwin, for the purpose of planning the program for Victory Mission to become a church.

The moderator called the meeting to order with all members present. Mrs. Dola Dudley, assistant secretary, prayed the opening prayer.

The moderator read a letter from the mission pastor, the Rev. Charles N. Parrish, requesting action of the Executive Committee and suggesting a tentative date, February 21, 1982, for the special service.

A motion was made by H. T. Hinson to accept the request of the pastor and membership of the mission to plan a program for the purpose of organizing the mission into a church and that the date be set for February 21, 1982, at 6:30 p.m. at the mission. The motion was seconded by the Rev. W. A. Martin and was carried unanimously by the Committee.

The Committee proceeded with planning the program with the moderator to preside and present the responsibilities to the church officers. The Rev. Ray Wells, chairman of the Home Missions Board, would present the subject, "The Bible—The Word of God"; Dr. Michael Pelt, chairman of the religion department at Mount Olive College, the Articles of Faith and Principles of Church Government; and the Rev. W. A. Martin, the Church Covenant. The program would be concluded with the Executive Committee extending the Right Hand of Fellowship to the chartered members of the new church. The Rev. W. F. Tew would pray the prayer of benediction and dedication.

A motion was made by Mrs. Dudley and seconded by Mr. Hinson to adjourn. The closing prayer was by the Rev. W. A. Martin.

EXECUTIVE COMMITTEE (July 1, 1982)

The Executive Committee of the Cape Fear Conference met July 1, 1982, at the home of the moderator, the Rev. C. Felton Godwin, for the purpose of planning the program for Catalpa Mission becoming a church.

The moderator called the meeting to order with four members present. The Rev. Alton Howard, pastor of the Catalpa Mission, was welcomed by the moderator. The Rev. W. A. Martin prayed the opening prayer.

The moderator stated that the mission pastor had made the request by telephone on behalf of the membership that the Executive Committee proceed with planning the service in which the mission would become a church.

The committee unanimously consented to the request and proceeded with planning the program to be held July 12, 1982, at 8 p.m., with the moderator to preside and to present the responsibilities to the church officers. The Rev. Charles Crisp, Home Missions Director, would present the topic, "The Bible—The Word of God"; Dr. Michael Pelt, chairman of the religion department at Mount Olive College, the Articles of Faith and Principles of Church Government; and the Conference treasurer, H. The Rev. Ronnie Mohn came before the Council to notify it that he had been called to pastor Powhatan Church. It was moved that he be received into the Conference to pastor. Motion adopted.

The Rev. Tony McLamb came before the Council to notify it that he had been called to pastor Daly's Chapel Church. It was moved that he be received into the Conference to pastor. Motion adopted.

The Rev. Elmer Thompson came before the Council to explain his absence from the Conference in session. It was moved to receive Mr. Thompson's explanation. Motion adopted.

Mr. Earl Johnson came before the Council and notified it that he had been called to pastor the West Clinton Church. Since Mr. Johnston had already taken and made a satisfactory score on the ordination exam, it was moved that Mr. Johnson be ordained at Johnston Union Church on Sunday evening, January 31, 1982, and that the Rev. Mike Scott plan the ordination service. Motion adopted.

It was moved that the Rev. W. F. Tew be received into the Cape Fear Conference as a minister if he could show proper credentials from the Rockfish Conference. Motion adopted.

Mr. David DeHart was given the written and oral ordination exams and made satisfactory scores on both. It was moved that he be ordained. Motion adopted.

The Rev. T. C. Farmer met with the Council to plan Mr. DeHart's ordination. Plans were made to ordain Mr. DeHart at Tee's Chapel Church on Sunday evening, April 4, 1982.

There being no other business, it was moved to adjourn. Motion adopted.

Mr. David DeHart gave the closing prayer.

Note:

The Cape Fear Conference Ordaining Council met at Johnston Union Church on Sunday evening, January 31, 1982, and ordained the Rev. Earl Johnson into the gospel ministry.

The secretary received a letter from the clerk of Smyrna Church on March 17, 1982, stating that the church had renewed Mr. Cecil's Blackmon's license to preach.

(May 24, 1982)

Mr. Haun was advised to counsel with the Rev. Charles Parrish, pastor of Victory Church, about membership with the church and Victory Church licensing him.

There being no other business, it was moved to adjourn. Motion adopted.

Note:

Since the above meeting, Mr. Robert Haun has joined Victory Church and has been licensed by the Church to preach.

The Conference Ordaining Council met on Sunday evening, April 4, 1982, and ordained the Rev. David DeHart. The service was held at Tee's Chapel Church.

(August 29, 1982)

Chairman Felton Godwin called the meeting to order, at Smithfield, First Church, at 1 p.m.

The Rev. Leonard Woodall gave the invocation.

The minutes of the previous meeting were read and approved.

The Rev. Charles Parrish and the Rev. W. F. Tew met with the Ordaining Council to explain the loss of the Rev. W. F. Tew's ministerial credentials and to ask that the Rev. Tew be received from the Rockfish Conference. After the Council interviewed both gentlemen, it was moved and adopted to present the Rev. Tew an ordination certificate

based on the statements they had given to the Council. The certificate is to be presented at the ministers' meeting at the First Free Will Baptist Church, Monday, October 25.

Mr. Dean Kennedy met with the Council and asked to take the ordination exam and, if he made a satisfactory score, to be ordained as a home missionary with the Home Missions Board of the North Carolina State Convention of Original Free Will Baptists. Mr. Kennedy was informed that if he passed the ordination exam, the Council could not ordain him without special permission of the Conference. The Council moved to examine Mr. Kennedy on Monday, October 25. The motion was adopted.

Mr. Wayne Pauley, a member of the Goldsboro Church, came before the Council for an interview concerning his call to preach and how to be licensed. After the Council interviewed Mr. Pauley, it was moved that the secretary notify the Goldsboro Church to license Mr. Pauley. Motion adopted. The Council was very impressed with Mr. Pauley as a candidate for the ministry.

The Rev. Jerry Allen met with the Council to request ministerial membership with the Conference. It was moved to receive Mr. Allen and for the secretary to make the transfer from the Western Conference to the Cape Fear Conference. Motion adopted. The transfer has been made.

The Rev. W. S. Burns met with the Council to be received into the Conference to pastor. It was moved to receive him. Motion adopted.

The Rev. Tony McLamb notified the Council that he wished for his ministerial membership to be transferred from the Western Conference to the Cape Fear Conference. It was moved that the secretary make the transfer. The transfer has been made.

There being no other business, it was moved to adjourn. Motion adopted.

The Rev. W. S. Burns prayed the closing prayer.

(October 25, 1982)

Chairman C. Felton Godwin called the meeting to order, at Smithfield, First Church, at 1:30 p.m.

Present were the Revs. C. Felton Godwin, Foy Futrelle, Mike Scott, alternate for C. M. Coats; and Philip Wood, alternate for Leonard Woodall.

The Rev. Philip Wood prayed the invocation.

The minutes of the previous meeting were read and approved.

The Rev. Foy Futrelle raised the question as to whether the secretary had sent the letter to the Goldsboro Church notifying the

Church that it had the permission from the Ordaining Council to license Mr. Wayne Pauley to preach. It was decided that the letter had been sent. It had.

Chairman Godwin presented a note from the Rev. Charles Parrish requesting his ministerial membership be transferred from the Cape Fear Conference to the Albemarle Conference. The transfer had been made.

The Rev. W. F. Tew was to receive his ordination certificate at the Union Meeting Saturday, October 30, 1982.

After Mr. Dean Kennedy's taking two ordination exams and making a satisfactory score on both the written and oral exams, it was moved and seconded to ask the Conference for the permission to ordain Mr. Kennedy as a missionary for the Home Missions Board of the State Convention of North Carolina Original Free Will Baptist Churches, if the Conference permitted.

There being no other business, a motion was made to adjourn. Motion adopted.

Mr. Dean Kennedy prayed the benediction.

RESOLUTION OF ORDAINING COUNCIL

(at Cape Fear Conference Session, November 4, 1982)

Before the Ordaining Council of the Cape Fear Conference can ordain Mr. Dean Kennedy, the Conference needs to adopt the following resolution while it is in session today:

WHEREAS, Mr. Dean Kennedy has taken and made satisfactory scores on both the oral and written exams of Ordaining Council; and,

WHEREAS, Bylaw 3 of the Ordaining Council of the Cape Fear Conference, paraphrased, says that the Ordaining Council cannot ordain a candidate for the ministry, if he has passed the exams, until a church requests with a written statement that it wishes the Council to ordain a specific candidate for its pastor;

THEREFORE BE IT RESOLVED:

That the Cape Fear Conference in its 1982 session permit the Ordaining Council of the Conference to dispense with Bylaw 3 of the Council just to ordain Mr. Dean Kennedy as a home missionary and pastor to work with/for the Home Missions Board of the State Convention of Original Free Will Baptist Churches of North Carolina.

SUNDAY SCHOOL CONVENTION

The 104th session of the Cape Fear Sunday School Convention convened with the First Free Will Baptist Church of Smithfield, October 9, 1982. The Rev. Philip Wood, president, opened the Convention with the congregation singing "Jesus Loves Me." Mr. Wood welcomed everyone attending the Convention and also remarked on the Theme—REACH AND TEACH—as Jesus gave His disciples the "Great Commission" to go and teach. He also commented on the relationship between Christian maturity and numbers.

The following committees were appointed:

Resolutions: Mr. Milton Wiggs, Chairman; the Rev. Ted Bryant, the Rev. T. C. Farmer.

Finance: Mr. Steve Beasley, Treasurer; Mrs. Ruth Warrick, Mr. Nelson Stewart.

On behalf of the Smithfield Church, Mrs. Pat Wall extended a welcome to everyone. Mrs. Ruth Warrick of the Johnston Union Church gave the response.

The Rev. Philip Wood brought the devotion. He read Scripture from Acts 1:8 on going into the nations witnessing.

The offering was received in the amount of \$33. The Rev. T. C. Farmer gave the offertory prayer.

President Wood then called the business session to order. The secretary read the minutes of the 1981 meeting. They were approved as read. The roll was called with ten (10) churches present and three (3) representing by letter. (Two reports were received from churches after the Convention.) Of the churches reporting at the time of the Convention, there were not any that had an increase in their attendance over the previous year. However, Robert's Grove, that reported late, did have an increase. The church with the most in attendance at the Convention was Pleasant Grove. Plaques are to be presented later so that names can be added to them.

The President then recognized the teachers and superintendents present at the Convention. There were ten (10) superintendents or assistants present.

The treasurer's report was given, with a balance of \$304.57 at the beginning of the Convention. With registrations from churches, offering and the disbursements for this Convention, the new balance was \$455.85.

Mr. Milton Wiggs brought greetings and reports of the workshops from the State Sunday School Convention.

There was not any old business.

New Business: The Rev. T. C. Farmer reported on the closing of the Smithfield Bookstore. He stated that at this time it would not close; instead, it would move into a new location and that requests for help in the renovation were being asked in the amount of \$100 per church or any donations. A plaque with the names of individuals and churches who help will be on display in the bookstore.

After some discussion, the motion was made and passed that the Cape Fear Sunday School Convention give \$100 to the bookstore renovation project.

There being no further business, a short intermission was called.

After re-convening, Mr. Wood announced that there would be a meeting of superintendents, teachers and pastors, and other interested persons, on January 10, 1983, at 7:30 p.m. at Smithfield, First Church, to seek means of helping our Sunday schools grow in the coming year.

Special singing was presented by the Capps Family. They sang, "Tell 'em Again" and "Give Them All."

The Rev. Edmundo Gonzalez brought a very inspirational message concerning the role that home life should take in the training program of a Sunday school. He also stressed that Sunday schools have the responsibility of being a "nurturing" Sunday school and that the teaching program should not compromise the Scriptures.

The Resolutions Committee presented the following resolutions:

- 1. BE IT RESOLVED, that all of our Cape Fear Conference Sunday schools be encouraged to support the Free Will Baptist Press and the Bible and Bookstores operated by the Press;
- 2. BE IT RESOLVED, that this Cape Fear Sunday School Convention encourage each superintendent of our Sunday schools to set an attendance goal and to work to accomplish this goal;
- 3. BE IT RESOLVED, that this Cape Fear Conference Sunday School Convention adopt the 1981 resolutions for another year; those resolutions are:
 - a. BE IT RESOLVED, that all of our Cape Fear Conference Sunday schools be encouraged to attend and to support the North Carolina State Sunday School Convention and that our superintendents and ministers be encouraged to attend the ministers' and superintendents' banquet;
 - b. BE IT RESOLVED that the work, history and the importance of the Sunday school be kept before our people in the form of announcements, bulletin inserts and special presentations;

- c. BE IT RESOLVED, that the importance of being on time for Sunday school be stressed for our members;
- d. BE IT RESOLVED that the practice of leaving Sunday school and not attending morning worship services be discouraged among Sunday school members, and especially among teachers and officers, and that the total Convention training program be stressed;
- e. BE IT RESOLVED, that a full report of this Convention be presented by the delegates to their churches;
- f. BE IT RESOLVED, that a report of this Convention be compiled for the *Yearbook*.

Mr. Milton Wiggs read the resolutions and moved that they be accepted. Motion passed.

A motion was made and seconded to give the Smithfield, First Church, a rising vote of thanks for hosting the Convention. Motion passed, everyone responded by standing.

A motion was made by the Rev. Ted Bryant that a copy of the minutes be sent to the superintendents and pastors of the Cape Fear churches. Motion was seconded and passed.

Tee's Chapel Church volunteered to host the Convention next year if no one else desired. (Shady Grove Church indicated that they would like to host it if the date was changed; motion on this matter did not pass.)

Motion to adjourn was passed. We were dismissed with prayer.


OBITUARY COMMITTEE REPORT

CONSTITUTION

PREAMBLE

We, the Cape Fear Conference of the Original Free Will Baptist denomination of North Carolina, desiring to be in fellowship in a bond of union, do ordain this constitution.

NAME

This shall be the constitution of the Cape Fear Conference of the Original Free Will Baptist Churches of North Carolina.

PURPOSE

The object of the Cape Fear Conference shall be to promote Christ's kingdom among men by means in strict conformity to the Holy Scriptures.

ARTICLE I. COMPOSITION

This conference shall be composed of affiliated ordained ministers and churches within its bounds, who are in good standing, and of all general officers, and members of standing boards or committees of the conference. It shall operate under the Statement of Faith and Discipline for Original Free Will Baptists of North Carolina. No church corporation whose articles of incorporation or constitution and bylaws conflict with the Statement of Faith and Discipline for Original Free Will Baptists of North Carolina shall be permitted membership in the Cape Fear Conference.

ARTICLE II. REPRESENTATION

Each church shall represent with one delegate for each one hundred members or fraction thereof. The delegation from each church shall carry to the conference a letter certifying their appointment, and giving the statistics and financial condition of the church, together with a statement of all funds received and disbursed for denomination and benevolent purposes during the year.

ARTICLE III. OFFICERS

The officers shall be a moderator, an assistant moderator, a secretary, an assistant secretary, and a treasurer, who shall be elected for a term of two years, entering upon the duties of said office at the close of the session in which they are elected. Temporary officers, representatives or messengers may be elected at the option of the conference for whatever purposes deemed essential.

ARTICLE IV. STANDING BOARDS AND COMMITTEES

It shall be the policy of this conference to elect as many boards and committees as may be necessary in carrying out its program. These shall keep records of their proceedings and make a report at each annual session of the conference.

A board of trustees, a board of Christian education, a board of missions and church extension, and a board of ordination consisting of five members each shall be elected. The term of office for members of these boards shall be five years, but shall be so adjusted as to terminate the tenure of office of one member annually.

Section 1—Standing boards shall write their own bylaws and administer their respective programs of work, but each shall remain subject to their conference.

Section 2—The executive committee shall be composed of the moderator, assistant moderator, secretary, treasurer, and one member elected by the conference at the time of the official election of officers.

Section 3—Temporary committees shall be appointed at option of the conference for whatever purpose deemed necessary.

Each church shall contribute to the conference annually according to its membership.

ARTICLE VI. ADMISSION OF CHURCHES

Any properly organized church that gives evidence of adherence to the doctrines of Christianity as taught by Original Free Will Baptists of North Carolina and desires to help promote the program and work of the Cape Fear Conference and the North Carolina State Convention may present its petition to the regular session of the conference. If the petition for membership is approved, the moderator shall extend the hand of fellowship to the delegates.

ARTICLE VII. DISMISSION OF CHURCHES

A church may be dismissed from membership in the conference by vote of the conference.

ARTICLE VIII. VISITORS

The Cape Fear Conference may extend to visiting brethren all the privileges of the body save that of voting and holding office.

ARTICLE IX. MEETINGS

The Cape Fear Conference shall meet in annual session on Thursday before the first Sunday in November. The host church shall be selected by vote of the conference in annual session or by the executive committee. The place of a future meeting thus selected may be changed by an act of the executive committee should such a change become necessary.

BYLAWS

Section 1: The duties of the moderator shall be to preside, according to accepted parliamentary procedure, over the sessions of the Cape Fear Conference; to appoint temporary committees, delegates, and representatives; to serve as ex officio member of all standing boards and committees; and, in general, to perform the duties of the office of moderator.

Section 2—The duties of the assistant moderator shall be the duties of the moderator when that officer is not present, and he shall assist the moderator when called upon. In the event of the resignation or death of the moderator, the assistant moderator shall fill the vacancy until the next session of the conference.

Section 3—The secretary shall record the proceedings of all sessions of the Cape Fear Conference and preserve an accurate record of said proceedings in a book provided for this purpose. The secretary shall prepare and cause to be published the minutes of the annual sessions of the conference; hold in trust all documents not otherwise preserved, and surrender same at the direction of the conference; conduct the official correspondence and sign such documents and instruments as require the secretary's signature; and serve as a member of the executive board.

Section 4—The duties of the assistant secretary shall be the duties of the secretary when that officer is not present, and he shall assist the secretary when called upon. In the event of the resignation or death of the secretary, the assistant secretary shall fill the vacancy until the next session of the conference.

Section 5—The treasurer shall hold in trust all money that belongs to the conference and pay out same by order of the conference, the executive committee, or any standing board invested with the authority to authorize the disbursement of funds. He shall keep an accurate account of all funds received and paid out and make an annual report to the conference.

Section 6—It shall be the duty of the executive committee to transact the business of the conference when the conference is not in ses-

sion, and make report at annual conference. The executive committee shall plan the program for the annual session of the conference.

Section 7—The board of trustees shall hold in trust all conference and real property, gifts and bequests of the conference, and convey or expend said property or assets as the Cape Fear Conference may direct.

Section 8—It shall be the duty of the board of ordination to examine, ordain, and discipline ministers in keeping with the provisions of the Statement of Faith and Discipline for Original Free Will Baptists of North Carolina, along with whatever additional requirements may be made by the conference. The board of ordination shall examine ordained ministers seeking membership in this conference and make recommendations in keeping with their findings.

Section 9—It shall be the duty of the board of missions and church extension to cooperate with the churches of the conference to promote the establishment of churches within the bounds of the conference. The board of missions and church extension shall cooperate with the state board of missions to raise money, arrange itineraries, and keep the work of missions before our churches.

Section 10: It shall be the duty of the board of Christian education to keep our people informed as to our educational needs, and endeavor to promote the cause of and stimulate interest among our people in the cause of Christian education. The board of Christian education shall cooperate with the educational institutions of our denomination and use all funds for the best interests of Christian education.

Section 11—The following temporary committees shall be appointed annually by the moderator and shall render reports during the sitting of the conference: credentials, nominating, resolutions, temperance, obituary, and letter digest.

Section 12—A board or committee will be recognized as having a quorum when there is a majority of the members present for a meeting, providing all the members of said board or committee have been duly notified concerning the said meeting.

Section 13—All reports, resolutions, and recommendations shall be considered properly presented to the conference in written form only.

Section 14—Each minister and delegate in good standing shall duly attend each day while the conference is in session or be subjected to censure by the conference and reported to his local church.

Section 15—If any member, in the judgment of the conference, shall show anger in his discussion on any subject, he shall forfeit his seat in that session.

Section 16—No member shall be excused from any session of the conference without leave of the moderator.

Section 17—The conference shall adjourn by a majority vote.

Section 18—Each officer and member of standing committees and boards in good standing shall be entitled to a seat and vote in the conference.

Section 19—The conference shall open and close with suitable devotional services.

Section 20—This constitution and its bylaws may be altered or amended by a two-thirds favorable vote of the members present, provided that said amendment shall be presented on the first day of the annual session for action on the following day.

UNION MEETING

CAPE FEAR CONFERENCE OF ORIGINAL FREE WILL BAPTISTS CONSTITUTION

ARTICLE I

Name—This organization shall be known as the Union Meeting of the Cape Fear Conference of Original Free Will Baptists of North Carolina.

ARTICLE II

Purpose—The purpose of this union meeting is the creation of an effective agency through which the Cape Fear Conference may successfully promote its work. It shall thus be and remain subject to the authority and use of the conference—except in the election of its general officers—as a consistent medium devoted to the advancement of the conference program of evangelism, education, benevolence and church extension.

ARTICLE III

Composition—This union meeting shall be composed of churches affiliated with the Cape Fear Conference, the ordained and licensed ministers who are members of churches that belong to the conference, and all general officers and members of standing committees of both the conference and the union meeting.

ARTICLE IV

Representation—The churches of the Cape Fear Conference shall represent in the quarterly sessions of the union meeting with one

delegate for each one hundred members or fraction thereof. Sunday schools, leagues, and auxiliaries shall each represent with one delegate.

ARTICLE V

Finance—Each church shall send with its delegation to the quarterly sessions of this union meeting one percent of its annual budget exclusive of funds for building and equipment, or a total of four percent of the church budget for the full year of four union meeting sessions. Sunday schools, leagues, and auxiliaries shall represent with whatever amounts they may choose. All funds shall be allocated by the executive board of the conference, but said allocations shall be approved by the union meeting in regular session or by the conference.

ARTICLE VI

Officers—The general officers of this union meeting shall be a moderator, an assistant moderator, a secretary, an assistant secretary, and a treasurer, each of whom shall be elected for a term of one year, at the last session of the union meeting before the annual session of the Cape Fear Conference.

ARTICLE VII

Boards and Committees—All standing committees and boards created by the conference shall avail themselves of the advantage of promoting their work through the union meeting.

The general officers of the union meeting shall be added to the executive board of the conference and this composite committee shall constitute the executive committee of the union meeting. This committee shall have power to act for and on the behalf of the union meeting between its regular sessions. It shall also be the duty of the executive committee to prepare and supervise the programs of the union meeting and to allocate all undesignated funds.

ARTICLE VIII

Meetings—The union meeting shall hold its regular sessions Saturday before each fifth Sunday in the churches of the Cape Fear Conference. The host church shall be selected from time to time, according to the alphabetic succession of the initial letter of the name of each church. This method of selecting the place of meeting may be changed when deemed expedient or necessary, by an act of the union in session or the executive committee.

ARTICLE IX

Amendment—This constitution may be amended at any regular session of the Cape Fear Conference by a majority vote of the members present, provided that the proposed amendment be presented in writing by the union meeting.

Bylaws Governing the Board of Education

- 1. The board shall be composed of five members. Their terms of office shall be as provided for in the constitution of the conference.
- 2. The officers shall be chairman, assistant chairman, recording secretary, assistant recording secretary, and executive secretary, who shall have charge of the promotional work of the board; provided, however, that any two offices may be combined at the option of the board, and provided further, that the executive secretary, may, or may not be, a member of this board.
- 3. The treasurer of the conference shall, unless otherwise provided for, hold all funds of the board and disburse same on order of the board, or when duly signed by the chairman and secretary of the board. Annual reports of all receipts and disbursements shall be made to the conference in session and interim reports to the executive board when requested.
- 4. The board shall meet as often as necessary for the proper dispatch of the work assigned to it by conference direction, but must meet at least twice a year.
- 5. The board shall make, or cause to be made, adequate records of meetings of this board, detail records, reports, etc., of all activities of the board and its officers, and preserve same as permanent records.
- 6. This board shall be charged with the responsibility of cooperating with our state and national education institutions in the promotion of general Christian education.
- 7. The organization, direction, and the training program of the Free Will Baptist League shall be under the direction and supervision of this board.
- 8. The general supervision of the Sunday school promotional activities, organization of new Sunday schools, training programs for workers, and any and all other Sunday school promotional programming shall be the responsibility of this board.
- 9. This board shall be charged with the responsibility of making or cause to be made emphasis on the Christian family life.
- 10. This board shall be responsible for conducting area institutes and conferences, on a conference scale, annually to instruct and help

our people when necessary to have a better understanding of our conference, state, or national programs.

- 11. It shall be the responsibility of this board to direct and supervise all training programs of the conference.
- 12. The board shall be empowered to make such rules and regulations as it may deem expedient for the proper prosecution of the responsibilities assigned to it, provided, however, that the same shall not be inconsistent with bylaws, nor the constitution of the conference.
- 13. The board shall be responsible for the promotion and administration of a Student's Loan Fund with which to aid worthy students in securing an education.
- 14. The board shall lend money only upon the following terms and conditions:
- a. Students must be adjudged worthy as to character and ability, and must attend an institution of learning approved by this board.
- b. A promissory note must be made by the student, with one or more good endorsements or other good security satisfactory to the board. The rate of interest shall be 1 percent while the student is in training. After completion of training, a new note shall be made bearing 6 percent interest with monthly or quarterly payments to be made until obligations are fully discharged.
- 15. These bylaws may be amended or revised at any annual session of the conference, provided that such amendments, or revisions, as may be deemed necessary, shall lie on the table at least three hours before a vote is taken, during which time they shall be read twice, and provided further that such amendments or revisions shall require a two-thirds vote.

Bylaws Governing the Board of Missions

- 1. The board shall be composed of five members. The first named shall serve for a term of one year, the second for two years, the third for three years, the fourth for four years, the fifth for five years, and thereafter, each for a term of five years.
- 2. The officers shall be chairman, assistant chairman, recording secretary, and an executive secretary, who shall have general charge of the promotional work of the board, provided, however, that any two offices may be combined at the option of the board, and provided, further, that the executive secretary may, or may not, be a member of the board.
- 3. The board shall meet as often as may be deemed necessary to attend to all matters pertaining to missions within the territory of the

Cape Fear Conference and mission points that have been approved for membership in the Cape Fear Conference.

- 4. The treasurer of the conference shall hold all funds designated for Cape Fear missions and pay out same on order of the board, or when said order is duly signed by the chairman and the secretary of the board. Annual reports shall be rendered to the conference of all funds received and disbursed by the treasurer.
- 5. Churches and/or individuals are encouraged to expedite the work of missions in the fulfillment of the Great Commission of our Lord in appropriate communities throughout the conference. No reimbursement, however, shall be made for expenses incurred without the approval of the Board of Missions.
- 6. Mission points, or stations, may be opened and maintained by the board for such a length of time as may be deemed best, and evangelists, missionaries, and such field workers as may be deemed necessary for the proper promotion of the mission work may be employed.
- 7. The board shall not make any investment in property, nor promote any investment in property, without first giving due consideration to the safety of the investment, property titles, and other matters relative to the security of any investment.
- 8. The board shall render annual reports to the conference and interim reports to the executive board when requested.
- 9. The board shall be empowered to make such rules and regulations as it may deem expedient for the proper prosecution of the mission program, provided that same shall not be inconsistent with these bylaws.
