PROCEEDINGS

The One Hundred and Forty Fourth session of the Cape Fear Conference of Original Free Will Baptist convened at Tee's Chapel Free Will Baptist Church Smithfield, N.C., on November 10, 1998.

The session was called to order by the moderator, Rev. Al Markuson. The congregation sang 'Stand Up, Stand Up for Jesus, ' led by song leader Peyton Lee. Scripture and prayer were offered by the Reverend John Massingill, pastor of Oak Grove Free Will Baptist Church. He based his devotional on 11 Chronicles 7: 1-3, & 12-14. We were welcomed to the church by Rev. Dennis Pollock, pastor of Tee's Chapel, the host church. The response was given by Rev. Dean Kennedy, pastor of Haymount Free Will Baptist Church.

The rules of the Credentials Committee were explained by Scott Satterfield as adopted by the One Hundred and Fourteenth Session of the Conference. These rules state: "In all future sessions of the Cape Fear Conference, the Credentials Committee shall be instructed to issue a badge of identification to all duly registered ministers, delegates, and visitors, and that no person be allowed to vote who does not properly display said badge. It is understood that visitors shall be grated all rights and privileges except the right to vote. It shall be the duty of the Credentials Committee to explain the registration at the opening of the Cape Fear Conference."

The roll call of the officers, ministers, standing boards, and churches were called by the clerk. The moderator recognized the visitors and welcomed them to the conference.

The following temporary committees were appointed to serve during the session with the first person named serving as chairman of each committee: Credentials Conunittee.- Scott Satterfield Temperance/Resolutions Committee: Jim Bogel, Kenneth Phillips, Jesse Fulcher Nominating Committee: Frank Harrison, Wayne Hargrove, Sam Weeks Obituary Conunittee: Dean Kennedy, Scott Casey, John Massengill

The moderator Rev. Al Markuson then gave his remarks to the conference. He spoke from John 4: 34-35. He challenged us to love one another and to up hold the word of God. He encouraged all of the ministers, delegates and visitors to pray for other and pray for others to hold to the word of Christ.

We then proceeded with the reports of the denominational ministries. Our newly appointed General Administrator, Rev. David C. Hansley came forward and spoke to us on the need to support our ministries and the overall work of Christ within the Original Free Will Baptist denomination. He then introduced the representatives of the Ministries that were present and allowed them to speak on behalf of each organization. Those present were Mrs. Mary Dudley, Sunday School Board, Dr. Bobby Taylor, Children's Home, Rev. C.H. Overman, FWB Press, Rev. Al Markuson, Home Missions, Rev. Bruce Dudley, Retirement Homes, Rev. Harold Jones, Foreign Missions, Rev. Frank Harrison, Mount Olive College, Rev. Leon Grubbs, President of the Convention of Original Free Will Baptist. The reports were enjoyed by all present.

Seeing that we were ahead of schedule the moderator then called for the report of the Standing Boards of the Conference be given in the morning session.

We were then given a small break asking everyone to come back into the sanctuary when they begin to hear the piano music, this was signal the start of our worship time. Our worship time began with the singing 'At the Cross'. The offering was taken and prayer was offered for God's blessings by Rev. Ronnie Hayes. The moderator asked for special request from the congregation. After sharing many needs the moderator lead the session in prayer. Rev. Markuson then introduced Rev. Roy Clifton the speaker for the conference and turned the service over to the host church for special singing. After the special, Rev. Clifton spoke to the session. Rev. Clifton spoke on Hebrews 13:8 "Jesus Christ, the same yesterday, today, and tomorrow." He knew that there was a lot of talk about the year 2000 and all the predictions. He continued to challenge the session to hold up Christ no matter what may be happening, He is the same Yesterday, Today and Tomorrow. There are a lot of different changes going on in the world but Christ will not change. His message touched our hearts and gave us hope for tomorrow.

Rev. Dennis Pollock then gave instruction on lunch and closed us in prayer giving the blessing for the meal as he prayed.

The afternoon session began with singing, "He Keeps Me Singing," by song leader Peyton Lee. Rev. Ed Miles then lead the group in our devotional. He used John 13:34-35 sharing with us "A new commandment I give unto you, love one another, for by this shall all men know you are my disciples that you love one another." He then led us in prayer.

In our business session a motion was then made properly seconded and passed for the following: From this session on, that a brief paragraph be included during the Obituary Committee on all the members that are mentioned who had died since our last meeting. This summary should be included in the minutes and printed in the yearbook.

A motion then was made, seconded and properly voted on that the Executive Committee studies the financial needs of the conference and come back to the 145th session with some suggestions.

A motion was made that the Executive Committee come up with a program for the Sunday Night meeting that was voted on last year.

The Laymen's League and Carolina Bible Institute gave some announcements. It was also suggested that the program of the conference be printed in the Free Will Baptist Paper to increase attendance. We were also reminded that the conference was asking for a history of each church for the year 2000. An announcement was also made on the cancellation of the November Union Meeting- Then next Union will be January of 1999 at First Free Will Baptist Church in Smithfield.

A motion was then made that all unfinished business be left to the Executive Committee. That motion was properly seconded and approved. With this, a motion was made properly seconded and passed to adjourn. Closed in prayer by Rev. Henry Armstrong.

Executive Committee

The Executive Committee of the Cape Fear Conference met on September 17, 1998 at Mount Olive College. Our moderator Rev. Al Markuson opened the meeting in prayer. We then began to discuss the 144th session of the Cape Fear Conference that will be held on Tuesday, November 10, 1998 at Tee's Chapel FWB Church. The conference will begin with registration from 8:30 am until 9:00 am and the meeting beginning at 9:00 AM. The committees will be as follows:

 - 4) Obituary Committee: Lewis Godwin - Chairman, Scott Casey, John Massengale
- For scripture and prayer in the morning session Rev. John Massengale. The afternoon session scripture and prayer, Rev. Ed Miles. The response will be given by Wooten's Chapel Free Will Baptist Church. The General Administrator will give the denominational reports. In our morning worship, the Reverend Roy Clifton will give the message. Our song leader will be Payton Lee. In the listing of Standing Boards, we will include the Cape Fear Youth. The Sunday School report will now be deleted. In the minutes from the 143rd session it was noted that in the letter to all churches concerning the conference meeting we "I need to remind our churches of the need for a history of each church to be compiled for the year 2000. We also discussed the resolution that was passed concerning a Sunday Night meeting once a year for all the churches in our conference. The Executive Committee needs some input from the conference on this meeting. We have several options; do we want this service to be tied into the Harvest 2000 meetings from our Home Mission Board? Does the conference want us to plan something for two nights to be tied in with a Youth Rally then carry over to Sunday Night also? Would the conference like a Friday, Saturday and Sunday Night meetings? Would they like to use the Home Missions tent or meet in a church? Or does the conference just want a Sunday Night program? With the input from the conference the Executive Committee will plan a meeting as soon as possible.

There was also a discussion on the January meeting of the Executive Committee with the Board of Education. At this meeting, the Bylaws for this committee were reviewed and revised There were some major changes that were adopted. It is the suggestion of the Executive committee that a copy be made available to all delegates and ministers at the 144th session of the conference. It was also noted that the November Union Meeting has been canceled and that it should be included in our bulletin that contributions for this

Board Of Education

The Cape Fear District Board of Education Committee and Cape Fear Conference Executive Committee met January 31, 1998, at 10:00 AM at Lee's Chapel Free Will Baptists Church.

Purpose of our meeting on January 31 was to draw up new Bylaws Governing the Board of Education and Sunday School Board During the Cape Fear Conference, which met November 11, 1997, voted to delete the Sunday School Board and incorporate it with the Board of Education.

The two Committee's decided to rename the Board of Education. The new name will be Board of Christian Education. A copy of the Bylaws Governing the Board of Christian Education are attached.

Bylaws Governing the Board of Christian Education

1. The board shall be composed of five members. The officers shall be: Chairman, assistant chairman, recording secretary, assistant recording secretary, and a member at large. They shall have charge of promotional work of the Board of Christian Education
2. The treasurer of the conference shall, unless otherwise provided for, hold all funds of the Board of Christian Education and disburse same on order of the board, chairman or the secretary. Annual reports of all receipts and disbursements shall be made to the conference in session and interim reports to the executive board when requested and all reports shall be given to the Board of Christian Education.
3. The board shall meet as often as necessary for the proper dispatch of the work assigned to it by the conference direction, but must meet at least twice a year.
4. The board shall make, or cause to be made, adequate records of meetings of this board, detail records, reports, etc., of all activities of the board and its officers, and preserve same as permanent records.
5. This board shall be charged with the responsibility of cooperating with The Convention of Original Free Will Baptists' educational institutions in promotion of general Christian education.
6. The general supervision of the Sunday School promotional activities, organization of new Sunday Schools, training programs for workers, and any and all other Sunday School promotional programming shall be the responsibility of this board.
7. This board shall be charged with responsibility of placing a strong emphasis on Christian family life.
8. This board shall be responsible for conducting area institutes and conferences, on a conference scale, annually to instruct and help our people when necessary to have a better understanding of our conference and Convention of Original Free Will Baptist.
9. The board shall be empowered to make such rules as it may deem necessary to carry out the responsibilities assigned to it, provided, however, that the same shall not be inconsistent with bylaws, nor the constitution of the conference.
- I.O. The board shall be responsible for the promotion and administration of Student Scholarship or Scholarships, when proper funding is available.
11. The board shall grant scholarship(s) upon the following terms:
 - (A) Submission of an application
 - (B) Application shall be graded on a point system based on the following: Finances, Church and school activities, College attending, Field of Study, Academic average.

12. These bylaws may be amended or revised by the board of Christian Education subject to the approval of the Cape Fear Conference.

The Cape Fear Conference Board of Christian Education met September 20, 1998, 2:00 PM, at Lee's Chapel Free Will Baptist Church. Members present, Bobby Tew, Chairman, Martha Parsons, Secretary and Payton Lee. Purpose of the meeting was to discuss the new Bylaws Governing the Board of Christian Education.

1. We elected officers, they are as follows:

Martha Parsons - Chairman

Peyton Lee - Assistant Chairman

Peggy Clifton - Recording Secretary

Bobby Tew - Assistant Recording Secretary

Helen Coates - Member at Large

2. We provide a Sunday School Handbook and Resource Catalogue to each Cape Fear Church/Sunday School. These were prepared and made available to us by the Original Free Will Baptist Sunday School Ministry.

3. We discussed # 6 in our New Bylaws reference Sunday School. After much discussion we decided to have the Secretary get a date, time and place to meet with the Cape Fear Conference, Executive Board to ensure we are headed in the right direction.

4. It was decided to give one (1) SCHOLARSHIP. An application, along with a letter of explanation why scholarships were not given in the last two years. The letter and application will be mailed to each church in the Cape Fear Conference in January 1999.

5. Meeting adjourned.
