PROCEEDINGS

The One Hundred and Fiftieth Session of the Cape Fear Conference of Original Free Will Baptists (OFWB) convened at Shady Grove FWB Church, Spivey's Corner, North Carolina on November 09, 2004.

The congregation opened in singing 'At Calvary' led by song leader, Brother Peyton Lee. Licensed Minister, Richard Witman of Pleasant Grove Church offered 'Scripture and Prayer' from Philippians 3:13. The conference was welcomed by Deacon Peyton Lee of host church Shady Grove. The response was heard from the Reverend Jeff Scarborough.

Moderator, the Reverend Roy Clifton, called the session to order. The rules of registration were then explained by the Credentials Committee Chair, the Reverend James Corbett, as adopted by the One Hundred Fourteenth Session of the Cape Fear Conference. Clerk Jesse Fulcher called the roll of Officers and Standing Boards, Churches, and Ministers. The Moderator recognized our visiting ministers and churches. By motion, Daly's Chapel FWB Church was received into the conference and given the right hand of fellowship by Moderator Roy Clifton. There were comments shared from those representing Daly's Chapel praising the 'Harvest Covenant' program and saying that the church is looking forward to being a part of the Cape Fear Conference.

Moderator Roy Clifton's remarks came from the Scripture passage, Nahum 1:7. He commented that God's creation declares how good God is and that God demonstrated His love as He went to the cross for us. God is a stronghold, He protects us and God knoweth

them that trust Him. It is a wonderful privilege to walk with God. Moderator Clifton challenged the conference to tell these things wherever we go. He also thanked the conference for the opportunity to serve and expressed his appreciation for the willingness of the executive committee to serve. Prayer was then offered for the needy by Convention President Fred Baker.

The following temporary Committees were appointed by Moderator Clifton.

Obituary Committee: Chair Dean Kennedy, Roger Hill

Credentials Committee: Chair James Corbett, Alan Price, Johnathan Pearce

Nominating Committee: Chair Sam Weeks, Aubrey Williamson, Ricky Warren

Representatives from our denominational ministries were present and given an opportunity to speak on the behalf of each ministry. The following ministries were represented: Convention of OFWB_ President Fred Baker, Mount Olive College_ Dr. Burkett Raper, Home Missions & Evangelism_ Dr. Graham Lane, Disaster Relief_ Tim Heath, FWB Press_ Cliff Gray, Foreign Missions_ Harold Jones, Retirement Homes_ Harold Jones on the behalf of Bruce Dudley, Children's Home_ Dr. Bobby Taylor, Cragmont Assembly_ Bryant Hines, Minister's Program_ Fred Baker on the behalf of Don Fader, State Layman's League_ Russel Tyson, and Camp Vandemere_ Wesley Taylor. Convention President Fred Baker encouraged each church to support our denominational ministries. He also announced that the Convention will be held on May 17-19 this coming year and that the churches will need to report for the period of July 01 – December 31, 2004 beginning with the 2005 Convention. President Baker then presented a plaque on the behalf of the convention "In Acknowledgement and Appreciation for 150 Years of Service" to the Cape Fear Conference. The plaque was received by Moderator Roy Clifton on behalf of the conference.

The following reports of the Standing Boards were received by the conference (see attached reports for the Standing Boards). The Executive Committee report was given by the clerk and approved by the conference. The Ordaining Council report was given by Aubrey Williamson. The Cape Fear Minister's Association report was given by Doug Seymour. The Blended Fellowship Mission report was given by Director/Pastor Doug Seymour. The mission has reached 29 of their goal to reach 40 new members this year and reported an influx of young people in their congregation. The Cape Fear Youth and the Cape Fear Youth Fellowship reports were given by Martha Parsons and Rita Jones. The Christian Board of Education report was given by Martha Parsons. Moderator Clifton received announcements from the churches. After the announcements we moved into a break.

Worship Service began with congregational singing 'Trust and Obey' led by Brother Peyton Lee. The conference received an offering and prayer was offered by Pastor Jesse Fulcher. Special music was presented by the 'Four Clefs'. The Reverend Jeff Scarborough brought the morning message from Ezekiel 33:1-9. He stated that ministers have a duty to "blow the trumpet and warn our people." The consequences will be the same as in Ezekiel's day if we do not do so. Second Timothy 4:2-5 tells us to "preach the word in season and out of season." Our ministers today will be accountable to do the same as Paul was instructing Timothy. He thanked God for those who have been saved and reminded us that we must not rest easy. We need to care about the lost souls if our conference is to be built to the glory of God. The challenge was given that we not rest but do all that the Lord has called us to do. The worship was closed with an invitation and prayer.

Cape Fear

AFTERNOON SESSION

The afternoon session began with the congregation singing 'I Have Decided to Follow Jesus' led by Brother Peyton Lee. 'Scripture and Prayer' was offered by Licensed Minister Alan Price of Powhatan Church from Psalm 62:2.

The reports of the Temporary Committees were then received (see attached reports of the Temporary Committees). The Temperance/Resolutions Committee had one resolution that was read and a motion carried to accept. The Obituary Committee reported no deaths this past year. The Credentials Committee gave a report of the Annual Conference's attendance and was adopted. The Nominating Committee made its recommendations to the conference and it was voted by acclamation to accept the committee's recommendations.

The conference then moved into its business session. Moderator Clifton called for Old Business. There being none the conference moved into New Business. Motion was made by the Executive Committee to place the plaque, "In Acknowledgment and Appreciation for 150 years of Service" at Shady Grove Church until the 151st Annual Session of the Cape Fear Conference and at that time the conference will determine where the plaque will be permanently displayed. This motion was carried by the conference. It was announced that Blended Fellowship Mission will host the 151st Annual Session of the Conference on November 08, 2005.

The Treasurer's Report was then given by Treasurer Sam Weeks. The report was received by motion. The Reverend Sam Weeks also gave a report on the progress at Blended Fellowship Mission reporting that the mission hoped to move into its new sanctuary in January 2005 and then to plan a dedication service. The business session was then closed by Moderator Clifton.

The Reverend Otis Hamm gave a presentation of the 'Heritage and History of the Cape Fear Conference' in celebration of the 150th Anniversary of the Conference. In the presentation it was said that "Our history is part of the conference today and will play a part in the conference's future." Also a brief written summary of the Cape Fear Conference was given to those in attendance. Dr. Burkette Raper commented that "The future is always rooted in the past and that the Bible is our history." It was also suggested that the last two years of the Annual Conference and the history of each local church be filed in the historical collection at Mount Olive College in order to preserve our heritage.

Motion was made by Aubrey Williamson that the conference give Moderator, Roy Clifton a "rising vote of thanks" for the service he provided to this conference with his capable leadership qualities during his term.

Motion was made by Jeff Scarborough to adjourn the 150th Session of the Cape Fear Conference. Motion was carried and the conference was then dismissed by Moderator Jerry Stephenson.

Executive Committee

The Cape Fear Conference Executive Committee met following the Annual Conference on November 11, 2003 at the First FWB Church, Smithfield. The Executive Committee discussed the nominations for General Administrator for the OFWB as reported to the committee by Conference Representative Sam Weeks. By motion the Executive Committee instructs Conference Representative Sam Weeks to vote in the negative on the current applicants for General Administrator for the Original Free Will Baptists.

The Cape Fear Conference Executive Committee met at the First FWB Church, Smithfield on February 02, 2004. Martha Parsons requested that the Executive Committee address the issue of the Sunday School Seminar and its relation to the Cape Fear Union meeting in May. The Executive Committee determined that if there were an issue this matter should be referred to the Cape Fear Union Executive Committee. Pastor/Director Doug Seymour and Dean Kennedy reported on the Blended Fellowship Mission.

The Cape Fear Conference Executive Committee met at the Blended Fellowship Mission following the Cape Fear Union meeting on February 21, 2004. Also present was the Cape Fear Conference Board of Christian Education. Martha Parsons requested to meet with the Executive Committee to address conflicts in scheduling with the Sunday School Board and the Board of Christian Education. It was discussed that the Executive Committee respond by letter to the Sunday School Board requesting that the Sunday School Board and the Board of Christian Education work together in the future to co-ordinate the scheduling of these ministries.

The Cape Fear Conference Executive Committee met at the First FWB Church, Smithfield on February 23, 2004. By motion, the minutes of the 2003 Annual Conference were approved as corrected. The Executive Committee discussed the concerns of the Board of Christian Education in its previous meeting. By motion a letter will be sent to the Sunday School Board requesting that the Sunday School Board work with the Board of Christian Education in scheduling future events.

The Cape Fear Conference Executive Committee met at the First FWB Church, Smithfield on June 21, 2004. Also present was Doug Seymour, Pastor/Director of Blended Fellowship Mission. A letter read by Moderator, Roy Clifton from Brother Jimmy Powell, Covenant Church and was discussed by the Executive Committee. The Financial Report for Blended Fellowship Mission was given by Pastor/Director Doug Seymour. The Executive Committee discussed with Pastor Seymour the possibility of hiring a maintenance worker to do general upkeep work for the mission. An update was given on the progress of the building project of the new sanctuary. Also a financial report was given by Sam Weeks for the building project at Blended Fellowship.

The Cape Fear Conference Executive Committee met at the First FWB Church, Smithfield on August 09, 2004. The treasurer's report was given by Sam Weeks. Brother Weeks also gave a report on the building project at Blended Fellowship Mission. A motion was carried to install a fire detection system for Blended Fellowship at the cost of \$7,400.00 to be paid 50% in 30 days and the balance in 60 days of installation.

Cape Fear

A report was given by Otis Hamm concerning the property deed for Covenant Church. The Convention Executive Committee Report was given by Representative Sam Weeks. The Executive Committee then planned the 150th Annual Session of the Cape Fear Conference for November 09, 2004 at Shady Grove Church.

The Cape Fear Conference Executive Committee met at the St. Paul FWB Church on November 01, 2004. By motion, the Executive Committee will recommend to the conference to accept Daly's Chapel Free Will Baptist Church of LaGrange into the Cape Fear Conference pending the completion of the 'Harvest Covenant' program under the direction of Home Missions & Evangelism. It is requested that Daly's Chapel FWB Church be represented at the 150th Session of the Cape Fear Conference.

Ordaining Board

The Ordaining Board met on November 24, 2003 at the First FWB Church Smithfield.

All board members were present. The Ordaining Board met with Johnathan Pearce. Motion was carried for him to serve Smyrna Church for 90 days.

It was discussed that the board needed to meet with Joseph "Pete" Rawls concerning his desire for ordination. He has served the one year of probation prior to approval for ordination, as was previously agreed upon by this Board. He has willingly surrendered his credentials from the National Association and abided by the guidelines as requested.

The Board met with Kyle Watson to discuss his educational progress and plans for ordination.

The Board met with Richard Watson from Pleasant Grove Church to discuss his educational progress and plans for ordination.

The Board met with Barry Croom to discuss a 90 day renewal for supplying Covenant Church. Motion was carried for him to renew the 90 day supply for Covenant Church.

The Ordaining Board attended a special called meeting with the Executive Committee of the Convention of OFWB in the Lois K. Murphy Regional Center on the campus of Mount Olive College on January 20, 2004.

Devotion was shared by Dr. Sam Weeks from Matthew 18.

The Reverend Fred Baker, President of the Convention of OFWB, commented on the following items and opened the floor of the meeting for discussion:

1. Accountability
2. Building integrity
3. The communication between ordaining boards
4. Special concerns
5. Other comments

Items that were brought forward from the discussion were:

a) To set-up guidelines in a pamphlet form for ordained ministers and licensed ministers. Each ordaining board was encouraged to send a representative to form a committee for this purpose.

b) To encourage and help one another by lifting each other with positive communication.

The Ordaining Board met on February 23, 2004 at the First FWB Church, Smithfield.

The Ordaining Board met with Joseph "Pete" Rawls. He stated that he desires a church to serve. He has been busy preaching at some churches in our conference and in the area. Motion carried to issue a certificate of ordination.

The Board met with Johnathan Pearce. He reported that things are going well at Smyrna Church. He requested to serve the church for an additional 90 days. Motion was carried to approve his request to serve.

The Board unanimously selected Frank Ray Harrison to represent the Ordaining Board by serving on a committee to set-up guidelines in a pamphlet form for ordained ministers and licensed ministers. The committee will consist of representatives from all ordaining boards in the Convention as per the January 20, 2004 meeting.

The Ordaining Board met on May 24, 2004 at the First FWB Church, Smithfield.

All board members were present. The Board met with licensed minister Johnathan Pearce who is serving Smyrna FWB Church for 90 days. Johnathan came to seek advice concerning a situation that had arisen at Smyrna Church since Mount Zion Missionary Baptist Church had burnt down. The Ordination Board discussed the matter with him, pledging our prayers and encouragement for the support of their ministry and approved him to serve the church for 90 more days to be used at his discretion. The motion was carried.

It was reported that the Reverend Ken Dabbs is now serving at Covenant Church in Hope Mills.

A discussion of the status of all our licensed ministers followed. Each mentor was encouraged to check on their licensed minister, particularly to make sure that all licenses were renewed as required.

Dr. Sam Weeks reported that the Reverend Jeff Scarborough had joined on staff as co-pastor of First FWB Church, Smithfield.

The Ordaining Board met on August 23, 2004 at the First FWB Church, Smithfield.

All board members were present. The Ordaining Board met with Johnathan Pearce to discuss his service as pastor at Smyrna Church. Johnathan is working out his notice and will finish his interim service at the end of this month. He plans to be prepared and to have met his requirements for ordination before the end of the year.

The Board had received the written ordination examination for Alan Price. After much discussion, it was determined that there was a need to defer grading the exam. A motion was offered to defer until after January 1, 2005 with five contingencies pending which included completion of his education requirement prior to ordination and preparation for the oral portion of the exam. Motion was unanimously carried.

Motion was made to delete the 35-year old waiver included in the text of the study guide that is provided to potential licensed ministers: "*The two years of college work may be waived for those 35 years of age or older."

Cape Fear

The Ordaining Board met on October 25, 2004 at the First FWB Church, Smithfield.

A letter was received from the Albemarle Conference acknowledging that the Reverend Al Markuson has requested to transfer his membership to the Albemarle Conference. This letter will be forwarded to the clerk of the Cape Fear Conference and the request granted.

A letter was received from Lee's Chapel Church concerning Kyle Watson. He has been approved by the church for another year of licensure. It was discussed that a letter will be sent to Lee's Chapel Church indicating that the church could extend his license for another year.

A discussion concerning the number of ordained ministers that were active in our conference led to the following motion: A motion was moved to submit a letter to the clerk of the Cape Fear Conference requesting a list of ordained ministers that are in violation of Conference guidelines for attendance. The motion was carried.

- **Youth Convention Exec. Committee** met at Mt. Olive College Aug. 28.
