PROCEEDINGS

The One Hundred and Fifty-first Annual Session of the Cape Fear Conference of Original Free Will Baptists (OFWB) convened at Blended Fellowship OFWB Mission Church, Pikeville, North Carolina on November 19, 2005.

The congregation opened in singing 'Tis So Sweet to Trust in Jesus', *Kirkpatrick*, led by song leader, Brother Peyton Lee. Pastor/Director, Doug Seymour of Blended Fellowship Mission offered 'Scripture and Prayer' from II Chronicles 2:1 and commented "the reason that we are able to be here at Blended Fellowship today is because a lot of people were determined. God is faithful to use us if we are determined in our heart to obey His will. God needs faithful men and women." The conference was welcomed by Pastor/Director Doug Seymour and the response was heard from Brother Peyton Lee of Shady Grove Church.

Moderator, the Reverend Jerry Stephenson, called the session to order. The rules of registration were then explained by the Credentials Committee Chair, the Reverend Ken Dabbs, as adopted by the One Hundred Fourteenth Session of the Cape Fear Conference. Clerk Jesse Fulcher called the roll of Officers and Standing Boards, Churches, and Ministers.

The following temporary Committees were appointed by Moderator Clifton. *Temperance/Resolutions Committee:* Chair Otis Hamm, Clarence Privette, Fred Johnson *Obituary Committee:* Chair Jim Bogle, Jimmy Price *Credentials Committee:* Chair Ken Dabbs, Richard McKeel, Joe Myrick

Nominating Committee: Chair Aubrey Williamson, Ricky Warren, Roy Clifton

The Moderator recognized our visiting ministers and churches. By motion, the Reverend Braxton Carter was received into the membership of the Cape Fear Conference.

Representatives from our denominational ministries were present and given an opportunity to speak on the behalf of each ministry. The following ministries were represented: Convention of OFWB_ Director of Convention Services, Buddy Sasser; Retirement Homes_ Ronnie Taylor; Sunday School Ministry_ Mary Dudley; Foreign Missions_ Harold Jones; FWB Press_ Cliff Gray; State Layman's League_ Russel Tyson; Camp Vandemere_ Wesley Taylor; Carolina Bible Institute_Jerry Stephenson. Director of Convention Services, Buddy Sasser, reported for Cragmont Assembly and Home Missions & Evangelism. A report was given of the health condition of our President of the Convention of OFWB, Fred Baker. A presentation of the 'Wall of Honor' plaque for the Reverend and Mrs. Fred Baker was left in the hands of the conference due to Brother Baker's sickness.

A time of prayer was offered on behalf of the sick and needy before the conference moved into a break.

The conference worshiped in a special program of dedication of the newly renovated facilities of Blended Fellowship Mission Church. Remarks were given by Pastor/Director Doug Seymour followed by special music from 'Blended Hands' and a video presentation of the construction process of the facilities. A moving expression of appreciation was given by Blended Fellowship through the song. 'Thank You For Giving To The Lord', *Ray Boltz.*

Director of Convention Services, Buddy Sasser, presented a 'Wall of Honor' plaque to the Reverend and Mrs. Sam Weeks on behalf of the conference for dedication of service to the renovation project of Blended Fellowship Mission.

The Reverend Dean Kennedy, Pastor of Haymount Church, brought the morning message entitled 'Come and See' from the scripture passage, Matthew 28:19,20. He expressed his appreciation to Haymount Church, the Churches of the Cape Fear Conference, and to all others that have helped with the Blended Fellowship project and mission. Brother Dean began the message with this comment, "I believe it is our purpose and commission to make Christ known to all the world. What can we learn from our experiences at Blended Fellowship? There must be a call on people's lives (I Samuel 3:9). The church needs to encourage those who are being called, keeping our eyes open to God's calling. We must lift up the name of the Lord that our people will see the Lord (Isaiah 6:5-8). The Apostle Paul was influenced by Stephen (Acts 9:6). Churches were planted, people were saved (Acts 16:9)." Brother Dean commented that "we are to 'come and see' the Lord lifted up high. If we are to carry out the great commission, we need to bring people to 'come and see' Jesus, not what we have accomplished (John 1:39)." He encouraged people to go and tell how Jesus has changed their lives. The message was closed with the encouraging words that our churches need to love one another and help each other in need.

Pastor/Director, Doug Seymour expressed appreciation to the conference and special music was offered by April Wilson. Moderator gave the benediction and led in asking the Lord's blessing upon the food prepared for the conference.

AFTERNOON SESSION

The afternoon session began with the congregation singing 'He Keeps Me Singing', Bridgers. 'Scripture and Prayer' was offered by Licensed Minister, Bryan Williamson from Luke 10:38. He commented that "sometimes we are so busy doing the Lord's work we tend to forget our focus in life which is Jesus Christ."

Dr. Burkette Raper addressed the conference with a report on the North Carolina Fellowship for Christian Ministry.

The following reports of the Standing Boards were received by the conference (see attached reports of the Standing Boards). The Executive Committee report was given by Clerk Jesse Fulcher and approved by the conference. The Ordaining Council report was given by Secretary Aubrey Williamson. The Cape Fear Minister's Association was given by Secretary/Treasurer Joe Ballance. The Cape Fear Youth Fellowship and the Christian Board of Education reports were given by Chairperson Martha Parsons.

The following reports of the Temporary Committees were then received (see attached reports of the Temporary Committees). The Temperance/Resolutions Committee had one resolution that was read and a motion carried to accept. The Obituary Committee reported the deaths of two of our ministers the past year. The Credentials Committee gave a report of the Annual Conference's attendance. The Nominating Committee made its recommendations to the conference and it was voted by acclamation to accept the committee's recommendations.

The conference then moved into its business session. Moderator Jerry Stephenson called for Old Business. Motion was carried to place the plaque, "In Acknowledgement and appreciation for 150 years of Service", presented to the conference at the 150th Annual Session of the Cape Fear Conference to be placed in the Historical Collection at Mount Olive College. A motion was also carried to accept the motto 'Come and See' for our conference and to teach this principle to our churches.

The Treasurer's Report was given by Treasurer Sam Weeks and was received by motion (see attached report). Brother Sam encouraged the delegates to honor someone in their church on the 'Wall of Honor' at Convention Headquarters. He also brought attention to the Executive Committee report for our churches to continue to support Blended Fellowship Mission with prayer and financial support for an additional two years beginning in year 2006. Our churches were also encouraged to invite Blended Fellowship into their worship some evening in the future.

The 152nd Annual Session will be planned to meet tentatively at the Smyrna OFWB Church on November 14, 2006.

Motion was carried to adjourn the 151st Session of the Cape Fear Conference and the conference was dismissed with prayer by Brother Billy Nowell.

Executive Committee

The Cape Fear Conference met on December 6, 2004, at the First FWB Church, Smithfield. The Executive Committee recognized Jean Ackiss, Director of Church Support, Mount Olive College. Mrs. Ackiss discussed with the committee the support of the conference in the naming of the 'Academic Complex' in honor of Dr. and Mrs. Burkette Raper. A motion was carried to pledge the support of the conference for the New Century Campaign and the naming of the 'Academic Complex' in honor of Dr. and Mrs. Burkette Raper. The

minutes of the 150th Annual Session of the Conference were reviewed and approved. A report was given by Treasurer Sam Weeks on the building progress for Blended Fellowship Mission. Brother Sam also gave Treasurer Reports for Blended Fellowship and the Conference.

The Cape Fear Conference Executive Committee met on January 1, 2005, at the First FWB Church, Smithfield. Pastor/Director Doug Seymour gave a report of the ministry and building progress for Blended Fellowship Mission.

The Cape Fear Conference Executive Committee met on May 23, 2005, at the First FWB Church, Smithfield. A motion was carried to inform those present at the ministerial meeting and the union meeting of the interest to move the conference meeting date this year to Saturday rather than Tuesday, and to observe the response and note that this is not to set a precedence, but rather to highlight the efforts by the conference with Blended Fellowship. A motion was carried for the conference to advance \$500.00, the total cost, to the Convention of OFWB today in order to place The Reverend and Mrs. Fred and Linda Baker on the 'Wall of Honor' at the OFWB Headquarters. The conference will receive two special collections: one at the May 5, 2005, minister's meeting and one at the July, 2005, minister's meeting to offset the cost and any balance owed to be absorbed by the conference. A motion was carried that the fourth Sunday in October, 2005, be designated Scholarship Sunday in the Cape Fear Conference with the money received that Sunday to go to the Board of Education to increase the amount and/or number of scholarships available and awarded in the Cape Fear Conference.

The Cape Fear Conference Executive Committee met on August 1, 2005, at the First FWB Church, Smithfield. A motion was carried to move the 151st Annual Session of the Cape Fear Conference to Saturday, November 19, 2005, for the year 2005, to simply accommodate Blended Fellowship Mission Church in their plans to host the Annual Conference. A motion was carried that the conference make up the amount of \$92.00 for the 'Wall of Honor' for The Reverend and Mrs. Fred and Linda Baker. Treasurer's report was given by Treasurer Sam Weeks. A letter from the Reverend Ed Gonzales suggesting that the conference include a brief history of the Cape Fear Conference at our Annual Meetings was discussed. The Executive Committee discussed concern for our ministers' (ordained and licensed) attendance at the Annual Sessions of the Conference. A motion was carried to remove the Reverend Mike Ledbetter from the list of Cape Fear Conference ministers due to transfer of membership to the Eastern Conference. The Executive Committee discussed the future support of our churches for Blended Fellowship Mission. The 151st Annual Session of the Cape Fear Conference was planned. It was decided that Moderator Jerry Stephenson, Treasurer Sam Weeks, Pastor/Director Doug Seymour, and Pastor Dean Kennedy will meet to plan the dedication service for Blended Fellowship. A motion was carried for the conference to pay for the cost of the meal for the 151st Annual Conference.

The Cape Fear Conference Executive Committee met on September 6, 2005, at the First FWB Church, Smithfield. The Executive Committee met with the Conference Disaster Relief Coordinator, Ricky Warren, to discuss the responsibilities of the Conference Coordinator and the Local Church Coordinator. A motion was carried to send a letter to each

church of the conference with suggestions and information concerning our disaster relief efforts. A motion was carried to recommend that the Cape Fear Union coordinate a date and meeting place with our Conference Disaster Relief Coordinator to provide information concerning Katrina disaster relief to local churches, pastors, and local disaster relief coordinators.

The Cape Fear Conference Executive Committee met on October 24, 2005, at the First FWB Church, Smithfield. Cape Fear Conference Disaster Relief Coordinator, Ricky Warren discussed with the Executive Committee the possible donation of trailers to be used in our Disaster Relief Ministry. A motion was carried to request a meeting with Director of Disaster Relief and the Board of Home Missions & Evangelism to discuss issues concerning the support of our Disaster Relief Ministry by our churches.

The Cape Fear Conference Executive Committee met on November 07, 2005, at the First FWB Church Smithfield. The committee reviewed the printed program for the 151st Annual Session of the Conference. Treasurer Sam Weeks gave the report of Blended Fellowship Mission and discussed the commissioning of the mission into church status. Pastor/Director Doug Seymour reports that the mission is not ready at this time. A motion was carried that at the 151st Annual Session of the Cape Fear Conference, the Executive Committee, will encourage our churches to support Blended Fellowship financially and prayerfully for an additional two years beginning in calendar year 2006. The Executive Committee plans to meet with Blended Fellowship at its location on a future date to discuss a plan to reach church status. Treasurer Sam Weeks gave the conference financial report. A meeting of the Executive Committee will be planned for November 30, 2005, to review the conference report for the Convention Yearbook.

The Report of the Ordaining Board 151st Cape Fear Conference of Original Free Will Baptists November 19, 2005

The Ordaining Board met on January 24, 2005 at the First FWB Church, Smithfield All board members were present.

The Board met with Richard Whitman, a licensed minister from Pleasant Grove Church, who requested to discuss two issues:

- 1.) He would like to serve at Smyrna Church for 90 days. Motion was made, seconded, and passed.
- Mr. Whitman asked for a waiver of the educational requirement so he can proceed with ordination for the following reasons- his age, years of experience in ministry-related work, and near completion of his educational requirements.
 The Board excused Mr. Whitman from the meeting and discussed his request. A motion

The Board excused Mr. Whitman from the meeting and discussed his request. A motion was made to offer Mr. Whitman a compromise. It was moved that he proceed with ordination procedures. Mr. Whitman will meet with the Ordaining Council at our next meeting

in May and bring a signed letter stating that the completion of the 60-hour minimum requirement would be met within a reasonable amount of time. Mr. Whitman will also bring a letter, signed by the clerk and pastor of Pleasant Grove Church, stating that he is approved by the church to sit for his ordination exam.

The Board met with Mr. Alan Price, licensed minister from Powhatan Church, to review his ordination exam. The Ordination Board recommends that Mr. Price be re-examined on church doctrine and Original Free Will Baptist history. Mr. Price may determine when he is prepared to take this portion of the exam at his convenience.

The Ordaining Council reviewed the enrollment of ministers and their attendance records for the last five years. It was determined that only two letters would be sent to ministers for their unexcused absences at the Cape Fear Conference for the last two consecutive meetings: Reverend Mike Ledbetter and Reverend Pete Rawls.

The Ordaining Board met on April 4, 2005 at the St. Mary's Grove Church, Benson

The Board members present were, Rev. Joe Ballance, Rev. Frank Harrison, Rev. Roy Clifton, and Rev. Aubrey Williamson.

The secretary reported that a phone call was received from Rev. Mike Ledbetter in response to failing to attend the conference. He stated that he had requested to transfer his conference membership to the conference of the church that he is now pastoring.

The Board met with Mr. Alan Price to review the answers to questions on Church doctrine and Original Free Will Baptist Church history relating to re-examination for ordination. After discussions and oral examination, the motion was moved, seconded, and passed to proceed to ordain Mr. Price. The ordination date was set for May 1, 2005, at 4pm at the Powhatan Church. Mr. Price indicated that he would like for the Rev. Roy Clifton to deliver his ordination message.

The Board met with Mr. Jonathan Pearce for oral examination after having graded his written exam. Motion was moved, seconded, and passed to proceed to ordain Mr. Pearce. The ordination date was set for May 15, 2005, at 3pm at the Faith Church. Mr. Pearce indicated that he would like for Rev. Donnie Massey to deliver the ordination message.

The Ordaining Board met on May 23, 2005 at the First FWB Church, Smithfield

The Board members present were, Dr. Sam Weeks, Rev. Frank Harrison, Rev. Roy Clifton, and Rev. Aubrey Williamson.

Sam Weeks, Convention Representative, reported on the progress of networking for youth pastors. His report stated that there is work that needs to be completed that is already started. The Board met with Mr. Clarence "Dickie" Privette. After review of ordination examination and oral questions it was moved to proceed with ordination. Ordination was

tentatively scheduled for June 12, 3pm, at the Haymount Church.

The Board met with Rev. Pete Rawls concerning a letter about missing two consecutive Cape Fear Conference meetings. Discussion followed and it was agreed upon to meet again concerning this issue at the next scheduled meeting of the board, July 25, 1:00pm.

The Board met with Mr. Richard Whitman to present oral examination questions. It was concluded that Mr. Whitman needed to review his history and doctrinal statements and return to conclude his oral examination. It was moved, seconded, and passed with one exception. Rev. Roy Clifton abstained. It was moved, seconded, and passed to approve 90 more days at Smyrna Church for Mr. Whitman.

The Ordaining Board met on June 6, 2005 at St. Mary's Grove Church, Benson

The Board members present were Rev. Joe Ballance, Rev. Frank Harrison, Rev. Roy Clifton, and Rev. Aubrey Williamson.

The Board met in special session to finish Mr. Richard Whitman's oral examination. Questions followed, it was moved, seconded, and passed unanimously to proceed with the ordination. Ordination is tentatively scheduled for July 10 and July 24 will be the alternate date. The service is to be held at Smyrna Church.

The Ordaining Board met on July 25, 2005 at the First FWB Church, Smithfield

The Board members present were Dr. Sam Weeks, Rev. Frank Harrison and Rev. Aubrey Williamson.

The Board met with Mr. Scott Satterfield to review the written portion of his ordination exam and administer the oral portion. After satisfactorily answering the questions posed to him, it was motioned, seconded, and passed to proceed with ordination subject to the approval of the absent members of the board. Ordination date was set for August 28, 3:00pm at Pleasant Grove Church in Erwin.

Discussion followed concerning Rev. Pete Rawls' absences at the Annual Session of the Conference and failure to attend today's meeting as requested. We will extend another invitation to him by letter to be in attendance at the next scheduled meeting of the Board on October 24, 1:00pm.

The Ordaining Board met on September 19, 2005 at the First FWB Church, Smithfield The Board members present were, Rev. Joe Ballance, Dr. Sam Weeks, Rev. Frank Harrison and Rev. Aubrey Williamson.

The Board met with Mr. John Butler, a candidate for licensure from Oak Grove Original Free Will Baptist Church, Newton Grove, NC. After reviewing his application and his call in the ministry, the Board discussed his intentions for ministry. A motion was made, seconded, and passed unanimously to approve Mr. Butler for license to preach the Gospel by his church.

The Board met with Mr. Bryan Williamson to review the written examination and administer the oral exam for ordination. After satisfactorily answering questions posed to him, the motion was recommended, seconded, and passed to proceed with ordination. Bryan will come back with a date for his ordination at a later time.

The Board was reminded that we decided to send a letter to invite Rev. Pete Rawls to our meeting on October 24, 2005.

The Ordaining Board met on October 24, 2005 at the First FWB Church, Smithfield The Board members present were Rev. Joe Ballance, Dr. Sam Weeks, Rev. Frank Harrison, and Rev. Aubrey Williamson.

Discussion that the Rev. Pete Rawls has failed to comply with the requests of this Board, ended with a motion to a send letter to Rev. Pete Rawls requesting that he turn in his ordination credentials from the Cape Fear Conference and we will reinstate his old credentials. Motion seconded and passed.

The Board met with Rev. Fred Johnson to discuss Rev. Wade Daughtry's intentions concerning affiliation with our denomination.

The Board met with Mr. Troy Jelley and Rev. Braxton Carter to discuss Mr. Jelley's letter of request for licensure to preach the Gospel. After discussion, motion seconded and passed that we approve Mr. Jelley and send a letter stating this to Wooten's Chapel Original Free Will Baptist Church for them to license him. (Rev. Aubrey Williamson will be his mentor). The Board met with Rev. Wade Daughtry, member of Lanwood Chapel Original Free Will Baptist Church. Rev. Daughtry is seeking recognition as an ordained minister. He comes to us as an ordained minister from the Independent Baptist Church. After discussion, the board approved with the following contingencies:

- a. We will recognize Rev. Daughtry as an ordained minister in good standing for a one year probation. (Rev. Joe Ballance will be his mentor)
- b. Rev. Daughtry will take a course in Original Free Will Baptist church history.
- c. Rev. Daughtry will return after one year to meet with the Ordaining Board on October 23, 2006 to review his year of service and decide on issuing a certificate of ordination.

Cape Fear Minister's Association November 19, 2005

During the past year, the Cape Fear Minister's Association had four meetings. Several good speakers made presentations that provided us with excellent information about our denomination and challenged each of the ministers to live closer to Christ.

Our guests included Reverend Doug Seymour and Dr. Sam Weeks, who gave us an update on Blended Fellowship's progress and their needs. Reverend Donald Fader, Director of Church Finance and Minister's Program spoke to us about how they could help the church manage its money and as a result, the church could help them. He also gave us information on the Minister's Program and how they were able to assist the retired ministers or the widow of an Original Free Will Baptist Minster through the gifts of the church. The Reverend Buddy Sasser, Director of Convention Services, came and left us with a challenge to increase our church membership by five percent each year in a 5-year program. He said the people are out there, we just have to go out and witness to them. Brother Ronnie Taylor, Director of our Retirement Homes Program informed us that the program was meeting the needs of their residents. He also challenged us to include them in the church budget if they were not a budget item. The Rev. Harold Jones came and presented a slide show of their mission work and stated that each Free Will Baptist should be proud of the work that is being accomplished by our Foreign Mission Program. Brother Harold told us that their funds were getting low and challenged us to increase our offering to the Foreign Mission Program.

During this year the Cape Fear Conference Minister's Association has placed two of our members and their wives on the Wall of Honor. They are the Reverend Fred Baker and wife, Linda and Dr. Sam Weeks and wife, Connie.

We have 21 ministers on the roll with an average attendance of 16 ministers each meeting. Our meetings were at the First Free Will Baptist Church in Smithfield. Dr. Sam Weeks and his wife, Connie, with assistance from members of his church, prepared the noon meals for us.
