PROCEEDINGS

The One Hundred and Fifty-second Annual Session of the Cape Fear Conference of Original Free Will Baptists (OFWB) convened at Smyrna OFWB Church, Meadow Community, North Carolina on November 14, 2006.

The congregation opened in singing 'Trust and Obey', Towner, led by song leader, Brother Peyton Lee. Licensed Minister John Butler offered "Scripture and Prayer" from Matthew 14:22-31 and commented "that obedience does not mean that we avoid the adversary. Many times obedience will place us in the midst of the storm. Jesus will come and give us grace to obey." The conference was welcomed by Pastor Whitman of Smyrna Church. The response was heard from Pastor/Director Doug Seymour of Blended Fellowship Mission Church.

Moderator Aubrey Williamson, called the session to order. The rules of registration were then explained by the Credentials Committee Chair Braxton Carter, as adopted by the One Hundred Fourteenth Session of the Cape Fear Conference. Clerk Jesse Fulcher called the roll of Officers and Standing Boards, Churches, and Ministers. The Moderator recognized our visitors. The Reverend John Hill and the Reverend Wade Daughtry were received into the Cape Fear Conference by motion and offered the right hand of fellowship in behalf of the conference.

Moderator Aubrey Williamson offered words of encouragement to the conference from Matthew 22 and 28. He commented that "we must love God and our neighbors. The Spirit will enable us to obey God in His commands." The conference paused for prayer remembering requests received during the conference. Prayer was led by the Reverend Joe Ballance.

The following temporary Committees were appointed by Moderator Willamson. Temperance/Resolutions Committee: Chair Frank Harrison, Joe Ballance, Ken Dabbs

Obituary Committee: Chair Roger Hill, Dean Kennedy

Credentials Committee: Chair Braxton Carter, John Butler, Richard Whitman

Nominating Committee: Chair Sam Weeks, Fred Baker, Jim Bogle

Representatives from our denominational ministries were present and given an opportunity to speak on the behalf of each ministry. The following ministries were represented: Convention of OFWB – Director of Convention Services, Buddy Sasser; Retirement Homes – Ronnie Taylor; Sunday School Ministry – Mary Dudley; FWB Press – Cliff Gray; Camp Vandemere – Wesley Taylor; Home Missions & Evangelism and Harvest Connection – David Hansley; Children's Home – Bobby Taylor; Mount Olive College – Jeff Daughtry; Cragmont Assembly – Bryant Hines. A closing report was given by Director Sasser encouraging churches to support our denominational ministries and to invite the ministry directors to visit with the local churches.

A report was give by Dr. Burkette Raper for the North Carolina Foundation of Christian Ministries.

The Reverend Ed Gonzalez, Pastor of First FWB Church, Warsaw, brought the morning message from Colossians 2:14. He stated that "God brought His plan of salvation to man. A man came to the cross who called himself Jesus, the Son of God. The High Priest ordered for a superscription to be placed above that cross to read "KING OF THE JEWS." The name was an indictment and charges for all to see. It exclaimed Jesus as the King. It was an exhibition of God's Word and exultation that Christ is King. The men on to the cross to the right and to the left deserved to be there, but Jesus did not. We should bow to our 'King' Jesus!"

Moderator asked the conference if the written report of the executive committee should be read to the conference. Motion was made to accept the written report of the executive committee as given. Motion was carried.

The blessing was offered by Pastor Whitman and the conference went to lunch.

AFTERNOON SESSION

The afternoon session began with the congregation singing "Leaning on the Everlasting Arms", *Showalter*. 'Scripture and Prayer' was offered by Licensed Minister, Tina Penny, from John 17:20-23. She commented that "God sent His Son and loves us just as much."

The following reports of the Standing Boards were received by the conference (see attached reports of the Standing Boards). The Cape Fear Minister's Association report will be submitted at a later date. The Cape Fear Youth Fellowship and the Christian Board of Education reports were given by Chairperson Martha Parsons. Motion carried to accept these reports.

The written report of the Ordaining Board was submitted to the conference by Chair Sam Weeks. Motion was made to receive the report. Motion was made to amend, to remove the portion of the report that reads "The following have been added to the list of licensed ministers since our last conference: Tina Webster Penny – Johnston Union Church – January 23, 2006." The motion to amend was ruled 'out of order' by the moderator. Motion to sustain the ruling of the chair was defeated by a vote of 32 to 20. Motion to amend the Ordaining Board report moved forward with a second. Discussion of the matter followed with a personal testimony from Licensed Minister, Tina Penny. 'Point of Order' was called by the Reverend Otis Hamm, stating that "since the conference has ordained women in the ministry in the past, precedence has been set. Therefore, a two-

thirds vote must be received in order to carry the motion to amend 'said portion' of the Ordaining Board's report." The Chair sustains the 'point of order' and 'question' was called for the vote. The motion to amend was then defeated by a vote of 33 to 27. Motion to accept the written report of the Ordaining Board was then carried 34 to 28.

The following reports of the Temporary Committees were then received (see attached reports of the Temporary Committees). The Temperance/Resolutions Committee had one resolution that was read and a motion carried to accept. The Obituary Committee reported the deaths of two of our ministers this past year. The Credentials Committee gave a report of the Annual Conference's attendance. The Nominating Committee made its recommendations to the conference and it was voted by acclamation to accept the committee's recommendations.

The Treasurer's Report was given by Treasurer Sam Weeks and was received by motion (see attached report). Motion carried to contribute the amount of \$1,200.00 to the North Carolina Foundation of Christian Ministries.

The conference then moved into its business session. The Reverend Roy Clifton resigned from his duties on the Cape Fear Ordaining Board.

A rising vote of appreciation was extended to the Cape Fear Conference Executive Board for their service to the conference.

The Nominating Committee adjourned to consider a nomination for the Conference Ordaining Board. It was determined that this matter be referred to the executive committee.

The 153rd Annual Session of the Cape Fear Conference will be held on November 13, 2007, at St. Mary's Grove OFWB Church.

Motion was carried to adjourn the 152nd Session of the Cape Fear Conference and the conference was dismissed with prayer by Brother Sam Weeks.

A summary of the following Ordaining Board Minutes was reported 152nd Cape Fear Conference of Original Free Will Baptists

The Ordaining Board met on January 23, 2006, at the First FWB Church, Smithfield.

Board members present were: Sam Weeks, Aubrey Williamson, Frank Harrison, and Roy Clifton.

The Board met to consider Mr. John Butler, licensed minister from Oak Grove Church, for approval to serve Covenant for 90 period. Moved, seconded, and passed unanimously. The Board discussed the status of Rev. Pete Rawls. The Secretary will contact Mr. Rawls by phone and request to exchange certificates of ordination. A request has been made by letter for him to return the Cape Fear Conference certificate of ordination with no response.

The Board met with Mrs. Tina Penny from the Johnston Union Church to discuss licensure. A letter was received from the church recommending her for our consideration for approval for licensure. After much discussion with Mrs. Penny and privately with the Board, a motion was moved, seconded, and passed to approve her for licensure by Johnston Union Church.

The Ordaining Board met on April 24, 2006, at the First FWB Church, Smithfield. Board members present were: Sam Weeks, Aubrey Williamson, Frank Harrison, and Joe Ballance.

The Secretary reported that Mr. Pete Rawls had surrendered his Cape Fear Conference ordination credentials as requested. His original credentials were returned to him as previously agreed.

It was noted that Rev. Wade Daughtry's mentor would contact him concerning the contingencies that we agreed upon at the October 2005 meeting of the Board of Ordination.

Mr. John Butler, licensed minister from Oak Grove Church met with the Board to discuss his request for a 90-day extension to serve Covenant Mission. After discussion, motion seconded and passed for the 90-day extension.

Mr. Bryan Williamson's, licensed minister from St. Mary's Grove Church, status was discussed. Bryan has successfully completed all of the requirements for ordination as set forth by the Board including passing the examination for ordination. He has not made a request for a date for Ordination. The Board of Ordination agrees to wait for his request with no time limit.

The Ordaining Board met on July 24, 2006, at the First FWB Church, Smithfield. Board members present were: Sam Weeks, Aubrey Williamson, Frank Harrison, and Joe Ballance.

The Board met with Mr. John Butler, licensed minister from Oak Grove Church, to discuss his request to serve for another 90 days at Covenant mission. After discussion, the motion seconded and passed for another extension.

The Board discussed Rev. Wade Daughtry's progress with the contingencies that were set at the October 24, 2005, meeting. The secretary will mail a letter to Mr. Daughtry requesting a meeting with the Ordaining Board at our October 23, 2006, meeting, as previously agreed upon.

It was noted that a letter was sent to Mr. Kyle Watson, former licensed minister from Lee's Chapel Church concerning his intentions for re-licensure. He has not responded as of the date of this meeting.

The Ordaining Board met on October 2, 2006, at the First FWB Church, Smithfield. All Board members were present, along with members of the Executive Committee of the Cape Fear Conference (Otis Hamm, Sam Weeks, Jesse Fulcher, Clerk, Aubrey Williamson, Interim Moderator)

This was a special called meeting.

The Board met with the Conference Executive Committee to discuss the withdrawal letter received from Vandora Springs Free Will Baptist Church, Inc., signed by the pastor, clerk, and deacons. Rev. Jerry Stephenson, pastor, was invited to attend a meeting at 10:30 a.m. to clarify questions regarding his intentions as an Original Free Will Baptist minister. Rev. Stephenson chose not to attend this meeting.

After much discussion, a motion was moved, seconded, and passed to send a letter from the Ordaining Board to Rev. Jerry Stephenson asking him to inform the Board concerning his intentions to continue as an Original Free Will Baptist Minister, or to surrender his credentials to the Conference by October 23, 2006.

The Ordaining Board met on October 23, 2006, at the First FWB Church, Smithfield.

All Board members were present.

The Board met with Rev. Wade Daughtry to review the contingencies mutually agreed upon at the October 24, 2005 meeting. Rev. Daughtry has successfully met the requirements set by the Ordaining Board. Motion made, seconded, and passed for him to surrender his current credentials with the Independent Baptist Church in exchange for Cape Fear Conference Ordination Credentials effective this date.

The Board considered Mr. John Butler, licensed minister from Oak Grove Church to serve Covenant for a period of 90 days. A motion was made, seconded, and passed for a 90-day approval.

The Board reviewed a letter received from the Eastern Conference stating that Rev. Tim Heath is a member in good standing and requests permission to serve Johnston Union Church. Motion made, seconded, and passed.

Rev. John Hill has expressed a desire to transfer his membership from the Eastern Conference, as he will be assuming the pastorate at First Free Will Baptist Church in Goldsboro effective December 2006. Motion was made, seconded, and passed to add his name to the list of Cape Fear Conference ministers, contingent upon receipt of his recommendation letter from the Eastern Conference.

Jerry Stephenson willingly surrendered his credentials to the Conference by mail. Motion was made seconded and passed to send two announcements for printing in *The Free Will Baptist* publication: 1.] Rev. Wade Daughtry is among the list of ordained ministers in the Cape Fear Conference. 2.] Jerry Stephenson is no longer an Original Free Will Baptist minister, nor a member of the Cape Fear Conference.

The Report of the Minister's Association 152nd Cape Fear Conference of Original Free Will Baptists

During the past year, the Cape Fear Minister's Association had four meetings. Several good speakers made presentations that provided us with excellent information about our denomination and challenged each of the ministers to live closer to Christ.

Our guests included Reverend Doug Seymour, who spoke at two meetings and gave us an update on Blended Fellowship's progress and their needs. At one meeting he showed a video entitled "A Man Called Norman" which taught us that God will bless us if we follow His teaching of "love thy neighbor". At another meeting he showed a video by David Ring which told us that we should be doing God's will, because if he can do it, anyone can. Reverend Mark Hobbs, a Chaplain of the OFWB serving in the U.S. Air Force, spoke of his life as a child growing up in Johnston County in a FWB Church, his acceptance of the call into the ministry, his ordination and entrance into the Chaplaincy. It was a very interesting and informative talk. Rev.
