PROCEEDINGS

The One Hundred and Fifty-Third Annual Session of the Cape Fear Conference of Original Free Will Baptists (OFWB) convened at St. Mary's Grove OFWB Church, Benson Community, North Carolina on November 13, 2007. Moderator Aubrey Williamson presented the program for adoption.

The congregation opened in singing 'When We All Get To Heaven', *Wilson*, led by song leader, Rev. Dean Kennedy. Carla Williamson offered scripture and prayer from Luke 24:44-49. The conference was welcomed by Pastor Williamson of St. Mary's Grove OFWB Church. The response was heard from Helen Smith of Smyrna OFWB Church.

Clerk Eva Ballance called the session to order. The rules of registration were then explained by the Credentials Committee Chair Roger Hill, as adopted by the One Hundred Fourteenth Session of the Cape Fear Conference. Clerk Eva Ballance called the Roll of Officers and Standing Boards, Churches, and Ministers. The Moderator recognized the visitors. A welcome was extended by Rev. Frank Harrison to Larry Coats for his return to the ministry.

Moderator Aubrey Williamson offered words of encouragement to the conference with reference to Galatians 4:4a, "When the fullness of time was come". He commented that "Our hour has come. God's timing is perfect. We are here at this time to do the work of impacting the world with the Gospel. Nothing is impossible with God. We should be the people we claim to be because of His love for us."

Motion was made to appoint the following temporary Committees by Moderator Williamson. The motion carried.

Temperance/Resolutions Committee: Chair Fred Baker, Otis Hamm, Richard Whitman Obituary Committee: Chair Doug Seymour, Emmitt Jones

Credentials Committee: Chair Roger Hill, Clarence Privette, John Hill Nominating Committee: Chair Sam Weeks, Dean Kennedy, Ken Dabbs

Representatives from our denominational ministries were present and given an opportunity to speak on the behalf of each ministry. The following ministries were represented: Convention of OFWB - President Charles Lynwood Renfrow, Blended Fellowship Mission/Ministry - Rev. Doug Seymour, Foreign Missions - Harold Jones, Mount Olive College - Jeff Daughtry, Sunday School Ministry - Mary Dudley, Home Missions & Evangelism and Harvest Connection - Mary Dudley, Children's Home - Cynthia Batten, Retirement Home Ministry - Ronnie Taylor, Free Will Baptist Press - Cliff Gray, Camp Vandemere - Wesley Taylor, Church Finance and Minister's Program - Charles Lynwood Renfrow, Cragmont Assembly - Carolyn Best.

A report was given by Dr. Burkette Raper for the North Carolina Foundation for Christian Ministries. John Hill spoke on behalf of the Ministerial Association.

The Morning Worship Service began with singing "I Will Sing the Wondrous Story", Bilhorn, led by song leader, Peyton Lee. Special music was presented by Heather Markuson. Dr. Alan Lamm, pastor of Casey's Chapel OFWB Church and Professor of History at Mount Olive College, brought the morning message from Daniel 5. He stated that "Our young people are being (incorrectly) taught that Christians are backward, the Bible is not the inspired Word of God, and that Jesus is not the way of salvation. People in the world and in the church, when weighed, are found lacking, just like Nebuchadnezzar and Belshazzar. The handwriting is on the wall today. People tend to come to church to be served, not to serve. There is a need for a spirit-filled, born again revival." An anointing service for Rev. Ronnie Hayes took place during the invitation and altar call.

The blessing was offered and the conference went to lunch.

AFTERNOON SESSION

The afternoon session began with the congregation singing "Sunshine In My Soul", Sweney. Scripture and prayer were offered by Chris Markuson, Jr. from Philippians 4:6-9.

The following reports of the Standing Boards were received by the conference (see attached reports of the Standing Boards). The Moderator asked the conference to accept the written report of the executive committee. Motion was made to accept the written report of the executive committee as presented. Motion was carried. The Mission's Committee report from Blended Fellowship was noted as having been given during the morning session. The Ordaining Council report was given by Aubrey Williamson. The right hand of fellowship was extended by Moderator Aubrey Williamson to Rev. Gene Britt, welcoming his transfer of membership from the Central Conference to the Cape Fear Conference. The Woman's Auxiliary Report was given by Carolyn Jernigan. The Cape Fear Youth Fellowship and the Board of Christian Education reports were given by Martha Parsons. The Cape Fear Minister's Conference report was given by Joe Ballance. These reports were accepted as information.

The following reports of the Temporary Committees were then received (see attached reports of the Temporary Committees). The Temperance/Resolutions Committee presented six resolutions, of which five passed and one was defeated. A rising vote of thanks was given by the Cape Fear Conference to St. Mary's Grove OFWB Church for graciously hosting the 153rd Annual Session. The Executive Committee members were given a rising vote of thanks for an excellent conference program. The Obituary Committee reported the deaths of two ministers and a pastor's wife during the past year. Recognition was made from the floor of the death of a previous secretary of the Cape Fear Union. The Nominating Committee made its recommendations to the conference and it

was voted by acclamation to accept the committee's recommendations. The Credentials Committee gave a report of the Annual Conference's attendance.

The Treasurer's Report was given by Treasurer Sam Weeks and was received by motion (see attached report).

Information regarding the Wall of Honor at Convention Headquarters was presented by Dr. Sam Weeks.

The conference then moved into its business session. New business was presented questioning if there is a need to increase the dues from the churches to the Conference. No action was taken.

The 154th Annual Session of the Cape Fear Conference will be held on November 11, 2008, at Powhatan OFWB Church.

Motion was carried to adjourn the 153rd Session of the Cape Fear Conference and the conference was dismissed with prayer remembering the multiple prayer requests that were made.

Cape Fear Conference Executive Committee Minutes 2007

The Cape Fear Conference Executive Committee met December 11, 2006, at the First FWB Church in Smithfield at 4:00 p.m.

The meeting was called to order by Moderator Aubrey Williamson. Conference Executive Committee present: Aubrey Williamson, Otis Hamm, Sam Weeks, Eva Ballance, Carolyn Jernigan and Ken Dabbs.

Opening Prayer and Devotion: Aubrey Williamson

The Cape Fear Conference Annual report for the Convention Yearbook was reviewed by the Executive Committee. A motion was carried to accept this report as corrected.

Rev. Jesse Fulcher read letters and previous meeting minutes regarding the withdrawal of Vandora Springs OFWB Church from the Cape Fear Conference.

Treasurer Sam Weeks reported the Treasurer's report to the Executive Committee.

A review was made of Daly's Chapel Church reports dated June to October 2006. A motion was carried to request Daly's Chapel Church by letter to continue sending copies of their reports quarterly and in addition to the reports, to request a visit from the Acting Director/Pastor every six months.

A letter regarding Disaster Relief Trailer donations will be sent to all churches in April, 2007.

A motion was carried to contact Rev. Roy Clifton for reconsideration of his decision to withdraw from the Ordaining Council.

A review of the CFC Annual Report 2006 and 2005 revealed three ministers who had missed two consecutive annual conferences without being excused. Ministers will be notified by letter.

A meeting of the Executive Committee was approved for April 23, 2007 at 4:00 p.m. at Smithfield 1st FWB

Motion was carried to adjourn. Rev. Ken Dabbs led the closing prayer.

The Cape Fear Conference Executive Committee and The Ordination Board met in Joint Session on February 5, 2007, at the First FWB Church in Smithfield at 4:00 p.m.

The meeting was called to order by Moderator Aubrey Williamson. Conference Executive Committee present: Aubrey Williamson, Otis Hamm, Sam Weeks, Eva Ballance, Carolyn Jernigan and Ken Dabbs. Ordination Board present: Sam Weeks, Aubrey Williamson and Joe Ballance.

Opening prayer and Devotion: Aubrey Williamson

The December, 2006 Executive Committee Meeting minutes stood approved as corrected.

Treasurer Sam Weeks reported the Treasurer's report to the Executive Committee.

The letter, requesting all churches and pastors to support the purchase of the trailer by the Disaster Relief Ministry, will be released in February, 2007, with a respond date of August, 2007.

Rev. Sam Weeks had an opportunity to interact with Ronnie Taylor, from Daly's Chapel Church, prior to his receipt of the letter from the Executive Committee. Ronnie Taylor stated that he would be glad to continue sending reports for the Executive Committee's review and come to meetings as scheduled by the Executive Committee.

Rev. Jesse Fulcher will submit the 2006 Cape Fear Conference Annual report to the Convention for publication and forward a copy to Clerk, Eva Ballance, when it is completed.

Conference Moderator, Aubrey Williamson and Ordination Chairman, Sam Weeks were in attendance at a meeting at Convention Headquarters. It was noted that the convention had been operating in the red for the past 4-5 quarters. A request was made to ask for financial support from all the conferences. Rev. Weeks asked the Cape Fear Conference

to give \$1000.00 to the Convention and ear-mark it to be a source of reimbursement for the Convention president. The motion carried.

Rev. Roy Clifton has responded that he would like to reconsider his withdrawal from the Ordination Board. Rev. Clifton has requested a meeting to discuss his reconsideration. The motion carried to schedule a joint meeting with the Executive Committee and the Ordination Board for this purpose.

Concern was expressed over the organization of a group within the Cape Fear Conference, known as "Fellowship of Conservative Original Free Will Baptists." This group formed during a meeting held at Carolina Bible Institute in January, 2007. It was noted that this may have developed as a result of the problems that arose at the Cape Fear Conference Annual meeting. It was determined that officers had been elected by the group. Rev. Roy Clifton had been seated as moderator and Rev. Jim Bogle, as secretary. In an effort to promote peace and unity within the Cape Fear Conference, a motion carried to request Rev. Clifton and Rev. Bogle to meet with the Executive Committee and the Ordination Board.

Motion was carried to adjourn. Rev. Sam Weeks led the closing prayer.

The Cape Fear Conference Executive Committee and The Ordination Board met in Joint Session on February 15, 2007, at the First FWB Church in Smithfield at 4:00 p.m.

The meeting was called to order by Moderator Aubrey Williamson.

Conference members present: Aubrey Williamson, Otis Hamm, Sam Weeks, Eva Ballance and Carolyn Jernigan. Ordination Board present: Sam Weeks, Aubrey Williamson, Frank Harrison and Joe Ballance.

Opening Prayer and Devotion: Aubrey Williamson

The February 5, 2007 Executive Committee Meeting minutes were approved as read. (MSP)

Treasurer Sam Weeks reported the Treasurer's report to the Executive Committee.

Moderator Aubrey Williamson stated there were two items of old business to be addressed. First, there would be a meeting at 5:00 p.m. with Rev. Roy Clifton, regarding his reconsideration to serve on The Ordination Board. Next, there would be a meeting at 5:30 p.m. with Rev. Jim Bogle, to discuss the relationship of the "Fellowship of Conservative Original Free Will Baptists."

At 5:00 p.m., Rev. Roy Clifton came before the CFC Executive Committee and The Ordination Board to discuss his decision to reconsider his position on The Ordination Board. Members of The Ordination Board offered words of support and encouragement to Rev. Clifton to serve with them. After much discussion, Rev. Clifton stated that he would make his decision and notify The Ordination Board.

At 5:30 p.m., Rev. Jim Bogle met with the CFC Executive Committee and The Ordination Board and offered insight regarding the formation of "Fellowship of Conservative Original Free Will Baptists". Rev. Bogle stated that anyone who desired to attend the next meeting of "Fellowship of Conservative Original Free Will Baptists" on Saturday, February 17, 2007, should attend even though it was noted that no Executive Committee member or Ordination Board member present at this meeting had received a letter of invitation to the upcoming meeting or any previous meeting. The Executive Committee and The Ordination Board encouraged Rev. Bogle to express to the "Fellowship" their desire to work together in the spirit of unity and peace.

It was noted that the next meeting of The Executive Committee would be held on April 23, 2007, at Smithfield 1st FWB at 4:00 p.m.

Motion was carried to adjourn. Carolyn Jernigan led the closing prayer.

The Cape Fear Conference Executive Committee met April 12, 2007, at the First FWB Church in Smithfield at 4:00 p.m.

The meeting was called to order by Moderator Aubrey Williamson.

Conference members present: Aubrey Williamson, Otis Hamm, Sam Weeks, Eva Ballance and Carolyn Jernigan. It was noted that Ken Dabbs had missed two consecutive executive committee meetings.

- Devotion and Opening prayer: Carolyn Jernigan.
- The February 15, 2007 Executive Committee minutes were approved as corrected. (MSP)
- Treasurer Sam Weeks reported the Treasurer's report to the Executive Committee.
- Old business was presented for discussion.
- A motion was made to place Rev. Aubrey Williamson in the unexpired term that was vacated by Rev. Roy Clifton. A second to the motion was made. The motion carried.
- It was noted that Rev. Roy Clifton had notified Rev. Aubrey Williamson, by phone, of his decision to reconsider his resignation from The Ordination Board and fill the remainder of the term.
- A motion was made to offer Rev. Roy Clifton the unexpired term that was vacated by Rev. Aubrey Williamson. A second to the motion was made. The motion carried with one dissension.
- Moderator Aubrey Williamson presented a letter to the Executive Committee to notify Rev. Charlie Tucker of his failure to attend two consecutive Cape Fear Conference Annual Meetings without being excused.

In the way of new business, Moderator Aubrey Williamson presented a petition that he had received by mail that read, "As pastors and /or members of the Original Free Will Baptists of North Carolina, we appeal to the Executive Committee and The Ordination Board of the Cape Fear Conference to stand by the Word of God, and to be faithful to our Faith and Disciplines which clearly limit ordination to the men of our Denomination..." Motion was made and carried to rule the petition out of order.

A discussion followed of the importance to inform and educate the laity of the Cape Fear Conference of the history and heritage of The Original Free Will Baptists. It was decided to hold a seminar in the summer, 2007 and invite a well-informed speaker to address those in attendance.

Motion was carried to adjourn. Closing prayer was led by Rev. Otis Hamm.

The Cape Fear Conference Executive Committee met April 23, 2007, at the First FWB Church in Smithfield at 4:00 p.m.

The meeting was called to order by Moderator Aubrey Williamson. Conference members present: Aubrey Williamson, Otis Hamm, Sam Weeks, and Eva Ballance.

Opening Prayer and Devotion: Aubrey Williamson

Ronnie Taylor, representing Daly's Chapel, gave a detailed six-month report on the church membership and attendance, expenses, repairs and plans for potential growth.

Ronnie Taylor announced that he had become a licensed minister in the Eastern Conference as of April 1, 2007. He was commended by the Executive Committee for his plan to become an ordained OFWB minister. Appreciation was expressed to Ronnie Taylor for his excellent report to the Executive Committee.

Previous Executive Committee minutes, from April 12, 2007, were accepted as information. (MSP)

Treasurer Sam Weeks reported the Treasurer's report to the Executive Committee.

In the way of old business, it was noted that Rev. Roy Clifton had accepted the vacant position on the Ordination Board.

It was decided that Moderator Aubrey Williamson would contact Rev. Ken Dabbs regarding his failure to attend the last three Executive Committee meetings. It was decided that a constitutional change regarding absenteeism was not necessary at this time.

Rev. Otis Hamm gave a report of a seminar he had attended in the Central Conference. Literature was provided to all members present. Explanation was given regarding the program and the Concert of Prayer that followed. A motion carried to proceed with a

program in a similar format for the Cape Fear Conference Ministers and laity. A motion carried to ask The Cape Fear Union's permission to present this program at the Union Revival in September. It was noted that this would be an informative session. Rev. Otis Hamm will get more detailed information for discussion at the next Executive Committee meeting.

The next Executive Committee meeting is scheduled for May 31, 2007 at 4:00 p.m. to discuss the program for September. The Executive Committee meeting in July will focus on the planning of the Cape Fear Conference Annual Convention to be held in November. It was requested that the clerk bring a preliminary layout of the program to this meeting.

New business presented was a request by Blended Fellowship to publicize a Fundraiser, Project 122, on their website. It was approved.

Motion was carried to adjourn. Closing prayer was given by Eva Ballance.

The Cape Fear Conference Executive Committee met May 31, 2007, at the First FWB Church in Smithfield at 4:00 p.m.

The meeting was called to order by Moderator Aubrey Williamson. Conference members present: Aubrey Williamson, Otis Hamm, Sam Weeks, Ken Dabbs and Eva Ballance.

Devotion: Aubrey Williamson Opening Prayer: Ken Dabbs

Previous minutes, from April 23, 2007, were read and accepted as information. (MSP)

It was decided that when an Executive Committee member misses two consecutive meetings, contact would be made with that member as a show of concern of their absence.

Treasurer Sam Weeks reported the Treasurer's report to the Executive Committee.

In the order of old business, a re-typed copy of the Constitution was given to each member present for their review. Any suggested changes should be presented at the next regular scheduled meeting.

A second item of old business was a letter received by Moderator Aubrey Williamson, addressed to the Executive Committee, by a member of Daly's Chapel, which expressed concerns of the support of Phase II-Harvest Covenant Agreement with Home Missions. Concerns were no pastor being supplied for Daly's Chapel, no teacher or officer training, and no implementation of a Sunday School program. A meeting was requested by the member for action by the Executive Committee. Moderator Aubrey Williamson noted that in a letter dated August 22, 2004, Daly's Chapel had received full reinstatement as a church in the Cape Fear Conference. Then, in another letter dated August 22, 2004,

Daly's Chapel had requested to be under Phase II-Harvest Covenant Agreement with Home Missions. Moderator Aubrey Williamson stated he had requested a copy of the covenant agreement from Ronnie Taylor. It was determined that letters would be mailed to Daly's Chapel Director, Licensed Minister Ronnie Taylor, Home Missions Board Chairman, Rev. David Charles Hansley, Executive Director, Howard McPherson and to the member from Daly's Chapel who requested the meeting. The letter would request their presence at a meeting with the Executive Committee at Daly's Chapel on June 10, 2007 at 3:30 p.m. to discuss these issues. An alternate date of July 8, 2007 was established. (MSP) A review of the covenant agreement by the Executive Committee was recommended prior to the scheduled meeting at Daly's Chapel. Moderator Aubrey Williamson stated he would contact the member of Daly's Chapel for confirmation of a date. Then the above-mentioned persons would be notified by letter.

A third item of old business concerned the status of Blended Fellowship becoming a church in the conference vs. remaining a mission. It was recommended to think and pray about this decision for discussion prior to the Annual Cape Fear Conference Meeting in November.

There was further discussion regarding a presentation to inform the ministers and laity in the Cape Fear Conference about the issue of women serving in the ministry. It was decided to ask two individuals to write a paper addressing the matter who are in agreement and two individuals to write a paper who are in disagreement. Two individuals will be asked as alternates. Instructions to the writers were that presentations should be a maximum of 20 minutes in length, professionally written, double-spaced, Times New Roman, 12 point, with footnotes. Recommended deadline was established as June 30, 2007. (MSP)

A meeting will be scheduled prior to the regular scheduled meeting for the review of the papers by the Executive Committee provided they are received in a timely manner. It was discussed to address an interest to the Cape Fear Union to consider the September Revival Meeting as an opportunity to present the Forum. Eva Ballance agreed to discuss this matter with the Moderator of the Cape Fear Union, Rev. Braxton Carter.

Motion was made to adjourn. (MSP) Rev. Otis Hamm led the closing prayer.

The Cape Fear Conference Executive Committee met on July 23, 2007, at Disaster Relief Ministry of OFWB in Kinston, North Carolina at 1:00 p.m.

The meeting was called to order by Moderator Aubrey Williamson. Conference members present: Aubrey Williamson, Otis Hamm, Sam Weeks and Eva Ballance.

Devotion: Aubrey Williamson Opening Prayer: Otis Hamm

Previous minutes, from May 31, 2007, were read and accepted as corrected. (MSP)

Treasurer Sam Weeks reported the Treasurer's report to the Executive Committee.

It was decided to discuss any recommendations for changes in the Constitution at the next scheduled meeting.

It was noted that Daly's Chapel Church was doing well and there was no need to meet with them at this time

It was decided to discuss the status of Blended Fellowship as a ministry vs. a church in the conference at the next scheduled meeting.

Discussion continued regarding the Forum. A summary of the following Ordaining Board Minutes was reported. 153rd Cape Fear Conference of Original Free Will Baptists

The Ordaining Board met on February 5, 2007, at the First FWB Church, Smithfield.

Board members present: Sam Weeks, Aubrey Williamson, Joe Ballance.

The Board met at the request of the Cape Fear Conference Executive Committee in a joint session. The meeting was called by the Conference Moderator, Rev. Aubrey Williamson, and Ordination Board Chairman, Rev. Sam Weeks, to discuss a meeting that they had been called to attend by the president of the Convention of Original Free Will Baptists. The meeting they attended was called with all Conference Moderators and Ordination Board Chairmen. It was held on January 24, 2007, at the Headquarters in Ayden, NC. There was discussion concerning procedures for licensure and ordination, with specific attention given to women in ministry. There is concern that all conferences understand the relationship to the churches and the churches to the conferences. The main

suggestion from our Convention President, Rev. Charles Lynn Renfrow, is the stress unity among our churches, our ministers, our Conferences, and our Convention.

The Ordaining Board met on February 15, 2007, at the First FWB Church, Smithfield.

Board members present: Sam Weeks, Aubrey Williamson, Joe Ballance, Frank Harrison The Board met in a joint session with the Cape Fear Conference Executive Committee to meet with the following:

The Rev. Roy Clifton to discuss his reconsideration to return to the Board of Ordination. After much discussion concerning his reaction at the Conference that resulted in his resignation from the Board, we also had questions concerning his affiliation with a newly formed organization called, "Fellowship of Conservative Free Will Baptists."

The Rev. Jim Bogle to discuss the Cape Fear Conference's relationship with an organization called, "The Fellowship of Conservative Free Will Baptists." It was noted that Jim had told his congregation at the first meeting of the Fellowship that it was hosted by the Cape Fear Conference, when, in fact, it was not. Jim noted that this was an oversight and that he had corrected that statement to his congregation. He stated that anyone who wanted to attend the Fellowship meetings was welcomed in the future. It was noted that everyone was not welcomed or invited at the onset, because meetings were held by exclusive invitation only. There were concerns that this group may have intentions that are contrary to the Articles of Faith and Principles of Church Government of Original Free Will Baptist Churches (of the English General Baptist Heritage). There are concerns that this group may be a sect and may have intentions of leaving this denomination. Jim Bogle stated that these are not the intentions of the Fellowship and that they are meeting for the purpose of fellowship and to provide an opportunity to meet with like-minded individuals

The Ordaining Board met on March 18, 2007, at the First FWB Church, Smithfield. Board members present: Sam Weeks, Aubrey Williamson, Joe Ballance

The Board met for the purpose of meeting with Larry Coats concerning his interest in returning to the Original Free Will Baptists as an ordained minister, requesting reinstatement of his credentials. The Board met privately for preliminary discussion concerning Mr. Coats' history with the Conference. Mr. Coats was ordained in 1966 out of the Powhatan FWB Church in the Cape Fear Conference. It is noted that Mr. Coats served Rock Springs Church (Bailey), Steven's Chapel Church (Benson), Johnston Union Church (Smithfield), and Wooten's Chapel Church (Clayton) during his tenure. He has been away from the Conference for 23 years.

The Board then met with Mr. Coats to discuss his intentions and for a question and answer session.

After further private discussion, the Board approved the following recommendation, which was seconded and passed unanimously:

We will permit Mr. Coats to return to the ministry of the Original Free Will Baptist Church for a probation period, with the privileges of a licensed minister for a minimum of 1-year. During the probation period, Mr. Coats will adhere to guidelines as prescribed by the Ordination Board. Mr. Coats will meet with the Ordaining Board on April 23, 2007, 1:00pm to receive information concerning requirements. Mr. Coats will return to

meet with the Ordination Board at the Spring 2008 meeting for a review of requirements and possible reinstatement of credentials. Frank Harrison will serve as his mentor.

The Ordaining Board met on April 23, 2007, at the First FWB Church, Smithfield. Board members present: Sam Weeks, Aubrey Williamson, Joe Ballance, Roy Clifton, Frank Harrison

The meeting was opened with prayer.

The following requirements for Mr. Larry Coats were outlined:

That he have the privileges of a licensed minister for a minimum of 1 year, probationary period.

- That he read Dr. Floyd Cherry's book and Dr. Michael Pelt's book concerning. 2. the history of the Original Free Will Baptist Church and review with his mentor, Frank Harrison.
- That he go through the "study guide" to the satisfaction of his mentor.

The following suggestions were outlined:

- That he begin some college education with biblical courses
- That he be a faithful attender of an Original Free Will Baptist Church.

This will be reviewed in April 2008 for action concerning whether or not to restore his ordination credentials.
