The One Hundred and Fifty-Fifth Annual Session of the Cape Fear Conference of Original Free Will Baptists (OFWB) convened at First OFWB Church of Goldsboro, Goldsboro, North Carolina on November 10, 2009. Moderator Aubrey Williamson welcomed everyone. Moderator Aubrey Williamson presented the program for adoption. Motion was made to accept the program for adoption. Motion was carried.

PROCEEDINGS

The congregation opened in singing "I Will Sing the Wondrous Story", Rowley, led by song leader, Peyton Lee. Licensed Minister Tod Creech offered scripture and prayer from Matthew 28:18-20. The conference was welcomed by Pastor John Hill of First OFWB Church of Goldsboro. The response was heard from Pastor Jim Bogle of Powhatan OFWB Church.

Clerk Eva Ballance called the session to order. The rules of registration were then explained by the Credentials Committee Chair John Hill, as adopted by the One Hundred Fourteenth Session of the Cape Fear Conference. Clerk Eva Ballance called the Roll of Officers and Standing Boards, Churches, and Ministers. Rev. Charles Petit requested to join the Cape Fear Conference. Motion was made to accept Rev. Petit's transfer from the Western Conference to the Cape Fear Conference. Motion was carried. The right hand of fellowship was extended by Moderator Aubrey Williamson to Rev. Charles Petit, as well as a rising vote of thanks, to welcome him to our conference. The Moderator recognized the visitors.

Moderator Aubrey Williamson offered words of encouragement to the conference from Ephesians 4:1-7. He commented that "We are the body of Christ, we are the church, therefore we are the body of Christ. We are His hands and feet, His representative, and as Paul stated, an ambassador for Christ. If the gospel isn't being shared, it is our fault. As God is love, we are to love all people. As believers, we must walk worthy of the position as the body of Christ."

Motion was made to appoint the following Temporary Committees by Moderator Williamson. The motion was carried

Dr. Sam Weeks was recognized as the Cape Fear Conference representative to the Executive Committee of the Convention, who gave the Convention report. He encouraged every Cape Fear Conference Church to place the Convention in their church budget. Rev. Buddy Sasser, Director of Convention Services of the Original Free Will Baptists, was recognized and he introduced the denominational ministry representatives.

Representatives from our denominational ministries were present and given an opportunity to speak on the behalf of each ministry. The following ministries were represented: Retirement Home Ministry - Ronnie Taylor, Children's Home - Gary Lee, Free Will Baptist Press - Cliff Gray, Mount Olive College - Jeff Daughtry, Cragmont Assembly - John Hill, Foreign Missions - Harold Jones, Sunday School Ministry - Gail Heath and Mary Dudley, Minister's Program - Ricky Warren, Home Missions & Evangelism and Harvest Connection - Buddy Sasser and Timothy Webber, Convention of OFWB - Buddy Sasser, Director of Convention Services, who announced the 2010 Directory was available online and in print.

Song leader Peyton Lee led the congregation in singing "There is Sunshine in My Soul", Hewitt.

Moderator Aubrey Williamson requested everyone to review the written report of the Executive Committee prior to the afternoon business session.

Buddy Sasser, Director of Convention Services, introduced Faith Comes By Hearing, a program to send the Word of God to our military through the purchase of Military BibleSticks, that are pre-loaded with the Audio New Testament.

Moderator Aubrey Williamson recognized Dr. Sam Weeks, who introduced Dr. Burkette Raper, President of the Foundation of Christian Ministries. Dr. Raper made an appeal to the Cape Fear Conference to appoint a historian to update the history of the Cape Fear Conference. He provided information on the Shepherd's Fund, endowments established for churches, ministries and scholarships, and a summary of gifts to the Foundation. A Certificate of Appreciation was presented to Dr. and Mrs. Sam Weeks for an endowment established in their honor by Sam's daughter and son-in-law, Frank and Betty Jean Weeks Sutton, for Blended Fellowship Mission/Ministry and First Free Will Baptist Church of Smithfield. Ms. Mae Ellen Warwick was presented a Certificate of Appreciation for an endowment established in memory of her grandparents, Campbell and Lou Allen Warren, for Blended Fellowship Mission/Ministry.

The Morning Worship Service began with singing "Revive Us Again", MacKay, led by song leader, Peyton Lee. Special music was presented by Rev. Buddy Sasser and Rev. John Hill, accompanied by Rev. Roger Hill. Rev. Otis Hamm, pastor of Saratoga OFWB Church, brought the morning message from Galatians 6:14-16. He noted that this letter, written by Paul, was a letter of justification by faith and a letter of restoration through relationships. The woman, caught in an act of adultery, was commanded to be stoned to death by Moses' Law. But through Jesus Christ, she found forgiveness, restoration and a relationship with Christ. The concept of judgmentalism continues in Christianity today. But all of us are one in the body of Christ. We may worship differently, but we are all the

church of Christ. It should not take a catastrophe to bring believers together for the cause of Christ. We're familiar with the Great Commission, but the great omission is not working together for the Kingdom of Heaven. Rev. Aubrey Williamson led in prayer.

Rev. John Hill gave the benediction and blessing and the conference went to lunch.

AFTERNOON SESSION

The afternoon session began with the congregation singing "Trust and Obey", *Sammis*, led by song leader Peyton Lee. Scripture and prayer were offered by Licensed Minister John Butler from John 21:15-17. An announcement was made acknowledging John Butler's upcoming Ordination Service.

Motion was made to adopt the written report of the Executive Committee as given. Motion was carried.

The following reports of the Standing Boards were received by the conference (see attached reports of the Standing Boards). The Conference Mission's Report for Blended Fellowship Mission/Ministry was given by Rev. Doug Seymour. The report was received as presented. Rev. Otis Hamm gave the Feasibility Study Report. It was received as presented. The Ordaining Council report was given by Dr. Sam Weeks. The Woman's Auxiliary Report was given by Carolyn Jernigan. The Cape Fear Youth Fellowship and the Board of Christian Education reports were given by Martha Parsons. The Cape Fear Minister's Conference report was given by Joe Ballance. These reports were accepted as information.

The following reports of the Temporary Committees were then received (see attached reports of the Temporary Committees). The Temperance/Resolutions Committee presented two resolutions, of which both passed. The Obituary Committee reported no deaths of any Cape Fear Conference ministers or wives during the past year. A moment of silence was observed for those who had lost their lives in the recent tragedy at Fort Hood and to show respect to all veterans. The Nominating Committee made its recommendations to the conference. The list of candidates for nomination received a motion to be elected, was seconded and passed. The Credentials Committee gave a report of the Annual Conference's attendance. The Treasurer's Report was given by Treasurer Sam Weeks and was received by motion (see attached report).

The conference then moved into its business session. Old business was from Dr. Burkette Raper, who encouraged an opportunity to come to churches and provide information about The North Carolina Foundation of Christian Ministries to strengthen and expand the work. New business presented was a motion from Rev. Otis Hamm, Chairperson of the Feasibility Committee, to extend the investigation of this committee one year and make a report at the conference in 2010. Motion was carried. Rev. John Hill made a motion to charge the Cape Fear Conference to establish a five-year plan to grow our conference. Motion was carried.

The 156th Annual Session of the Cape Fear Conference will be held on November 9, 2010, at Robert's Grove OFWB Church.

Motion was carried to adjourn the 155th Session of the Cape Fear Conference and the conference was dismissed with prayer by Rev. Ricky Warren.

CAPE FEAR CONFERENCE EXECUTIVE COMMITTEE MINUTES 2009

The Cape Fear Conference Executive Committee met on November 24, 2008, at First Smithfield OFWB Church at 4:00 p.m. The meeting was called to order by Moderator Aubrey Williamson. Conference members present were Aubrey Williamson, Otis Hamm, Sam Weeks, Eva Ballance and Carolyn Jernigan. Otis Hamm gave the devotion from the Gospel of John. Aubrey Williamson prayed the opening prayer.

The final report of the 154th Annual Session of the Cape Fear Conference was reviewed and corrections were made. It was decided to include the revised Constitution in the

yearbook. Motion was made to accept the report for the yearbook. (MSP)

It was noted that two ministers had missed two consecutive annual meeting without requesting to be excused. Rev. Scott Satterfield and Rev. Joe Myrick will be notified by letter from the Executive Committee to arrange a meeting with the Ordination Board in March or May, 2009.

Treasurer Sam Weeks gave the treasurer's report. Balance was \$3054.20. A motion was

made to accept the treasurer's report. (MSP)

The Executive Committee will schedule a meeting with Blended Fellowship for a Feasibility Committee meeting. Recommended dates are January 8, 15 and 22 and February 19 and 26 of 2009 at 7:00 p.m. or 7:30 p.m.

Sam Weeks will take a copy of the letter, dated June 26, 2008, to Daly's Chapel Church on November 29, 2008, to follow up on the Executive Committee's response to their specific needs.

It was recommended that the churches make monetary contributions to Disaster Relief to assist with the making of kits since their supply has been depleted.

Motion was made to adjourn. (MSP) Eva Ballance led the closing prayer.

The Cape Fear Conference Executive Committee met on January 15, 2009, at First Smithfield OFWB Church at 4:00 p.m. The meeting was called to order by Moderator Aubrey Williamson. Conference members present were Aubrey Williamson, Otis Hamm, Sam Weeks and Eva Ballance. Aubrey Williamson gave the devotion from Psalms 6 and prayed the opening prayer.

Treasurer Sam Weeks gave the treasurer's report. Balance was \$1282.07. A motion was

made to accept the treasurer's report. (MSP)

A motion was made to accept the minutes of the Executive Committee meeting from November 24, 2008. (MSP)

A letter from the Executive Committee was delivered to Daly's Chapel Church by Sam Weeks, in response to their specific needs.

It was requested that a letter from the Executive Committee be sent to Covenant, requesting their presence at the March 23, 2009 meeting at 2:30 p.m. to discuss the release of deed from the Cape Fear Conference to Covenant.

It was requested that letters be mailed to Daly's Chapel Church, their pastor and to Home Missions, requesting continuance of the six month reporting to the Executive Committee.

The first meeting will occur May 25, 2009.

The Executive Committee, chosen to serve on the Feasibility Committee for Blended Fellowship met with the Feasibility Committee. Doug and Melanie Seymour and Dean Kennedy were present along with the Executive Committee. The committee discussed the unique situation of this mission/church/ministry and established a regular meeting order.

It was determined that certain tasks needed to be completed by the committee and individual assignments were made.

In conclusion, it was noted that roof repair was a dire need for the Blended Fellowship Worship facility.

The next Executive Committee meeting is scheduled for Monday, March 23, 2009, at 2:30 p.m. with Covenant and 3:30 p.m. with Blended Fellowship.

Motion was made to adjourn. (MSP) Rev. Doug Seymour led the closing prayer.

The Executive Committee of the Cape Fear Conference met on Monday, March 23, 2009, at 4:00 p.m. at First Free Will Baptist in Smithfield. Executive Committee members present were Aubrey Williamson, Otis Hamm. Sam Weeks, Eva Ballance and Ken Dabbs. Moderator Aubrey Williamson called the meeting to order. Aubrey gave the devotion from James 1 and Eva Ballance prayed the opening prayer.

A motion was made to accept the January 15, 2009 minutes with correction. (MSP)

A treasurer's report was given by Treasurer Sam Weeks. Balance was \$1597.07. A motion was made to accept the treasurer's report. (MSP)

Old business discussed was Daly's Chapel OFWB Church had been requested by letter to

report at the next Executive Committee meeting.

New business discussed was a need for roof repair at Blended Fellowship. It was noted that the quote for repair is \$95,000.00 with the possibility of receiving a 5% discount on the total repair cost. Further discussion was tabled until after the meeting with Covenant OFWB Church.

Licensed Minister John Butler and Frank Parsons met to discuss the release of deed from the Cape Fear Conference to Covenant OFWB Church. After review of the budget, accounts and reports from Covenant, Licensed Minister John Butler requested that the Cape Fear Conference leave their name on the deed indefinitely. A motion was made to leave the Cape Fear Conference name on the deed indefinitely. (MSP) Otis Hamm prayed for Covenant prior to their departure.

Moderator Aubrey Williamson stated that he had asked Assistant Moderator Otis Hamm to chair the Feasibility Committee and he had accepted.

Blended Fellowship joined the Executive Committee to further discuss the feasibility of it becoming a church/ministry. Representation included Rev. Dean Kennedy, Rev. Doug and Melanie Seymour, Kayla, their daughter, and a couple that serve on Blended Fellowship's Leadership Council. Aubrey Williamson asked Rev. Dean Kennedy to lead in prayer. Then Aubrey informed everyone of his decision to place Otis Hamm as Chairman of the Feasibility Committee and asked him to take charge of the meeting.

Otis Hamm welcomed everyone to the meeting and asked Blended Fellowship to present information to the Executive Committee. Rev. Dean Kennedy explained the importance of proper selection of persons to serve on the Board of Directors. Also, he stated there was a need for presentation of materials to all serving on the board so they would have a full understanding of the deaf culture. He noted that Doug and Melanie Seymour needed to be a voting voice on the Board. Otis Hamm recommended Sensitivity Training for all new board members. He asked Melanie Seymour to gather information and present a Sensitivity Training Program at the next meeting.

Otis Hamm stated that work was needed to establish a Constitution and leadership at Blended Fellowship. Discussion continued about the present leadership at Blended Fellowship. There are two Leadership Councils, one for the hearing and one for the deaf,

who meet separately for better understanding. A sign language class is taught each Wednesday evening to enhance their ability to communicate.

Rev. Doug and Melanie Seymour addressed the issue of becoming a church. First, Rev. Seymour expressed how the organization is labeled is not so important to him; what is important is that God's work continues to be done. He feels one of two things needs to happen; develop a status that does not conflict with the ministry or modify the The Articles of Faith and Principles of Church Government for Original Free Will Baptists (of the English General Baptist Heritage) to state ... "except for a church that establishes under a ministry." Rev. Seymour shared potential problems that could result by separating the church and the ministry. First, he noted that the mixture of ethnic backgrounds, the hearing and deaf, had worked for them over the past ten years. There are denominational mixes yet they work well together. He explained that the conference oversees the pastor and the leadership, therefore preventing any type of dictatorship. By separating the church and ministry, there could be issues with the voice of authority. Their vision and purpose could be over-ruled by a vote at a business meeting. There would be great difficulty in separating contributions between the church and the ministry. Otis Hamm requested a copy of Blended Fellowship's purpose, vision and present leadership structure, including the number serving. He asked that their church/ministry status be presented at the next meeting. He requested a copy of their church budget and stated that incorporation was inevitable.

The importance of including Doug and Melanie on the Board of Directors was reiterated. All agreed that the Board of Directors should serve as an Advisory Board for guidance to Blended Fellowship.

The next Executive Committee meeting will be held on Monday, June 15, 2009, at First Free Will Baptist in Smithfield. Blended Fellowship will be attending this meeting.

Otis Hamm, Chairman of the Feasibility Committee, turned the meeting over to Moderator Aubrey Williamson. Aubrey requested additional information about the roof repair from Rev. Doug Seymour. Melanie stated that their present loan payment was \$1200.00. Presently, they have \$17,000.00 in the building fund. Approximately \$78,000.00 would need to be borrowed to cover the cost of repairing the roof. Melanie felt that Blended Fellowship could afford a payment increase of \$500.00 per month.

Aubrey thanked everyone from Blended Fellowship for attending the meeting and for providing additional information. He led the group in prayer before their departure.

The Executive Committee continued the discussion regarding the necessary roof repair at Blended Fellowship. Sam Weeks will contact Donald Fader, Church Finance Director, to work out the details of financing this repair and report back at the next meeting. All committee members were in agreement to send a letter to all churches requesting immediate financial support for this emergent need of protecting the interior renovations from further water damage. The letter is to be mailed after March 29, 2009. Sam Weeks is to review the letter prior to mailing.

A letter will be mailed to Daly's Chapel OFWB Church, Rev. Ed Thornton and Rev. David Charles Hansley, Director of Home Missions, to notify them to report to the Executive Committee on August 24, 2009, instead of May 25, 2009.

Ken Dabbs will go to Blended Fellowship and assess the roof situation to see if a temporary repair can be done to prevent further damage until the final repair can be financed.

Motion was made to adjourn. Ken Dabbs led the closing prayer.

The Executive Committee of the Cape Fear Conference met on Wednesday, May 6, 2009, at 10:00 a.m. at First Free Will Baptist in Smithfield. Executive Committee members present were Aubrey Williamson, Otis Hamm, Sam Weeks, Eva Ballance, Carolyn Jernigan and Ken Dabbs. Otis Hamm opened with prayer.

Moderator Aubrey Williamson asked the representatives from CentiMark, Chris Sellers and Keith Battenfield, to present the roof repair recommendations for Blended Fellowship.

The guests provided an impressive report of their product and plan for repairs. They discussed prices and alternative materials that could be used to successfully repair the roof at Blended Fellowship.

A letter of intent was requested to secure the company, CentiMark, for the job. Once the sales agreement is received, it will lock in the price of the roof repair materials.

An Operations Manager will come to Blended Fellowship and arrange the details of the worksite.

The CentiMark representatives answered numerous questions from members of the Executive Committee. Moderator Aubrey Williamson expressed appreciation for the excellent detailed presentation and they were dismissed.

Moderator Aubrey Williamson excused the Centimark representatives and the Executive Committee proceeded in session and a prayer was offered.

He stated that our purpose was to discuss moving quicker with the necessary roof repair at Blended Fellowship. Sam Weeks explained that he had attended a meeting with the Christian Board of Education recently and it had led to comments by Foundation members to move forward with the repair more quickly.

Sam Weeks had determined that funds for this repair were available through Church Finance Association per Director Donald Fader. They would approve a second mortgage. A loan application would need to be completed. Interest rates would be in the range of 6-7%.

Contributions from local churches as a result of the recently mailed requests were noted. It was felt that approximately \$30,000.00 would be received within the month to place as a down payment on the roof repair.

Otis Hamm made a motion to formally address a Letter of Intent to CentiMark and borrow \$75,000.00 from Church Finance Association to repair the roof at Blended Fellowship, including the entrance area, and upgrade to a 60 mil. membrane with a 20-year warranty. The motion was seconded and passed unanimously.

The Letter of Intent would require signatures by Blended Fellowship and the Executive Committee. Clerk Eva Ballance will write a Letter of Intent and arrange a meeting with Moderator Aubrey Williamson, Rev. Doug Seymour and herself for signing purposes at Bojangles in Princeton, NC.

The Executive Committee was in 100% agreement to publicize the need for contributions for this roof repair on the Convention Headquarters' website. Clerk Eva Ballance would forward an email requesting assistance for the roof repair at Blended Fellowship from all churches and laity. A request will be made of Blended Fellowship to publish literature requesting assistance to distribute at the State Convention later this month.

Moderator Aubrey Williamson will notify Chris Sellers, CentiMark, of our intent to contract with them for this repair. Aubrey will request an updated Sales Agreement to be emailed to him reflecting the decision to upgrade the roof membrane and warranty.

Sam Weeks will be responsible to follow up with Donald Fader, Church Finance Association, regarding the loan application. Clerk Eva Ballance will notify all five

trustees by letter that the Executive Committee had voted to proceed with the roof repair at Blended Fellowship and their signatures would be needed on the loan application from Church Finance Association for \$75,000.00. Sam Weeks will try to acquire these signatures at the Convention of Original Free Will Baptists or by other prior arrangement. Other quotes from interested companies were reviewed. Quotes ranged from \$113,900.00 to \$135,000.00.

The meeting was adjourned. (MSP) Sam Weeks closed in prayer.

The Executive Committee of the Cape Fear Conference met on Monday, June 15, 2009, at 8:00 a.m. at First Free Will Baptist in Smithfield. Executive Committee members present were Aubrey Williamson, Otis Hamm, Sam Weeks, Eva Ballance, Carolyn Jernigan and Ken Dabbs. Moderator Aubrey Williamson called the meeting to order. Eva gave the devotion from Romans 15:1, 1 John 1:7 and 1 John 4:7 and prayed the opening prayer.

A motion was made to accept the minutes as read. (MSP)

A treasurer's report was given by Treasurer Sam Weeks. Balance is \$3594.07, with \$1375.00 designated for roof repair at Blended Fellowship, \$665.00 to be paid for the report in the Convention Yearbook, \$1100.00 in the Education Fund, and \$150.00 to be deposited into the Union account, leaving a remaining balance of \$604.07. A motion was made to adopt the treasurer's report. (MSP)

A motion was made to give the Clerk of the Cape Fear Conference a gift of \$300.00 for extra work that she had done. (MSP)

Old business discussed was the cost of the roof repair at Blended Fellowship, which will be \$101,884.00. It was noted that the increased cost for a 20 mil. membrane vs. 15 mil. membrane was between \$3000.00 and \$4000.00. Twenty-five percent is due by the date materials are uploaded and the remainder is due 30 days after completion of the repair. Church Finance is completing the paperwork for a loan concerning the roof repair at Blended Fellowship.

Blended Fellowship's budget that had been received was discussed briefly.

Planning began for the 155th Annual Session of the Cape Fear Conference, which will be held on Tuesday, November 10, 2009, at the First OFWB Church of Goldsboro. Licensed Minister Tod Creech will be contacted to give the morning devotion and Licensed Minister Neil McLamb will be contacted to give the afternoon devotion. Rev. Joe Ballance will be asked to be the Alternate Speaker and Rev. Fred Baker will be asked to be the 2nd alternate.

Motion was made that the Executive Committee recommends to the conference that all the officers whose terms expire 2009 retain their positions with new terms expiring according to the Constitution. (MSP) A letter will be sent to the Chairperson of the Nominating Committee listing each name and position.

The Conference program will be changed from "Mission Committee" to read "Conference Missions" on the program. (MSP) This will be an opportunity for reports to be given by Blended Fellowship and the Task Force Feasibility Study.

Planning of the 155th Annual Convention of the Cape Fear Conference was suspended to discuss issues related to the meeting that followed with Blended Fellowship.

Motion was made that the Executive Committee of the Cape Fear Conference, Pastor/Director of Blended Fellowship, Haymount Church Pastor and one other officer from Blended Fellowship will serve as the Board of Directors for Blended Fellowship Mission/Ministry. (MSP)

It was discussed that Melanie Seymour had been asked to bring information for a Sensitivity Training Presentation to the meeting today.

Also, Pastor Doug Seymour will be informed that modification of the The Articles of Faith and Principles of Church Government for Original Free Will Baptists (of the English General Baptist Heritage) stands as the governing manual for all churches and cannot be amended by one conference. This is a Convention issue.

The Executive Committee meeting was suspended to meet with Blended Fellowship as

scheduled.

Cape Fear Conference Executive Committee Meeting with Blended Fellowship

The Taskforce Feasibility Committee met with Blended Fellowship at 9:00 A.M. Chairman Otis Hamm welcomed everyone. Rev. Doug and Melanie Seymour and Rev. Dean Kennedy joined the Executive Committee for the meeting.

Otis reviewed the minutes from the meeting on March 23, 2009. He reiterated that the Executive Committee was unanimously supportive of the ministry at Blended Fellowship. Details needed to be worked out by the Taskforce Feasibility Committee to satisfy the expectations of the Cape Fear Conference.

Rev. Doug Seymour addressed the issue of the need to have "everything" completed by the upcoming conference. He was informed that this is not an issue. The Taskforce Feasibility Committee needs to be prepared to give a report to the conference in November. He was also informed of the inability to amend the The Articles of Faith and Principles of Church Government for Original Free Will Baptists (of the English General Baptist Heritage).

Clerk Eva Ballance restated the previous motion that had passed, establishing the Board of Directors for Blended Fellowship. It was met with approval by Blended Fellowship.

Melanie Seymour asked if the Constitution and Bylaws had to be completed prior to presenting themselves to the conference for adoption as a ministry. Rev. Sam Weeks stated that from past experience with other ministries, the ministry is adopted first, the Board of Directors is established and the Constitution writing process begins. It was noted that the Board of Directors (Executive Committee) may or may not feel ready to present Blended Fellowship as a ministry to the conference this year due to the ongoing work of the Task Force and the uniqueness of the situation. There needs to be a clear understanding by the conference to prevent harm to the ministry.

Melanie presented Sensitivity Training material entitled, "A Simple Orientation to Deaf Ministry." It was decided that the Board of Directors would go through training at Blended Fellowship from 6:00 p.m. until 9:00 p.m. on Monday, August 10, 2009. Prior to the training, everyone will meet at Andy's at Pikeville at 5:00 p.m. for dinner.

Otis requested a church ministry status update. Melanie stated she has a list of the church leadership at Blended Fellowship, for the hearing and deaf, which are separate. Treasurer for the church is Melanie Seymour.

Rev. Seymour stated that the congregation, who attends church regularly, is connected to the ministry at Blended Fellowship. Otis noted that the setting of a congregation as part of a ministry has to be addressed. Sam Weeks stated that a congregation who meets under a ministry should be called a chapel, not named a church, but there is some confusion. Maybe a chapel/ministry board could be established in the Constitution and Bylaws. Or maybe this could be directed to the convention if there were to be a revision of *The Articles of Faith and Principles of Church Government for Original Free Will Baptists (of the English General Baptist Heritage)* Blended Fellowship is unique; the process of a

ministry forming and establishing a church is reversed. It is a congregation that grew into a ministry.

It was noted that once the loan application is completed for the roof repair at Blended Fellowship, the work can begin by mid-June.

The meeting with Blended Fellowship was adjourned.

Executive Committee of the Cape Fear Conference Meeting (cont.)

It was suggested that Dr. Burkette Raper may be instrumental in giving a different prospective on ways to deal with the unique situation at Blended Fellowship. He may add insight into the difficulties and situations of working with a chapel in our ministries.

Dr. Raper will be contacted and a date will be established for a meeting with him. Otis Hamm and Sam Weeks were placed in a sub-committee to develop questions to present to Dr. Raper.

The question was asked if the timing was right to approach the revision of *The Articles of Faith and Principles of Church Government for Original Free Will Baptists (of the English General Baptist Heritage)*, since Dr. Raper and Dr. Pelt would be instrumental in working toward this goal.

Carolyn Jernigan gave information on the Bulgaria Building Project.

Aubrey Williamson announced that St. Mary's Grove OFWB Church will be hosting the Code of Ministerial Ethics, presented by Dr. Burkette Raper and Professional Ethics presented by Donnie Lassiter, in the fall of 2009. He suggested inviting churches of the conference to attend and will present this invitation at the Minister's Meeting following this meeting.

Motion was made to adjourn. (MSP)

Devotion will be given by Carolyn Jernigan at the next meeting scheduled on Monday, August 24, 2009, at 2:00 p.m. and Daly's Chapel will be represented at 2:30 p.m. to meet with us.

Ken Dabbs led the closing prayer.

The Executive Committee of the Cape Fear Conference met on Monday, August 10, 2009, at 5:00 p.m. at Andy's in Pikeville for dinner prior to a training session on Deaf Ministry at Blended Fellowship from 6:00 p.m. until 9:00 p.m. Executive Committee members present were Aubrey Williamson, Otis Hamm, Sam Weeks, Eva Ballance, and Ken Dabbs. Moderator Aubrey Williamson called the meeting to order.

A motion was made for Sam Weeks to contact the Harvest Connection/ Home Mission's Board and Director for more information about the acquiring of Messiah OFWB Church in the Piedmont Conference by Home Missions. (MSP)

A letter written by the Fellowship of Conservative Free Will Baptists was reviewed by the committee. After discussion of its content, it was decided that Sam Weeks would address concerns to the Convention Executive Committee at their next meeting. (MSP) The meeting was adjourned.

b) The purpose of this meeting:

1) to discuss the meeting called by the Convention President for all Conference moderators and Ordaining Board members that was held at Johnston Union Church on June 16.

2) make suggestions for our procedures in regard to that discussion.

Note: The meeting primarily gave opportunity to discuss the requirements and procedures concerning the licensing and ordination of candidates in prospective Conferences. There was a consensus that there are differences concerning the intricate details that each Conference follows. No decisive move toward standardizing those procedures was agreed upon, but many of the pros and cons of the conference procedures were weighed and discussed. There was discussion concerning educational requirements. The requirements included those educational requirements prior to ordination and discussions were shared concerning whether there is a need for continuing education requirements. Nothing was finalized, but the discussion was initialized.

As a result, the Board of Ordination of the Cape Fear Conference makes these suggestions for the future:

- 1) Direct questions concerning continuing education unit (CEU) requirements to the Commission on Education and continue the discussion of a standardized ordination examination.
- 2) Leave the 90 day approval limitation "as is" for licensed ministers serving a church in our conference.
- 3) Make a list of the "do('s) and don't('s) for licensed ministers to be given to each candidate.
- 4) Continue to offer suggested readings to the ministers of our Conference for their use as needed.
- 5) To emphasize the requirement that a candidate cannot allow their license to lapse during their preparation period for ordination. Further, that it is responsibility of the licensed minister to make the request to their church annually for their license to be renewed, to ensure that the license does not lapse. A church issues a license for one year and can renew the license annually up to five years. Note Section 2: The Ministry in The Articles of Faith and Principles of Church Government for Original Free Will Baptists (of the English General Baptist Heritage). c) The meeting was adjourned in prayer.
