PROCEEDINGS

The One Hundred and Fifty-Eighth Annual Session of the Cape Fear Conference of Original Free Will Baptists (OFWB) convened at Blended Fellowship, Pikeville, North Carolina on November 13, 2012. Moderator Aubrey Williamson welcomed everyone. Moderator Aubrey Williamson presented the program for adoption. Motion was made to accept the program for adoption. Motion carried.

The congregation opened in singing "When We All Get to Heaven," *Hewitt*, led by song leader, Dean Kennedy. Licensed Minister Duane Casey offered scripture and prayer from Philippians 3. The conference was welcomed by Licensed Minister Jason Bordeaux of Blended Fellowship. The response was heard from Lee Jernigan of Shady Grove OFWB Church.

Clerk Eva Ballance called the session to order. The rules of registration were then explained by John Butler, Chairperson of the Credentials Committee, as adopted by the One Hundred Fourteenth Session of the Cape Fear Conference. Clerk Eva Ballance called the Roll of Officers and Standing Boards, Churches, and Ministers. The Moderator recognized visiting ministers and guests.

Moderator Aubrey Williamson offered words of encouragement to the conference from Philippians 2:1-8 and Romans 12:1, 2. He expressed the importance of being obedient to God, having the mind of Jesus Christ and His unconditional love for all mankind. He stressed that all believers should love Him likewise. Moderator Williamson led in prayer.

Motion was made to receive the written report of the Executive Committee as information. Motion carried.

Motion was made to appoint the following Temporary Committees by Moderator Williamson. The motion carried.

Obituary Committee: Chair Jim Bogle, Roger Hill

Parliamentarian: Ricky Warren

Dr. Sam Weeks was recognized as the Cape Fear Conference representative to the Executive Committee of the Convention, who gave the Convention report. He encouraged every Cape Fear Conference Church to consider recognizing an individual on the Wall of Honor and support the Convention through the Century of Grace. Rev. Buddy Sasser, Director of Convention Services of the Original Free Will Baptists, was recognized and he introduced the denominational ministry representatives, encouraging support for all ministries.

Representatives from our denominational ministries were present and given an opportunity to speak on the behalf of each ministry. The following ministries were represented: Retirement Home Ministry - Ronnie Taylor, OFWB International - Harold Jones, Children's Home - Gary Lee, Mount Olive College - Neal Cox; Cragmont Assembly - John Hill, Home Missions & Evangelism and Harvest Connection - Tim Heath, Free Will Baptist Press - Jeff Daughtry, Minister's Program and Church Finance - Ricky Warren, and Sunday School and Convention of OFWB - Buddy Sasser. Moderator Aubrey Williamson recognized Ricky Warren for a report from the N.C. Foundation for Christian Ministries.

The Morning Worship Service began with singing "Lord, I Lift Your Name on High" and "I Surrender All." Blended Hands presented "God's Building the Church" and "The Midnight Cry" led by Kayla Seymour. An offering was received and the offertory prayer was given. A video, created by Blended Fellowship, was presented. Special music was presented by Kayla Seymour, who signed "Amazing Grace." Rev. Doug Seymour, pastor of Blended Fellowship, brought the morning message from Matthew 5:1, 2 and Mark 4. He noted that churches in our conference are declining in membership. It is important to involve younger people and their ideas for potential church growth, as long as their suggestions are not in direct opposition to the Holy Scriptures. Allowing the younger members the opportunity to make changes and permitting them freedom gives them a feeling of ownership. Trust in the Holy Spirit to lead our churches to accept change and grow. Rev. Seymour closed with a prayer of commitment.

A blessing was prayed and the conference went to lunch.

AFTERNOON SESSION

Assistant Moderator Dr. Otis Hamm called the session to order. The afternoon session began with the congregation singing "Victory in Jesus," *Bartlett*, led by song leader Buddy Sasser. Scripture and prayer were offered by Provisional Minister Frank Gonzalez from Isaiah 45:41, 42.

The following reports of the Standing Boards were received by the conference (see attached reports of the Standing Boards). The Conference Missions report for Blended Fellowship was given by Rev. Doug Seymour. The Ordaining Council report was given by Rev. Aubrey Williamson and Cape Fear Conference Minister's Association report was given by Rev. Joe Ballance. Martha Parsons gave the Board of Education report. Assistant

Moderator Doctor Otis Hamm asked for a motion to receive these reports as information as presented to the conference. Motion carried.

The following reports of the Temporary Committees were received (see attached reports of the Temporary Committees). The Temperance/Resolutions Committee presented two resolutions, of which both passed. The Obituary Committee reported the passing of three Cape Fear Conference ministers during the past year. Motion was made to receive the report as information. Motion carried. The Credentials Committee gave a report of the Annual Conference's attendance. Motion was made to receive this report as information. Motion carried. The Nominating Committee made its recommendations to the conference. The list of candidates for nomination received a motion to be elected, was seconded and passed. The Treasurer's Report was given by Treasurer Sam Weeks and was received by motion (see attached report).

The conference then moved into its business session. Old business included a motion to submit Rev. Doug Seymour's message for printing in the Free Will Baptist publication. Motion carried. New business included a motion to send \$150.00 from the conference to Harvest Connection to distribute water to victims of the Hurricane Sandy. Motion carried. The 159th Annual Session of the Cape Fear Conference will be held at a location to be announced on Tuesday, November 12, 2013.

Motion carried to adjourn the 158th Session of the Cape Fear Conference and the conference was dismissed in prayer by Dr. Otis Hamm.

CAPE FEAR CONFERENCE EXECUTIVE COMMITTEE MINUTES 158th Annual Session of the Cape Fear Conference

The Cape Fear Conference Executive Committee met on November 8, 2011, at Shady Grove OFWB Church following the Annual Session of the Cape Fear Conference. The meeting was called into order by Moderator Aubrey Williamson. Conference members present were Aubrey Williamson, Sam Weeks, Eva Ballance, Carolyn Jernigan and Stephen Prescott. Aubrey Williamson recognized Pastor John Butler and members of Covenant OFWB Church. Rev. Butler's resignation, effective January 1, 2012, was noted. Due to concerns of the stability of Covenant OFWB Church, a decision was made for the Executive Committee of the Cape Fear Conference to meet with Covenant OFWB Church in Hope Mills on Sunday, January 22, 2012, at 3:00 p.m. The meeting adjourned and Covenant OFWB Church was lifted up in prayer.

The Cape Fear Conference Executive Committee met with Covenant OFWB Church on Sunday, January 22, 2012, at their church. Executive Committee members present were Aubrey Williamson, Sam Weeks, Eva Ballance, Carolyn Jernigan, Stephen Prescott and Otis Hamm. Four members of Covenant OFWB were present. The purpose of this meeting was to discuss how the Executive Committee could assist them with issues of church attendance, offerings and pastoral needs. Members of Covenant had strong concerns that the church would have to close its doors if they continued to decline in membership and support. They requested assistance for leadership to help them develop a plan to save their church. It was felt that the presence of the

church in the community was important, too important than watching it fail to exist. They presented ideas and programs they had tried, but without success.

A review was made of their financial situation and the present cost to operate on a monthly basis. A major concern was the salary owed to their previous pastor and the need to resolve this debt.

Covenant is not presently following church guidelines. Deacon's meetings and business meetings are no longer held. They do not have a pastor nor do they have the financial means to support a pastor.

First Free Will Baptist in Smithfield offered pastoral support for 90 days. The following motion was made. The Executive Committee will give Covenant a 90-day probationary period, assistance for 90 days and meet with them again in 90 days to discuss the situation (MSP). After the probationary period and 90-day commitment, decisions will be made by the Mission Board and Covenant combined, not Covenant alone. Covenant will continue as an OFWB church for now.

A request was made by the Executive Committee to examine their financial report at the next meeting at a time to be announced. The next meeting will be held in April 2012, Motion was made to adjourn (MSP). Otis Hamm prayed the benediction, asking for God's guidance and blessings upon Covenant.

The Cape Fear Conference Executive Committee met at Covenant OFWB Church on Sunday, May 6, 2012, at 3:00 p.m. Members present were Aubrey Williamson, Otis Hamm, Sam Weeks, Eva Ballance, Carolyn Jernigan and Stephen Prescott.

Treasurer Sam Weeks gave the treasurer's report. Balance was \$4392.20, of which \$150.00 was designated for an honorarium, \$1053.89 for the Education Fund, \$81.50 for Foreign Missions and \$81.50 for Home Missions.

Motion was made to send \$500.00 to Convention of OFWB for delegates and Century of Grace (MSP).

Discussion began for the Fellowship Meeting scheduled on July 28, 2012.

The Executive Committee moved to the sanctuary of Covenant OFWB Church to meet with the members in attendance. Seven members of Covenant were present. Sam Weeks opened the meeting with prayer.

A report by Covenant acknowledged they had 18 on roll and 8-10 members in attendance for services. The members were feeling more positive about the condition of their church. The church budget was reviewed and it was noted that \$50.00 had been added beginning. May 2012, for pastoral support. The Executive Committee recommended that the church treasurer contact the previous pastor, Rev. John Butler and establish payment of debt. The members had no complaints, expressed their concerns and confirmed their feelings that a church was needed in the present community. The lack of finances to support a pastor was discussed. There was a willingness among the members to work for church growth and stability.

The Executive Committee went back into private session. After further discussion, it was decided to meet with Covenant in November 2012, and review their church status at that time.

The following motion was presented to Covenant OFWB Church members. Motion to continue the probationary period until the Annual Session of 2012 Cape Fear Conference on a provisional basis providing they seek their own pastoral supply with special attention given to the "church" as indicated in the Articles of Faith and Principles of Church Government for Original Free Will Baptists (of the English General Baptist

Heritage), at which time we will expect to see documentation to support fifty percent average growth from the average of the past 90 days in finance and attendance with a plan to resolve the debt to Rev. John Butler (MSP).

Motion made to adjourn at Covenant (MSP). Myrisha Goodson prayed the closing prayer. The Executive Committee reconvened at the Cracker Barrel Restaurant in Fayetteville. Motion was made to invite Dr. David Hines or Rev. Neal Cox to present the twenty-two Articles of Faith as a seminar for continuing education on July 28, 2012, for the quarterly Fellowship Meeting (MSP).

The next Executive Committee Meeting will follow the Fellowship Meeting at First OFWB Church of Smithfield on Saturday, July 28, 2012, which will include a meeting with the Blended Fellowship Feasibility Committee.

The Cape Fear Conference Executive Committee met at First OFWB Church of Smithfield on Saturday, July 28, 2012, at 2:00 p.m. Members present were Aubrey Williamson, Sam Weeks, Eva Ballance, and Carolyn Jernigan.

Moderator Aubrey Williamson gave the devotion from Psalm 92:12-15 and opened with prayer.

Minutes from the meeting on May 6, 2012, were reviewed and accepted as corrected (MSP).

Treasurer Sam Weeks gave the treasurer's report. Balance was \$1917.14. Motion was made to accept the Treasurer's Report as information (MSP).

An update was given on Covenant OFWB Church. Covenant will contact Rev. John Butler and establish a method of payment for unpaid salary. Licensed Minister Vicky Medlin is temporarily serving the church and Rev. Earl Johnson has presided over Communion. Attendance is better.

Planning of the upcoming 158th Annual Session of the Cape Fear Conference continued. Sam Weeks will contact the licensed ministers for the morning and afternoon devotions. Aubrey Williamson will contact the Alternate Speaker.

Motion was made for the Conference to pay for the meal for the Annual Session of the Cape Fear Conference at Blended Fellowship (MSP).

Motion was made to retain the three positions on the Executive Committee due to their intricate nature of their work on the Blended Fellowship Feasibility Committee (MSP). Motion was made to give Duane Casey a Conference Love Offering of \$500.00 (MSP). Motion made to adjourn (MSP). The meeting closed in prayer.

The next Executive Committee Meeting will follow the 158th Session of the Cape Fear Conference at a time to be decided.

Blended Fellowship Mission/Ministry Report 158th Cape Fear Conference of Original Free Will Baptists

The past year has been a busy one for our ministry team. As you might recall, we had a tremendous response to our "deaf" version of the "Judgement House" drama last year and saw 32 deaf teens receive Christ as their Savior. We have followed up with these young people at every opportunity and have made numerous visits to the Eastern North Carolina School For the Deaf. For example, several members of our team attended their graduation

ceremonies and presented Bibles to the graduates. Other visits allowed us more time to fellowship with the students and get to know them better, while at the same time showing them we care enough to be there for them. These visits included helping students get ready for prom night by providing outfits, assisting with makeup and hair, etc., helping serve meals on special occasions and volunteering at various events. The students also came to our facility for "Blended Who?" a special program in which we entertain, share about our ministry and teach them about Jesus. Through this interaction with the students we hope to establish long lasting relationships that will keep these young men and women connected to Christ and Blended Fellowship after they complete their high school education.

We recently completed this year's "Deaf Judgement House" and the results were once again phenomenal. 37 accepted Christ, including a young man who graduated from Gallaudet University, the most prestigious school for the Deaf in the country. We are overjoyed and encouraged by this tremendous response to the Good News of the Gospel! During the month of July we implemented our first ever "Blended Bridges" program for the purpose of ministering to main-streamed deaf children, those who attend hearing public schools. About 20 volunteers, including adults and young people skilled in sign language, came to Blended Fellowship 4 days a week for the entire month. Their compassionate service was invaluable as they assisted siblings and parents of deaf children in learning how to communicate with their deaf family members and reinforced not only the signing skills, but other educational needs of the deaf children themselves. Each day a drama was presented in sign language to teach Biblical concepts. More than a dozen children participated in the program. It was a huge success and we definitely plan to do it again next year.

We have started a visitation program to minister to deaf seniors. We are in the process of seeking out elderly deaf people who are isolated and lonely. Several visits have already been made as well as providing transportation for these special people to come to our events.

We are very grateful to all of you for your continued support of the ministry. Particularly, we want to express our deep gratitude to all of our Blended Investment Partners (BIP's), those who provide regular monthly support to the ministry. Because of your giving, we were able to establish Administrator as a paid staff position which will help anchor the ministry for the future. As more partners join with us, we hope to also establish Pastor/Director as a paid staff position. We feel these positions are essential for the ministry to continue beyond our lifetimes.

We would greatly appreciate the opportunity to come to your church and share with your congregation the vision and ministry of Blended Fellowship. If you are interested, please call our office at 919 736-7676 or you can speak with my wife, Melanie, today about scheduling.

Again, we appreciate your prayers as we continue to make Jesus known to the Deaf.
