1998 Yearly Meeting Minutes 111th Yearly Meeting of the Cave Springs Association of Free Will Baptist

The 111th meeting of the Cave Springs Free Will Baptist met with the Clifton Free Will Baptist on Friday, May 15, 1998.

The moderator asked for letters from corresponding messengers and one from Cave Springs Free Will Baptist Church was read. Motion was made and seconded to receive their report and it carried. Delegates were then seated with a handshake as the congregation sang "I'm in the Gloryland Way."

No letter was received from the Youth Organization.

Denomination Committee: Darrell Strain, Richard Todd, and Charles Melton.

State of Religion Committee: Charles Cunningham, James Dodson, and Cody Freeman.

Divine Service Committee: Jerry Strain, Tom Marcum, and Norman Walker.

The moderator asked the Clifton pastor, Bro. Russell Hensley if the church would be available for evening services. It was stated that Koshkonong graduation was scheduled for this evening. Therefore, due to no other response, the moderator concluded and announced there would be no night service.

Bro. Reed stated the morning schedule of business was concluded. MS/C to continue with the afternoon business. The moderator then called for Miscellaneous Business: Bro. Darrell Strain asked for permission to leave the conference for a doctor's appointment. It was granted.

Committee reports were called for.

The Denomination Committee

As we are Free Will Baptist by choice, therefore the logical conclusion is that we are Free Will Baptist because we believe FWB doctrine as outlined in the Treatise of the Faith and Practices of Free Will Baptist.

Not every saved person will become a Free Will Baptist, however it should be expected that those who become Free Will Baptist believe and adhere to FWB doctrine. Not every church will be a Free Will Baptist church, however it should be expected that those churches who choose to become FWB adhere to FWB doctrine. Therefore, we the denomination committee recommend that the Cave Springs Yearly Meeting, to encourage member churches, to follow FWB doctrine.

We also recommend that this body encourage our churches to use ordained or licensed Free Will Baptist as pastors and evangelist. We recommend that each church devote some time each year to the study of the treatise of the faith and practice of FWB. We strongly urge our churches, people, and pastors, to mature spiritually through a daily study and application of the scripture.

Executive Board Report

We the Executive board, met on December 17, 1997, at the Pleasant Hill FWB Church at 7:00 p.m. to discuss a request from the Quarterly Conference. Prayer by Bro. Darrell Mitchell. The moderator read the request from the Quarterly Conference Business Committee to adopt a set of questions to give to ministers and deacons coming in to the Cave Springs Association. After some discussion a motion was made and carried to adopt questions for the Yearly Conference.

We also had a letter from the Smyrna FWB Church to consider ordaining Bro. Greg Watson. After much consideration and discussion, a motion was made and carried to refer it to the Yearly Ordaining Council. Motion was made and seconded to adjourn, the Board dismissed in Prayer by Bro. Howard Dethrow.

Yearly Ordaining and Credential Committee

On March 8, 1997, Brother Greg Watson made a request to the Credentials Committee that his license be annulled, due to a conflict in fundamental beliefs. On April 10, 1997, the Credentials Committee consisting of Brother J. W. King, Brother Darrell Mitchell, and Brother James Ray, met on this issue at the Cotton Creek Free Will Baptist Church. It was discussed and voted that Brother Greg Watson's request be honored. Therefore, the Credentials Committee took the proper actions to annull the license. A letter was sent to the Executive Board that Brother Greg Watson's license had been annulled.

December 29, 1997, at Pleasant Hill Free Will Baptist Church, a meeting was convened by the Credentials Committee/Ordaining Council and involved the Executive Board. Due to a letter from Smyrna Free Will Baptist Church, recommending that Brother Greg Watson be ordained as a Minister of the Gospel. Since the Credentials Committee had already acted on this matter by annulling Brother Greg Watson's license we could not accept this request. The Credentials Committee and Executive Board sent the following reply to Smyrna Free Will Baptist Church.

"We, the Ordaining Council and The Executive Board, recommend to the Smyrna Free Will Baptist Church, that the church recommend Brother Greg Watson to the Quarterly Meeting to be licensed for one year according to Article 15 of the Standing Rules."

On February 15, 1997, the Ordaining Council met with Brother Jim Thompson to examine him to be an ordained Minister of the Gospel. Being found worthy, we recommeded he be ordained.

On February 16, 1997, the Ordaining Council met with the Shiloh Free Will Baptist Church to ordain Brother Jim Thompson as a Minister of the Gospel in the Cave Springs Association of Freewill Baptists. Brother James Ray took charge of the service. Opening

prayer was led by Brother J.W. King. Special singing by the Shiloh Singers; Sister Julie Thompson, Sister Linda Parrott, Sister Darlene and Brother Jerry Johnson, "I've Got A Reservation". Sister Julie Thompson sang "I Surrender All". Brother Wayne Adrian brought the message and charge from I Timothy 3:1-7, and II Timothy 4:1-6, title of message "Qualifications of a Bishop". Brother Jim and Sister Julie and their boys were asked to come to the altar for the laying on of hands and the Ordination prayer. The Ordination prayer was led by Brother Truman Parrot. Everyone shook hands with Brother Jim and Sister Julie while the congregation sang "The Prettiest Flowers Will Be Blooming". Brother Jim Thompson dismissed in prayer. The Ordinaing Coucil member present were Brother J.W. King, Brother James Ray. Brother Darrell Mitchell could not be present.

On February 15, 1997, the Ordaining Council met with Brother Craig Hensley to examine him to be ordained as a Minister of the Gospel. Being found worthy, we recommended that Brother Craig be ordained.

On February 23, 1997 the Ordaining council met with the Mt. Zion Free Will Baptist Church to ordain Brother Craig Hensley as a Minister of the Gospel in the Cave Springs Association of Free Will Baptist. Brother James Ray took charge of the service. Opening prayer was led by Brother Darrell Mitchell. There was congregational singing, "In The Sweet Forever" and "Lord Build Me A Cabin". We had special singing by Amanda and Megan Hensley. They sang "He's Still Working On Me", Sister Pam Bowers sang "He's In The Midst". Brother Russell Hensley brought the message and the charge from St. John 21: 15-17 and II Timothy 4:1, the title of the message was "Feed My Sheep, and Preach the Word". Brother Craig and his family were asked to come to the altar for the laying on of hands on Brother Craig. The Ordination prayer was led by Brother O.T. Bowers. Brother Craig Hensley was asked to dismiss in a word of prayer, then the congregation shook hands with Brother Craig and family. The Ordaining Council members present were Brother Darrell Mitchell, Brother J.W. King and Brother James Ray.

Brother James Ray took charge of the service. Opening prayer was led by Brother J.W. King. The congregation sang two songs, "The Longer I Serve Him" and "Have Thine Own Way". There was special singing by the First Free Will Baptist Singers, "The Blood Will Never Lose It's Power" and "His Grace Is Sufficient". Brother Ronnie Blanks brought the message. His thought was "Responsibilities of a Minister", his text was from I Peter 5. Brother Wayne Adrian then brought the charge from II Timothy 4. The Ordination prayer and the laying on of hands on Brother Jeff took place. Brother Jeff dismissed services in prayer. The congregation sang and extended the right hand of fellowship. Ordaining Council members present were Brother J. W. King, Brother Darrell Mitchell and Brother James Ray.

On April 5, 1997, the Ordaining Council met with Brother Jason Roberts to examine him to be a minister of the Gospel. Being found worthy, we recommended him to be ordained.

On April 19, 1997, the Ordaining Council met with the Alton Free Will Baptist Church to ordain Brother Jason Roberts as a Minister of the Gospel in the Cave Springs Association of Free Will Baptist. Brother James Ray took charge of the services. Opening prayer was led by Brother Darrell Mitchell. The congregation, led by Brother Leroy Chronister, sang "The Old Account Was Settled Long Ago" with Sister Kathleen Crigler at the piano. Special singing by the Keith Family of Mansfield sang "Stand By Me", "In The Twinkling of An Eye" and "You Can't Ask Too Much Of My God". Brother Leroy Chronister sang "He Leadeth Me". Brother Glenn Murray brought the message and the charge from Jeremiah 1:4. The Ordination prayer was then led by Brother Dwight Chronister. Services were dismissed in prayer by Brother Jason Roberts. The congregation sang and shook hands with Brother Jason and family. Ordaining Council members present were Brother James Ray and Brother Darrell Mitchell.

On April 10, 1997, the Ordaining Council met with Brother Chuck Cook to examine him to be ordained as a deacon. Being found worthy, we recommended he be ordained.

On April 10, 1997, the Ordaining Council met with Brother Terry Lunyou to examine him to be ordained as a Minister of the Gospel. Being found worthy, we recommended he be ordained.

On April 20, 1997, the Ordaining Council met with the Faith Chapel Free Will Baptist Church to ordain Brother Chuck Cook as a deacon and Brother Terry Lunyou as a Minister of the Gospel. Brother Darrell Mitchell took charge of the service. Opening prayer was led by Brother Chuck Cook. There was special singing by Brother Stan Silva who sang "He Was There All The Time" and by the Johnson Quartet. The message and the charge were brought by Brother James Ray. His Scripture was read from 11 Timothy 4. He addressed the qualifications of both the deacons and the ministers and their wives. Missouri State General Board Report

There was a change in the CO-OP allocation. The 3.50% allocation for General Board was changed to 3%. The .5% was allocated to the Show-Me Plan for program expenses. The closing of the State Meeting sessions will be changed from Thursday morning to Wednesday night. The retirement program was increased from \$650 per year to \$700 per year. It has been pointed out that those who own cabins at Youth Camp are liable for accidents that might happen in them. It has been talked and talk only at this point about moving the youth camp to a new location, possibly on the property that State has purchased on the lake. I attended the General Meetings and State association Meeting. Expenses: Room, Meals and Gas \$65.00 Thank you for helping me have this opportunity.

The Temperance committee would like to submit the following report. Temperance is defined in the Webster's Dictionary as "Total abstinence from alcoholic beverages". The Bible warns us in Proverbs 23:32 of the problems and destruction that drunkenness brings to our society. Therefore, we believe as Christians we should abstain from all sanction of the use and sale of intoxicating beverages as stated in our Free Will Baptist Church Covenant; Ephesians 5:18 "And be not drunk with wine, wherein is excess, but be filled with the Spirit." Signed: David Honeycutt and John Barton. M/S/C to accept as read.

The moderator called for any other committee reports: Bro. Cody Freeman stated the Mission Board had not met, since there were no guide lines as to what their responsibilities were. He gave a verbal report of things he's like to see done, such as putting together a mission conference and asked for encouragement regarding this board of its function. He also asked the association to give their stamp of approval to go ahead with a project such as this. Bro. Walter Simpson stated he believed the board already had the bodies approval for their discussion and recommendations. M/S/C that we receive the oral report of the Mission Board.

Bro. Reed announced that the MO State Meeting would be held at Lebanon on June 8, 9, and 10 and that we needed seven delegates. The floor was then opened for volunteers and/or nominations. OBITUTARY COMMITTEE: Nominations: Ruth Thompson, Linda Honeycutt, Ester Strain. M/S nominations cease and proceed to elect as a whole. M/C

TEMPERANCE COMMITTEE: Nominations: David Honeycutt, John Barton, Russell Hensley. M/S nominations cease and proceed to elect. M/C.

The moderator called for any other business. M/S to render heartfelt thanks to the Clifton Church for their hospitality in hosting the conference. With a standing vote the M/C.

M/S/C to thank Bro. Reed for his work on the General Board.

The floor was then turned over to Bro. Nathan Ruble, who brought greetings as State Executive Secretary. He gave thanks to Cave Springs Association for their contribution to the Co-op giving and other support to the State. He commended all the Cave Spring Churches and said Missouri was number four in giving on the national level. ARTICLES OF FAITH

THE BIBLE: The Scriptures of the Old and New Testament were given by the inspiration of God and are our infallible rule of faith and practice.

GOD: There is one living and true God revealed in nature as the Creator, preserver and Righteous Governor of the Universe, and in Scripture as Father, Son and Holy Ghost, as one God infinitely wise and good whom all intelligent creatures are supremely to love, adore and obey.

CHRIST: Christ is God manifest in the flesh, in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified He is now risen and glorified and is our ever present Savior and Lord.

THE HOLY SPIRIT: The Scriptures assign the Holy Spirit all the attributes of God.

THE GOVERNMENT OF GOD: God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special act of grace, not otherwise provided for, as the highest welfare of man requires.

THE SINFULNESS OF MAN: Man was created innocent, by his disobedience, fell into a state of sin and condemnation. His posterity, therefore, inherited a fallen nature of such tendencies that all who come to years of accountability, sin, and become guitly before God.

THE WORK OF CHRIST: The Son of God, by His incarnation, life, sufferings, death and resurrection effected for all a redemption from sin that is full and free and is the ground of salvation.

THE TERMS OF SALVATION: The conditions of salvation are:

- 1. Repentance or sincere sorrow for sin and hearty renunciation of it.
- Faith, or the unreserved committal of one's self to Christ as Savior and Lord, with purpose to love and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit, freed from the dominion of sin and becomes a child of God.
- 3. Continuance in faith and obedience until death.

ELECTION: God determined from the beginning to save all who would comply with the conditions of salvation. Hence, by faith in Christ men become His elect.

FREEDOM OF WILL: The human will is free and self controlled, having power to yield to the influence of the truth and the Spirit to live, or to resist them and perish.

SALVATION FREE: God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whomsoever will may come and take of the water of Life freely.

PERSEVERANCE: All believers of Christ who through grace persevere in holiness to the end of life, have promise of eternal salvation.

GOSPEL ORDINANCE

BAPTISM, or the immersion of believers in water, and the LORD'S SUPPER are ordinances to be perpetuated under the gospel. Feet Washing, an ordinance teaching humility, or universal obligation and to be administered to all true believers.

THE CHRISTIAN SABBATH: The divine law requires that one day in seven be set aside from secular employments and amusements, for rest, worship, holy works, and activities and for personal communications with God.

RESURRECTION, JUDGMENT AND FINAL RETRIBUTION: The Scriptures teach the resurrection of all men at the final day. They that have done good will come forth to the resurrection of life, and they that have done evil unto the resurrection of damnation, then the wicked shall "go away into eternal punishment, but the righteous to eternal life."

FREEWILL BAPTIST CHURCH COVENANT

Having given ourselves to God by faith in Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant. We promise by His grace to love and obey Him in all things; to avoid the appearance of evil; to abstain from all sinful amusements and unholy conformity to the world; from all sanction of the use and sale of intoxicating beverages; and to "provide things honest in the sight of all men."

We agree faithfully to discharge our obligations in reference to the study of the Scriptures, secret prayer, family devotions and social worship, and by self-denial faith and good works endeavor to "grow in grace and the knowledge of our Lord and Savior, Jesus Christ."

We will not forsake the assembling of ourselves together for church conference, public worship and the observances of the Gospel, nor fail to pay according to our ability for the support of the church, of its poor, its ill, and its benevolent work.

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love endeavoring to "KEEP THE UNITY OF THE SPIRIT" in the bond of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, as far as we are able, promote the success of the Church and of the Gospel.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme, counting it our chief business in life to extend the influence of Christ in society, constantly praying and toiling that the Kingdom of God may come, and His will be done on earth as it is in Heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday Schools, and evangelistic efforts for the salvation of the world. And may the God of Peace sanctify us wholly and preserve us blameless into the coming of our Lord Jesus Christ.

CONSTITUTION

This organization shall be known as the Cave Springs Yearly Meeting of Free Will Baptist and shall be composed of such well regulated quarterly meetings and churches as may embody themselves under this constitution.

- ARTICLE 1. It shall be the purpose of this organization to cooperate with the state and national associations in their effort to combine and direct the energies of the Free Will Baptist Church for the promotion of Home and Foreign missions, Christian education, Sunday Schools, Church Training Service, and Women's Auxiliary and for the extension of the Kingdom of God in general.
- ARTICLE 2. The acting members of this yearly meeting shall be three (3) delegates from each church chosen by the churches, three (3) delegates from each quarterly meeting together with all ministers, deacons, church clerks, quarterly meeting clerks, and associational clerks belonging to this body.
- ARTICLE 3. The officers of this yearly meeting shall consist of a moderator and assistant moderator, a clerk and assistant clerk, and a treasurer and assistant treasurer. The clerk and treasurer shall have authority to choose their assistants. Each shall hold office until their successor is elected. The Clerk shall recieve an honorarium of twenty-five dollars (\$25.00) for his service each year.
- ARTICLE 4. An executive board composed of five members shall be elected. It shall be the duty of this board to transact the business of this body between the regular session. The members of the board shall be elected in the following manner: one for one year, one for two years, one for three years, one for four years and one for five years, hereafter, one board member shall be elected each year, whose term of office shall be five years. If any vacancies occur between sessions of the Yearly Meeting, the board shall have power to fill such vacancy until the next session of the yearly meeting.
- ARTICLE 5. An Ordaining Council composed of three members shall be elected in the following manner: one for three years, one for two years, one for one year and thereafter one member shall be elected each year, whose term of office shall be for three years. If any vacancy shall occur between session of the Yearly Meeting, the Executive Board shall have power to fill such vacancy until the next session of the Yearly Meeting. Two regular members must be present at any ordination service.
- ARTICLE 6. Any regular organized Free Will Baptist Church maintaining gospel order, agreeing with the denomination in doctrine, in favor of benevolent enterprises such as Sunday School, missions, temperance, and education, may be received into this yearly meeting by presenting a petition asking for membership, by a majority vote of all members voting.

ARTICLE 7. This yearly meeting shall have power to discipline its churches and exclude them for disorderly conduct if labor proves unsuccessful, to ordain deacons, to license and ordain ministers such as give evidence of being qualified and called of God, by request of the church of which he belongs, to settle questions of discipline and doctrine as the church or quarterly meeting may refer to it. To make rules and by-laws necessay and not inconsistent with its constitution, but in no case shall the body have power to reverse a decision of one of its churches or quarterly meetings, nor in any way interfere with its internal regulations nor hold any ecclesiastical authority over the churces or quarterly meeting composing this yearly meeting.

ARTICLE 8. Each session of this yearly meeting shall convene annually beginning on Friday at nine in the morning before the third Sunday in March and shall adjourn at the close of the Saturday afternoon session.

ARTICLE 9. This yearly meeting shall decide at each session where the next session shall convene. It shall consider each invitation from its churches and shall decide by majority vote of all members voting.

ARTICLE 10. This constitution may be amended at any regular session of this body by twothirds vote providing notice of the contemplated change has been read and placed on the table one day previous to the time voting.

ARTICLE 11. The Ordaining Council may license a minister but only while this body is in session.

ARTICLE 12. This yearly meeting shall have power to grant a yearly certificate at the same time a license is granted, both to expire at the same time.

ARTICLE 13. Each minister recommended by the church of which he is a member is to receive a yearly certificate.

ARTICLE 14. All Ministers coming into the Association whose credentials have not been examined and approved by the Quarterly Meeting must go before the Yearly Associational Ordaining Council for approval before being accepted by the Association.

ARTICLE 15. Since the scriptures in Romans 1:24-27 condemn homosexual practive, this body will not license or ordain any person who is involved in this sin.

BY-LAWS

- ARTICLE 1. Each session of this conference shall be called to order by the standing clerk when present, and in his absence by the member having seniority in years.
- ARTICLE 2. Each session and adjourned session of the conference shall be opened and closed with prayer.
- ARTICLE 3. Ten members shall be required to constitute a quorum to transact any business of this conference. But any less number may adjourn from time to time.
- ARTICLE 4. This conference shall elect (or cause to be appointed) a standing committee composed of three (3) members, which is the Ordaining Council. Their duty shall be to examine, pass upon, or recommend suitable action to the Conference, on all Credentials referred to them by the Conference or by the Business Committee of the conference.
- ARTICLE 5. At each session of this conference, standing committees shall be appointed on such subjects as the following: Missions, Obituary, Executive Board, Ordaining and Finance. All petitions and committees on particular subjects shall be referred to appropriate committees. Special committees may be appointed at the pleasure of the conference.
- ARTICLE 6. This conference may hold correspondence by messenger or otherwise with religious bodies as it may deem advisable.
- ARTICLE 7. This conference may sit with open doors except when it may go into committee of the whole.
- ARTICLE 8. Any person not a member of this conference may be allowed to take part in its discussion by obtaining permission of the conference.
- ARTICLE 9. It shall be the duty of the members of this conference to be present at the time appointed for each daily session and anyone wishing to retire shall first obtain leave of the moderator.
- ARTICLE 10. No member shall absent himself from conference during the sessions without first obtaining permission from the conference.
- ARTICLE 11. Every member wishing to speak in conference shall address the moderator.
- ARTICLE 12. No person shall be allowed to speak more than ten (10) minutes at any one time nor more than twice on any subject without leave of the conference.
- ARTICLE 13. There shall be no discussion of any issue unless first there be a motion and second made from the floor.

ARTICLE 14. No person shall be allowed to nominate more than one member of any committee provided the brother nominated be elected.

ARTICLE 15. The yeas and nays may be taken on any question before the conference by request of one-fifth of the members present.

ARTICLE 16. The constitution and by-laws of this conference shall be read at each session near its commencement.

ARTICLE 17. The Clerk, Assistant Clerk and Treasurer as elected each year are to serve as the printing committee.

ARTICLE 18. The Moderator shall have authority to appoint the Divine Committee.

ARTICLE 19. The Moderator shall have authority to appoint temporary committees prior to yearly meeting. (Whole committees can be appointed from any church delegation.)

ARTICLE 20. Any committee doing business for the Yearly Meeting must be a committee formed by the Yearly Meeting.

ARTICLE 21. Since the scriptures in Romans 1:24-27 condemn homosexual practice, this body will not license or ordain any person who is involved in this sin.

STANDING RULES

- ARTICLE 1. The Constitution, By-Laws, Standing Rules and Order of Business are to be printed in the minutes.
- ARTICLE 2. Our fiscal year shall be from January 1 to December 31 and all reports are to be made using the same dates.
- ARTICLE 3. That we adhere quite strictly to the principles of our Church Covenant as Pastors, Deacons and Lay Members.
- ARTICLE 4. All church letters, requesting the next yearly meeting, are to be turned in prior to the Eleven O'clock Service on Friday and all other letters are to be accepted no later than the opening session on the second day.
- ARTICLE 5. All Standing Committees appointed or elected by the Yearly Meeting shall hold office until released or replaced.
- ARTICLE 6. No person shall serve in the same office more than five consecutive years.

- ARTICLE 7. The Ordaining Council is to assume the duties performed by a Credential Committee.
- ARTICLE 8. The Ordaining Council is to use the drafted set of questions in aid to their Committee work.
- ARTICLE 9. Each minister coming from another body, shall present a letter of recommendation from the body of which he is a member.
- ARTICLE 10. If a minister is not recommended by his church, the church and the minister is to be investigated to length by the Executive Board and if the minister be worthy of a certificate, the Executive Board has power to grant a yearly certificate.
- ARTICLE 11. Each Church is to recommend its worthy Deacons to the Yearly Meeting and also to list their non-recommended Deacons.
- ARTICLE 12. Any Church having Deacons or Ministers who do not do the work of a Deacon or Minister or does not walk uprightly as they are members of this association; that such Church report to the Executive Board their grievance.
- ARTICLE 13. All business referred to the Executive Board shall be in written form.
- ARTICLE 14. Any minister or Deacon who has two living wives or any Minister or Deacon's wife who has two living companions shall not be Ordained or recommended worthy to the Association.
- ARTICLE 15. Any licensed Minsiter must preach for one year before being eligible to be ordained.
- ARTICLE 16. Any person who would give false answers to obtain licenses or Ordination papers, after investigation and proven guilty, their papers be anulled immediately.
- ARTICLE 17. To be elected to an office or a standing committee, a person must have been a member in good standing in the association for one year.
- ARTICLE 18. Before a deacon can be ordained in our yearly meeting, a church must place him on trial, proving him worthy as a deacon in the church, for one year.
- ARTICLE 19. Since the scriptures in Romans 1:24-27 condemn homosexual practice, this body will not license or ordain any person who is involved in this sin.
