We also urge that our members abstain from breaking the Sabbath by doing such things as hunting, fishing and indulging in ungodly conversitions and seek to strengthen the weak, living such lives before the world that sinners can see Christ in them.

Executive Board Report—

We, your committee, report having examined Bro. W. I. Cook, and Bro. J. A. Mize and find them worthy of ordination as Free Will Baptist ministers.

CHURCH COVENANT

We agree faithfully to discharge our obligations in reference to the study of the Scripture, secret prayer, family devotion, and social worship, and by self denial, faith, and good works endeavor to "grow in grace and the knowledge of our Lord and Saviour, Jesus Christ." We will not forget the assembling of ourselves together for church conferences, public worship and the observance of the ordinances of the Gospel, nor fail to pay according to our ability for the support of the church of its poor, and all its benevolent work. We agree to accept Christian admonition and reproof with meekness and to watch over one another in love, endeavoring to "keep the unity of the Spirit in the bonds of Peace, to be careful of one another's happiness and reputation, and to seek to strengthen the weak, encourage the afflicted, admonish the erring and as far as we are able, to promote the success of the church and the Gospel. We will everywhere hold Christian principles sacred and Christian obligations and enterprises supreme, counting it our chief business in life to extend the influence of Christ in Society.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sabbath School, and evangelistic efforts for the salvation of souls and the conversion of the world.

RULES OF ORDER

1. The Moderator or Assistant Moderator or in their absence the oldest minister present shall call the Association to conference.

2. Each session shall be opened and closed by prayer.

3. Five members from two or more churches shall constitute a quorum. A less number may adjourn until such time as a quorum is present.

4. Visiting brethren are invited to seat as advisory members.

5. Those who speak shall rise and address the Moderator. Personal reflection shall be avoided in all debates.

6. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and a vote taken.

7. Motions made and lost shall not be recorded.

8. No one shall speak more than twice on the same subject without special leave of the Moderator.

9. The Moderator shall not allow discussion when not carried on in a Christian spirit.

10. The ruling of the Moderator may be overruled by a two-thirds majority membership voting.

11. No question from any church shall come under the consideration of the Association unless it has first been discussed at its own church.

12. At each Association arrangements shall be made to insure two or more sermons or their equivalent devotional exercises each day.
