#### **COMMITTEE REPORTS**

#### **Resolution Committee**

Tabled from first quarterly meeting August 18-19, 1955.

We recommend that the quarterly meetings meet on Friday night and Saturday.

#### Temperence Committee

We recommend that our people avoid all appearance of evil, practice and teach temperance in all things, and concentrate our teaching of temperance to our young people. This being observed and enforced as far as possible.

Sunday School Committee

We recommend that each church have a teacher training course once a year.

#### Obituary Committee

We report that God in His infinite wisdom has called Rev. Lester Davis of Calwa, Bro. B. L. Lawless of Selma, Sister Carrie Wheller of Parlier, and George McLain, Jr. of Kerman from our midst.

#### Resolution Committee

- 1. Be it resolved that Resolution No. 4 of 1955 be changed to read, "The Churches send reports of tithes of ordained deacons and ministers and licensed ministers that are in their churches."
- 2. Be it resolved that the clerk and assistant clerk have the annual minutes printed and distributed before the frist quarterly meeting.
- 3. Be it resolved that \$80.00 be made available to be used in helping pay expenses of Youth Camp at Hume Lake beginning June 18, 1956.
- 4. Be it resolved that a standing vote of thanks be given Selma Church for their hospitality.

#### Finance Committee

- 1. We recommend that each church pay 30 cents per member quarterly into the association.
- 2. We recommend that \$60.00 be paid to the host church for the quarterly meetings and \$160.00 for the annual association.

Amendment— We recommend that \$100.00 be given to host church rather than \$60.00.

- 3. We recommend that 300 minutes be printed.
- 4. We recommend that \$115.00 be sent to the Calif. State Association.
- 5. We recommend that the Moderator be paid \$10.00 and the Clerk be paid \$25.00 annually.

6. We recommend that .06 cents per mile be paid executive board members for expense.

#### **EXECUTIVE BOARD REPORT**

On June 11, 1955 the executive board met at Orange Cove for the purpose of electing officers. Those elected were Chairman, Rev. Winston Lawless and Clerk, Rev. Cecil Thurman.

On August 19, 1955 the executive board met at Calwa, California for the purpose of examining Carl Young for ordination to preach the gospel. After examining him and finding him sound in doctrine, the board recommended him for ordination. Gragrie Hunsucker was also examined and found sound in doctrine and recommended for ordination as a deacon.

On November 18, 1955 the executive board met at Parlier with three members present. Rev. Wade Jernigan and Rev. Clark Casteel were appointed to serve in the absence of Rev. Sam Winters and Rev. Winston Lawless to go to Hanford as advisory members.

On November 25, 1955 the executive board met with the Hanford Church in conference The church filed charges against Bill Mize for non christian conduct. With sufficient evidence of this charge the Church asked the advise of the board. The board asked the Church to comply with Matt. 18:15-17. The Church reported this had already been done. Motion carried in church conference to exclude Bill Mize and ask the Executive Board to request his credentials.

On November 18, 1955 Lee Shores and Edward Shores were examined and found sound in doctrine and recommended for ordination as deacons. Ovalon Lee was also examined and recommended for license to preach.

On December 10, 1955 the Executive Board met at Parlier and examined and recommended E. J. Radar for ordination as a deacon.

On February 24, 1956 four members of the Executive Board visited Bill Mize's home at 3386 W. Belmont Ave., Fresno. Mrs. Mize reported that the credentials had been lost for some time.

On February 25, 1956 the Executive Board voted to annul the credentials of Bill Mize and publish same in

"Contact" of Nashville, Tennessee and in "California Free Will Baptist."

On February 25, 1956 the Executive Board met with Delbert Spain. He promised to return to Sanger Church and make apologies. He did same on March 2nd at church conference.

#### CONSTITUTION

#### Preamble

From long experience, we the menbers of the Free Will Baptist denomination, being regularly baptized upon the profession of our faith in Christ and realizing the necessity of a bond of union and fellowship among us as an association of churches and to preserve and maintain correspondence and coordination among us, do therefore ordain this Constitution for our better denominational governmental government.

#### Article I

This organization shall be known as the Center Association of Free Will Baptists of the state of California

#### Article II

The object and purpose of this organization shall be to unify the work of our churches and to devise and execute measures for expanding our work in the cause of Christ into broader fields.

#### Article III

This Center Association shall consist of three delegates duly appointed or elected by the church they represent and all ordained Free Will Baptist ministers, their wives, all ordained Free Will Baptist deacons and their wives, and church clerks.

#### Article IV

The Center Association shall have the right to settle any and all questions of discipline, doctrine or practice that may properly come before it from any of the churches composing this organization, or act upon an appeal that may be made by any member of a member church who fells he has been unjustly charged. Said appeal shall have been written and properly signed by the person or body making such appeal.

#### Article V

Officers—The officers of this Center Association shall consist of a Moderator, Assistant Moderator, Clerk and Assistant Clerk and Treasurer, each of whom shall be elected at the opening of each setting of the annual association.

Committees— Committees as necessary shall be appointed by the Moderator unless otherwise provided for and shall hold office until their work is completed or their successors are appointed.

#### Article VI

This Executive Board shall be composed of five members. Each member shall be an ordained minister in good standing in the Center Association and their terms of tenure shall be as follows:

- (1) One for one year
- (1) One for two years
- (1) One for three years
- (1) One for four years
- (1) One for five years

Succession to office thereafter shall be determined as order requires.

#### Article VII

The center Association shall hold its meeting annually the dated and place to be decided upon at each previous setting of said Association.

#### Article VIII

Should necessity arise which calls for and requires immediate action, the Executive Board of this Association shall convene upon call of its chairman and shall take whatever action it deems necessary in the best interest of the cause of Christ. The action, however, shall not conflict with the purpose and edicts of the Constitution as set forth in the preceding Articles. Expenses of 6 cents per mile will be paid executive board members while attending to business.

#### Article IX

The Executive Board of this Center Association shall not license nor ordain any deacon or minister who does not believe and practice titheing, their titheing being a part of the record to be submitted to the board at the time of presentation for examination for credentials.

#### Article X

This Constitution may be altered or amended at any regular session of the Center Association by a two-thirds vote of members present and voting. All proposed alterations or amendments shall be presented in writing to the body one day in advance.

#### Amendment No.!

This Association shall refrain from ordining anyone to the Ministry who is not actively engaged in a work that necessitates ordination.

#### BY LAWS

- 1. The Moderator or Assisant Moderator or in thier absence the oldest minister (in the work) present shall call the Association into conference.
  - 2. Each session shall be opened and closed by prayer.
- 3. Representation from a majority of the member churches shall constitute a quorum. A less number may adjourn until such a quorum is present.
- 4. Visiting brethren are invited to seat as advisory members.
- 5. Those who shall speak, shall arise and address the Moderator. Personal reflections shall be avoided in all debates.
- 6. If any proposition or motion under debate contains two or more points it shall be divided at the request of any member and a vote taken.
  - 7. Motion made and lost shall not be recorded.
- 8. No one shall speak more than twice on the same subject without special permission of the Moderator.
- 9. The Moderator shall not allow disussions when not carried on in a Christian spirit.
- 10. The ruling of the Moderator may be over-ruled by a two-third majority of members voting.
- 11. No question from any church shall come under the consideration of the Association unless it has first been discussed in its own church.
- 12. At each Association, arrangements shall be made to insure two or more sermons or their equivalent devotional exercises each day.
- 13. The Center Association shall have power to fill vacancies in the delegation from any composite body.
