3. No motion shall be discussed without first being seconded.
4. When a motion has been made and seconded, the Moderator shall ask, "Any discussion or remarks?" If none, the question shall be disposed of as usual.
5. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and the vote taken separately.
6. Motions made and lost shall not be recorded on the minutes unless ordered by the party making the motion.
7. No one shall speak more than twice on the same subject without special leave of the Moderator.
8. All questions shall be decided by the majority of members present and voting.
9. In respect for the chair, anyone needing to leave the Assembly while business is in session, should ask leave of the Moderator, if possible. All delegates, elected and standing, are obligated to stay until the close of the Association.
10. Minutes shall be leisurely read and corrected if necessary before the close of the Association.
11. Arrangements shall be made at each session of the Association for one sermon and one devotion during each day of the annual or Quarterly Meeting.
12. Alteration may be made in these rules at any regular session.

## **BOARD OF TRUSTEES REPORTS QUARTERLY MEETING**

**May 12, 1985**

1. Associational work days will be held at the camp grounds on June 2nd. and June 23rd. Much work remains to be done prior to our youth camps. We therefore, solicit, the assistance of each church in preparing the camp property for our summer activities. Information will be mailed to the churches prior to these work days.

### **ITEM OF INFORMATION:**

A camp work day was held on April 7, 1984. We extend sincere thanks to those who participated. Progress was made on several current projects. We should emphasize however, that only four (4) of the nineteen (19) churches in the association were represented. We encourage more participation in camp activities.

## **REPORT OF THE BOARD OF TRUSTEES to the ANNUAL ASSOCIATION**

**August 11, 1985**

We wish to extend a sincere thanks to those who have assisted in improving and maintaining the campgrounds, and in preparing the facilities for camping. We feel that significant progress has been made in upgrading the camp. This progress has been achieved as a result of many hours of dedicated labor and through the financial support of the association. Unfortunately the bulk of the sacrifice has been borne by a very small segment of the associational body. In spite of efforts to organize and encourage a broad-based support, interest in camp-related projects has steadily declined.

Although a long range camp program was adopted less than two (2) years ago, current signs of apathy cause us to question the body's commitment to this program. This apathy has been evident in the response to scheduled work days and in the difficulty in obtaining adult youth camp workers. To the best of our knowledge, no more than six (6) of our nineteen (19) churches were represented at any scheduled activity with exception of the youth camps.



An apathetic attitude is also evidenced by the poor utilization of our camp facilities. Potential use far exceeds the actual use of this property. We do not feel that it is good stewardship to continue to invest a large proportion of our resources into the camp unless there is a concomitant effort to more effectively incorporate these facilities into the ministry of the association.

Our board does not have, nor do we desire to have, the authority to set policy. Our responsibility is to carry out the wishes of the association as they are made known to us. We hope that we have not, in our zeal, unduly influenced the body into making commitments which we were unwilling to keep. It has been our goal to present as on all issues falling within our purview. If we have failed to do this effectively; we apologize.

Given these stated concerns, we the Board of Trustees propose that:

1. The Board of Trustees prepare and present a revised and updated long range camp improvement plan to the November, 1984 quarterly meeting, and
2. Each church reevaluate their commitment to the camp program and come to the next quarterly prepared to vote accordingly.

Let us emphasize that a vote of support is of little benefit unless it is subsequently demonstrated by action.

## QUARTERLY MEETINGS

**November 19, 1980<sup>3</sup>**

The first quarterly meeting met with the Maranatha Free Will Baptist Church in Ardmore.

The meeting was called to order by the Moderator, Bro. Carroll Milner. Bro. David Sutton led in prayer. Bro. Steve Turner led the congregation in "Footsteps of Jesus", accompanied at the piano by Sis. Vilma McAffery. The morning devotion was led by Bro. Guy Keys, he used Matthew Chapter 28 as his scripture.

The letters from the churches were read by Bro. Eugene Hobbs, the requests were referred to the proper boards. Motion carried that the letters be accepted and the delegates be seated.

A letter from the Calvin Church was read, they stated that they wish to withdraw from the Center Association. Motion carried that we receive the letter as read, and consider the request, and table it for consideration later in the meeting.

Visiting brethren were invited to sit in counsel with us.

The Moderator welcomed two new pastors to the association, Bro. Guy Keys, Cedar Grove, and Bro. Ralph Hampton, Non.

The rules of order were read by the Assistant Moderator, Bro. Leroy Holman.

The pulpit committee was appointed to select a speaker for the February quarterly meeting, they were; Bro. Carlos Scroggins, Sis. Beulah Sweatman, and Sis Marie Murray.

The Moderator read the names of the members of the standing boards and committee, all the boards and committee were represented, with adequate members present, with the exception of the Resolutions Committee, motion carried that the Moderator appoint three members to serve for this session only, they were; Bro. Emmitt Owens, Sis. Marzell Briggs, and Bro. James Manning.

Motion carried that the letter from the Calvin Church be considered at this time, after discussion from the body, motion carried that the Executive Board visit with the Church, extend fellowship, and counsel with them, and bring a report to the February quarterly meeting.

Bro. Eugene Hobbs presented the treasurers report. Motion carried to accept it as presented.

A letter from the Healdon Church was read, since it required some discussion from the Examining Committee it was referred to them for consideration.

It was reported to the body that Bro. Charles Murphy had confirmed that he would hold the camp revival.

Bro. Ernest Harrison, from the National Retirement Board was asked to speak concerning retirement plans for the minister in the association. After he spoke to the body, he stated that he had literature with him and would counsel with anyone that might be interested in the program.

The Pulpit Committee reported that they had selected Bro. Guy Keys to speak at the February Quarterly meeting.

Reports from the standing boards and committees were called for, there were none.

Bro. David Sutton spoke to the body on behalf of the National Home Missions, he stated to the body that November 20th. has been designated as National Home Mission Sunday. He requested that every church consider doing something for this occasion. He related to the body that there are twenty accounts that are in the red at the present time. He also requested that any activity that the churches did, that they send him a brief report. He in turn would send in a report for the association.

Bro. Eugene Hobbs, called to the attention of the body, that some of the churches are still sending money to the Dock Caton account and that he is no longer on the Mission field. He suggested that they might consider earmarking it to some other missionary, or some of the other home missionaries that have accounts in the red.

November quarterly meeting cont.

Adjourned for the morning worship. Prayer by Bro. Lewie Jefferies.

The morning worship opened with singing led by Bro. Steve Turner, accompanied by Sis. Debbie Keys. The songs were "There's Something About That Name", "The Haven of Rest", and "Because He Lives". Bro. James Murray led in prayer. Special music was provided by Sis. Heather Harris, she sang, "Heavenly Sunlight".

Bro. David McDougal brought the morning message, he used as his scripture 2nd. Peter Chapter 1.

Bro. David used as his theme "Doing the things that we need to do as Christians, and asking for the strength to do them."

The afternoon meeting was called into session by the Moderator, Bro Milner.

The Examining Committee presented their report to the body, motion carried to accept the report as a unit, unless there is an objection. "We recommend that Bro. Larry Weatherman, be received into the Association on the merit of the letter of recommendation from the Healdton Church to the Ada Church."

"We recommend that Bro. Robert Scroggins be received into this Association upon receipt of a letter from First Oklahoma Association."

"We recommend that Bro. Ralph Hampton be received into this Association upon receipt of a letter from the First Oklahoma Association and the request from the Non Church."

"We recommend that Bro. Guy Keys be received into this Association upon receipt of a letter from Union Association in Tennessee."

In closing the session the Moderator, Bro. Milner, read the Church Covenant. We were dismissed in prayer by Bro. Eugene Hobbs.

Quarterly Meeting February 19, 1984

The second quarterly meeting of the Center Association met at the First Free Will Baptist in Ada. The meeting was called to order by the Moderator, Bro. Carroll Milner. Bro. Lewie Jefferies led in prayer. The song service was led by Bro. Steve Turner with Janice Presley at the piano, the songs were, "Blessed Assurance", and "There's something about that name." The devotional was presented by Bro. Bill Griffin, his theme being "Increase your faith," taken from St. Luke Chapter 17, verse 5.

The letters were read and the delegates were seated

The Moderator recognized our visitors, Bro. N.R. Smith represented Hillsdale, and Sis. Lynn Midget, was introduced as our Missionary appointee to Spain.

The Rules of Order were read by the Assistant Moderator, Bro. Leroy Holman.

The following committees were appointed. Pulpit Committee Bro. Willie White, Bro. Jerry Price, Bro. Larry Wood.

The Moderator read a letter of introduction concerning our Missionary to the Ivory Coast, Bro. David Felkins.

The Missionary appointee to Spain, Sis. Lynn Midget, spoke to the group, and asked that anyone wishing to have her visit their church she would be more than glad to make an appointment.

The Moderator introduced Bro. N.R. Smith the representative from Hillsdale, he presented a slide presentation concerning the building of the new Library. Bro. Milner announced that a special offering would be taken at the close of the service for the project.

## February Quarterly Meeting cont.

The Treasurer Bro. Eugene Hobbs presented the treasurers report. Motion carried to accept it as read.

The following report was presented by the Executive Board. The Executive Board met at noon Wednesday, February 15, 1984 in Ada, those present were Bro. Carroll Milner, Bro. David Sutton, and Bro. Charles Bigger. We discussed the conversation Bro. Bigger had with the Church Clerk and the Pastor of the Calvin Church concerning their request to withdraw from the Center Association. Where as the Church is in violation of the Covenant and the Treaties in practice, we recommend that we take no action at this time as there may need to be a meeting of the Executive Board with the Church.

Motion carried that we send a letter to the Calvin Church, informing them that we received the letter, and that we did not take action at this time, also inform them that we will take action, when we receive a recommendation from the Executive Board.

The morning worship opened with Bro. Steve Turner leading "Victory in Jesus" accompanied at the piano by Janice Presley. He also led "How Beautiful Heaven Must Be". Special Music was presented by Kay Prince, Judy Hanks, and Brenda Lance they sang "Till The Last Leave Shall Fall". Judy Hanks sang as a solo "A Light In The Darkness" accompanied by Brenda Lance. Bro. Guy Keys brought the message using as his scripture, Matthew Chap. 6 Verse 24.

The Afternoon session was opened with prayer by Bro. Carl Shivers; motion carried to give the host church a rising vote of appreciation for hosting the meeting. Bro. Steve Turner led "The Old Gospel Ship" accompanied by Janice Presley at the piano.

It was brought to the attention of the body that the meeting date for our next quarterly meeting is the same date as the State CTS Competition, after discussion, motion carried to move the date of the quarterly meeting to May 12th.

The Pulpit Committee reported that they had chosen Bro. Lewie Jefferies to speak at the next quarterly meeting.

The Board of Trustee's gave an oral report, they announced that they had a work day planned for April 14th. at 8:00 A.M. They also need someone to do bedding and taping at the camp, they asked everyone to let them know if they know of someone that would be interested.

The report from the Examining Board was read, "We the Examining Board recommend that Bro. James Presley from the Ada First Free Will Baptist Church be ordained as deacon. Motion carried to accept the report as read.

Bro. Carroll Milner requested that the association be in prayer for the Executive Board as they fellowship with the Calvin Church.

It was brought to the attention of those present that it had cost a considerable amount of money this year to have the associational minutes printed, after discussion, it was suggested that each church decide how many minutes they need, and inform the clerk at the next quarterly meeting.

Motion carried that we elect a Missionary Coordinator for the Association. Bro. Carroll Milner was elected.

Motion carried that the Association give \$500.00 to the Hillsdale building fund, and earmark it for the library.

Motion was made that we reduce the number of associational minutes from (500) to (200). This was tabled until the next quarterly meeting in May.

Motion carried that we give \$200.00 to the Lynn Midget Missionary Fund.

It was requested by the assistant clerk, Bro. Eugene Hobbs, that the churches bring back a list of approximately the number of active members, to help decide about the number of minutes to be printed.

Motion to adjourn.

The third quarterly meeting of the Center Association of Free Will Baptist met at the Stratford May 12, 1985.

The meeting was called to order by the Moderator, Bro. Carroll Milner. Bro. David McDougal led in prayer.

Bro. Dean Stone led the delegation in "He Keeps Me Singing" accompanied at the piano by Sis. Debra Gentry.

Bro. Willie White brought the morning devotion from Psalms Chapter 1, Verses 1-6.

The letters from the churches were read, motion carried to receive the letters and seat the delegates.

The following correspondence that the clerk had received since the last quarterly meeting was read for information. A thank you note from Sis. Lynn Midget was read thanking the association for the offering. A letter of recommendation from the First Oklahoma Association for Bro. James Murray, Bro. Lewie Jefferies, Bro. Ralph Hampton, and Bro. Robert Scroggins. A letter from the Stobtown Free Will Baptist Church was read that they are in need of a pastor.

Bro. Milner reminded the body, that because Hillsdale is in the process of building at this time, and are asking for help in that area, not to forget the giving to the general fund.

The contributions from the churches helps keep the enrollment fees lower.

In other business, the Moderator, Bro. Carroll Milner, announced to the body that a Memorial Fund for John and Kay Medcalf has been established at Hillsdale. Motion carried that the association send \$100.00 to the fund.

The morning worship was opened by the Assistant Moderator, Bro. Leroy Holman, Bro. Bigger led in prayer. Bro. Dean Stone led "Joy Unspeakable" and "Sunlight" accompanied at the piano by Sis. Debbie Gentry. Special music was presented by Bro. and Sis. Jack Jones, they sang "What A Day That Will Be". Bro. Dean led "To God Be The Glory", and Bro. Carl Shivers led in prayer prior to the message. Bro. Lewie Jefferies brought the message from 2nd Timothy Chapter 4 Verse 16. The service was dismissed in prayer by brother Anthony Prince.

## May Quarterly Meeting Cont.

The afternoon session was opened by the Moderator, Bro. Carroll Milner.

The Examining Board reported that they recommend to the Association that Bro. Alvin Hardison, from the Marantha Free Will Baptist Church, be ordained as a deacon, and Bro. Willie White from the Cedar Grove Free Will Baptist Church be ordained as a minister. Motion carried to accept the report as read. The Board of Trustee presented their report (See Board of Trustee Reports). Motion carried to accept the report as read.

Bro. Dean Stone reported for the State CTS, he informed the body that the State Competition will be held May 19th. at Hillsdale. He has a schedule of events. They are expecting (750) young people from all over the state. He also gave the dates for the state camps, Junior High, June 4-8; Junior, June 11-15; Senior High, July 2d-6; they are hoping to have (600-700) young people attend. He challenged all young people to attend if at all possible. Also, the State Youth Conference will be held in Ada again, November 10th. He stated to those present, that he would appreciate anyone available to help prepare for this event.

Motion to Adjourn.

## **RULES GOVERNING CAMP GROUND PROPERTY**

1. No camping will be allowed on the west side of the brook that runs across the property.
2. No person or persons will be allowed to take up residence, permanent or temporary, on the property, unless by special permission by the Board of Trustees.
3. Lots shall be located and numbered beginning with Lot 1, on east side of brook where it comes into property on north side and numbered eastward consecutively to the NE corner of property, thence southward still consecutively along the east side of property to the SE corner of said property, said lots shall be 40 feet square. A plat of same shall be kept by Board of Trustees, also a record of the disposal of lots.
4. Any Free Will Baptist belonging to any Church in our Association may build a cabin on this property subject to the following regulations:
  - A. No cabin or permanent camps shall be built on any part of the property except on lots mentioned in Rule No. 3.
  - B. No person may build a cabin or permanent camp without getting permission from the Board of Trustees.
  - C. No person shall have the right to move any cabin or permanent camp off the property at any time or for any purpose.
  - D. If and when the owner of a cabin or permanent camp shall move out of the State of Oklahoma he shall offer for sale said cabin or permanent camp and if not sold within one year from the date of his departure to some person who is a member of some church in the Center Association it shall become the property of the Association or he may give it to the Association or to some person, if such person is a member of some church in the Center Association.
5. Only church sponsored groups may use the camp facilities.
6. Camp property may be used only upon permission of the Board of Trustees.
7. Camp property shall be cleaned following each activity. This shall be the responsibility of the group using the property. Any damages to or problems with camp facilities must be reported to the Board of Trustees. The trustees or their designated representative shall ascertain the condition of the camp at the conclusion of each camp activity.
8. Camp facilities may not be used between November 1 and March 31 of each year except by special permission of the Board of Trustees.
9. A report describing camp utilization will be made to the association at each annual meeting. This report shall include:
  - a) a list of groups using the camp
  - b) total number using camp
  - c) financial report
  - d) proposed changes in the Rental Agreement

# CONSTITUTION

## PREAMBLE

From long experience, we the members of the Center Association of Free Will Baptists being regularly baptised upon the profession of faith in Jesus Christ and being convinced of the necessity of combination of churches to perpetuate a union and communion among us, and to preserve and maintain correspondence with each other, we do therefore ordain this Constitution for better associational government.

## ARTICLE I—MEMBERSHIP

The Center Association of Free Will Baptists shall be composed of Free Will Baptist Churches in Oklahoma which maintain gospel order and are in agreement with denominational doctrines and practices.

Voting members shall include ordained ministers and deacons who are members in good standing of member churches in the Association, elected officers of the Association, and delegates chosen by the different churches in the union, not to exceed three (3) delegates from each church, who upon presentation of letters from their respective church to each meeting shall be entitled to seats.

## ARTICLE II—LETTERS OF REPRESENTATION

Letters from each church giving information requested on letter forms supplied by the associational clerk shall be presented at the annual session. Letters from each church to quarterly meetings shall include only the names of delegates and alternates from the churches.

## ARTICLE III—FEES

Each church should send \$10.00 to the annual meeting for printing of minutes which shall be distributed at the discretion of the Clerk. Each church should share in the support of the Association with a \$10.00 love offering to each quarterly and annual meeting.

No board or individual, except the Executive Board in time of emergency, within the framework of the Association shall have the authority to set, designate, or levy any certain amount of fees or finance upon any individual, church, or group without the approval of the associational body while in regular session.

## ARTICLE IV—OFFICERS AND STANDING BOARDS

**OFFICERS:** Officers of the Association shall include a Moderator, Assistant Moderator, Clerk, Assistant Clerk-Treasurer who shall be chosen by sufferage of members present at the close of each annual session and shall serve for the ensuing associational year.

**STANDING BOARDS:** All boards shall be composed of five (5) members who shall be elected at the annual meeting to terms of 5, 4, 3, 2, and 1 year. No individual shall serve on more than one standing board at one time. Board members with two consecutive absences from the Quarterly Meetings without notifying by letter or telephone, will be eliminated and replaced from the respective board. Vacancies in the boards may be filled at the Quarterly Meetings of the Association. Standing boards and duties are as follows:

**BOARD OF TRUSTEES:** This board shall hold title to all real property owned by the Association. It shall be responsible for the upkeep and maintainance of the associational property.

**EXECUTIVE BOARD:** This board shall act for and in behalf of the Association when not in session. It shall examine all churches desiring to unite with the Association and shall act as an organizational council for newly constituted churches.

This board shall have the authority to call the Association into special session by notifying member churches at least ten (10) days in advance of the called session.

**CHRISTIAN EDUCATION BOARD.** This board shall be responsible for arranging the program and selecting workers for the annual youth camp. They shall promote the Sunday School and Church Training Service programs in the member churches of the Association.

## ARTICLES OF FAITH

### ARTICLE I

We believe in the living God, the Father, Son and Holy Ghost; and these are equal in the Divine Essence, power and glory.—Romans 1:20; John 1:1.

### ARTICLE II—THE BIBLE

The Scriptures of the Old and New Testament of the King James Version Bible were given by the inspiration of God, and are our infallible rule of faith and practice.—II Tim. 3: 16-17; II Pet. 1—20-21.

### ARTICLE III—THE FALL

Section 1. We believe God created man and gave him holy commandments. Whereby, we should live holy, but man voluntarily disobeyed the commandments of God, transgressed the law and fell under just condemnation of the same, whereby all mankind are sinners, but now by constraint, but by choice.—Gen 3: 1-13.

Section 2. Being partakers of the sinful nature attained by the fall.—Romans 5:14-19.

Section 3. And that man is unable to save himself with his own power; but we see Jesus by the suffering death, crowned with glory, that He by the Grace of God, tasted death for every man.—Heb. 2:9.

### ARTICLE IV—PARDON

Section 1. We believe that Christ by His death, suffering and resurrection, purchased our pardon.—I Cor. 15:3.

Section 2. And offers it freely to all mankind upon the principle of repentance toward God with faith in the Lord Jesus Christ.—Eph. 5:2; Heb. 9:28.

Section 3. He now commands all men everywhere to repent; therefore, He sayeth: "Look unto me and be saved all the ends of the earth for I am God and there is none else."—Matt 4:17; Isa. 45:22; Acts 20:21, 17:30.

### ARTICLE V—REGENERATION

We believe that all persons reaching the age of accountability, or the knowledge of right from wrong, must be regenerated and born of the Spirit of God if they inherit eternal life.—John 3:3, 1:12-13; Romans 5:1-13.

### ARTICLE VI—INFANTS

We believe that infants and those who are never mentally capable of being accountable are saved upon the mercies of the Son of God.—Jonah 4:11; Mark 10:14; Luke 18:16; I John 2:12.

### ARTICLE VII—APOSTASY

We believe all Christians should persevere in grace and be faithful to the end if they inherit eternal life. "For blessed are they that do His commandments, that they may have a right to the tree of life and enter in through the gates of that city."—Rev. 22:14; Gal 5:4; Heb. 12:14-28; James 5:19-20.

### ARTICLE VIII—BAPTISMAL MODE

We believe that baptism by immersion is the apostolic mode, even the burial of believers in water, and that Christ, who is our life, showed His humble example to His children and bids us to walk therein.—Matt. 3:16, 28:19; Rom 6:4-5. (Latin to plunge, to submerge, baptizo; Greek, to dip, baptism: Greek, a dipper, bapton; Freck to wash, to dip.—Matt. 3:13-17, 28:19; Rom. 6:4-5; I Peter 3:21.

Examining Board: This board shall examine all ministers for license and ordination including those who shall come from other Associations. It shall examine all deacons for ordination. The time of examination of candidates shall be at the discretion of the board with a written recommendation to be presented to the next meetings of the Association following the examination for approval by the body.

All candidates for ordination to the Gospel Ministry shall be required by the board to answer the questions as adopted by the Oklahoma State Association of Free Will Baptists entitled "Questionnaire for Ministers to be Ordained" as printed in the minutes of the State Association.

"This board shall have the duty and right to investigate reports of and alleged errors in doctrine or practice within our licensed and ordained ministers contrary to those outlined in the Free Will Baptist Treatise.

#### ARTICLE V — PETITIONARY LETTERS

Any church, including newly constituted churches, may be admitted into the Association at any regular meeting when the names of delegates and a letter petitioning for membership are presented, and when the church has been examined by the Executive Board of the Association and are found orthodox and orderly.

#### ARTICLE VI — QUESTIONS

No question from any church in the Association shall come under the consideration of the Association except it has first been discussed in its own church conference.

#### ARTICLE VII — MOTIONS

Every motion made and seconded shall come under the consideration of the Association unless it be withdrawn by the person making the motion.

#### ARTICLE VIII — CLERK

It shall be the duty of the Clerk to keep a regular file of the minutes of the Association in a book to be kept by the Association for that purpose.

#### ARTICLE IX — SIGNATION

The minutes of the Association shall be read, corrected when necessary, and signed by the Moderator and Clerk at the close of the Annual Association.

#### ARTICLE X — MEETINGS

The meeting date of this Association shall be Saturday Morning before the second Sunday in August of each year. Quarterly meetings of the Association shall meet on the third Saturday of November, February, and May of each calendar year.

#### ARTICLE XI — AMENDMENTS

Amendments to the Constitution may be made at any annual meeting by a 2/3 majority vote when presented in writing at the May Quarterly Meeting.

#### ARTICLE IX—MINISTRY CALL

We believe that God, in His goodness, displays His power of grace in a great degree in calling and qualifying His servants by the teaching of the Holy Ghost and by the instruction of His blessed word to go forth and proclaim life and salvation.—Eph. 3:7; I Tim. 1:8-9; Rom. 15:15-16.

#### ARTICLE X—COMMANDMENTS

We believe that baptism and the Lord's Supper, and the washing of the Saint's feet, and keeping the Lord's Day holy, and to abstain from all worldly lust and carnal cares, and to assemble ourselves together, is an ornament which prepares and beautifies the soldiers of the cross to march onward in the army of the Lord.—Matt. 26:26-29; John 13:2-17; I Tim. 5:9-10; Luke 22:7-20.

#### ARTICLE XI—BAPTISMAL RIGHT

Section 1. We believe that none have the right to baptism only those who have obtained a living hope in the Lord Jesus Christ.—Acts 10:47.

Section 2. And none have the right to administer the same only those who are called of God and have come under hands of the presbytery of elders.—Acts 13:1-4; Matt. 28:19-20.

Section 3. And we shall receive none other.—Matt. 3:13-17; Titus 1:5; Acts 14:23.

#### ARTICLE XII—LORD'S SUPPER-DUTY

We believe it is the duty of each church as oft as they assemble themselves together for the observance of the Lord's Supper, and washing the Saint's feet, to invite all Christians to participate in the observance of the ordinances.—I Cor. 11:27-28.

#### ARTICLE XIII—WOMAN'S PRIVILEGE

We believe the Bible teaches woman's privilege to preach the Gospel.—Judges 4:4; Rom. 16:12; II Kings 22:14; Acts 2:17-18

#### ARTICLE XIV—FORNICATION

We believe that nothing but death and fornication, gives a scriptural right to a second marriage, and a second marriage under divorce for any other cause than fornication, is a sin of adultery and contrary to the will and Word of God.—Matt. 19:3-11, 5:32; Luke 16:18; Mark 10:11; Rom. 7:1-3; Prov. 5:19-20; I Cor. 7:10-11; Mal. 2:14-17.

#### ARTICLE XV—RESURRECTION

We believe in the resurrection of all dead both just and unjust.—John 5:28-29.

The resurrection of the just to glory and immortality in the presence of God.—Mat. 25:34; Job. 19-26.

And the unjust to everlasting shame and banishment from the presence of God.—Matt. 25:31-32; Matt. 25:41; I Cor. 15-52; 11 Thes. 1:4-11; Rev. 20:14-15.

# Church Covenant

Having given ourselves to God by faith in Christ and adopted the Word of God as our rule of faith and practice, we now give to one another by the will of God, in this solemn covenant.

We promise by His grace to love and obey Him in all things, to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanctions of use and sale of intoxicating beverages, and to "provide things honest in the sight of all men."

We agree faithfully to discharge our obligation in reference to the study of the Scriptures, secret prayer, family devotion, and social worship, and by self-denial, faith and good works endeavor to "grow in the grace and knowledge of our Lord and Savior, Jesus Christ."

We will everywhere hold Christian principles sacred and Christian obligations and enterprise supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling, that the Kingdom of God may come, and His will be done on earth as it is in Heaven.

To this end we agree to labor for the promotion of educational and denominational enterprise, the support of missions, the success of Sabbath schools, and evangelistic efforts for the salvation of souls and the conversion of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.
