5. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and the vote taken separately.
6. Motions made and lost shall not be recorded on the minutes unless ordered by the party making the motion.
7. No one shall speak more than twice on the same subject without special leave of the Moderator.
8. All questions shall be decided by the majority of members present and voting.
9. In respect for the chair, anyone needing to leave the Assembly while business is in session, should ask leave of the Moderator, if possible. All delegates, elected and standing, are obligated to stay until the close of the Association.
10. Minutes shall be leisurely read and corrected if necessary before the close of the Association.
11. Arrangements shall be made at each session of the Association for one sermon and one devotion during each day of the annual or Quarterly Meeting.
12. Alteration may be made in these rules at any regular session.

PROCEEDINGS

SATURDAY MORNING:

The ninety- fourth annual association of the Center Association of Free Will Baptists convened at the First Free Will Baptist Church of Sulphur, August 8, 1987.

The meeting was called to order by the Moderator, Bro. James Murray. Sister Roberta Summers was asked to serve as clerk for the session today. Prayer was led by Bro. Jack Griffin. Steve Turner led the congregation in singing "I Am Bound For the Promised Land" and "Is It Well With Your Soul" accompanied at the piano by Donna Wood. Bro. A.L. McAffrey gave a devotion from I Corinthians, Chapter 13.

Church letters were read from sixteen churches. The letters were received and the following delegates seated by right hand of fellowship:

The rules of order were read by the assistant Moderator Bro. Carroll Milner.

Bro. Milner appointed a pulpit committee to select the speaker for the first quarterly meeting in November and also the memorial speaker for the annual meeting next year. The committee appointed Sister Ida Stewart, Sister Ora Angel, and Sister Janice Hobbs.

The Moderator introduced Bro. Burton Perry from the State Office.

Bro. Perry spoke to the group on the importance of supporting the cooperative in their church. He expressed his appreciation for the support received from the Center Association for the state work.

Bro. Edwin Wade, President of Hillsdale was introduced. Bro. Wade expressed special "thanks" to the Center Association, for supporting the college, financially, prayerfully and other various gifts and support. He reported several of the teachers at Hillsdale were from the association. He reported that the Center Association gave \$14,967.14 in 1986 to help carry on work at the college.

The floor was opened for old business, There being none, the Moderator proceeded into the new business at hand. The Moderator called for reports from the various boards and committees. The Executive had no report at this time. The body elected Bro. L.D. Stonecipher to serve on the Executive Board for the 5 year term by acclamation. Bro. Lynn Wood reported for the Board of Trustees(see reports). Motion carried to accept the report as read.

We were dismissed for for recess before the Memorial Service.

MEMORIAL SERVICE:

Bro. Steve Turner led the congregation in songs: "I Won't Have to Cross Jordan Alone" and "How Great Thou Art" accompanied at the piano by Pam Scroggins. Bro. Anthony Prince led in prayer. A special song "Going Home" was sung by Leroy Holman, Donna Wood, and Steve Turner. Bro. Dennis O'Donnell led in prayer. Bro. Jerry Dudley was the speaker for the Memorial Service. He chose as his scripture Joshua Chapter 1, using "It was the people of God who brought us where we are today. Where do we go from here?" He stated that we are given the task of doing the work of the Lord now. It is the leaders that have gone on before us, that makes it possible for us to go on and press for the goal before us, to make Heaven our home. He closed with prayer. We were dismissed for the noon meal.

AFTERNOON SESSION:

The afternoon session was opened by the Moderator leading the congregation in "He Keeps Me Singing", accompanied at the piano by Pam Scroggins. The congregation gave the host church a standing vote of appreciation for the noon meal.

Bro. Eugene Hobbs presented the Treasurer's Report. It was accepted as read, and Bro. Hobbs was given a standing vote of appreciation from the congregation. It was called to the attention of the Moderator that a position needed to be filled on the Board of Trustees. Bro. Steve Turner was elected by acclamation for a 5 year term. Bro. Dean Stone reported for the Christian Education Board (see report). The following dates were suggested for the camps: Junior Camp - June 5-10, 1988; Senior Camp - June 19-25, 1988. Bro. Stone also asked that each church consider giving on a regular basis to the Board to help offset the expenses of the monthly rallies. The report was received as read. Bro. Mark Rierison was elected for the 5 year position on the Board of Trustees. The floor was opened for the nominating for the 5 year position on the Examining Committee. Bro. Keith Burden was elected by acclamation. Nominations for the Resolution Committee 5 year position was called for. Joe Summers was elected by acclamation. It was called to the attention of the Moderator that the 3 year position on the Examining Board needed to be filled. Bro. N.R. Smith was elected by acclamation. The Pulpit Committee report was given. Bro. Keith Burden was elected to speak at the November quarterly meeting and Bro. N.R. Smith as alternate. The following churches were selected by the body to host the quarterly meetings and annual:

Letter of recommendation for Bro. Dallas Davis was received. A letter of resignation from Sister Judy Griffin, Clerk was received. State Delegates were appointed by the Moderator for those churches not listing one in their letter.

MINUTES OF QUARTERLY MEETINGS

November 15, 1986

The first quarterly meeting met with the Memorial Church in Sulphur, November 15, 1986. The meeting was called to order by the Moderator, Bro. James Murray, prayer by Bro. Bill Bratcher. The music was led by Bro. Bobby Williams, accompanied at the piano by Carla Williams. The morning devotion was led by Bro. James Murray. He used as his scripture, Deut. 29: 29 and Psalm 100. He closed with prayer.

Bro. Lewie Jefferies, pastor of the Sulphur Memorial Church welcomed everyone present. The moderator asked permission to appoint Sis. Roberta Summers to serve as clerk for the day. Sis Norma Weatherman sent a letter of resignation. The letters were read by the Assistant Clerk Eugene Hobbs, the requests were referred to the committees, motion was made and seconded to receive the letters and seat the delegates. It was called to the attention of the Moderator that a member need to be appointed to fill a vacancy on the examining committee for today, so it would enable them to conduct the business requested in the letters. Bro. Jerry Dudley was appointed. A letter of resignation was read from Norma Weatherman, who has been serving as clerk. Motion was made to accept the letter and also send her a letter of appreciation for the wonderful job she had done. Motion carried. Sister Judy Griffin from the Camp Ground Church was nominated. There being no other nominations, she was elected by acclamation. It was called to the attention of the body at the annual association, that a resolution had been passed in previous years stating that no two members from the same church serve on standing boards. Sis. Norma Weatherman researched and found that it was passed in August 9, 1986.

The assistant moderator, Bro. Carroll Milner appointed the pulpit committee to select a speaker for the Feb. quarterly meeting. They were Sis. Rena Wood, Sister Judy Griffin, and Sister Cleo Jones. The clerk informed the body that the evangelist Bro. Little, would not be able to come. Motion was made that the alternate Bro. Tom Ballard be contacted. Motion carried. Motion was made and seconded that Bro. Bobby Thomas be the alternate, motion carried.

The treasurer's report was presented by Bro. Eugene Hobbs. Motion was made to accept the report as reported. Motion carried. It was called to the attention of the Moderator that since Bro. Larry Weatherman would be pastoring a church at Mustang that a vacancy will need to be filled on the resolution committee until the annual. Bro. Lewie Jefferies was elected to serve. Bro. Lynn Wood presented the report for the Board of Trustees. Motion made that it be received as a matter of information. Bro. Dean Stone reported for the Christian Education Committee. He listed the following dates: CTS competition for the local churches will be April 25th, a place has not been selected as of this date. The State CTS competition will be May 16th. He also called attention to the change in the date of the camps. This report was received as information. The pulpit committee reported that they had selected Bro. Jerry Dudley for the speaker for the second quarterly at Stonewall, alternate was Bro. N.R. Smith.

The morning worship began with Bro. Bobby Williams leading, "When the Roll is Called Up Yonder" accompanied at the piano by Carla Williams. Bro. Carroll Milner led in prayer. Bro. Williams led "Tis So Sweet To Trust in Jesus". Sis. Carla Williams sang "The Old Ship of Zion"

as a special song. The message was brought by Bro. Leroy Holman, his text being Philippians, Chapter 3, verses 14-21. The theme was "Aim to please God in our Christian walk".

The Moderator called the meeting to order. The Examining Committee reported the following: Bro. Dean Sewell be ordained as a minister, Bro. B. J. Dalton be ordained as a minister, Bro. Tim Scroggins be ordained as a deacon, Bro. N. R. Smith be accepted into our association as an ordained minister. Each recommendation was voted on individually and accepted. A motion was made, seconded, and carried that each church be sent a copy of the questionnaire for ordination for ministers and deacons, so that those being sent for examination would be better prepared. A motion was made that Bro. Quinton Kay's license be extended for one year. Motion carried.

Motion was made that we give the host church a standing vote of appreciation. Motion carried.

Motion made to adjourn. Motion carried.

February 21, 1987

The second quarterly meeting was held at Stonewall Church, February 21, 1987. Bro. James Murray, Moderator, called the meeting to order. Congregational singing was led by Bro. Bobby Williams assisted by Sister Connie Kay. The songs were "Leaning On The Everlasting Arms" and "Are You Washed In The Blood Of The Lamb". Devotion was given by Bro. David McDougal, Philippians, Chapter 3. He closed with prayer.

The letters were read and accepted from all churches, except Wolf. All delegates were seated with the right hand of fellowship. There were 41 delegates and 23 ordained present. Bro. Carroll Milner, Assistant Moderator, read the Rules of Order. A petitionary letter from the Mustang Free Will Baptist Church of the First Oklahoman Association was read by Bro. Eugene Hobbs. They asked to be given membership in this association. Bro. Jerry Dudley made a motion for it to go before the Executive Committee and be reported on its findings. Bro. Hobbs read the Treasurers Report. Motion was made and seconded that it be accepted as read. Bro. Carroll Milner selected the Pulpit Committee. They were: Sister Rena Wood, Sister Onetia Manual, and Bro. Lloyd McIlroy.

Bro. Connie Cariker from Hillsdale came and gave a pamphlet of information on the Support Your State Co-op Program. Bro. James Murray chose Bro. N. R. Smith and Bro. Bill Bratcher to sit on the Executive Committee. Point of interest was a letter and response from Bro. Tom Ballard, that he would be able to attend the Senior Youth Camp, June 21-27, 1987. Letters were read from the North West Association, answering our request for a letter for I. L. Florence and also one from the Salina Association for Bro. Gentry. Report was given on the Christian Education Board. This report was received as information. New business was asked for, and there being none, church was recessed for thirty minutes for the Executive Board and Examining Committee to deal with the Mustang Church. Bro. Bill Griffin led prayer.

Bro. Murray called the meeting back to order. The Executive Board recommended that the Mustang Church be accepted into the Center Association with full fellowship and voting rights. The body approved 100%. Examining Committee recommended that Bro. John Judd of the Stratford Church be granted a license for one year, with the condition that all former ordination papers or license be returned to the issuing organizations. They

also recommend that Bro. Dallas Davis of the Mustang Church be received as an ordained deacon in full fellowship, with the recommendation of the Executive Committee pertaining to the church. Both recommendations carried. The Pulpit Committee selected Bro. B. J. Dalton to be speaker at our next meeting and Bro. Bob Hatcher as alternate. Our worship service was brought by Bro. Jerry Dudley. Bro. Bobby Williams and Sister Connie Kay led the congregation in two songs, "Shall We Gather At The River" and "I Am Resolved!" Special singing was by Sister Bea Dudley. Bro. Bill Adcock led in prayer. The message was on Biblical Preservance. He covered elements of saving faith concerning Free Will Baptist beliefs. Faith is not merely an intellectual move, but a heart felt movement, based on several doctrines such as: repentance, obedience, etc. Belief without faith will produce no works, as needed. Bro. Loy Wood dismissed in prayer, asking the blessing on the food.

May 9, 1987

The third quarterly meeting met at the Center Church May 9, 1987. The meeting was called to order by the Moderator, Bro. James Murray. Prayer was led by Bro. I. L. Florence. The congregation sang "O How I Love Jesus" and "Heavenly Sunlight", led by Bobby Williams, accompanied by Gayla Bratcher. A devotional was given by Bro. Bill Bratcher from Galatians 6:1-10, "Let us not be weary in well doing". He closed with prayer. The ministers, deacons and standing delegates were recognized. Church letters were read from all churches, except Asher, Oakman and Pauls Valley. The delegates were seated by right hand of fellowship as Bro. Bobby Williams led "We'll Work Til Jesus Comes" and "Glory To His Name". There were 59 voting delegates present.

Bro. Carroll Milner read the Rules of Order. The Treasurer's Report was distributed and presented by the Treasurer. The Board of Trustees report was given by Bro. Lynn Wood. Motion carried that this report be received as information. An oral report of the Christian Education Board was given by Bro. Dean Stone. He announced the young people who will represent Center Association in the State CTS Competition on May 16. He also announced district camps and state camps. Motion carried to receive this report as information. Bro. David McDougal spoke in behalf of Hillsdale. We were dismissed for recess before the worship service.

Worship service began with congregational singing, "Leaning On The Everlasting Arms" and "Take The Name Of Jesus With You". Prayer was led by Bro. Jimmy Ray Nichols. Sis. Ora Angel sang "It Took A Miracle" and Sis. Kay Harris sang "Jesus Was Born To Die For Us" and "Because I Am". Bro. B. J. Dalton was the speaker for the worship service. He led in prayer and read his scripture from Matthew 28:1-7 emphasizing the following points" (1) He is risen (2) He sends us out (3) He goes before us (4) He will reveal Himself to us, and (5) He keeps His Word.

Motion carried to enter into business session. The Examining Board Report was read. Motion carried to accept this report. Following announcements, we were dismissed and the blessing on the food was given by Bro. Meryl Erickson.

BOARD OF TRUSTEES REPORTS

QUARTERLY MEETING

May 9, 1987

1. Camp Maintenance and Improvement

Several improvement projects are in progress at the camp. These include:

- 1) leveling and reflooring of the girls wooden dorm
- 2) renovation of the shower and the bathroom facilities in the metal dormitory
- 3) construction of a storage building.

These projects are in various stages of completion, but all are projected to be finished prior to Junior camp. In order to accomplish this and to complete maintenance and clean-up activities, two work days are scheduled in the next few weeks. These will be on May 23, and June 6. Please plan to participate in these efforts. We want to thank those who have given of their time and labor already this spring.

2. Report of Theft

Three items were stolen from the camp kitchen during the winter. These were a freezer, a clothes dryer, and an electric chainsaw. Total value of the items were approximately \$350.

ANNUAL ASSOCIATION

August 8, 1987

I. Camp Usage

The camp was used on three occasions during the past year. These were:

1. L.I.F.E. program in September, 1986 with approximately 75 participants
2. Junior Youth Camp, June 7 through June 12, having 136 campers
3. Senior Youth Camp and Associational Revival, June 21 through June 27, with 36 campers.

II. Camp Improvements

Major improvements completed during the past year were:

1. Remodeling bathroom facilities in the metal dormitory
2. Addition of footing and stemwall to wooden girls dormitory
3. New floor in girls wooden dorm.

III. Financial Report

Expenditures for 1986-87 are included in the treasurer's report.

IV. Improvement Plans

The construction of a storage building which was scheduled for 1986, has not been completed. We recommend that this and proposed improvements for 1987-88 be temporarily put on hold until additional information concerning the improvements to Highway 3W is available. The Board has been in contact with the State Highway Department

concerning the highway project but plans and their impact on the camp are uncertain at this time. We will keep the association informed about this matter.

An oral report of the Christian Education Board was given by Bro Dean Stone. He announced the young people who will represent Center Association in the state CTS competition on May 16, 1987. He also announced district camps and state camps.

August 8, 1987

The Christian Education Board reflects another productive year in our Lord's work.

The monthly L.I.F.E. meetings offered a variety of programs for our young people. These rallies averaged approximately 70 in attendance. In regard to the 1987-88 L.I.F.E. schedule, a planning meeting with church youth leaders will be held on August 21, 1987 at the Wilson FWB Church beginning at 7:00p.m. The 1987-88 L.I.F.E. rallies will be held the first Saturday evening of each month beginning with September. Meeting time will be 6:30 p.m.

The board also sponsored once again the district CTS competitive activities on Saturday, April 25, in the Stratford FWB Church. Ada, Center, Maranatha, Stratford, and Wilson FWB had entries in the competition. Several district entrants in the state competition held in OKC received first place honors and advanced to national competition which was held in Birmingham, Alabama. EXAMINING BOARD REPORT

November 15, 1986

The Examining Committee reported that the following, Bro. Dean Sewell be ordained as a minister, Bro. B.J. Dalton be ordained as a minister, Bro. Tim Scroggins be ordained as a deacon, Bro. N.R. Smith be accepted into our association as an ordained minister. Each recommendation was voted on individually and accepted. Motion was made, seconded, and carried, that each church be sent a copy of the questionnaire for ordination for ministers and deacons, so that those being sent for examination would be better prepared. Motion was made that Bro. Quinton Kay's license be extended for one year. Motion carried.

February 21, 1987

Examining Committee recommended that Bro. John Judd of the Stratford FWB Church be granted a license for one year, with the condition that all former ordination papers or license be returned to the issuing organizations. They also recommend that Bro..Dallas Davis of the Mustang FWB Church be received as an ordained deacon in full fellowship, with the recommendation of the Executive Committee pertaining to the church. Both recommendations carried.

May 9,1987

We recommend that we receive Bro. Keith Burden into fellowship of this Association upon receipt of a letter from Greater Tulsa, thanking God for His leadership in bringing him to us.

EXECUTIVE BOARD REPORT

February 21, 1987

We recommend that the Mustang FWB Church be accepted into the Center Association with full fellowship and voting rights. The body approved 100%.

RULES GOVERNING CAMP GROUND PROPERTY

1. No camping will be allowed on the west side of the brook that runs across the property.
2. No person or persons will be allowed to take up residence, permanent or temporary, on the property, unless by special permission by the Board of Trustees.
3. Lots shall be located and numbered beginning with Lot 1, on east side of brook where it comes into property on north side and numbered eastward consecutively to the NE corner of property, thense southward still consecutively along the east side of property to the SE corner of said property, said lots shall be 40 feet square. A plat of same shall be kept by Board of Trustees, also a record of the disposal of lots.
4. Any Free Will Baptist belonging to any Church in our Association may build a cabin on this property subject to the following regulations:
 - A. No cabin or permanent camps shall be built on any part of the property except on lots mentioned in Rule No. 3.
 - B. No person may build a cabin or permanent camp without getting permission from the Board of Trustees.
 - C. No person shall have the right to move any cabin or permanent camp off the property at any time or for any purpose.
 - D. If and when the owner of a cabin or permanent camp shall move out of the State of Oklahoma he shall offer for sale said cabin or permanent camp and if not sold within one year from the date of his departure to some person who is a member of some church in the Center Association it shall become the property of the Association or he may give it to the Association or to some person, if such person is a member of some church in the Center Association.
5. Only church sponsored groups may use the camp facilities.
6. Camp property may be used only upon permission of the Board of Trustees.
7. Camp property shall be cleaned following each activity. This shall be the responsibility of the group using the property. Any damages to or problems with camp facilities must be reported to the Board of Trustees. The trustees or their designated representative shall ascertain the condition of the camp at the conclusion of each camp activity.
8. Camp facilities may not be used between November 1 and March 31 of each year except by special permission of the Board of Trustees.
9. A report describing camp utilization will be made to the association at each annual meeting. This report shall include:
 - a) a list of groups using the camp
 - b) total number using camp
 - c) financial report
 - d) proposed changes in the Rental Agreement

CONSTITUTION

Preamble

From long experience, we the members of the Center Association of Free Will Baptists being regularly baptised upon the profession of faith in Jesus Christ and being convinced of the necessity of combination of churches to perpetuate a union and communion among us, and to preserve and maintain correspondence with each other, we do therefore ordain this Constitution for better associational government.

ARTICLE I--Membership

The Center Association of Free Will Baptists shall be composed of Free Will Baptist Churches in Oklahoma which maintain gospel order and are in agreement with denominational doctrines and practices.

Voting members shall include ordained ministers and deacons who are members in good standing of member churches in the association, elected officers of the Association, members of associational standing boards and committees, and delegates chosen by the churches in the union, not to exceed three (3) from their respective church to each meeting shall be entitled to seats.

ARTICLE II--Letters of Representation

Letters from each church giving information requested on letter forms supplied by the associational clerk shall be presented to the annual session. Letters from each church to quarterly meetings shall include only the names of delegates and alternates from the churches.

ARTICLE III--Fees

Each church should send \$10.00 to the annual meeting for printing of minutes which shall be distributed at the discretion of the Clerk. Each church should share in the support of the Association with a \$10.00 love offering to each quarterly and annual meeting.

No board or individual, except the Executive Board in time of emergency, within the framework of the Association shall have the authority to set, designate, or levy any certain amount of fees or finance upon any individual, church, or group without the approval of the associational body while in regular session.

ARTICLE IV--Officers and Standing Boards

OFFICERS: Officers of the Association shall include a Moderator, Assistant Moderator, Clerk, Assistant Clerk-Treasurer who shall be chosen by suffrage of members present at the close of each annual session and shall serve for the ensuing associational year.

STANDING BOARDS: All boards shall be composed of five (5) members who shall be elected at the annual meeting to terms of 5, 4, 3, 2, and 1 year. No individual shall serve on more than one standing board at one time. Board members with two consecutive absences from the Quarterly Meetings without notifying by letter or telephone, will be eliminated and replaced from the respective board. Vacancies in the boards may be filled at the Quarterly Meetings of the Association. Standing Boards and duties are as follows:

BOARD OF TRUSTEES: This board shall hold title to all real property owned by the Association. It shall be responsible for the upkeep and maintenance of the associational property.

EXECUTIVE BOARD: This board shall act for and in behalf of the Association when not in session. It shall examine all churches desiring to unite with the Association and shall act as an organizational council for newly constituted churches.

This board shall have the authority to call the Association into special session by notifying member churches at least ten (10) days in advance of the called session.

CHRISTIAN EDUCATION BOARD: This board shall be responsible for arranging the program and selecting workers for the annual youth camp. They shall promote the Sunday School and Church Training Service programs in the member churches of the Association.

EXAMINING BOARD: This board shall examine all ministers for license and ordination including those who shall come from other Associations. It shall examine all deacons for ordination. The time of examination of candidates shall be at the discretion of the board with a written recommendation to be presented to the next meeting of the Association following the examination for approval by the body.

All candidates for ordination to the Gospel Ministry shall be required by the board to answer the questions as adopted by the Oklahoma State Association of Free Will Baptists entitled "Questionnaire for Ministers to be Ordained" as printed in the minutes of the State Association.

This board shall have the duty and right to investigate reports of and alleged errors in doctrine or practice within our licensed and ordained ministers contrary to those outlined in the Free Will Baptist Treatise.

ARTICLE V--Petitionary Letters

Any church, including newly constituted churches, may be admitted into the Association at any regular meeting when the names of delegates and a letter petitioning for membership are presented, and when the church has been examined by the Executive Board of the Association and are found orthodox and orderly.

ARTICLE VI--Questions

No question from any church in the Association shall come under the consideration of the Association except it has first been discussed in its own church conference.

ARTICLE VII--Motions

Every motion made and seconded shall come under the consideration of the Association unless it be withdrawn by the person making the motion.

ARTICLE VIII--Clerk

It shall be the duty of the Clerk to keep a regular file of the minutes of the Association in a book to be kept by the Association for that purpose.

ARTICLE IX--*Signation*

The minutes of the Association shall be read, corrected when necessary, and signed by the Moderator and Clerk at the close of the Annual Association.

ARTICLE X--*Meetings*

The meeting of this Association shall be Saturday morning before the second Sunday in August of each year. Quarterly meetings of the Association shall meet on the third Saturday of November, February, and the second Saturday of May.

ARTICLE XI--*Amendments*

Amendments to the Constitution may be made at any annual meeting by a 2/3 majority vote when presented in writing at the May Quarterly Meeting.

Whereby, we should live holy, but man voluntarily disobeyed the commandments of God, transgressed the law and fell under just condemnation of the same, whereby all mankind are sinners, but now by constraint, but by choice.—Gen 3: 1-13.

Section 2. Being partakers of the sinful nature attained by the fall.—Romans 5:14-19.

Section 3. And that man is unable to save himself with his own power; but we see Jesus by the suffering death, crowned with glory, that He by the Grace of God, tasted death for every man.—Heb. 2:9.

ARTICLE IV—PARDON

Section 1. We believe that Christ by His death, suffering and resurrection, purchased our pardon.—I Cor. 15:3.

ARTICLE V—REGENERATION

We believe that all persons reaching the age of accountability, or the knowledge of right from wrong, must be regenerated and born of the Spirit of God if they inherit eternal life.—John 3:3, 1:12-13; Romans 5:1-13.

ARTICLE VI—INFANTS

We believe that infants and those who are never mentally capable of being accountable are saved upon the mercies of the Son of God.—Jonah 4:11; Mark 10:14; Luke 18:16; I John 2:12.

ARTICLE VII—APOSTASY

We believe all Christians should persevere in grace and be faithful to the end if they inherit eternal life. "For blessed are they that do His commandments, that they may have a right to the tree of life and enter in through the gates of that city."—Rev. 22:14; Gal 5:4; Heb. 12:14-28; James 5:19-20.

ARTICLE VIII—BAPTISMAL MODE

We believe that baptism by immersion is the apostolic mode, even the burial of believers in water, and that Christ, who is our life, showed His humble example to His children and bids us to walk therein.—Matt. 3:16, 28:19; Rom 6:4-5. (Latin to plunge, to submerge, baptizo; Greek, to dip, baptism: Greek, a dipper, bapton; Greek to wash, to dip.—Matt. 3:13-17, 28:19; Rom. 6:4-5; I Peter 3:21.

ARTICLE IX—MINISTRY CALL

We believe that God, in His goodness, displays His power of grace in a great degree in calling and qualifying His servants by the teaching of the Holy Ghost and by the instruction of His blessed word to go forth and proclaim life and salvation.—Eph. 3:7; I Tim. 1:8-9; Rom. 15:15-16.

ARTICLE X—COMMANDMENTS

We believe that baptism and the Lord's Supper, and the washing of the Saint's feet, and keeping the Lord's Day holy, and to abstain from all worldly lust and carnal cares, and to assemble ourselves together, is an ornament which prepares and beautifies the soldiers of the cross to march onward in the army of the Lord.—Matt. 26:26-29; John 13:2-17; I Tim. 5:9-10; Luke 22:7-20.

ARTICLE XI—BAPTISMAL RIGHT

Section 1. We believe that none have the right to baptism only those who have obtained a living hope in the Lord Jesus Christ.—Acts 10:47.

Section 2. And none have the right to administer the same only those who are called of God and have come under hands of the presbytery of elders.—Acts 13:1-4; Matt. 28:19-20.

Section 3. And we shall receive none other.—Matt. 3:13-17; Titus 1:5; Acts 14:23.

ARTICLE XII—LORD'S SUPPER-DUTY

We believe it is the duty of each church as oft as they assemble themselves together for the observance of the Lord's Supper, and washing the Saint's feet, to invite all Christians to participate in the observance of the ordinances.—I Cor. 11:27-28.

ARTICLE XIII—WOMAN'S PRIVILEGE

We believe the Bible teaches woman's privilege to preach the Gospel.—Judges 4:4; Rom. 16:12; II Kings 22:14; Acts 2:17-18

ARTICLE XIV—FORNICATION

We believe that nothing but death and fornication, gives a scriptural right to a second marriage, and a second marriage under divorce for any other cause than fornication, is a sin of adultery and contrary to the will and Word of God.—Matt. 19:3-11, 5:32; Luke 16:18; Mark 10:11; Rom. 7:1-3; Prov. 5:19-20; I Cor. 7:10-11; Mal. 2:14-17.

ARTICLE XV—RESURRECTION

We believe in the resurrection of all dead both just and unjust.—John 5:28-29.

The resurrection of the just to glory and immortality in the presence of God.—Mat. 25:34; Job. 19-26.

And the unjust to everlasting shame and banishment from the presence of God.—Matt. 25:31-32; Matt. 25:41; I Cor. 15:52; 11 Thes. 1:4-11; Rev. 20:14-15

Church Covenant

Having given ourselves to God by faith in Christ and adopted the Word of God as our rule of faith and practice, we now give to one another by the will of God, in this solemn covenant.

We will everywhere hold Christian principles sacred and Christian obligations and enterprise supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling, that the Kingdom of God may come, and His will be done on earth as it is in Heaven.

To this end we agree to labor for the promotion of educational and denominational enterprise, the support of missions, the success of Sabbath schools, and evangelistic efforts for the salvation of souls and the conversion of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.
