3. No motion shall be discussed without first being seconded.
4. When a motion has been made and seconded, the Moderator shall ask, "Any discussion or remarks?" If none, the question shall be disposed of as usual.
5. If any proposition or motion under debate contains two or more points, it shall be divided at the request of any member and the vote taken separately.
6. Motions made and lost shall not be recorded on the minutes unless ordered by the party making the motion.
7. No one shall speak more than twice on the same subject without special leave of the Moderator.
8. All questions shall be decided by the majority of members present and voting.
9. In respect for the chair, anyone needing to leave the Assembly while business is in session, should ask leave of the Moderator, if possible. All delegates, elected and standing, are obligated to stay until the close of the Association.
10. Minutes shall be leisurely read and corrected if necessary before the close of the Association.
11. Arrangements shall be made at each session of the Association for one sermon and one devotion during each day of the Annual or Quarterly Meeting.
12. Alteration may be made in these rules at any regular session.

August 7, 1993

The annual treasurers report was presented by the treasurer, Bro. Eugene Hobbs. Motion carried to receive the report, and commend Bro. Hobbs for a job well done.

The following guests were recognized by the Moderator, Bro. Lynn Wood, representing the National Home Missions, and Bro. Connie Cariker, State Executive Secretary. Bro. Wood spoke briefly concerning Benjamin Randall Day, and asked pastors present to commit to an offering November 21th, and they will receive a book "Journals of Benjamin Randall". Bro. Cariker spoke about all the coming events at Hillsdale. He also praised the association for their faithful offerings. A letter of recommendation was read from the First Okla. Association for Bro. DeArthur Yandell. Also an oral report was given for Bro. James Franklin from First Mission Association, the clerk had received a telephone call from their clerk giving him full recommendation. Bro. Meryl Erickson introduced Bro. Paul Hemmonds who is serving as youth pastor at the First Sulphur Church. Bro. Leroy Holman presented an oral report for the Executive Board. In his message Bro. Murray reminisced about the past years of the Center Association, and about individuals that had played a large part in his ministry. He was ordained to preach by the association in 1954. He used as his text, Hebrews 6:19, his theme being "Getting on the Old Gospel Ship", he further stated that you can know you are saved, and the compass on the ship is the Bible. We were dismissed in prayer by Bro. Jimmy Ray Nichols.

The body was called into session by the Moderator, Bro. James Murray. An election was held for the Resolutions Committee. Bro. DeArthur Yandell was elected to serve for the five year member. Bro. Lewis Perry the three year member, and Bro. L. R. Manuel, Jr. the one year member.

The annual election of officers for the association was held, all the officers presently serving were elected by acclamation, there are, Bro. Eugene Hobbs, Assistant-Clerk-Treasurer, Sis. Roberta Summers, Clerk, Bro. James Murray, Moderator, and Bro. David McDougal, Assistant Moderator. In other business Bro. Jimmy Ray Nichols gave an oral report about the progress of the printing of the association history book. There being no further business the meeting was adjourned.

SPECIAL PROGRAM

This session of the Center Association marks the one hundredth anniversary. In observance of this special occasion, Sis. Zora Williams former clerk was asked to speak about things she could remember over the years, along with Sis. Williams Bro. DeArthur Yandell and Bro. A. L. McAffrey were also invited to speak and share past events with those present. In her remarks Sis. Williams told of attending the associational meeting regularly. Also, about the many evangelists and delegates that stayed in their home. She has been a part of this association since she was fourteen years. She has an old clerk's book that is 96 years old. She expressed love for the association, and counts it an honor to have served as clerk for so many years.

Bro. Yandell opened his part of the program by leading the congregation in singing "I Shall Not Be Moved". In other remarks he told of a revival held by his father Bro. I. W. Yandell, after which he baptized eighty-four people, Bro. Walter Wood assisted in the baptism. He stated that he planned to always contend for the faith, and that he is grateful for his heritage in the Free Will Baptist denomination.

The next speaker was Bro. A. L. McAffrey, he told of his ordination held at Yeager. He also told about the churches at Postoak, and Old McGee, Prairie Grove, and Maxwell. He also recalled events about Bro. Vard Wood, and all that he meant to him and this association. He told of attending the state convention and going home with John and Effie Wood. CENTER ASSOCIATION OF FREE WILL BAPTISTS EXECUTIVE BOARD REPORT (February 20, 1993)

Subsequent to the Center Association's decision at the Annual meeting in August, 1992 to sell the Pauls Valley Free Will Baptist Church property, the Executive Board retained an attorney to effect the transfer of title to the property to the Center Association. On October 5, 1992 the church property was legally conveyed to the Center Association and the First Free Will Baptist Church of Pauls Valley was officially dissolved.

The Executive Board has listed the property with Abel Realty in Pauls Valley. Although interest has been light, the property has been shown a few times. One offer of \$15,000 was made, but withdrawn, before the Board could get together to act upon it.

As there have been two inquiries to the board chairman about renting the building, the Executive Board met January 14, 1993 at the Pauls Valley property to discuss that possibility. The board decided to keep the property listed for sale with the realtor, but allow the chairman to pursue the possibility of renting it until a buyer is located. The board also stipulated that the renter must purchase insurance on the building and the renter must agree to vacate within 30 days of notification by the board in case a contract to buy the property is secured.

Two churches currently on the membership list of Center Association need to be removed from that list. The Wolf Free Will Baptist has resumed having services. Bro. Delbert Akin pastors there and he reports an average attendance of 25. Bro. Akin reports that the church has joined the First Oklahoma Association. The Mustang Free Will Baptist Church has disbanded, and deeded the property to the First Oklahoma Association for a possible mission work by that Association. The Executive Board recommends that both these churches' names be removed from the Center Association directory of churches.

ANNUAL REPORT
August 7, 1993

The Christian Education Board met May 3, to discuss final plans for Youth Camp and district C.T.S. Two churches sent entrants to State C.T.S. Competition: Ada; Jennifer Pearce - *Painting / Maranatha*; Tia Holman - *Piano Solo* (1st at State), Tia Holman - *Painting*, Stacy Dishman - *Graphics*, James Riggs - *Graphics*, Jillian Bell - *Ceramics* (1st at State & National), Gloria Bell - *Ceramics* (1st at State).

It is hoped that more of our youth will participate in these Church training activities. The 1994 National Youth Conference will be held in Little Rock, Arkansas. The NYC Guidelines booklet (for CTS competition) is available through any of our FWB Bookstores. Please contact one of the C.E. Board members for more information if further assistance is desired.

The L.I.F.E. Lock-In is scheduled for January 28 & 29, 1994. It will be held at the Ardmore YMCA. We encourage all our youth (age 12 and older) to attend.

The C.E. Board also met July 29, 1993 to evaluate Camp and consider several other issues. Senior Camp included 65 campers plus 21 workers and sponsors. There was one saved. Junior Camp registered 72 campers with 17 workers and sponsors. Eleven were saved this week. A total of twelve were saved, plus an untold number made personal commitments for a closer walk with Jesus.

We enjoyed excellent preaching from our Evangelists; Bro. Charlie Murphy and Bro. Randy Puckett. There were multitudes of opportunities for teaching and training our young people to follow the principles of Scripture. We thank all the workers and sponsors who helped to make this possible. We do encourage each Church that sends campers to include at least one sponsor. This is a great opportunity to draw closer to your young people and help establish stronger ties.

The C.E. Board is seeking to establish a budget for Youth Camp. In order to accomplish this task the C.E. Board asks the Association to consider these recommendations. It has been our practice that during camp time any individual can purchase items from a variety of local merchants and charge it to the Association. This policy does not allow the C.E. Board to keep track of expenses. Although, there is no reason to suspect that this has been abused, it is recognized the potential for abuse does exist. The C.E. Board requests permission to establish a *Requisition / Purchase Order System* for C.E.B. fund Youth Camp expenses. It would require camp workers to use a *Purchase Order* form to charge items to the Association and bring a receipt back to camp officials. Billing procedures would remain the same.

It is the goal of the C.E. Board to provide the best camp feasible while maintaining proper stewardship of finances. The average C.E.B. fund expense for 1992 camp was \$40.56 per person. The C.E. Board recommends Camp Tuition for 1994 be increased to \$40.00 per camper. Realizing this may make it difficult for some to attend camp, the C.E. Board offers this suggestion: Instead of having every Church send \$100 for food, each Church could use that money to help supplement tuition for campers from their Church. This method would seem more equitable since each Church does not send the same number of campers. The Association *General Fund* supplemented \$15.56 for each camper in 1991, over \$2,600.00. By setting tuition at \$40.00 per camper there would be less strain on our General Fund budget. With each Church using the \$100 food allotment to supplement tuition for their campers, the overall cost for camp tuition will average about \$5.00 - \$10.00 more per camper. Those sending less than seven campers would have no increase.

The C.E. Board encourages each Church to inform their youth and support their participation in *See You At The Pole '93*. This is a student-led effort to gather around their school flag pole and join in pray for their friends, school and country. This event is scheduled for Wednesday, September 15, at 7:00 a.m.

The annual *L.I.F.E. Hayride* is scheduled for Saturday, October 2, at 6:30 pm. We will be meeting at the Gaar Corner FWB Church. Please remember to bring hot dogs and buns for your group.

The L.I.F.E. checking account posted a balance of \$514.37, as of July 29, 1993. An additional \$160.00, (allocation for June and July) is yet to be added to this total.

There are two vacancies to fill on the C.E. Board. Bro. Mike Wood has moved and is unable to complete his term. Sis. Marzell Briggs has expressed her desire to not be elected for another term. The C.E. Board wishes to express thanks to Sis. Marzell Briggs for her dedication and service with the Christian Education Board and the youth of the Center Association. The C.E. Board offers the recommendation that Sis. Penny Turner and Sis. Eva Muck be selected to serve with this board.

Thank you for allowing us the opportunity to serve this body and the youth of our association.

RULES GOVERNING CAMP GROUND PROPERTY

1. *No camping will be allowed on the west side of the brook that runs across the property.*
2. *No person or persons will be allowed to take up residence, permanent or temporary, on the property, unless by special permission by the Board of Trustees.*
3. *Lots shall be located and numbered beginning with Lot 1, on east side of brook where it comes into property on north side and numbered eastward consecutively to the NE corner of property, thense southward still consecutively along the east side of property to the SE corner of said property, said lots shall be 40 feet square. A plat of same shall be kept by Board of Trustees, also a record of the disposal of lots.*
4. *Any Free Will Baptist belonging to any Church in our Association may build a cabin on this property subject to the following regulations.*
 - A. *No cabin or permanent camps shall be built on any part of the property except on lots mentioned in Rule No. 3.*
 - B. *No persons may build a cabin or permanent camp without getting permission from the Board of Trustees.*
 - C. *No person shall have the right to move any cabin or permanent camp off he property at any time or for any purpose.*
 - D. *If and when the owner of a cabin or permanent camp shall move out of the State of Oklahoma he shall offer for sale said cabin or permanent camp and if not sold within one year from the date of his departure to some person who is a member of some church in the Center Association it shall become the property of the Association or he may give it to the Association or to some person, if such person is a member of some church in the Center Association.*
5. *Only church sponsored groups may use the camp facilities.*
6. *Camp property may be used only upon permission of the Board of Trustees.*
7. *Camp property shall be cleaned following each activity. This shall be the responsibility of the group using the property. any damages to or problems with camp facilities must be reported to the Board of Trustees. The trustees or their designated representative shall ascertain the condition of the camp at the conclusion of each camp activity.*
8. *Camp facilities may not be used between November 1 and March 31 of each year except by special permission of the Board of Trustees.*
9. *A report describing camp utilization will be made to the association at each annual meeting. This report shall include:*
 - a) *a list of groups using the camp*
 - b) *total number using camp*
 - c) *financial report*
 - d) *proposed changes in the Rental Agreement*

CONSTITUTION

Preamble

From long experience, we the members of the Center Association of Free Will Baptists being regularly baptized upon the profession of faith in Jesus Christ and being convinced of the necessity of combination of churches to perpetuate a union and communion among us, and to preserve and maintain correspondence with each other, we do therefore ordain this Constitution for better associational government.

ARTICLE I - Membership

The Center association of Free Will Baptists shall be composed of Free Will Baptist churches in Oklahoma which maintain gospel order and are in agreement with denominational doctrines and practices.

Voting members shall include ordained ministers and deacons who are members in good standing of member churches in the association, elected officers of the association, members of associational standing boards and committees, and delegates chosen by the churches in the union, not to exceed three (3) from their respective church to each meeting shall be entitled to seats.

ARTICLE II - Letters of Representation

Letters from each church giving information requested on letter forms supplied by the associational clerk shall be presented to the annual session. letters from each church to quarterly meetings shall include only the names of delegates and alternates from the churches.

ARTICLE III - Fees

Each church should send \$10.00 to the annual meeting for printing of minutes which shall be distributed at the discretion of the clerk. Each church should share in the support of the Association with a \$10.00 love offering to each quarterly and annual meeting.

No board or individual, except the executive Board in time of emergency, within the framework of the Association shall have the authority to set, designate, or levy any certain amount of fees or finance upon any individual, church, or group without the approval of the associational body while in regular session.

ARTICLE IV - Officers and Standing Boards

OFFICERS: Officers of the association shall include a moderator, Assistant Moderator, Clerk, Assistant Clerk-Treasurer who shall be chosen by suffrage of members present at the close of each annual session and shall serve for the ensuing associational year.

STANDING BOARDS: All boards shall be composed of five (5) members who shall be elected at the annual meeting to terms of 5, 4, 3, 2, and 1 year. No individual shall serve on more than one standing board at one time. Board members with two consecutive absences from the Quarterly Meetings without notifying by letter or telephone, will be eliminated and replaced from the respective board. Vacancies in the boards may be filled at the Quarterly meetings of the Association. Standing Boards and duties are as follows.

BOARD OF TRUSTEES: This board shall hold title to all real property owned by the Association. It shall be responsible for the up-keep and maintenance of the associational property.

EXECUTIVE BOARD: This board shall act for and in behalf of the Association when not in session. It shall examine all churches desiring to unite with the association and shall act as an organizational council for newly constituted churches.

This board shall have the authority to call the Association into special session by notifying member churches at least ten (10) days in advance of the called session.

CHRISTIAN EDUCATION BOARD: This board shall be responsible for arranging the program and selecting workers for the annual youth camp. They shall promote the Sunday School and Church Training Service programs in the member churches of the association.

EXAMINING BOARD: This board shall examine all ministers for license and ordination including those who shall come from other Associations. It shall examine all deacons for ordination. The time of examination of candidates shall be at the discretion of the board with a written recommendation to be presented to the next meeting of the Association following the examination for approval by the body.

All candidates for ordination to the Gospel ministry shall be required by the board to answer the questions as adopted by the Oklahoma State Association of Free Will Baptist entitled "Questionnaire for Ministers to be Ordained" as printed in the minutes of the State Association.

The board shall have the duty and right to investigate reports of and alleged errors in doctrine or practice within our licensed and ordained ministers contrary to those outlined in the Free Will Baptist Treatise.

ARTICLE V - Petitionary Letters

Any church, including newly constituted churches, may be admitted into the association at any regular meeting when the names of delegates and a letter petitioning for membership are presented, and when the church has been examined by the Executive Board of the Association and are found orthodox and orderly.

ARTICLE VI - Questions

No question from any church in the Association shall come under the consideration of the Association except it has first been discussed in its own church conference.

ARTICLE VII - Motions

Every motion made and seconded shall come under the consideration of the Association unless it be withdrawn by the person making the motion.

ARTICLE VIII - Clerk

It shall be the duty of the clerk to keep a regular file of the minutes of the Association in a book to be kept by the Association for that purpose.

ARTICLE IX - Signation

The minutes of the Association shall be read, corrected when necessary, and signed by the Moderator and Clerk at the close of the Annual Association.

ARTICLE X - Meetings

The meeting of this Association shall be Saturday morning before the second Sunday in August of each year, and the third Saturday of February.

ARTICLE XI - Amendments

Amendments vote to the constitution may be at any annual meeting by a 2/3 majority vote when presented in writing at the May Quarterly Meeting.

We believe all Christians should persevere in grace and be faithful to the end if they inherit eternal life. "For blessed are they that do His commandments, that they may have a right to the tree of life and enter in through the gates of that city." - Rev. 22:14; Gal 5:4; Heb.. 12:14-28; James 5:19-20.

ARTICLE VIII - BAPTISMAL MODE

We believe that baptism by immersion is the apostolic mode, even the burial of believers in water, and that Christ, who is our life, showed His humble example to His children and bids us to walk therein. - Matt.. 3:16, 28:19; Rom. 6:4-5. (Latin to plunge, to submerge, baptize; Greek, to dip, baptism: Greek, a dipper, bap tion; Greek to wash, to dip - Matt.. 3:13-17, 28:19 Rom. 6:4-5; I Peter 3:21.

ARTICLE IX - MINISTRY CALL

We believe that God, in His goodness, displays His power of grace in a great degree in calling and qualifying His servants by the teaching of the Holy Ghost and by the instruction of His blessed word to go forth and proclaim life and salvation.- Eph. 3:7; I Tim. 1:8-9, Rom. 15:15-16.

ARTICLE X - COMMANDMENTS

We believe that baptism and the Lord's Supper, and the washing of the Saint's feet, and keeping the Lord's Day holy, and to abstain from all worldly lust and carnal cares, and to assemble ourselves together, is an ornament which prepares and beautifies the soldiers of the cross to march onward in the army of the Lord.- Matt. 26:26-29; John 13:2-17; I Tim. 5:9-10; Luke 22:7-20.

ARTICLE XI - BAPTISMAL RIGHT

Section 1. We believe that none have the right to baptism only those who have obtained a living hope in the Lord Jesus Christ. - Acts 10:47.

Section 2. And none have the right to administer the same only those who are called of God and have come under hands of the Presbytery of elders. - Acts 13:1-4; Matt. 28:19-20.

Section 3. And we shall receive none other.- Matt. 3:13-17; Titus 1:5; Acts 14:23.

ARTICLE XII - LORD'S SUPPER - DUTY

We believe it is the duty of each church as often as they assemble themselves together for the observance of the Lord's Supper, and washing the saint's feet, to invite all Christians to participate in the observance of the ordinances. - I Cor. 11:27-28.

ARTICLE XIII - WOMAN'S PRIVILEGE

We believe the Bible teaches woman's privilege to preach the Gospel. - Judges 4:4; Rom. 16:12; II Kings 22:14; Acts 2:17-18.

ARTICLE XIV - FORNICATION

We believe that nothing but death and fornication, gives a scriptural right to a second marriage, and a second marriage under divorce for any other cause than fornication, is a sin of adultery and contrary to the will and Word of god. - Matt. 19:3-11, 5:32; Luke 16:18; Mark 10:11; Rom. 7:1-3; Prov. 5:19-20; I Cor. 7:10-11; Mal. 2:14-17.

ARTICLE XV - RESURRECTION

We believe in the resurrection of all dead both just and unjust. - John 5:28-29.

The resurrection of the just to glory and immortality in the presence of God. - Matt. 25:34; Job. 19-26

And the unjust to everlasting shame and banishment from the presence of God. - Matt 25:31-32; Matt. 25:41; I Cor. 15:52; II Thes. 1:4-11; Rev. 20:14-15.

Church Covenant

We will everywhere hold Christian principles sacred and Christian obligations and enterprise supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling, that the Kingdom of God may come, and His will be done on earth as it is in Heaven.

To this end we agree to labor for the promotion of educational and denominational enterprise, the support of missions, the success of Sabbath schools, and evangelistic efforts for the salvation of souls and the conversion of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.
