

PROCEEDINGS.

The One Hundred and Sventy-Fourth Annual Session of the Central Conference of the Original Free Will Baptist of North Carolina, met with the church at Howell's Swamp, Green county, November 8, 1922. The introductory sermon was preached by Rev. R. F. Pittman from the subject of "The Possibilities of the Free Will Baptist Church."

The following was presented in memory of A. T. Dawson:

Bro. A. T. Dawson was born at Institute, Lenoir county, April 23, 1851, and died at Kinston November 5, 1921. He joined the church about 1870; was married to Trumella Nethercut, December 22, 1875; served as county commissioner of Lenoir county about eighteen years; was a member of the Board of Trustees of the Seminary and President of the Board for a number of years.

He was loyal to the church, the paper and the Orphanage, having contributed liberally to the support of each one. He never opposed any institution that had for its purposes the betterment of humanity. His life was an exemplary one. His honest conviction and fairness toward all issues which came to his knowledge was one of the many characteristic evidences of a broad Christian life.

Patient and strong under suffering, faithful to all duties, public and private, kind and human in his sympathy, a Christian in his thought for others, he has become a shining example for us to emulate.

His brave Christian spirit and abiding faith in his Savior will ever be an inspiration to those who knew him. May the memory of his life serve as an incentive to the high ideals and lofty aspirations which he ever kept in view.

Educational Report.

We, the Committee on Education, report our findings as follows:

That in 1919 our people seeing the great need of education and the great fields of service, initiated a program to build a college; that in 1920 the slump following the great world war hit our undertaking a serious blow; that there is an administration building now about two-fifths completed, and that at the present rate of the collection of funds, it will take longer to complete the building program than our people first anticipated. In view of the fact that the administration building has been under construction for two years, that we are so badly in need of a working educational institution, and believeing an educational institution to be the rock bottom of our denomination, we submit the following recommendations, which we believe will complete the administration building by next fall, and be to the best interest of our denomination, to-wit:

First That the campaign for the College and Orphanage be separated, and that all funds collected on notes and pledges in the future given on this campaign be used for the erection of the College building, and a campaign for that purpose continued.

Second. That we pledge our support to the orphans of our brethren, and assure the Orphanage Directors that we want to help equip our Orphanage so it will be second to none.


