INTRODUCTION

On May 20, 1960 seventeen representatives together with their pastors, met at the Capitol City Free Will Baptist Church in Little Rock, Arkansas. The representatives were from the following Free Will Baptist Churches; First Church of Pine Bluff, First Church of Hot Springs, First Church of North Little Rock, 18th Street Church of North Little Rock, and the Capitol City Church of Little Rock.

The purpose of the meeting was to discuss the possibilities of the organization of a New District Association to be composed of the above named churches.

Services was opened by singing led by Mr. Marshall Smith. Devotion was given by Rev. Raymond Patrick. Rev. William J. Mishler, was selected to serve as chairman of the group and Rev. Jimmy Bundy to serve as clerk.

After brief discussion as to the purpose, benefits, needs, etc., of a new association in the area, the thinking of the group appeared to center around two main objectives; first, this would open up to these churches a new stewardship challenge. Second, that because of the strategical location of these churches, the opportunities to establish new churches in the towns and cities of the area, could become a reality.

It seemed apparent from the very outset of the first meeting, that God through His Providence was leading the group along. New zeal was evedient on the part of everyone. It was apparent that God had led us to an open door. A door, through which, if we would by faith enter, would lead us into a much broader field of service, first to God, secondly to our local churches, and finally to every phase of our denominational work. This surely seemed to be the hour. After further discussion and prayer, it became evident that we were all of "one accord" in this place to begin, from here, our march through the door. This was begun by a motion "that the Pastors of each of the above named churches, together with a Deacon from each church, formulate a committee to draft a Constitution and By-laws" that would govern the activities of this new association. This Committee met June 1, 1960 at the Capitol City Church, and carried out the wishes of the group. Copies of the Constitution and By-laws were sent to each local church wishing to become a part of the New Association. These were unanimously adopted by four of the five churches that met in the first meeting.

September 17, 1960 will always be a red-letter date in the history of the Central Association of Free Will Baptist. This was the organizational date. This meeting was held at the Capitol City Church in Little Rock, Arkansas.

The Executive Board of the Arkansas State Association presided in the organization of the New Association. The members of the Board present were; Rev. Bob King, Mr. Millard Williams, Rev. Ray Watkins, and Rev. W. S. Isbell. Rev. Willard C. Day, State Promotional Secretary was also present. Rev. Bob King served as moderator, and Rev. Raymond Patrick was appointed clerk Pre-tem.

Petitionary letters were present from the following churches: First Church North Little Rock, Capitol City Church, Little Rock,

First Church, Hot Springs, and the First Church, Pine Bluff. These letters were read together with letters of dismissal from the various associations from which these churches were coming. All was declared by the Board to be in order.

The Rev. W. S. Isbell presented the "Treatise of the Faith and Practise of the National Association of Free Will Baptist to the group. The same was adopted by the group. The Bible was adopted by the group as their rule of faith and Practice.

The Preposed Constitution and By-laws were read and with a few minor changes were adopted by the group. And now, according to the statement in the adopted Constitution this group would, from now on be known as, "The Central Association of Free Will Baptists" affiliated with both the State and National Associations of Free Will Baptists. After adoption of the Constitution the right-hand of Christian fellowship was given by the counsel. The Rev. Ray Watkins, prayed the prayer of consecration. The Rev. Willard C. Day, brought the message at the eleven o'clock hour, using as his text Esther 4:14 — "and who knoweth whether thou art come to the kingdom for such a time as this?" The message was a real challenge to all present.

The following officers were elected to lead this new work: Rev. William J. Mishler, Moderator; Rev. Jimmy Bundy, Assistant Moderator; Rev. Alton Loveless, Clerk; and Mrs. Alton Loveless, Treasurer. Other committees were chosen, and members are named in the following records.

The first delegates to represent and carry the petitionary letter from the Central Association to the Arkansas State Association of Free Will Baptists were: Mrs. Alton Loveless, Mrs. William Mishler, Mrs. A. C. Cotton, and Mr. and Mrs. Oscar Walling. The Association was accepted into the State body. And so on September 29, 1960 the Central Association became an official member of the State and

National bodies.

There were two ideas born out of this new organization that were relative new to Free Will Baptist work in Arkansas. The first was, that through systematic giving on the part of the local church, God would bless her efforts because of her faithfulness in the stewardship of giving, and through this means the local church would be supporting all phases of the denominational work. Secondly, that it is more fesible to operate a Church Extension Program on the local level in cooperation with the State or National Program, rather than to leave it to the higher bodies alone.

Thus, was the humble beginning of the work of the Central Association of Free Will Baptists/A work that was destine to set a precedent in the State of Arkansas for other Free Will Baptist Churches and leaders who have a zeal to extend their stewardship vision.

Jan. 14, 1961—Be it resolved that we give \$100.00 to the Free

Will Baptist Bible College on the indebtedness of the New Alumni Building. Passed

April 7th and 8th, 1961—Be it resolved that we give \$36.06 to the college to make our offering total \$50.00. Passed

July 8th, 1961—Be it resolved that we make available to the State Treasure \$70.00 in the form of a loan for the purpose of paying the State dues to the National Association. Passed

EXECUTIVE BOARD REPORT

From Oct. 8th, 1960 to July 8th, 1961

Oct. 8th, 1960—Motion made and seconded to accept report and vote item by item.

1. We recommend the we pay the Association Clerk \$15.00 per quarter for his services. Passed.

2. We recommend that we pay the Associational Treasurer \$10.00 per quarter for his services. Passed.

3. We recommend that the League Board and Sunday School Board set their said conventions to meet semi-annually alternating their conventions each quarter. The time and place to be decided by said boards. The Associational clerk to inform said board concerned. Passed.

4. We recommend that the distribution of the 50% of the Cooperative funds retained in the Association and the percentages to each board be delayed until the organization of said boards are determined so that the percentage to each board can be better made. Passed.

5. We recommend that the quarterly meeting use the short forms with the church membership and the average attendance of all the Auxiliarys of the church, and that the Yearly Meeting use the long form with all information concerning the church be given. Passed.

6. We recommend that the Missions Board consider and study the proposal by Rev. Hurbert Rodgers concerning sponsoring a Chaplin in the State Sanitorium at Booneville. Passed.

January 14, 1961-----

1. We recommend that all Boards of the Association meet on Friday night April 7th, 1961 before the next District Conference in order that the boards can decide the amount of funds to be allocated to each said board. Passed.

2. We recommend that a meeting, the time to be decided by this convention, for the purpose of organizing a Ministers and Deacons Meeting. Passed.

3. We recommend that this Association place in the By-Laws in this Association's Constitution prohibiting the establishment of a mission, or church in a city, where we have an Orthodox church, doing such under our name without the fellowship and sponsorship of that church already located in the city or community. The Executive Board to prepare said constitutional change. Passed.

4. Bro. E. T. Taylor has been selected to fill vacancy on Sunday School. Board.

April 8, 1961

1. We recommend these allocations, after the 50% Co-operative is sent to the State Treasurer for our own District Association: This is for the 50% retained: General Fund 25%, Sunday School Board 2%, League Board 2%, Presbytery Board 2%, Missions Board 69%. These totals are figured on the 50% retainment becoming the usual figuring per cent basis of 100%. Passed. July 8. 1961

Annual Report—We the Executive Board of the Central Association met July 6, 1961 at the Capitol City Free Will Baptist Church. Items of Business:

1. (Amendments) This constitution may be amended or alternated at any regular (Yearly Session) of this association by a two-thirds vote of members present, provided amendments or alterations be placed on the table no later than 11:00 on the session day, and to be taken up no earlier than 2:00 P.M. on the same day.

2. Proposed amendments to Article IX Sec. #3.

The Sunday School and League Boards shall work in co-operation with the State and National Boards. They shall assist the churches of this Association in the teaching and training programs, workshops, of the Sunday School, and Leagues. These boards shall sponsor conventions as they deem advisable.

3. Proposed Addition to Article IX Sec. #1.

1b—The Missions board shall not participate in the organization of any church, or mission that is being organized in a town, city or community where there is an organized Free Will Baptist Church, without first seeking the cooperation of said church. Neither shall their board participate in the organization of a group that is out of fellowship with established church.

April 8, 1961

The Presbytery Board met at the First Church of Hot Springs to ordain Bro. Oscar Walling to the ministry, on Jan. 22, 1961. The Rev. R. A. Patrick, Rev. Jimmy Bundy, Rev. Alton Loveless, Deacon M. E. Westerman and Rev. Jimmy Richardson were the Ordaining cancel Rev. Richardson brought the message and Rev. Loveless the Presbytery clerk administered the charge. Passed.

July 8, 1961—Annual Meeting

In comply to the request of the Hot Springs and Capitol City Free Will Baptist Churches, the Presbytery Board met for the purpose of ordaining two men to the Ministry. Both met qualification and were ordained at local churches. Bro. Cecil Rushing was examined Oct. 8, 1960 at the First F.W.B. Church of Hot Springs and found worthy of the Boards recommendations. He was ordained at Capitol City Church Oct. 19, 1960. Rev. Alton Loveless led the charge. The ordaining counsel consisted of Rev. Loveless, Rev. Patrick, Rev. Geo. Rollen and Deacon Archie Henderson, all in good standing as Free Will Baptists. Bro. Oscar Walling was examined orally Oct. 29, 1960 and Nov. 29, 1960 and completed his written examination on Jan. 6, 1961. The Board met on Jan. 22, 1961 and conducted the ordination service. The ordaining service was at 3:30 P.M. at the First Church of Hot Springs. The Rev. Jimmy Richardson spoke as the ordaining speaker. The ordaining counsel consisted of Rev. Jimmy Richardson and Deacon M. E. Westerman. All in good standing as Free Will Baptist. Bro. Loveless, Secretary of Presbytery Board administered the Charge.

The Presbytery Board met (4) four times during the year for business purposes. They introduced the Questionnaires for Ordination of Ministers and Lecentiate. Both were accepted at Quarterly Conference No. 3 (January 14, 1961) at Pine Bluff, Ark.

The Missions Board was formed Oct. 8, 1960 by the acceptance of the nominating Committees report recommending the following to serve on the board: Bro. Aldrich Tygart, Rev. Raymond Patrick, Bro. Oscar Walling, Bro. Howard Trent, Bro. Verl Pinkerton. April 8, 1961

We recommend that the Association place a Missionary on the fields as soon as possible and the Missions Board be responsible for the selection of such man. Passed

Mishler will conduct a workshop on "Evangelism in the Sunday School." The Capitol City and North Little Rock Churches will give programs. Rev. W. C. Day will be the evening speaker on "Importance of Evangelism in Sunday School." Bro. Eugene Small, Bro. Harlon Sory and Sis. Alton Loveless will also conduct workshops for the various age group problems in the Sunday School. Passed. MISSIONS BOARD

Report from Oct. 14, 1961 to July 21, 1962

Oct. 14, 1961 - Bro. Lowell Tanner was nominated to replace Bro. Howard Trent for a five year term and Bro. John Small to replace Bro. Pinkerton for a four year term.

Jan. 13, 1962 - The Mission Board met in Hot Springs Oct. 29, 1961 at which time an allociation of seventy-five (75.00) dollars was made to the Mission Church in Jacksonville with the recommendation that they make a payment on a piano. Ten (10.00) dollars of this amount was used to pay for a sign for the mission and sixty-five (65. 00) on the Piano. Bro. John Small, Bro. Lowell Tanner, and Bro. Raymond Patrick participated in the organization of the church on Jan. 7th, 1962. Accepted.

April 14, 1962 - Having been blessed by the Lord as we have in the terms of financial support from our sister churches, we the Missions Board recommend that we give financial assistance to each of our Mission Churches at Jacksonville and Benton, to purchase property suitable to each body. The assistance shall be in the form of an outright gift in the amount up to five hundred (500.00) dollars, provided a promise from each body taking advantage of gift is made, at such time the said body will leagally relinguish through it's board and trustees, it's rights to titles to the property so that the Central Association of Free Will Baptist, may salvage what it can from the adventure. Accepted.

LEAGUE BOARD

Oct. 14, 1961 - We recommend that Bro. Richard Harrison replace Bro. Jimmy Richardson for a five year term. Passed.

RESOLUTION COMMITTEE

From Oct. 14, 1961 to July 21, 1962

Oct. 14, 1961 - Be it resolved that the Central Association go on record in that we indorse the action of the State Concerning Congregational form of government of our church, be it further resolved that we re-affirm our Doctrinal, and Church Practices as stated in our National Treaties. Passed.

July 21, 1962 - A motion made and second that article six in the constitution and by-laws be changed. A motion was made and seconded that the following ammendment be attached. The allocations of this money be made through a budget committee to this body at each yearly meeting. Passed. Article six read as follows:

FINANCE: This Association shall receive its support from a designated percentage of the Cooperative receipts that come from the churches composing this body. The remaining percentage shall be sent to the State Promotional office for State and National Programs. This Association recommends that each church belonging to said body give One-tenth (10%) of its tithes and offerings to this body for its support and the support of the State and National Programs. The allocations of this money be made through a budget committee to this body at each yearly meeting. Passed. Delegates elected to go to the State Meeting Oct. 3, 4, 5. Sis. Miley Ashbrook, Benton - Sis. Ruby Henderson, Capitol City - Sis. Mary Isbell, North Little Rock - Sis. Orville Johnson, Jacksonville - Bro. Frank DuValle, Russellville - Sis. William Mishler, Pine Bluff - Sis. John Small, Hot Springs. A motion and second that the first five of these serve as delegates and the last two as alternates. Passed.

Auditing Committee: Bro. Ashbrook, Bro. Charles Richen, Sis. Joan Ewing.

A letter of resignation was read from Bro. Glenn Campbell.

A motion and second that we accept Bro. Campbell's resignation.

NOMINATING COMMITTEE

We your nominating committee submit the following recommendations:

Bro. Thurston Taylor be re-elected to the Executive Board.

Bro Jimmy Bundy be re-elected to the Presbytery Board -5 years

Mrs. Morris Westerman be re-elected to the Sunday School Board - 5 years

Bro. Delbert Hughes be re-elected to the League Board - 5 years Bro. A. C. Tygart be re-elected to the Mission Board - 5 years

Bro. Laymon Johnson be elected to replace Bro. Glenn Campbell on the Execuitve Board - 3 years.

Bro. and Sis. Cotton did not wish to continue serving as Treasurer and Clerk. Bro. Harlon Sory was elected Treasurer, Bro. Staggs as Asst., Sis. Jean Sory was elected Clerk.

A motion was made and seconded that we accept the report for the balance of the officers as requested. Passed.

Motion was made and seconded that the Executive Board with the officers of the Association check into the possibilities of getting the minutes printed in book form. Passed.

Report of the Auditing Committee

We, the Auditing Committee find the Treasurer's books in good order. The report was received as read.

CONSTITUTION Of The CENTRAL ASSOCIATION Of FREE WILL BAPTIST Of The STATE OF ARKANSAS

PREAMBLE: From long experience, we the members of the Free Will Baptist Churches of this district, having been baptized by immersion upon profession of our faith in Christ as Saviour and Lord, and realizing the necessity of a bond of union and fellowship among our churches do, for the purpose of co-ordinating our efforts for the extension of the kingdom of God, ordain this constitution and its affixed By-Laws for the betterment of our Associational Government.

ARTICLE I

NAME: This organization shall be called the "Central Association of Free Will Baptist", affiliated with the State Association of Free Will Baptist of Arkansas, which is a member of the National Association of Free Will Baptist, with headquarters in Nashville, Tennessee.

ARTICLE II

PURPOSE: The object and purpose of this Organization shall be to unify the work of its various boards and churches composing this Association and to devise and execute measures for the extension of the Gospel of Christ in connection with the various boards, auxiliaries and churches; or those that may hereafter be represented therein.

ARTICLE III

COMPOSITION: This Association shall be composed of such well regulated Free Will Baptist Churches as subscribed (agree) with the doctrine and practices as stipulated in the Treaties of the Faith and Practices of Free Will Baptist, (favoring the various enterprised as endorsed by the State Association and denomination proper) by its General Officers, Standing Boards; the duly appointed delegates of the local Churches, all Ordained Ministers, Deacons and Church Clerks who are in good standing with their local Churches.

ARTICLE IV

REPRESENTATION: Section 1. Each local church shall be represented by delegates elected as follows: Three (3) delegates for the first fifty (50) members or fraction thereof, and one (1) delegate for each subsequent twenty-five (25) members or fraction thereof, not to exceed seven (7) elected delegates. A letter from each church shall accompany said delegates as requested by this body.

Section 2: In event only part of the elected delegation is present from a church, they together may in consultation with their pastor fill said vacancies with other members who are present from said church. Said delegates to be approved by this body.

Section 3: New churches desiring membership in this body shall send delegates bearing a petitionary letter. Churches coming from another association, quarterly meeting or denomination shall send delegates, bearing a petitionary letter, together with a letter of recommendation from said body they are leaving. If the above churches, upon examination by the Credential Committee are found to be properly organized and willing to adhere to the Faith and Practices of Free Will Baptists as specified in the Treatise, they shall by vote of this body be received into full fellowship.

ARTICLE V

DISCIPLINE: This Association shall act only in an advisory capacity. Should there arise in the local Church any question on doctrine, practice or discipline, the Bible and the Treatise of the Faith and Practices of Free Will Baptists shall be considered the final authority. This body, when in session, may by majority vote of members present, withdraw the hand of fellowship from said church or churches until such a time they have set their house in order. (The above statements shall also apply to individual members belonging to said body.)

ARTICLE VI

FINANCE: This Association shall receive its support from a designated percentage of the Co-operative receipts that come from the churches composing said body. The remaining percentage shall be sent to the State Promotional Office for State and National Programs. This Association recommends that each church belonging to said body gives one-tenth (10%) of its tithes and offerings to this body for its support and the support of the State and National Programs. The allocation of this money be made through a budget committee to this body at each yearly meeting.

ARTICLE VII

OFFICERS: Section 1. The officers of this Association shall be a Moderator, Assistant Moderator, Clerk, Assistant Clerk and Treasurer. These officers shall be elected annually on the last day of the Association, at the close of the business period. These officers shall also serve for each quarterly meeting of the Association.

ARTICLE VIII

BOARDS AND COMMITTEES: The Standing Boards of this Association shall be: The Executive Board, and the Presbytery Board. The District Women's Auxiliary Convention shall be considered Auxiliaries of this Body. Each of the above named boards and auxiliaries are requested to report to the Yearly meeting of this Association. The Credential Committee, as well as other committees deemed necessary, shall be appointed by the Moderator, or by the body if it so desires. All Standing Boards shall be composed of five (5) members who shall serve terms of 5,4,3,2,1 year.

ARTICLE IX

DUTIES AND RULES OF BOARDS: All Board and Committees are to organize when elected or appointed, at the beginning of each associational year. They shall have a Chairman, Assistant Chairman, Secretary, and Treasurer when funds are entrusted to a board. Each board or committee shall keep a written report of each meeting, the receiving and disbursement of its funds, etc., and shall make a written report to this body of its work done during the year, or as requested by the body. Each standing board shall have its own by-laws which shall govern its activities, only when otherwise stated by this constitution. All by-laws are to conform to the principles and tenets of this association.

Section 1A: The Executive Board is delegated the power to act in behalf of and for the Central Association or its quarterly meetings, when either of these bodies are not in session. It shall have power to fill vacancies that may occur on any of these Standing

Boards or offices of the Association or quarterly meeting. This Board shall be responsible for all legal matters that might claim the properties that belong to or have been purchased by said body, attention of this body. It shall hold in trust and supervise all unless otherwise ordered by the body.

Section 1B: The Mission Board shall not participate in the organization of any church or mission that is being organized in a town, city or community where there is an organized Free Will Baptist Church without first seeking the cooperation of said church, neither shall their board participate in the organization of a group that is out of fellowship with an established church.

Section 2: Missions Board: It shall be the duty of this board to work in conjunction with the State and National Home and Foreign Missions Board in arranging an active Missionary Program. The activities of this board shall be governed by its By-laws and approved by this body, and shall be answerable to this body for all of its activities.

Section 3: The Sunday School and C.T.S. Boards shall work in cooperation with the State and National Boards. They shall assist the churches of their Association in the teaching and training programs, workshops, and in recommending methods of the Sunday Schools and Leagues. These boards shall sponsor conventions as they deem advisable.

Section 4: It shall be the duty of the Presbytery Board to examine all candidates (Ministers and Deacons) at the request of the local church. Such candidates shall be members in good standing with the local church (Having been a Christian for at least two (2) years. All licensed Ministers seeking ordination shall be given a written examination Questionnaire to be furnished by this board. Ministers coming from other states, Associations, or Denominations shall be examined by this board at the request of the local church. Deacons shall be examined according to the Scripture and Practice of Free Will Baptist. (See Treatise) No prospective Minister or Deacon shall be ordained by Association who have been divorced or does not practice and teach tithing.

ARTICLE X

MEETINGS: This Association shall meet annually at such time and place as shall be decided upon by said body. It shall also meet in regular quarterly meetings and at such quarterly meetings shall have power to transact business for the Association. With the exception of changing the Constitution, setting up new boards or electing of board members to standing boards. The quarterly meeting shall meet on the Second Saturday of the first month in each calendar quarter. (The meeting date preceding the Arkansas State Association shall be the yearly meeting date.) Place of meeting to be chosen as that of Association.

ARTICLE XI

RULES FOR CONDUCTING BUSINESS: Robert's Rules of order shall be used as a guide in all business transactions, parliamentary usage, etc.

ARTICLE XII

AMENDMENTS: The constitution may be amended or altered at any regular (yearly) session of this Association by a two-thirds vote of members present, provided amendments or alterations be presented in writing with proposed change or alterations to be placed on the table no later than eleven (11:00) A.M. on session day and to be taken up no earlier than two (2:00) P.M. on the same day.

PROPOSED BY-LAWS

(Can be used as Decorum)

- 1. The Clerk or assistant Clerk or in their absence, the Senior Minister in years shall call the Association or quarterly meeting into conference and if a quorum is present the Moderator, or in his absence the Assistant Moderator shall take charge and if neither of them is present the Senior Minister in years of service shall act as Moderator.
- 2. Each meeting shall be opened by reading a portion of the Bible and with Prayer, and shall be closed with Prayer.
- 3. It shall be the duty of the clerk to enroll the delegates to the Association, who shall present themselves with proper credentials of their rights to be seated therein. Those enrolled by the clerk shall, with the other Boards and Members mentioned in the Constitution, compose the Association and quarterly meeting. Should there be questionable representation the case shall be referred to the credential committee.
- 4. It shall be the duty of each church, Minister, Board, Committee, Auxiliary and Quarterly Meeting to report their work and statistics by letter or prepared form, to the annual session of this Association. (Ministerial Report Blanks and yearly and quarterly report blanks to be prepared according to wishes of this body).
- 5. This Association and quarterly meeting may correspond by messenger or otherwise with other religious bodies.
- 6. This Association shall sit with open doors except when it shall go into a committee as a whole.
- 7. Any person not a member of this Association may be invited to a seat as advisory council and by permission from Moderator, speak. But in no case shall he, or they, be allowed to vote.
- 8. It shall be the duty of all members of this Association and quarterly meeting to be present at the time appointed for each meeting and worship service. Anyone wishing to retire shall first obtain leave from the Moderator.
- 9. No person shall be allowed to nominate more than one member of any Board, Committee or office, provided the person nominated be elected.
- 10. The Moderator shall not allow discussions when not carried on in a Christian Spirit, or when he thinks it will cause discord or cast reflection upon another person.
- 11. Anyone desiring to speak shall rise to his feet and address the Moderator by the appellation "Brother Moderator", and shall not speak further until recognized by the Moderator.
