# REPORT OF THE ORDAINING COUNCIL (November 9, 1977)

The Ordaining Council of the Central Conference has had six meetings since the last session of the Conference.

During these sessions, the following actions have been taken and await the approval of the Conference.

On April 12, 1977, the Ordaining Council met at the Press. Ray Williamson from the Ormondsville Free Will Baptist Church presented himself for examination for license. The council voted to recommend that his church grant him license for one year.

The secretary was instructed to write to the Rev. Bruce Dudley and ask for a letter of transfer from the Eastern Conference to the Central Conference for the Rev. David C. Hansley. The letter has been received from the Eastern Conference.

By motion it was decided to ask all ministers to sign a Code of Ethics and that two copies be given to each minister and the minister send one signed copy to the secretary of the Ordaining Council.

On April 25, 1977, the Ordaining Council met at the Press. The purpose of the meeting was to give Ronald Dale Albertson an examination for ordination. By motion it was decided to ordain Dale at the Daniel's Chapel church on Sunday, May 15.

On July 25, the Council met at Parker's Barbecue in Greenville. Ronnie Hobgood from the Ayden Free Will Baptist Church came seeking license to preach. After examination by the council it was decided to ask the Ayden church to grant him license to preach for one year.

Mike Harrell of the Peace Free Will Baptist Church, Pinetops, North Carolina, came before the Council seeking a license to preach. It was decided to ask the Peace church to grant Harrell a license to preach for one year.

A letter of transfer was granted by the Council for the Rev. Paul Montgomery to the New Liberty General Presbytery in Maldon, Missouri.

At a meeting on September 12, the Council granted the Rev. R. P. Harris a letter of dismissal based on his request, made by letter. He is working with a national church in Rocky Mount.

Motion passed that a list of things the licensed minister can and cannot do be made up and given to each candidate at time of examination.

On September 26, 1977, the Rev. Wiley Lewis was called in for some explanation concerning his standing in the Central Conference. A motion was made that he clear himself with the Eastern Conference or he would be declared out of order in the Central Conference.

November 8, 1977, the Ordaining Council met at the Press. A motion was made that Wiley Lewis be declared not in good standing with the Central Conference based on information received from the Eastern Conference.

By motion the Council requested Franklin Robbins to study for six more months and re-appear before the council for ordination examination.

By motion it was decided to ordain Rex Edwards of Elm City as soon as possible after the Conference on November 9.

Charles H. Lacher from Otter's Creek Free Will Baptist Church was examined for license. By motion it was decided to ask Otter's Creek church to grant him a license to preach.

By motion the Ordaining Council recommends that the Central Conference adopt the Ordination Procedures and Requirements presented with this report.

The Rev. Ronald Dale Albertson and the Rev. Keith Cobb have transferred to the Western Conference.

The Rev. Larry Barbour is a member of the Western Conference and we recommend that his name be dropped from the list of Central Conference ministers.

The Rev. Sheldon Howard has transferred to the Eastern Conference.

The Council recommends that the name of Rex Edwards appear in the list of Ordained Ministers in the new yearbook, provided he is ordained before date of publication.

The Ordaining Council met at the Hugo Free Will Baptist Church on the day of the Conference.

It was called to the attention of the Council that the license of Wayne Griffin had been allowed to lapse. By action of the Council his name will be dropped from the list of licensed ministers.

The Rev. Bobby Futrell of the Winterville Free Will Baptist Church appeared before the council seeking membership in the Central Conference. By

vote of the Council he was received, pending a letter from the Western Conference.

The Rev. Jerry Rowe, pastor of Gum Swamp church, appeared before the Council seeking transfer from the Eastern Conference to the Central. By vote of the Council he was received, pending a letter from the Eastern Conference.

# CENTRAL CONFERENCE ORDINATION PROCEDURES AND REQUIREMENTS

#### I. REQUIREMENTS FOR THE MINISTRY:

- A. License Standards:
- 1. The candidate must possess or attain a high school education or its equivalent prior to licensing.
- 2. The candidate must serve one year as a licensed minister under the direction of his conference ordaining board or an ordained minister approved by the said ordaining board, (this does not affect those now licensed).
- 3. A candidate shall be allowed a maximum period of five years as a licentiate. If the licentiate fails to qualify for ordination within five years, his license shall be terminated. However, after a period of one year he may request to be examined for license.
- 4. The candidate shall be required to inform the secretary of the Board of Ordination before each convening conference, giving dates of issue and renewal of his license. Be advised that the license and renewal must be validated by the signature of the church clerk.
  - B. Ordination Standards:
- 1. Two years of college work, or the equivalent thereof, with an overall "C" grade average (64 semester hours or 96 quarter hours; 18 semester hours or 28 quarter hours are to be in Professional Preparation for the Ministry).
- a. Equivalency must give a candidate a thorough knowledge concerning the faith and practice of Free Will Baptists, their history and church government.
- b. The candidate for ordination should be thoroughly questioned in regards to irregularities in his sex life.
- c. A very solemn promise in writing shall be required of candidates for ordination to relinquish their credentials voluntarily when they feel they can no longer be loyal to our denomination, our doctrines, or our denominational enterprises and institutions.

- d. The two years college work requirement may, at the discretion of the ordaining council, be waived for those who are 35 years of age or older.
  - 2. The Ordination Examination:
    - a. The ordination examination shall deal with the following areas:
- (1) Homiletics, (2) History of the Free Will Baptist Church, (3) Theology (Doctrine), (4) The Church and its Ordinances, and (5) The Scripture.
  - 1. Ministerial Ethics:
- a. Candidates will be required to agree, in writing, to the Ministerial Code of Ethics.
- b. Failure to agree to this reasonable standard of ethics will disqualify the candidate for ordination.

#### II. CONFERENCE RELATIONSHIPS:

- A. If any minister is not in good standing with any conference, the other conference should be notified by communication in writing through the ordaining councils.
- B. We request our churches to call pastors from a list of duly ordained Original Free Will Baptist ministers subject to approval of their own conference ordaining council (this list can be obtained from the Yearbook). It shall be the responsibility of the Church and minister to see that the pastor is an approved minister where the church is located.
- C. For the transfer of ministers from conference to conference, refer to Page 48, paragraph number 2 of *The Statement of Faith and Discipline*.
- D. Ministers who fail to represent at the conference by letter or in person for 3 consecutive years will have their names dropped from the Roll of Ministers; and be required to turn over their credentials to the secretary of the Ordaining Council.

#### III. MINISTERS TRANSFERRING FROM ANOTHER DENOMINATION:

- A. They must join an Original Free Will Baptist Church of the Central Conference and receive a letter of recommendation from them.
- B. Unless a good reason can be shown, the candidate must secure a letter of transfer and recommendation from the previous denomination.
- C. The minister shall be questioned and shall meet the same requirements as would one of our own licensed ministers who is examined for ordination.
  - . D. New credentials should be given to the candidate.

#### IV. THE DOCTRINE OF SANCTIFICATION:

- A. We reaffirm the historical position of Free Will Baptists and endorse the statement on Sanctification as stated on Page 30 of *The Statement of Faith and Discipline*.
- B. This does not include a Second or Third Definite Work of Grace apart from or superior to the salvation experience or spiritual growth of the Christian.
