Proceedings

The Central Conference, being the continuation of the General Conference of Original Free Will Baptists of North Carolina, convened in its 254th annual session with the Rose Hill Free Will Baptist Church of Winterville, North Carolina, on Thursday, November 7, 2002, at 9:30 am.

The Conference opened with the hymn, "To God Be The Glory." Opening scripture and prayer were offered by Mr. Doug Tyson.

The Reverend Franklin Baggett, clerk, called the 254th annual session to order. The Reverend Leon Harris from the host church extended a cordial welcome to the Conference.

The Reverend Ray Williamson, moderator, gave a challenging address from 1 Corinthians 15:58. The main point of the address was to stand fast. We are to stand fast and not compromise with the world. The message of Jesus Christ must be kept constant. As Free Will Baptists we need to make sure that we are standing in the right place. God wants us to be completely faithful. God will give us direction and purpose if we seek Him. After knowing that direction and purpose we need to follow it. God requires our obedience. Our obedience is essential to our Christian walk. We must stand fast.

The roll of churches was called with thirty-six churches responding with delegates.

Fourteen visitors were recognized and welcomed by the moderator.

The Moderator appointed temporary committees as follows:

Parliamentarian: Reverend Stanley Buck; Resolutions: Reverend Grady Tucker, Reverend Roger Hathcock and Irvin Mizelle;

Nominating Committee: Reverend Ronnie Hobgood, Reverend Philip Wood and Reverend Kevin Jackson

The report of the Executive Committee was read by the clerk. By motion, the report was adopted. [see Reports]

By motion, the proposed constitutional changes were laid on the table.

The report of the Board of Ordination was read by Reverend C.H. Overman. By motion, the report was adopted. [see Reports]

The Reverend Ray Williamson, moderator, along with the Conference extended a welcome to membership in the conference to Reverend Charlie Carroll, Reverend Woodrow Freeze, and Reverend Phillip Boykin. The Conference also extended the right hand of fellowship to Tony Parrish, Mr. Jay Tripp, Mr. Kelly Smart, Mr. Charles Russell, Mr. Charles Sutton and Mr. Doug Tyson.

The Constitutional changes were read by the clerk.

At 10:25 a.m. the Conference business was set aside for the worship service. The service was opened with scripture reading from Hebrews 2:1-3, and the prayer of invocation was given by Reverend Joey Williams. The Reverend Ray Williamson led the congregation in the singing of "How Great Thou Art" followed by the offering for the conference and the offertory prayer by Reverend Walter Reynolds. Special Music was presented by Rick Langley, Charlie Langley and Becky Miller. The Reverend C.H. Overman preached the conference sermon entitled "Meeting the Conditions for Service and Loyalty." His text came from Philippians 3:14. The main emphasis and challenge of this message was that we need to make ourselves available to serve the Lord. The Reverend Overman pointed out four conditions for service. 1. Each person must have had a spiritual encounter with the Trinity. 2. Each person must make a commitment. 3. Each person needs to understand they are part of a journey. 4. We need to strive to have the best outcome possible.

The worship service concluded with the singing of "I Surrender All."

The service closed in prayer by Reverend Carroll Bradbury.

The business session continued at 11:20.

The Conference recessed for the noon meal at 12:05 with a prayer by Reverend Kevin Jackson.

The Reverend Joey Williams gave the report of the Continuing Education Committee. By motion, the report was adopted. [see Reports]

The Reverend Tony Glass gave the report of the Church Growth Committee. By motion, the report was adopted. [see Reports]

The roll of ministers was called with forty-two ministers responding present.

By motion, the Constitutional changes were removed from the table.

By motion, the Constitutional change for Article IV section 12 was adopted. [see Executive Committee reports for constitutional changes]

By motion, the Constitutional change for Article IV section 2 was adopted. [see Executive Committee reports for constitutional changes]

By motion, the Constitutional change for Article X section 9 was adopted. [see Executive Committee reports for constitutional changes]

By motion, the Constitutional change for Article IV section 5 was adopted. [see Executive Committee reports for constitutional changes]

By motion, the Constitutional change for Article X section 12 was adopted. [see Executive Committee reports for constitutional changes]

By motion, the Constitutional change for Bylaws section 9 was adopted. [see Executive Committee reports for constitutional changes]

The Reverend Ronnie Hobgood gave the report of the Nominating Committee. By motion, the report was adopted. [see Reports]

The floor was opened for other nominations. There were no other nominations.

By motion, the nominations ceased, and the nominees were elected by acclamation.

The Reverend Roger Haithcock gave the report of the Resolution Committee. By motion, the report was adopted. [see Reports]

The moderator called for miscellaneous business. There was no miscellaneous business.

Bylaws section 9 shall read: The minutes of the conference shall be approved by the Executive Committee before publication.

It was decided that the clerk should send letters to the churches and ministers at the end of September to remind them of the Central Conference in November.

The next Executive Committee meeting will be held on October 1st at the Peace Free Will Baptist church near Pinetops beginning at 4:00.

The meeting was adjourned with prayer by Reverend Joey Williams.

October 1, 2002

Constitution Changes

To change the wording in article VI from North Carolina State Convention to the Convention of Original Free Will Baptists.

Article IV section 12 to read: A board of trustees consisting of three members shall be elected. The term of office for members of this board shall be three years but shall be adjusted to terminate the office of one member annually.

Article IV section 2: A board of trustees, a board of ordination, and a board of finance, consisting of five members each shall be elected. The term of office for members of this board shall be five years but shall be adjusted to terminate the office of one member annually.

Article IV section 2 to read: A board of ordination, consisting of five members shall be elected. The term of office for members of this board shall be five years but shall be adjusted to terminate the office of one member annually.

Delete Article X section 9 which reads: It shall be the duty of the board of finance to check and verify all money to be received by the treasurer; they shall make recommended allocations and report same to the conference.

Article IV section 5: A credentials committee and an obituary committee, consisting of three members each, shall be elected. The term of office for members shall be three years but shall be so adjusted as to terminate the office of one member annually.

Article IV section 5 to read: A credentials committee and a memorial committee, consisting of three members each, shall be elected. The term of office for members shall be three years but shall be so adjusted as to terminate the office of one member annually.

Article X section 12: It shall be the duty of the obituary committee to prepare suitable memorial services for all ministers who die during the year preceding the conference and to present to the conference a suitable obituary for publication in the conference minutes and in the Free Will Baptist. Copies of the obituary are to be presented to the family of the deceased and to his local church.

Article X section 12 to read: It shall be the duty of the Memorial Committee to prepare and present a memorial service for all ministers who die during the year preceding the Conference. The Memorial Committee shall prepare a brief biographical sketch for the Historical Collection.

Bylaws section 9 shall read: The minutes of the conference shall be approved by the Executive Committee before publication.

Report of the Continuing Education Committee

The Continuing Education Committee of the Central Conference of the Original Free Will Baptist denomination met once this year on January 21, 2002 at the First Free Will Baptist Church of Greenville.

The committee endorsed a seminar, which was held at the La Grange Free Will Baptist Church. The seminar was entitled "User Friendly Church" and was a success. We would like to express thanks to the La Grange Free Will Baptist Church and their pastor, Reverend Brad Williamson, for all the work they did to make this seminar a success.

The committee also planned a new book reading program for 2002. This program would encourage each minister to read a specific book each quarter and then come together for a time of discussion. The committee planned the first session for April 16, 2002 at the First Free Will Baptist Church of Greenville. The book chosen for review was the "21 Irrefutable Laws of Leadership" by John Maxwell. The review session was cancelled however for lack of participation.

Church Growth Committee Report to the 2002 Central Conference

At the Central Conference Meeting on November 9, 2001, the Central Conference formed the Church Growth Committee. As stated by the Conference the purpose of the Church Growth Committee is, "to promote and provide financial support for church growth and/or leadership development. Through the work of the committee, Central Conference Churches will be more fully equipped to effectively reach people without Christ in their communities."

Since this was a new program in our conference, each Church Clerk and each Pastor were mailed letters of intent, which outlined the Church Growth program, and an application. All one had to do was fill out an application giving a brief explanation of how the funds would be used in their church for Church Growth and/or Church Leadership training and a total cost estimate of the project. We also provided information in the Conference Newsletter.

Last year we were able to assist five churches as follows:

 A church hosted a "User Friendly Church Seminar" which not only benefited the host church but other churches in the community. The Church Growth Committee gave \$100.00 toward this project.

- 2) A church distributed 300 booklets titled, "He Did This For You", written by Max Lucado as an outreach event. The Church Growth Committee approved payment of the total cost of the booklets, which was \$447.00.
- 3) A church canvassed every home within 2 miles placing a Bible, Jesus Video, Gospel coloring book, Roman Road to Salvation and area church information in each home. They requested \$500.00 to purchase Bible, which the Church Growth Committee approved.
- 4) A church purchased 192 "He Did This Just For You" New Testaments and outreach literature for their "Ten For Him" program. Volunteers were trained to canvas the community. The total cost of the project was \$553.00 of which the Church Growth Committee paid \$500.00.
- 5) A church canvassed their community with New Testaments, tracts, pens, note pads, coloring books and crayons, church information, and Jesus Videos. They requested \$480.00 to purchase 96 Jesus Videos, which the Church Growth Committee approved.

Last year we were budgeted with \$5,000. We distributed \$2,027.00 among the five churches who sent in completed applications. We respectfully request the same funding of \$5,100.00 for this year. It is our prayer that more churches will take advantage of this opportunity to receive funding to assist them in church growth.
