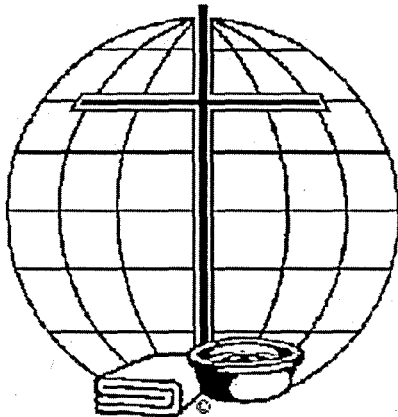

Proceedings

Preliminary Gathering

The host church provided space for our denominational ministries to set up displays and to have ministry representatives available to meet and greet Conference attendees from 3:30 to 5:00 pm.

Opening Session

The Central Conference, being the continuation of the General Conference of Original Free Will Baptists of North Carolina, convening its 265th Annual Session at Winterville OFWB Church on Thursday, November 7, 2013 at 5:00 p.m.

The service began with the congregation singing, "There Shall Be Showers of Blessing."

Mr. Adam Tyndall read scripture and led in prayer.

The Reverend Mark Hobbs, clerk, called the 265rd Annual Session to order. The host church extended words of welcome to the Conference.

Visitors were recognized by the moderator.

The Reverend Bryant Hines gave the moderator's message emphasizing Joshua and Caleb with their witness of faithfulness and obedience to God without fear of failure. They trusted God to lead them and their people into the future and as a conference we ought to remember and do likewise.

Reverends Charles Russell and Ray Williamson conducted our Memorial Service. The Reverend Earl Glenn was remembered for his dedicated service to the Lord.

The Conference offering was received.

New Jerusalem provided inspiring music.

The moderator appointed the temporary committees needed to conduct our Conference.

Central

The clerk read the two proposed constitutional changes, [See Reports] and reported the Executive Committee had met six times during the year and the minutes were printed in the Conference Report Book on pages 2 through 9.

The Reverend Dr. Frankie Baggett gave the Conference Ordaining Board report.

The Rev. Dr. Brad Williamson provided the treasurer's report.

The Woman's Auxiliary Report was shared.

Newly licensed and ordained ministers were recognized.

Our supper was blessed and we were dismissed to eat and fellowship.

Evening Session

The evening session was called to order at 7:00 p.m.

The session opened with the singing of, "Victory in Jesus."

The business session included the second reading of the proposed constitutional change.

The Conference accepted the constitutional change that establishes a Ministry Care Committee for the Conference.

The moderator presented certificates of service to Central Conference ministers for their dedicated service to the Lord.

The Credentials Committee reported a registered attendance of 47 ordained Central Conference ministers, 8 visiting ordained ministers, 7 licensed ministers, 57 delegates and 6 visitors for a total of 125 physically registered at the Conference.

The Reverend Kevin Jackson provided the Nominating Committee report. The Conference accepted the report and elected the nominees provided by the committee.

The Reverend Greg Barnes presented the Resolutions Committee report.

The business session ended and the worship celebration began with a period of praise and worship music led by Allen Moye followed by New Jerusalem sharing music of praise. Linda Weathersby led the Conference Celebration Choir in a time of worship music.

The Rev. Barry Williamson introduced our Conference speaker, the Rev. Al Warrick, Pastor of the Micro Free Will Baptist Church. Pastor Warrick shared his story of how reaching out to others in the name of Christ Jesus can and will change the lives of the individuals reaching out, the local church, as well as the individuals to whom the outreach is directed. After the message, the Rev. Kelley Smart led in a time of prayer and focus as the Conference celebrated Holy Communion.

The Conference ended upon the conclusion of the service of Holy Communion. The Conference plans to reconvene on November 6, 2014 at Elm Grove Original Free Will Baptist Church, Ayden, North Carolina.

The Board of Ordination sent a letter on 21 Jan 2013 requesting a joint meeting with the Executive Committee. Mark will contact the Board with suggested dates of 12, 19 or 26 Feb 2013 with the location at La Grange.

Brad was authorized to purchase financial software to modernize his ability to function as treasurer. Mark was authorized to purchase a stand-alone hard drive to back up conference records. The Ordination Board was authorized funds to pay for food and supplies for the day of training set by the Ordaining Board to train all licensed ministers on 23 Feb at Elm Grove Church.

Brad was authorized to set up a "Drop box" account for the team to use.

Kelley informed us the correct date for the 2013 Conference at Winterville will be 7 Nov 2013.

Bryant inspired us with his vision for ways we could help our Conference gain vitality.

Our next meeting is set for 18 April at 0930 at Free Union Church.

Kelley dismissed us in prayer.

We met with the Central Conference Board of Ordination for fellowship and to discuss an issue of concern.

Several Central Conference churches have called and hired persons to be pastor of their churches that were not duly ordained Original Free Will Baptists Ministers.

Central

Disregard for Conference Policy often causes confusion for the church, their pastor and our work for the Lord.

We decided to—

1. Require all churches experiencing a pastoral vacancy to notify the Executive Committee as soon as the church becomes aware of the vacancy.
2. Require the Conference Moderator and Board of Ordination Chair to meet together with the leadership of the church to share helpful ideas and practices concerning searching for and hiring a pastor.
3. Develop a brochure that will help the pastoral search team.
4. Research ways to help churches seeking an interim minister.
5. Request the Board of Ordination to develop a procedure to provide a Provisional Certificate of Ordination to help ministers from other Christian denominations desiring to become ordained Original Free Will Baptist ministers.

Our meeting was closed in prayer.

The IMPACT Dinner is to be held at the Convention opener on Tue 21 May at Mount Olive. Kelley made a motion to pay \$1000 for the dinner. Barry made the second. The team approved the motion in order to provide for all the ministers of our denomination that attend the IMPACT Dinner.

The team explored options for the annual conference meeting. Suggestions were:

- Will highlight key actions by the Board of Ordination and Executive Committee
- Will welcome newly ordained and licensed ministers
- Denominational ministries can set up and man information stations
- May set up a room with memorial info with setting conducive for remembrance and prayer
- Possible 4 pm start with registration and work shops
- 5 pm—Call to order with miscellaneous business and constitutional changes
- 6 pm—meal and fellowship
- 7 pm—final business
- 7:30 pm—keynote speaker (Al Warrick) and Mass Community Choir
- Possible theme—"Fall in Love with Jesus"

Executive Meeting Central Conference
24 June 2013
Free Union Church

The Executive Committee of the Central Conference of Original Free Will Baptists convened at 0945 on 24 June 2013 at Free Union OFWB Church, Walstonburg, NC. Team members present were the Reverends Bryant Hines, Kelley Smart, Barry Williamson and Brad Williamson.

Central

Bryant called the meeting to order and led the devotion. Reading from Galatians 3:27-29, he reminded us that our 42 conference churches are one in Christ. He also read from Psalm 42 reminding us that our ministry is worth it. In spite of discouragement at times, there is joy in ministry and our work for the Lord and for the Central Conference is worthwhile! Barry led in prayer after the devotion.

The team reviewed the Executive Minutes from the 18 Apr 2013 meeting. They were approved. Motion made by Kelley and seconded by Brad.

Brad provided the Treasurer's Report.

He reported that the \$500 storm relief check to Bethel Church which had been given to Home Missions has been paid back.

He reported that Church Finance can give us a better rate than PNC on the Central Conference money market fund. The only concern of Brad is that if we move the money to Church Finance, it would not be FDIC insured. He asked for the Executive Committee thoughts and approval on the transfer. The committee was in agreement that Church Finance has a solid history and is trustworthy. We agreed to proceed with what was previously discussed and go ahead and transfer this fund to Church Finance.

The Treasurer's Report was approved. Motion by Kelley and seconded by Barry.

Our discussion of Old Business also incorporated our items of New Business.

Update on Missing/Found \$500 check: We are still trying to resolve an issue with the \$500 donation sent to Home Missions on behalf of Bethel Church for hurricane relief. Bryant and Brad shared the story of how the \$500 check was found, how the date was changed on the check and that it was deposited after it had expired. Bryant discussed his conversation with Laura Monroe about the check. Our concerns: What do we need to do about investigating why this check was deposited after it had expired, why the date was changed, and why Bethel Church never received the funds? A motion was made for our moderator and treasurer to meet with the Director of Home Missions & Disaster Relief to discuss the issues and concerns surrounding checks issued to 3 churches through home missions in Nov 2011—namely why it took so long for two of the checks to clear and why the third check was lost/misplaced and then processed 16 months later. Motion made by Brad and seconded by Kelley.

Update on the conference church that had requested help. Bryant will contact the clerk of the church and try to set up one more meeting with the church officers. Kelley volunteered to go with Bryant.

2013 Annual Conference Planning: We discussed the schedule in detail and particularly what would be included in the 5 pm session. See details below.

We will not read the minutes of each Executive Committee Meeting. In previous meeting, we also decided not to have a Roll Call of Ministers and Churches.

7:30 pm—Keynote Speaker (Al Warrick) and Mass Community Choir

Possible theme—"Fall in Love with Jesus"

Al Warrick, Vice President of the COFWB, did agree at the conference.

Bryant will contact each of our denominational ministry heads, give them the schedule and explain it to them.

Annual Letter: We need to rework the Annual Conference letter which is sent out to all the churches and ministers. The new letter needs to reflect the changes in our Annual Conference.

This rework needs to be done so that the letter can be mailed out at least by the first of September and earlier if possible. We need to look at this in our next Executive Committee meeting.

We mentioned sending out a flier about the new format, new approach, more worship & fellowship, and to "be watching."

The next meeting of the Executive Committee is scheduled for August 1, 2013 at Free Union at 9:30 a.m.

Inclusions to this report:

1. The Articles of Faith and Principles of Church Government for Original Free Will Baptists in Section 1: The Local Congregation states the following on page 68 concerning the church's calling of a pastor: ***"The church shall call its own pastor, from among the duly Ordained Original Free Will Baptist ministers who are approved by the Conference of which the church is a member."*** We wish to remind any church in our Conference, when extending a call to a minister to serve as your pastor, to be sure that the minister gets proper clearance from the Conference Board of Ordination before assuming duties as pastor of the church.
2. All candidates for ordination in the Central Conference of Original Free Will Baptists must take and pass the Ordination Examination.
3. We wish to remind all Central Conference ordained ministers of the following resolution, which was adopted at the conference meeting of November 6, 2008. ***"All Central Conference Ordained Ministers must physically attend at least one Conference meeting every three years to maintain their Conference Credentials. Exceptions will include those on active full time military duty, full time foreign missionaries and those confined to home or health care facilities."***
4. In accordance with "The Articles of Faith and Church Government for Original Free Will Baptists (of The English General Baptist Heritage) under 'The Rules Of Church Government,' 'Section 1: The Local Congregation,' 'Meetings Of the Local Congregation:' ***'The ordinances of the Gospel are administered only by ordained ministers.'***"
5. The Central Conference gives a Christian flag to the family of a deceased ordained minister.

Report of the Continuing Education Committee

Many ministers are pursuing additional educational opportunities on a regular basis. Perhaps you have attended a seminar or read a book or completed a college or seminary course. We applaud you in this endeavor. We also want to reward you and give you credit for your diligence in continuing your education and training. To receive credit from the Central Conference, simply complete a Continuing Education Report Form and write a 150 word summary about the seminar, book read, or course completed and send it to one of the Continuing Education committee members. More information for submitting requests for Continuing Education Credit is outlined in the "Procedures" section below.

Purpose

The purpose of the Central Conference Continuing Education Program is to help our ministers with the practice of life-long learning. By continuing their education Central Conference ordained ministers will continue to grow in their spiritual walk with Christ as they grow they will be better equipped to serve the churches of the Central Conference. As the leadership of the churches grow the church itself will grow, therefore the growth and continuing education of the ministers is vital to the growth of the church. It is imperative that the ministers of the Central Conference follow the advice given to Timothy by Paul when he said, "Study to show thyself approved unto God, a workman that needeth not to be ashamed, rightly dividing the word of truth."

Guidelines Continuing Education Units (CEU's) will be based on educational opportunities. These would include reading a book, attending a seminar or class, or taking a college or seminary course.

Continuing Education Units/Credits

CEU credits will be given according to the following scale:

Books: up to 200 pages-½ CEU; 200-400 pages-1 CEU. Books over 400 pages will be considered on an individual basis.

Seminars: 3-5 hour seminar-½ CEU; 6-10 hour seminar-1 CEU. Seminar over ten hours will be considered on an individual basis.

College or Seminary Course: If the class is taken from an accredited institution (Southern Association of Colleges and Schools or Association of Theological Schools in the United States and Canada), one will receive 4 CEUs for each credit hour. Credit hours equal one hour per week in class for sixteen weeks. If you take a 3 credit hour course, you will receive 12 CEU's. If the course is taken from an institution that is not accredited by SACS or ATS, it will be considered on an individual basis.

Areas of Study

Biblical Studies: This includes any area of study from the Bible such as books of the Bible, themes, authors, or historical information from the Bible.

Historical Studies: This includes History of the Christian Church, Free Will Baptist Denomination, or Local Churches.

Theological Studies: This includes areas of studies from the following: Prolegomena, Bibliology, Theology Proper, Christology, Pneumatology, Anelogy, Anthropology, Soteriology, Ecclesiology, Eschatology, etc.

Practical Studies: This includes area of studies concerning the working and growth of the local church, pastoral care, counseling, leadership, administration, evangelism, preaching and worship.

Spiritual Formation Studies: This includes area of studies concerning maturity of Christians.

Procedures

To receive continuing education credits, work should be submitted to the Continuing Education Committee. Simply write a 150 word summary and application of the seminar, book read, or college or seminary course completed and attach it to the Continuing Education Report Form. The report form is available at the annual conference or can be requested from a committee member or you can simply create your own report form by including the following. For a seminar, include the title of the seminar, sponsoring organization, presenter's name, and length of seminar. For a book you have read, include the title of the book, author, publisher, and date the book was read. For a college or seminary course, include the name of the course, name of the college or seminary, professor's name, and a copy of the syllabus. The committee will review all work and will send notification to the one who submitted the work and also the Board of Ordination.

2013 Constitutional Changes (Proposed and Passed)

Article IV. STANDING BOARDS AND COMMITTEES Section 13

A Ministry Care Committee shall be composed of three members. Each member will follow a three year rotational term with one member rotating off each year.

Article X. DUTIES AND RESPONSIBILITIES Section 16

It shall be the duty of the Ministry Care Committee to provide and maintain relationships with appropriately accredited agencies to provide counseling, coaching, and other supportive services for ordained and licensed ministers of the Central Conference and their immediate families.

CENTRAL CONFERENCE CONSTITUTION

PREAMBLE

We, the Central Conference of the Original Free Will Baptist denomination of North Carolina, desiring to be in fellowship in a bond of union, do ordain this constitution revised at annual session November 7, 1979, November 4, 1981, November 10, 1982, November 8, 1984, November 5, 1998, November 9, 2000, November 8, 2001, November 7, 2002, November 4, 2004, November 4, 2010 and November 7, 2013.

NAME

This shall be the constitution of the Central Conference of Original Free Will Baptist Church of North Carolina.

PURPOSE

The object of the Central Conference shall be to promote Christ's kingdom among men by means in strict conformity to the Holy Scriptures.

Article I. COMPOSITION

This conference shall be composed of affiliated ordained ministers and churches within its bounds, who are in good standing, and of all general officers, and members of standing boards or committees of the conference. It shall operate under *The Articles of Faith and Principles of Church Government for Original Free Will Baptists (of the English General Baptist Heritage)*. No church corporation whose articles of incorporation or constitution and bylaws conflict with *The Articles of Faith and Principles of Church Government for Original Free Will Baptists (of the English General Baptist Heritage)*, shall be permitted membership in the Central Conference.

Article II. REPRESENTATION

Each church shall represent with one delegate for each one hundred members or fraction thereof. The delegation from each church shall carry to the conference a letter certifying their appointment, and giving the statistics and financial condition of the church, together with a statement of all funds received and distributed for denominational and benevolent purposes during the year.

Article III. OFFICERS

The officers shall be a moderator, an assistant moderator, a clerk, and an assistant clerk who shall be elected for a term of two years, serving two (2) full terms of two (2) years each. The office of treasurer may serve up to ten (10)

years consecutively, the office of treasurer will be elected every two (2) years, no member shall be eligible for nomination to the same office until after an interval of one (1) year when their term expires. The duties of said office shall be entered into at the close of the session in which they are elected.

Article IV. STANDING BOARDS AND COMMITTEES

Section 1. It shall be the policy of this conference to elect as many boards and committees as may be necessary in carrying out its program. These shall keep records of their proceedings and make a report at each annual session of the conference.

Section 2. A board of ordination, consisting of five members each shall be elected. The term of office for members of these boards shall be five years but shall be adjusted to terminate the office of one member annually.

Section 3. A committee of one shall be elected to represent the conference's membership in the Free Will Baptist Press; the term of office shall be two years.

Section 4. A committee of one shall be elected to represent the conference's membership in the Church Finance Association, Inc.; the term of office shall be two years.

Section 5. A credentials committee and an memorial committee, consisting of three members each, shall be elected. The term of office for members shall be three years but shall be so adjusted as to terminate the office of one member annually.

Section 6. A committee of one shall be elected to serve as conference historian; the term of office shall be two years.

Section 7. A committee of one shall be elected to serve as publicity committee; the term of office shall be two years.

Section 8. The executive committee shall be composed of the moderator, assistant moderator, clerk, assistant clerk, and treasurer elected by the conference at the time of the official election of officers.

Section 9. Temporary committees shall be appointed at the option of the conference for whatever purposes may be deemed necessary.

Section 10. A committee of five shall be elected to serve as a Continuing Education Committee with three members being elected to serve three year terms, one rotating off each year, and one member elected by the Ordaining Council annually (from its membership) and one member to be elected by the Executive Committee annually (from its membership).

Section 11. A committee of five shall be elected to serve as a Church Growth Committee with three members being elected to serve three year terms, one rotating off each year, and one member elected by the Executive Committee annually (from its membership) and one member to be elected by the Continuing Education Committee annually (from its membership).

Section 12. A board of trustees consisting of three members shall be elected. The term of office for members of this board shall be three years but shall be adjusted to terminate the office of one member annually.

Section 13.

A Ministry Care Committee shall be composed of three members. Each member will follow a three year rotational term with one member rotating off each year.

Article V. FINANCE

Each church shall contribute to the conference according to its membership.

Article VI. ADMISSION OF CHURCHES

Any properly organized church that gives evidence of adherence to the doctrines of Christianity as taught by Original Free Will Baptists of North Carolina and desires to help promote the program and work of the Central Conference and the Convention of Original Free Will Baptists may present its petition to the regular session of the conference. If the petition for membership is approved, the moderator shall extend the hand of fellowship to the delegates.

Article VII. DISMISSION OF CHURCHES

A church may be dismissed from membership in the conference by vote of the conference.

Article VIII. VISITORS

The Central Conference may extend to visiting brethren all the privileges of the body save that of voting.

Article IX. MEETINGS

The Central Conference shall meet in annual session on Thursday before the second Sunday in November of each year, except in years when Veteran's Day falls on that day. In years when Veteran's Day falls on the Thursday before the second Sunday the Central Conference shall meet one week earlier. The host church shall be selected by vote of the conference in annual session or by the executive committee. The place of a future meeting thus selected may be

changed by an act of the executive committee should a change become necessary.

Article X. DUTIES AND RESPONSIBILITIES

Section 1. The duties of the moderator shall be to preside, according to accepted parliamentary procedure, over the session of the Central Conference; to appoint temporary committees, delegates, and representatives; to serve as ex officio member of all standing boards and committees; and in general to perform the duties of the office of moderator.

Section 2. The duties of the assistant moderator shall be the duties of the moderator when that officer is not present and he shall assist the moderator when called upon. In the event of the resignation or death of the moderator, the assistant moderator shall fill the vacancy until the next session of the conference.

Section 3. The clerk shall record and preserve a permanent record of the proceedings of all sessions of the Central Conference. He shall prepare and cause to be published the minutes of the annual sessions of the conference, hold in trust all documents not otherwise preserved, and surrender same at the direction of the conference. He shall conduct the official correspondence and sign such documents and instruments as require his signature.

Section 4. The duties of the assistant clerk shall be the duties of the clerk when that officer is not present, and he shall assist the clerk when called upon. In the event of the resignation or death of the clerk, the assistant clerk shall fill the vacancy until the next session of the conference.

Section 5. The treasurer shall hold in trust all money that belongs to the conference, except that held by other boards and committees of the conference. He shall keep an accurate account of all funds received and paid out and make an annual report accordingly to the conference.

Section 6. It shall be the duty of the executive committee to transact the business of the conference when the conference is not in session. The executive committee shall plan the program for the annual session of the conference.

Section 7. It shall be the duty of the board of trustees to hold in trust title to all tangible property belonging to the conference. It shall have power to convey such property when authorized by the conference.

Section 8. It shall be the duty of the board of ordination (1) to examine and recommend the license of ministers; (2) to examine, ordain, and discipline ministers in keeping with the provisions of *The Articles of Faith and Principles of Church Government for Original Free Will Baptists (of the English General Baptist Heritage)* and (3) to examine ordained ministers seeking membership in this conference and to make recommendations in keeping with their findings.

Central

Section 9. It shall be the duty of the Free Will Baptist Press Foundation committee to represent the conference's stock in the Free Will Baptist Press and to do so at any stockholders' meeting.

Section 10. It shall be the duty of the credentials committee to check each church report for verification as to their delegates and make recommendations to the conference as regarding their seat during the annual session. The credentials committee shall check registration cards of the enrolling ministers and make recommendations of same to the conference.

Section 11. It shall be the duty of the memorial committee to prepare and present a memorial service for all ministers who die during the year preceding the conference. The memorial committee shall prepare a brief biographical sketch for the Historical Collection.

Section 12. It shall be the duty of the conference historian to collect and preserve any historical data concerning the conference.

Section 13. It shall be the duty of the publicity committee to see that proper publicity is given to the activities and work of the conference.

Section 14. It will be the duty of the Continuing Education Committee to set guidelines concerning what materials, classes, seminars, and other forms of training and instruction will be recognized as qualified disciplines for our ministers to receive credits as Continuing Education and to set the number of units that can be credited for such work. Also, this committee is to plan and promote seminars and training opportunities which will be recognized as qualified disciplines for our ministers to receive credits as Continuing Education. Furthermore, this committee is to review annually such applications as may be submitted by our ministers for Continuing Education Units of Credit and report them to the Conference in session.

Section 15. It shall be the duty of the Church Growth Committee to promote and support local church growth through outreach ministry and leadership development. Through the work of the committee Central Conference Churches will be more fully equipped to effectively reach people without Christ in their communities. The committee shall establish and coordinate a process and method whereby local churches of the Central Conference may apply for funds to subsidize the cost of special church growth projects and/or leadership development programs.

Section 16. It shall be the duty of the Ministry Care Committee to provide and maintain relationships with appropriately accredited agencies to provide counseling, coaching, and other supportive services for ordained and licensed ministers of the Central Conference and their immediate families.

BYLAWS

Section 1. A board or committee will be recognized as having a quorum when there is a majority of the members present for a meeting, providing all the members of said board or committee have been duly notified concerning the said meeting.

Section 2. All reports, resolutions, and recommendations shall be considered properly presented to the conference in written form only.

Section 3. Each minister and delegate in good standing shall duly attend each day while the conference is in session or be subject to censure by the conference and reported to his local church.

Section 4. If any member, in the judgment of the conference, shall show anger in his discussion on any subject, he shall forfeit his seat in that session.

Section 5. No member shall be excused from any session of the conference without leave of the moderator.

Section 6. The conference shall adjourn by a majority vote.

Section 7. Each officer and member of standing committees and boards in good standing shall be entitled to a seat and vote in the conference.

Section 8. The conference shall open and close with suitable devotional services.

Section 9. The minutes of the conference shall be approved by the Executive Committee before publication.

Section 10. This constitution and its bylaws may be altered or amended by a two thirds favorable vote of the members present, provided that said amendment shall be presented in the morning session.
