The 271<sup>st</sup> Annual Session of the Central Conference of Original Free Will Baptists
First OFWB Church, Greenville, NC
November 7, 2019

The 271st Annual Session of the Central Conference of Original Free Will Baptists convened at Greenville First Original Free Will Baptist Church on Thursday, November 7th at 9:00 a.m.

The 271st Annual Session was officially called to order by the Reverend Josh Hobgood.

The welcome and invocation were given by Dr. Franklin Baggett, Assistant Moderator.

The congregation joined in worship by singing "How Great is Our God".

The Treasurer then presented the 2019-2020 Central Conference budget. By motion the budget was adopted.

The Board of Ordination report was given by the Reverend Dustin Bannister By motion the report was adopted.

The Reverend John Hill presented a report of information from the Minister Care Committee. This was accepted as information.

Time was given to greet newly licensed and ordained ministers during a break

The Reverend Todd Sutton recognized minister for their years of service and gave out certificates of Recognition to Reverend Walter Reynolds (70), Reverend Melvin Moore (60), Reverend Charles Branch (50), Reverend Phillip Wood (40), Reverend Jack Weathersby (25), Reverend Charlie Carroll (25), Reverend Tony Glass (20), Reverend Frank Cockrell (20), and Reverend Charles Russell (15).

The Reverend Kelly Smart presented the Nominating Committee Report. The report was accepted. By motion nominations were ceased and elected by acclamation.

The Reverend Dr. Franklin Baggett introduced the Keynote speaker, the Reverend Justin Barnett, Pastor of Jackson Heights OFWB Church.

The Reverend Justin Barnett gave the Key Note address, "Why Does Your Church Exist?," from Jonah 4:11.

The Congregation sang the hymn of commitment "Send the Light."

## Central Conference Executive Committee Special Communication Via E-mail October 18, 2021

The Executive Committee of the Central Conference was scheduled to meet in-person on October at Elm Grove OFWB Church to finalize plans for the upcoming November 4, 2021 Annual Conference. However, over the weekend, one Executive Committee member tested positive for the Covid-19 virus. A second Executive Committee member suspected he was positive for Covid-19 and was waiting on test results to confirm his suspicions. A third Executive Committee member had recently found out that he had been in close proximity for an extended period of time to several people who had just been diagnosed with Covid-19. As a result, the in-person meeting was cancelled and the Committee communicated via group texts and email.

Discussion centered around the impact of Covid-19, the increase in Covid statistics and the safety of those who would be in attendance at the November Conference. With the uptick in Covid-19 cases in the surrounding region and the presence of infections on the Executive Committee, it was decided to postpone the Annual Conference for two months with the hope that by January, Covid-19 case and hospitalization rates would be much lower.

The following items were included in an email from the Moderator to the members of the Executive Committee:

- 1) Choose a new date for the November 4th Annual Conference in January 2022.
  - a. Ensure Reverend Harold Jones is available on the new date.
  - b. Ensure Elm Grove is available on the new date.
  - c. Ensure our committee is available on the new date.
- 2) Send out a post card (at the earliest opportunity) to our churches, pastors and denominational leaders informing them of the postponement and the new date and giving them an explanation for the delay.

Ask the OFWB Headquarters to also send this new date out via email to their mailing list.

After these items were discussed, a new date was selected for the Annual Conference. It was agreed that the Conference would be postponed to Thursday, January 27, 2022. It was also decided that the Executive Committee would meet on November 4, 2021 to continue making preparations for the January 27, 2022 Annual Conference.

## POSTPONEMENT OF THE 272<sup>nd</sup> ANNUAL SESSION of the Central Conference of Original Free Will Baptists (Due to a Rise in the COVID-19 Delta Variant)

Dear Ministers, Leaders and Member Churches of the Central Conference, This letter is to inform you that the upcoming Annual Session of the Central Conference originally scheduled for November 4, 2021 is being postponed two months to January 27<sup>th</sup>, 2022. It will still be held at Elm Grove OFWB Church, located at 5403 Weyerhaeuser Rd, Ayden, NC, 28513.

According to the CDC, there has been a significant increase in new COVID cases which has reversed what had earlier been a steady decline. The CDC has seen a rapid and alarming rise in the COVID-19 case and hospitalization rates around the country. The CDC has also confirmed that the Delta variant is more infectious and is leading to increased transmissibility when compared with other variants, even in some vaccinated individuals.

In recent days, the COVID-19 virus has touched the lives of individuals on our Executive Committee as well as family members. Others have been in contact with friends, family members and/or church members who have recently tested positive for COVID-19. In an abundance of caution, we are postponing the Conference to January in hopes that the increase of Delta Variant infections will have subsided. We do not plan to cancel the Conference—only postpone it two months until January 27<sup>th</sup>.

The Executive Committee would be grateful if all Central Conference churches and ministers would move forward in submitting your church contributions and minister's dues prior to the Conference. ## Central Conference Executive Committee Special Communications Via Text and Email Concerning Postponing (Again) or Cancelling the January 27, 2022 Annual Conference

On Friday, January 14, 2022, after a week-long quarantine and serious fight with Covid-19, our Moderator contacted the Director of Convention Services, Reverend Gary Bailey, to discuss concerns over the rise of the Covid-19 Delta Variant in our region and the upcoming Annual Conference on January 27. The Executive Committee had already been monitoring the spike in Covid-19 infections, reflecting on the upcoming Conference and communicating with fellow Committee members via phone, email and text. After discussing the current situation, the Executive Committee agreed to cancel the upcoming January 27<sup>th,</sup> 2022 Conference in the interest of health and safety. The Executive Committee continued to communicate via text and email to develop a plan for electing officers and adopting a modified budget. A Zoom videoconference meeting was scheduled for February 17, 2022.

Below is a copy of the letter mailed to Central Conference ministers, leaders and member churches.

January 18, 2022

CANCELLATION OF THE 272<sup>nd</sup> ANNUAL SESSION of the Central Conference of Original Free Will Baptists (Due to the recent spike in the Covid-19 Omicron variant)

Dear Ministers, Leaders and Member Churches of the Central Conference,

This letter is to inform you of the **cancellation** of the 2021 Annual Session of the Central Conference which was originally scheduled for November 4, 2021 **(and was postponed to January 27, 2022 due to a rise in the Delta variant)**.

Never did we imagine that the Covid-19 Omicron variant would be an issue of concern when we made the decision to postpone the Conference from November 2021 to January 2022. However, in recent weeks, the Omicron variant of the Covid-19 virus has managed to break records for daily positive cases in the U.S. and here in N.C. With the rapid rise in Covid-19 infection rates, sicknesses and hospitalizations and the recent infection of several members of the Executive Committee, we have made the difficult decision to cancel the Conference which had been rescheduled for next week—January 27, 2022.

The Executive Committee will meet in the coming weeks to adopt a new budget and to elect (on behalf of the Conference) the slate of officers and committee members that have been selected by our Nominating Committee. The new budget and nominating report will then be shared with our ministers, leaders and member churches.

The Executive Committee would be grateful if all Central Conference churches and ministers would move forward in submitting your church contributions and minister's dues in spite of the cancellation of the Annual Conference so that we may continue to support the many important items in our Conference Budget.

The next Annual Session of the Central Conference will be November 10, 2022.

Thank you for your understanding and for your continued support of our Conference.

## Central Conference Executive Committee Meeting Zoom Videoconference February 17, 2022

The Executive Committee of the Central Conference held a Zoom videoconference due to concerns about the spread of Covid-19.

Those present were the Reverends Barry Williamson, Bill Groce, Frankie Baggett and Tom Malin.

Reverend Barry Williamson, moderator, opened our session with prayer. In the absence of our clerk, our Moderator recorded the minutes for this meeting.

This special meeting was primarily to adopt a new budget and approve the Nominating Report since we did not have our Annual Conference in November 2021 or the postponed Annual Conference in January 2022 due to concerns related to the increased transmission of Covid in our state and nation. See Article 5.3 and 5.4 for information governing Executive Committee decisions.

It shall be the duty of the Executive Committee to transact the business of the Conference when the Conference is not in session. In the event a called special meeting is necessary for the entire Conference, the Executive Committee will set a date for said meeting with at least a four-week notice to member churches, licensed, ordained, and retired ordained ministers. The only business to be transacted at said meeting will be the specific business for which it is called.

5.4 - Cancellation of a Regularly Scheduled Meeting

The Executive Committee will have the duty of cancellation of a regularly scheduled meeting with just cause. Notification will be at the earliest date known for the decision of cancellation and will be carried out by the Conference clerk, in writing, or by other expeditious

The Treasurer's Report was presented and adopted. The committee discussed the decline in Minister's Dues and Church Contributions in light Covid-19 and the cancellation of the Annual Conference. We updated the Minister's Dues spreadsheet in an effort to make it easier to understand.

A motion was approved to include (in our next mailing) a copy of the Church Contributions spreadsheet and the Minister's Dues spreadsheet along with the Nominating Committee Report and the new 2021–22 Conference Budget and ask ministers and churches to catch up on dues/contributions as soon as possible.

The Executive Committee reviewed the 2021–22 Central Conference Proposed Budget. Since the Annual Conference was cancelled and income has been down, a modified budget based on a reduction in Conference income was drafted and adopted by the committee on behalf of the Conference. Several line items were reduced and some were dropped to zero with the hopes to restore these line items to pre-Covid amounts in our next Annual Conference in November 2022.

The Executive Committee also reviewed the Nominating Committee Report which was compiled by Reverend Mark Hobbs, Reverend Johnny Sullivan and Reverend Carlton Oakley. A motion was approved to elect the slate of officers and committee members who were recommended by the Nominating Committee. Reverend Josh Hobgood was not present for the vote, but previously shared his approval of the Nominating Committee Report. No changes were made to the Nominating Committee's recommendations by the Executive Committee.

The Moderator will draft a cover letter to accompany the Nominating Committee Report, New Conference Budget, Church Contributions spreadsheet and Minister's Dues spreadsheet.

The Executive Committee will meet in again in March or April and welcome the new members to the Executive Committee.

The meeting was dismissed with prayer.

#### Inclusions to this report:

- I. The Articles of Faith and Principles of Church Government for Original Free Will Baptists in Section 1: The Local Congregation states the following concerning the church's calling of a pastor: "The church shall call its own pastor, from among the duly Ordained Original Free Will Baptist ministers who are approved by the Conference of which the church is a member." We wish to remind any church in our Conference, when extending a call to a minister to serve as your pastor, to be sure that the minister gets proper clearance from the Conference Board of Ordination before assuming duties as pastor of the church.
- II. All candidates for ordination in the Central Conference of Original Free Will Baptists must meet the educational requirements set forth by the Conference of November 8, 2007, and take and pass the Ordination Examination.
- III. We wish to remind all Central Conference ordained ministers they are required to attend the annual session of the Conference each year. Requests for excusal shall be submitted in writing to the Clerk of the Conference before the Conference, or within thirty days after the Conference for those with unanticipated causes for absence. Ministers who fail to attend the annual Conference physically for three consecutive years shall be subject to lose their credentials.
- IV. In accordance with "The Articles of Faith and Church Government for Original Free Will Baptists (of The English General Baptist Heritage) under 'The Rules Of Church Government,' 'Section 1: The Local Congregation,' 'Meetings Of the Local Congregation:' 'The ordinances of the Gospel are administered only by ordained ministers.'" These ordained ministers must be ministers approved by the Central Conference Board of Ordination.
- V. Upon request by the family of a deceased ordained minister who is a member of the Conference, the Central Conference presents a Christian flag to the family.
- VI. All Ordained Ministers of the Central Conference must maintain membership in an Original Free Will Baptist Church.
- VII. The Central Conference of Original Free Will Baptists prohibits Central Conference ordained ministers, and any ordained minister from any other Conference serving within the Central Conference, from officiating same gender marriages. Ordained ministers who violate this rule will be subject to the disciplinary actions issued by the Board of Ordination and the minister may lose ordination credentials.
- VIII. Licensed Ministers from any conference are not allowed to be interim pastors in the Central Conference. Licensed Ministers cannot supply speak more than four Sundays in a calendar year in the same congregation, and two of those Sundays must have ninety days separating them.

The Board of Ordination stands ready to help people who are called to the Gospel Ministry.
