Fourth, We would reccommend to our Sunday Schools to use our denominational Sunday School Literature, and to our churches to patronize our denominational papers.

Report of Commmittee of the State of the Country: Our country's condition need not beget a spirit of morbid pessimism, nor create a blind optimism. The assassination of our president has plunged our nation and the nations of the world into deep poignant grief, and at the same time forced upon our vision the alarming proportions that anarchy has assumed.

We reccommend the expeditious and dignified unsensational manner in which the Buffalo courts and officers discharged their respective duties in the trial of the assassin, and we reccommend to our state and national legislators that stringent laws be created and strenuous efforts be put forth to put an effectual check to the principles of anarchy and dangerous ravings of such male-contents as Emma Goldman and Herr Most.

We watch, with apprehension, the gigantic syndicate that, if successful, are to revolutionize our commercial system, and we deplore all efforts and causes that divide men into irrconcilable classes.

We should pray for the safety and preservation of our present Governor and trust that the efficiency that characterises Presdent Roosevelt in his former positions of trust and honor will follow him into his new office as our Chief Executive.

Committee on Temperance: No indictment or arraignment of the liquor traffic is needed. It stands confessedly an out law and is the mother of every vicious principle known to man or devil. The chief end of man so for as Free Baptist is concerned is to abstain from the use of liquor as a beverage and refuse political bedfellowship with the saloon and political boodler. Therefore the only logical, practical, sensable place for the Christian man is in the only political party that stands opposed to the manufacture, sale, importation, exportation and transportation of alcoholic liquor as a beverage.

WEDNESDAY MORNING SESSION

Opened with devotion, conducted by Rev. Geo. E. W. Wood.

The program as submitted by the committee was now taken up, the first number being a paper by Rev. W. W. Jacobs, subject: "The need of a special revival in Sunday School Work." Discussion of the same by Rev. McMinn, Bagwill, Tatum, Cochran and Carter.


