The Sixth Annual Session of the Central Western Missouri Association of Free Will Baptists convened with the Bluff church, September 3-6, 1914.

Introductory sermon, Thursday evening, delivered by Rev. W. H. McKown. Scripture lesson, II. Tim. 3. Text, II. Tim. 3: 16.

Adjourned to meet at 9 a. m. Friday.

FRIDAY MORNING SESSION

Meeting called to order by Moderator, W. H. McKown.

Opening song No. 307.

Scripture lesson, Isiah 12, by W. H. McKown. Song No. 352, "Labor On," by congregation.

Prayer by W. H. McKown.

Reading of Constitution and By-Laws by clerk.

T. C. Ferguson and O. T. Fast were nominated for Moderator and voted for by ballot. Bro. Ferguson received 10 votes and Bro. Fast received

13 votes. Motion carried to make Bro. Fast's election as moderator unanimous. Motion carried that Bro. Ferguson act as assistant Moderator.

Bessie Dobbs of Wagoner was elected assistant clerk.

Church letters were called for and read by assistant clerk.

to admit the Sylvandale church to membership in the Association and to extend the hand of fellowship to the delegates and deacons and to seat them in the conference. Sister Washburn and Bro. Hopkins were named as delegates and Bro. Ed Washburn as deacon; but no one was present. Pastor E. F. Crabtree. State of religion good. Sunday School evergreen and prayer meeting weekly. Membership 25. Church requests that J. V. Harbart be ordained as deacon.

Letter from Stockton church asking for admission to this Association read. Motion carried that Stockton church be admitted to membership and that we extend the hand of fellowship to her delegates and deacons and seat them in the assembly. Delegate, Fenis Pruitt, present. Deacons, A. W. Hartley, present; Fred Galyon, absent; E. Pruitt, absent. Church has no pastor at present. Membership 23. Church requests the next session of the Association.

On motion the Moderator appointed the following committees: Pulpit committee, Mollie Taylor, W. L. Douglas and Edith Mayfield. Business committee, T. C. Ferguson, Frankie Wade and A. W. Hartley.

Bro. McKown was granted all privileges of the floor except voting.

Pulpit committee reported that T. C. Ferguson would preach at 11 o'clock and E. F. Crabtree tonight.

Motion carried to adjourn till 2 p. m. Closing prayer by T. C. Ferguson.

FRIDAY AFTERNOON SESSION

Minutes of morning session read and approved.

Business committee reported the appointment of the following committees: Committee on Ministerial standing, Chas. Miller, Loten Thomas, Ed Coles, Chas. Mayfield and Roy Bogart. Committee on publication, B. F. Brown, Mollie Taylor and L. C. Wade.

Motion carried that this Association instruct its clerk to write for Rev. W. H. McKown a letter of greeting to whom it may concern, also stating the work the brother has done in the churches of this Association.

The following resolutions submitted by the business committee were adopted by the Association.

No. 1. Be it resolved that article 4, sections 1 and 2 of the constitution be changed to read as follows:

Section 1. This Association shall elect a board of five members, two of which shall be preachers. This board shall be called the Home Mission and Executive Board of the Association. One member of the board shall be elected to hold office for one year, one for two years, one for 3 years, one for 4 years and one for 5 years. After the first election one member shall be elected each year and each shall hold office for 5 years or till his successor is elected. This board shall have charge of the work of the Association when it is

not in session.

Sec. 2. The Home Mission and Executive Board of this Association shall be the trustees of the Association and shall have charge of its property.

No. 2. Be it resolved that this Association shall try to put an evangelist in the field the en-

suring year.

No. 3. Be it resolved that this Association meet next year with the church at Stockton, in Cedar Co. The session to begin on Wednesday night before the 4th Sunday in September, 1915.

No. 4. Be it resolved that this Association send a delegate to the Missouri State Association which meets at the Philadelphia church near Pattonsburg, Mo., on Wednesday night before the 5th Sunday in November, this year.

Be it further resolved that this Association is in favor of organizing a Missouri State Association and that this Association send a letter of greeting and a request that this Association be admitted to membership in the Missouri State Association.

W. H. Potts and A. W. Hartley were chosen delegates to the Missouri State Association and were given the right to choose their alternates.

The financial report of clerk and treasurer showed a balance in the treasury of \$3.10.

Clerk was allowed 75 cents for postage.

Each of the following churches paid \$2.00 to be used to defray the expenses of the Association: Verdella, Bluff, Hannon, Wagoner, Fair View, Stockton and Hickory Grove.

Members of the Home Mission and Executive Board were elected as follows: O. T. Fast for a term of three years; E. F. Crabtree for a term of four years; T. C. Furguson for a term of five years.

Motion carried that Brothers Grover Lewis of Hannon church, J. V. Harbart of Sylvandale church and W. L. Douglas of Wagoner church be ordained as deacons at the close of preaching services Friday night, Bro. McKown to give the charge to the church and Bro. Crabtree the charge to the deacons.

Motion carried to adjourn till 9:30 a.m. Saturday.

Closing prayer by A. W. Hartley.

FRIDAY EVENING SESSION

Bro. Crabtree occupied the pulpit, taking for his subject, "A Voice from Eternity."

- No. 3. Be it resolved the clerk be instructed to send a letter of greeting to the Southwest Convention of Free Will Baptists and to pay the \$3.00 we owe them.

Motion carried to instruct the clerk of this Association to notify the clerk of the Southwest Convention that we will specify the number of copies of their minutes we want after this.

We, your committee on publication, beg to submit the following report:

We recommend that our people take our church papers, especially the Free Will Baptist News, published at Weatherford, Texas, and the Free Will Baptist, published at Ayden, North Carolina. The News is semi-monthly and costs 65 cents a year. The Baptist is weekly and costs \$1.00 a year.

We also recommend that all our churches having Sunday Schools use the Free Will Baptist Sunday School Literature published at Ayden, North Carolina

We further recommend that the clerk have at least 300 copies of the minutes of this session published and distributed among the different churches and that he draw on the treasurer to pay for same.

We further recommend that our church covenant and articles of faith be put in the minutes if there is money in the treasury to pay for same.

CHURCH COVENANT

Having given ourselves to God, by faith in Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant. We promise by his grace to love and obey him in all things, to avoid all appearance of evil to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to "provide things honest in the sight of all men."

We agree faithfully to discharge our obligations in reference to the study of the Scriptures. secret prayer, family devotions, and social worship and by self-denial, faith, and good works endeavor to "grow in grace and the knowledge of our Lord and Saviour, Jesus Christ." We wil not forget the assembling of ourselves together for church conferences, public worship, and the observance of the ordinances of the Gospel, nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolen work. We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity o the Spirit" in the bond of peace, to be careful o one another's happiness and reputation, and seek to strengthen the weak, encourage the afflict ed, abmonish the erring, and as far as we are abl promote the success of the church and of th We will everywhere hold Christia principle sacred and Christian obligations an enterprises supreme: counting it our chief bus ness in life to extend the influence of Christ i

society: constantly praying and toiling that the Kingdom of God may come, and his will be done on earth as it is in heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sabbath schools, and evangelistic efforts for the salvation of souls and the conversion of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.

CONSTITUTION

- ART. 1. This body shall be known as the Central Western Missouri Association of Free Will Baptists, and shall be composed of such consistent well regulated Free Baptist churches as shall, from time to time, unite with the body and agree to this constitution.
- ART. 2. The acting members of this Association shall be such as are chosen by the several churches of which this Association is composed. Each church being entitled to one delegate and each church having twenty-five members two delegates, and one delegate for each additional twenty-five members or major part thereof, and all ordained deacons, ordained ministers and licensed ministers of the several churches of the Association.
- ART. 3. The officers of this Association shall be a Moderator who shall be elected at each session and shall hold office until his successor is elected, a Clerk and a Treasurer, who shall be standing officers of the Association.
- ART. 4. SEC. 1. This Association shall elect a board of five members, two of which shall be preachers. This board shall be called the Home Mission and Executive Board of the Association. One member of the board shall be elected to hold office for one year, one for 2 years, one for 3 years, one for 4 years and one for 5 years. After the first election one member shall be elected each year and each shall hold office for 5 years or til his successor is elected. This board shall have charge of the work of the Association when it is not in session.

SEC. 2. The Home Mission and Executive Board of this Association shall be the trustees of the Association and shall have charge of its property.

ART. 5. SEC. 1. This Association shall meet annually at such a time and place as shall meet with the pleasure of the Association and it shall be the duty of all churches of which it is composed to represent themselves by letters and delegates.

SEC. 2. It shall be the duty of all ministers of this Association to attend each session or report by letter. And all ministers reporting by letter or in person shall be entitled to a certificate of ministerial standing from the Association.

ART. 6. This constitution may be altered or amended by vote of any session of the Association, notice of such intended change having been given in writing at least three months before such change shall be voted upon, to the executive board.

BY-LAWS

- 1. Each session of this Association shall be called to order by the clerk when present, and in his absence by the member having seniority of years.
- 2. Each session of this Association shall be opened and closed by prayer.
- 3. Delegates from three (3) or more churches shall constitute a quorum to transact business for the Association but any less number may adjourn from time to time.
- 4. A member wishing to speak in conference shall arise and address the moderator, and be recognized by same, and shall not be allowed to speak longer than five minutes nor more than twice on any subject without the consent of the conference.
- 5. New churches may be admitted to this Association by majority vote of conference.
- 6. The yeas and nays may be taken on any question by the request of one-fourth of the members present.
- 7. These by-laws may be amended at any session of the Association by a two-third's vote of the members present.
- 8. A committee of five lay members, delegates present at the Association shall be elected to look into the standing of the ministry, and make their report to the Association before it adjourns for approval or rejection.
