### MINISTERS' REPORTS

ALICE DICKEY — I submit the following report of my work for the Lord since answering the call to preach November 18,1940.

I have been going once a month to Shiloh school house. I have assisted in three revivals; made ten or more sick calls. I have preached 43 sermons, traveled 1494 miles, received \$49.63, and have witnessed nine conversions. I have been called to pastor the Verdella Free Will Baptist Church for the coming year.

I ask an interest in your prayers, that I might prove more worthy of the Lord's bountiful blessings.

LLOYD T. JEFFREYS — Feeling the weakest among you. I humbly submit this report:

Since answering the call to the ministry, I have filled the sacred stand a few times. Although my ministry has been limited I have felt God's leadership each time. It is through His leadership that I am determined to do more for the Master in the future.

Trusting God to direct, I am expecting greater things in the future.

MARIE THOMAS - I submit the following report:

I acknowledged my call to the ministry during the month of November, 1940. My license was granted to me by the executive board in December. During the nine months of my work I have had a number of appointments at different churches. I have also helped conduct two revivals. Sermons delivered, 43; professions witnessed, 4; miles traveled, 1258; finance re ceived, \$72.88.

I have attended the National Association which convened at Drumright, Oklahoma, in July and the Christian Workers' Institute at Monett, Missouri, which was sponsored by the National Board of Education.

I have received the call for the pastoral work of the Hickery Grove church for the coming year. -12 The Lord is blessing in an abundant way in opening doors before me. I ask your prayers that I may be a real servant of the Lord.

ARLIE E. HOOVER - I wish to humbly submit the following report:

Number of sermons, unknown; performed two marriages; have made a special habit to visit the sick. I have been active in executive board work; helped to license five ministers are ordain one. I have also been busy on the state executive board. At present I am trying in my weak way by the help of God to superintend the Hannon Sunday School.

Pray for me that I may be of more service to my Master.

FLOY HARTLEY-I humbly beg to submit my report:

In my ministry of 7½ months I have witnessed eight souls saved. I have tried to preach 30 sermons. I have traveled about 1,000 miles. Every cent I have received has been strictly a free will offering, the amount being \$103.68. I have three appointments a month and they are in school houses in remote districts. I praise the Lord that He blesses our feeble efforts wherever we humble ourselves before Him. Pray that God will lead me where I can serve Him best.

C. R. DICK — I submit the following report:

I have pastored the Eldorado Springs church the last year. I have preached 64 sermons; had one reclaimed; received \$16.00 for pastor's salary.

ARTHUR KICENSKI — Great joy and blessings from the Lord was mine to share with those whom I labored. I conducted one revival; pastored one church; witnessed two conversions and several reconsecrated to the Lord; conducted two funerals.

I am seeking to do more for the Kingdom of the Lord, 1 ask an interest in your prayers.

LOWELL MARTIN — I have held three appointments this year besides supplying for other ministers. During the year I have preached 102 sermons; conducted two funerals; solemnized one marriage; conducted one short revival; traveled around 2,200 miles; received \$199.65 in money besides other donations.

The Lord is graciously giving added opportunities for service in this new associational year and by His grace and through His strength we desire to go forward.

ROENA THOMAS — I beg to submit the following report of my work in the Lord's vineyard during the past year.

I have had two regular appointments each month since November, also one afternoon service a month at a school house since February.

I have conducted two short revival meetings; one at Bluff church and one at St. James church. In all I have witnessed seven conversions. I have supplied a few times for other pastors; also preached two funerals and performed two marriage ceremonies. Total number of sermons, 40; number of miles traveled, about 600. I do not know how much money I have received.

I covet your prayers that I may be used by the Lord in the places where He may want me; that I may follow the leading of the Holy Spirit and be a soul winner for Him.

H. S. FORD — I have preached 209 sermons; have seen 68 seek the Lord for salvation; traved around 5,000 miles.

HAROLD HOOVER — I have lately received a new vision of the field of labor "white unto the harvest" and I give God the glory for that. I am determined to better this report very soon if the Lord is willing. I feel the call to evangelistical work and desire the prayers of all that we may do God's will

I have delivered six sermons the past year and do not pastor any church. I drive quite a few miles in the Lord's service and am now beginning to enjoy His work more and more. I have cared for the sick. I attended the Christian Workers Institute at Monett.

MRS. CALLIE ACHORD — I just want to say I still love the Lord and am still trying to lift up the banner for God. I am sorry I could not attend the meeting, but as there is sickness in my son's home I just could not come.

I have been working hard for the Lord in my weak way this summer: I have three regular appointments every month, and have been busy somewhere my extra Sunday. I especially want to mention our church at Conners Chapel that has just been started a year. We are having a wonderful time over there and souls are finding their way to the Christ. I preach there twice a month. I am planning to hold some revival meetings

#### CONSTITUTION

Art. 1. This body shall be known as the Central Western Missouri and Southeastern Kansas Association of Free Will Baptists, and shall be composed of such consistent, well regulated Free Will Baptist churches as shall, from time to time, unite with the body and agree to this constitution.

Art. II. The acting members of this Association shall be such as are chosen by the several churches of which it is composed. Each acting church being entitled to one delegate, and each church having twenty-five (25) resident members two delegates. and one delegate for each additional twenty-five resident members or major part thereof, together with all ordained deacons, ordained and licensed ministers, and church clerks of the several churches composing this Association.

Sec. 2. A resident member shall be a member in good standing who discharges his or her obligations to the church, and who resides near enough to attend church services, or who reside at a distance, but discharges his or her obligations to the church; unless feeble minded or invalids. All other members shall be considered non-resident members.

Art. III. The officers of this Association shall be a Moderator, an assistant Moderator, a Clerk, an assistant Clerk and a Treasurer; all of said officers to be elected annually at the regular session of the Association, and shall hold their office until their successors are elected and qualified.

Art. IV. This Association shall elect a board of five members, two of them shall be ministers. This board shall be called the Home Mission and Executive Board of this Association. One member of this board shall be elected to hold office for one vear, one for two years, one for three years, one for four years, and one for five years. After the first election one member shall be elected each year and hold office for five years, or until his successor is elected. This board shall have charge of the work of the Association when it is not in session.

Sec. 2. The Home Mission Board of this Association shall be Trustees of the Association, and shall have charge of its property.

Art. V. This Association shall meet annually at such time and place as shall meet with the approvel of the Association, and it shall be the duty of the churches of which it is comresed to represent themselves by letter and delegates.

Sec. 2. It shall be the duty of all ministers of this Association to attend each session or report by letter. And all ministers reporting by letter or in person shall be entitled to Annual Certificates of Ministerial Standing by the Association.

Art. VI. This Constitution may be altered or amended by vote at any regular session of the Association, notice of such intended change having been given in writing not less than three months before such change shall be voted on to the Executive Board.

#### BY-LAWS

1. Each annual session of this Association shall be called to order by the Clerk, or in his or her absence, the assistant Clerk, and in his or her absence, the standing member having seniority in years in service. After the Clerk, or the one calling the assembly to order, shall declare a quorm present, he or she shall call the Moderator to the chair, and in his or her absence, the assistant moderator, and in his or her absence, the standing member having seniority in years of service.

2. Each session of this Association shall be opened and closed with prayer.

3. Five (5) delegates from three (3) or more churches shall constitute a quorum to transact business for the Association, but any less number may adjourn from time to time.

4. A member wishing to speak in conference shall arise and address the Moderator, and shall be recognized by him, and shall not be allowed to speak longer than five minutes nor more than twice on the same subject without the consent of the conference.

5. New churches may be admitted to this Association by a majority vote of the Association.

6. The yeas and nays may be taken on any question when requested by one-third of the members present.

7. A committee of five lay members, delegates present at the Association, shall be elected to look into the standing of the ministry of the Association, and shall report to the Association before it adjourns, for approval.

8. No one shall be ordained to the ministry in this Association until they have carried preacher's license at least one "ear and must receive a call to pastor some church or be active in evangelistic efforts. The call for ordination must come from the church that called him or her to pastor it or from the church in which he or she holds membership.

9. All committees or a Committee on Committees shall be appointed by the Moderator or Assistant Moderator, unless otherwise provided for by the Association.

10. Whenever practicable, all business of importance coming before the local churches shall be decided by secret ballot, a majority vote shall decide.

11. It shall be the duty of the churches of this Association to collect, during the month of July each year, a sum of money not less than ten cents (10c) per member, to comply with the Budget System enacted by the Missouri State Association, and all of the money collected to be turned over to the Treasurer of

this Association, who shall send half to the Treasurer of the State Association. It shall be the pastor's duty to see that this "budget" of ten cents per member is collected and turned in so it will be on hand for associational expenses.

12. It shall be the duty of the preachers and the churches of this Association to try to work in harmony with the Home Mission Board of this Association.

13. A request from the church that a brother or a sister be examined for license or ordination to preach the Gospel shall not mean that he or she shall be licensed or ordained, but that a council be appointed to examine him or her, and if, after examination, the council thinks best, he or she may be licensed or ordained.

14. Any preacher belonging to this Association who does not make a report of his or her work, either in person, by letter, or by proxy, for three successive years, shall have his or her name dropped from the minutes.

, 15. It shall be the duty of each church of this Association to have its pastoral year end with the annual session of the Association, and to hold its annual business meeting before the Association meets each year.

16. When a church fails to report to the Association, its last report shall be carried in the minutes.

17. All old afflicted ministers, who so desire, may be enrolled on a superannuated list, and not be required to report to the Association in order to receive an Annual Certificate of Ministerial Standing.

18. It shall be the duty of the preachers belonging to this Association to present their ordination papers to the Clerk, that a correct copy can be secured and become a part of our permanent record for future reference and use.

19. No one shall be licensed or ordained to preach the gospel, or deacon ordained, who is a user of tobacco.

20. These By-Laws may be amended at any session of this Association by a two-thirds vote of the members present.

## FREE WILL BAPTIST ARTICLES OF FAITH

1. THE BIBLE.— The Scriptures of the Old and New Testaments were given by inspiration of God, and are our infallible rule of faith and practice.

2. GOD — There is one living and true God, revealed in nature as the Creator. Preserver, and Righteous Governor of the universe, and in the Scriptures as the Father. Son and Holy Ghost. yet as one God, infinitely wise and good, whom all intelligent creatures are supremely to love, adore and obey.

3. CHRIST.— Christ is God manifest in the flesh; in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified, He is now risen and glorified and is our ever present Savior and Lord.

4. THE HOLY SPIRIT.— The Scriptures assign to the Holy Spirit all the attributes of God. He is the Reprover. Com forter, Guide and Sanctifier of men.

5. THE GOVERNMENT OF GOD.— God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts of grace, not otherwise provided for, as the highest welfare of man requires.

6. THE SINFULNESS OF MAN.— Man was created innocent, but by disobedience fell into a state of sin and condemnation. His posterity, therefore, inherited a fallen nature of such tendencies that all who come to years of accountability sin, and become guilty before God.

7. THE WORK OF CHRIST.— The Son of God, by His incarnation, life, sufferings, death and ressurrection affected for all a redemption from sin that is full and free and is the ground of salvation by faith.

8. THE TERMS OF SALVATION — The conditions of salvation are: 1. Repentance or sincere sorrow for sin and the hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Savior and Lord, with purpose to love and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit, freed from the dominion of sin and becomes a child of God. 3. Continuance in faith and obedience until death.

9. ELECTION.— God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ men become His elect

10. FREEDOM OF WILL.— The human will is free and selfcontrolled, having power to yield to the influence of the truth and the Spirit and live, or to resist them and perish.

11. SALVATION FREE.—God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take of the water of Life freely.

12. PERSEVERANCE.— All believers in Christ, who through grace, persevere in holiness to the end of life, have the promise of eternal salvation.

13. GOSPEL ORDINANCES — *Baptism.* or the immersion of believers in water, and the *Lord's Supper*, are ordinances to be perpetuated under the Gospel: *Feet Washing*, an ordinance teaching humility, of universal obligation, and to be administered to all true believers.

14. THE CHRISTIAN SABBATH. The divine law requires that one day in seven be set apart from secular employments and amusements, for rest, worship, holy works, and activities, and for personal communion with God.

15. WAR.— War destroys the lives of the innocent, and is contrary to the New Testament, therefore, we are opposed to war.

16. RESURRECTION. JUDGEMENT, AND FINAL RETRI-BUTION.— The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done evil unto the resurrection of damnation; then the wicked shall "go away into eternal punishmen" but the righteous into eternal life."
