#### PROCEEDINGS

# Tuesday Evening-July 31, 1962

The Fifty-fourth Annual Session of the Central Western Missouri Association of Free Will Baptists convened with the Verdella church, Liberal, Missouri. The service opened with congregational singing led by Sis. Iona Mae Phillips with Sis. Joyce Davis at the piano. We sang "We're Marching to Zion" and "Heavenly Sunlight." Bro. Roger Phillips, member of the host church, welcomed the Association.

The clerk declared a quorum present and the Association in session for business and called the assistant moderator, Rev. Glenn Rehkop, to the chair. Rev. Rehkop read and commented on Romans 12:1-16. Another number, "Praise Him, Praise Him" was sung, after which an offering of \$28.73 was taken.

Rev. Rehkop presented Rev. Harry Beatty, our State Promotional Secretary, as speaker of the evening. Rev. Junior Ussery led our thoughts in prayer. The Scripture read was from Acts 10 and 11. #### LEAGUE CONSTITUTION

Article 1.—The organization shall be known as the Central Western Missouri League Convention, to be composed of the Leagues of the Central Western Missouri Association.

Article 2.—The officers of the convention shall be a President, who shall preside over all League rallys and meetings and appoint all committees; a Vice-President, who shall preside over the meeting in the absence of the President and generally assist in the supervision of the work, and a Secretary-Treasurer, who shall record proceedings of all meetings, edit minutes, send an annual report to the State League Convention, and give an accurate account of all funds received and disbursed.

Section 2.—These officers shall compose the Executive Board of the convention.

Section 3.—All officers of this Convention shall be elected at the close of the regular session and shall hold office until the close of the next regular session and any vacancy which might occur may be filled by the Executive Board between sessions.

Article 3.—The standing delegates of this Convention shall be General officers of the Convention, the President and Secretary of each League, and all Free Will Baptist ministers in good standing.

#### **BY-LAWS**

- 1. Representation—Each local League shall be entitled to one (1) delegate for each five (5) members of their League.
- 2. Dues—It shall be the duty of each League to send yearly to the Secretary-Treasurer of the convention an amount equal to twenty cents (20c) per member to be divided as follows; one-half ( $\frac{1}{2}$ ) to be sent to the State League Convention, and the remaining one-half ( $\frac{1}{2}$ ) to be used by the local Convention. The Convention shall pay the expenses (meals and transportation) of the Sword Drill contest winner to the State League Convention.

These By-Laws may be amended or altered at any regular session of the League Convention by a two thirds (%) vote of the members present.

# Friday Morning, August 3, 1962 District Womens' Auxiliary Convention

# Ministèrial Standing:

Having examined individual letters from the following ministers we find them eligible to receive certificates of ministerial standing. The following have asked for letters of recommendation to the East Kansas Association. We recommend that the Association grant this request. Rev. James McAllister and Rev. Junior Ussery. #### Publications:

We the publication committee recommend the following:

- 1. That our churches adopt the Family Plan to the Gem and Contact.
- 2. That our churches purchase their Sunday School literature and supplies from the National Sunday School Board, Nashville, Tenn.
- 3. That our churches purchase their League literature from the National League Board, Nashville, Tenn.
- 4. That our people patronize the Missouri Free Will Baptist Book Store, 3100 Mt. Pleasant St., St. Louis 11, Missouri.
- 5. That we reaffirm our stand for the King James version of the Bible in preference to the New Revised Standard version.
- 6. Whereas the American Bible Society is doing extensive work in translating and distributing the Scriptures in different countries, and whereas this organization has given invaluable service to our missionaries, we recommend that our churches make a special offering to this organization: American Bible Society, 450 Park Avenue, New York 22, New York.
- 7. Whereas our denomination is affiliated with the National Association of Evangelicals, we recommend that our people subscribe to its publication, "Action," price, \$5.00 per year. National Association of Evangelicals, P.O. Box 28, Wheaton, Ill. Signed: Rev. Woodrow Matthews, Edna Hudson, Wilma M. Smith.

#### Missions:

We the Missions committee recommend the following:

- 1. That churches observe November as National Home Missions month, and April as Foreign Missions month, and special emphasis be made in giving at these times.
- 2. We urge that churches see that each member receive the publications, "Mission-grams," and "Heartbeat."
- 3. We recommend that the need of "Cuban Emergency Refuge Fund" , be kept before the people of our churches.
  - 4. We recommend consistent support for all our missionaries.
- 5. That we place systematic emphasis on Missions and individual missionaries in some department of our church work.
- 6. We recommend that the need of our Medical Missions program in Africa be kept before the people. Jean Williams chairman, Thora Grider, Evelyn Rehkop.

#### Christian Education:

- 1. We suggest that each church make a part of its regular program or a given time for the advancement of Christ by our young people.
- 2. We suggest that each church conduct a Vacation Bible School each year.

- 3. We recommend that each church encourage her young people to attend Missouri State Youth Camp and Free Will Baptist Bible College.

#### CONSTITUTION

Article 1—Name and Composition.—This organization shall be known as the Central Western Missouri Association of Free Will Baptists, and shall be composed of such consistent, well-regulated Free Will Baptist churches as shall from time to time unite with the organization and agree to this constitution.

Article 2—Purpose.—The purpose of this organization shall be to unify the work of the various churches of which it is composed, and to promote plans for the extension of the Kingdom of God.

Atricle 3—Representation.—Representation to this Association shall be those who are chosen by the churches of which it is composed; each church to be entitled to one delegate, and each church having twenty-five resident members two delegates, with one delegate for each additional twenty-five resident members or major part thereof, together with all ordained deacons, ordained or licensed ministers and their companions who are members in good standing with the Free Will Baptist church and the church clerks of the churches of this Association, and one delegate from each church represented in a Quarterly Meeting from the Central Western Missouri Association.

Section 2.—A resident member shall be one in good standing who,

if able, discharges his or her obligations to the church. All other members shall be considered non-resident.

Article 4—Discipline.—Should a grievance arise which cannot be properly and satisfactorily settled in the local church, a request may be made to the Association that a council be appointed to advise or arbitrate; the decision of that council to be accepted as final.

Article 5—Officers.—The officers of this Association shall be a Moderator, an Assistant Moderator, a Clerk, an Assistant Clerk, a Treasurer, and a Statistician; all said officers shall be elected annually at the regular session of the Association; and shall hold office until their successors are elected and qualified.

Article 6—Boards.—This Association shall elect a Board of five members of which two shall be ministers, to be elected as follows: the first named for a period of one year, the second for a term of two years, and the fifth for a term of five years. After the first election one member shall be elected each year for a term of five years or until his successor is elected. This Board shall be called the Home Mission and Executive Board of the Central Western Missouri Association, shall act as Trustee of any property of the Association, and shall be the examining council of the Association.

Article 7—Meetings.—This Association shall meet annually at such time and place as shall meet with the approval of the Association, and it shall be the duty of the churches composing it to represent themselves by letter and delegates.

Article 8—Amendments.—This Constitution may be altered or amended at any regular session of this Association by a two-thirds vote of members present, provided proposed alteration or amendment has lain on the table at least one day.

#### BY-LAWS

Article 1. Each annual session of this Association shall be called to order by the Clerk or the Assistant Clerk, or in his or her absence the standing member having seniority in years of service. After the clerk or the one calling the assembly to order shall declare a quorum he or she shall call the Moderator to the chair, or in his or her absence the standing member having seniority in years of service.

Article 2. Each session of this Association shall be opened and closed with prayer.

Article 3. Delegates equal in number to the number of active churches and representing at least a simple majority of the active churches shall constitute a quorum to transact business for the Association, but any less number shall adjourn.

Article 4. Regular Parliamentary procedure as set forth in Roberts' "Rules of Order" shall be followed. The method of voting shall be determined by the moderator unless one-third of the voters present dissent. No one shall be allowed to speak more than five minutes nor more than twice on the same subject without the consent of the Conference.

Article 5.—Section 1—The first item of business of the Association shall be to receive the church letters and seat the delegates. However, business shall not be suspended to wait for late or delayed letters. Such letters shall be received upon their arrival and their delegates seated.

Section 2.—Item 1.—The election of the officers of this Association shall be held at the closing business session of the regular session of the Association. They shall hold office until their successors are elected.

Section 2.—Item 2.—The Clerk-Treasurer shall supervise the printing of the minutes for the year of which they were Clerk-Treasurer.

Section 3. The second item of business of the Association shall be the report of the Executive Board.

Article 6. All Committees or a Committee on Committees shall be appointed by the Moderator.

Article 7. It shall be the right of each church of the Association to determine its own pastoral year. We urge that each church have its business year end on June 30th.

Article 8. A committee of five lay members, qualified delegates to the Association, shall be chosen to look into the standing of the ministry of the Association and shall report to the Association for approval before adjournment.

Article 9. It shall be the duty of the churches of the Association to accompany their church letter with three dollars (\$3.00) per church plus twenty-five cents (25c) per resident member for the Central Western Missouri Association Fund to be allocated thus: 15% for Missouri State Association General Fund, 15% honorarium for Central Western Missouri Associational Clerk, and 70% for Central Western Missouri Associational Expense.

Article 10.—Section 1.—No one shall be ordained to the ministry in this Association until they have carried a minister's license two years, or major fraction of the second year, and must be currently performing the duties of pastor of an organized group.

Section 2. Examination for ordination to the ministry may be carried out at the regular session of the Association, or as otherwise directed by the Association. Examination for license or for ordination (both ministers and deacons) to be done at a time and place agreeable to both candidate and examining council. Ordination may be carried out in the local church (if desired) subsequent to examination and favorable action of the examining council.

Article 11. No one shall be licensed or ordained in this Association who is a user of tobacco, alcohol, or who cannot qualify according to I Timothy 3:1-12 and Titus 1:6-9.

Article 12.—Section 1.—It shall be required of the ministry of this Association to adhere to sound doctrine in both preaching and practice as embraced in our Treatise of Faith and Practice. It shall further be the duty of the active ministers to report each year by letter and at least once in three years in person. Ministers in the Armed Forces shall not be required to report in person during their term of service. All ministers meeting these requirements shall be granted a Certificate of Ministerial Standing when and if approved by the appointed Committee on Ministerial Standing.

Section 2. All aged or afflicted ministers, who so desire, may be enrolled on the superannuated list, not being required to report to the Association in order to have a Certificate.

Article 13. These By-Laws may be altered or amended at any session of this Association by a two-thirds vote of members present.
