## **PROCEEDINGS**

## Tuesday Evening, July 30, 1974

The worship service began with congregational singing, led by Roger Phillips, with Virginia Bunton at the piano. Bro. Bob Dickey led in prayer.

The Clerk officially convened the business session by declaring a quorum present to transact business, and calling the Moderator, Charlie Hoover, to the chair.

The Moderator read some appropriate Scripture, and made some preliminary comments, relative to the necessity of maintaining harmony and love, in order to experience spiritual blessing and progress desired.

Vonda Johnson sang "I Can Make It After All," accompanying herself on the piano. The congregation joined in singing, "We've a Story to Tell to the Nations." Bro. Hollis Walker led in prayer, and an offering was received for associational expense, amounting to \$19.20.

Bro. Fidell Bridges was called to the pulpit to bring the message of the evening. He took a text from John 21:6, in keeping with the theme of the association "Cast Your Net." His message was relevant to the times, and his admonitions encouraging, in light of the promises of God.

Following the worship service, the Moderator took charge to make announcements concerning the business of the following day, and called for the benediction.

#### Wednesday Morning, 9:45, July 31, 1974

Devotional service opened with congregational singing "'Tis So Sweet to Trust in Jesus," led by Roger Phillips, with Jan Cross at the piano.

Bro. Steve Burton read from Matt. 13.47 as a basis for his devotional thoughts, and called on Bro. Andy Lay to lead in prayer. He made timely remarks on what God expects of His people, and how we may expect to accomplish the task.

Moderator, Charlie Hoover, called the meeting to order for business, and asked Bro. Bob Dickey to read the By-Laws.

Church letters were read, and delegates seated. Business proceeded, with the first item of business being the reading of a Petitionary Letter, from the newly organized Evangel Free Will Baptist Church of Webb City, Mo., requesting membership in the Central Western Missouri Free Will Baptist Association.

The Moderator called on Bro. Andy Lay, pastor of the new church, to give a more detailed verbal report, of their work and the progress being made. The work is progressing real well, and the future is bright.

M/S/C to accept Evangel Church into the fellowship of the

Central Western Missouri Free Will Baptist Association.

Report of Executive Board was read. M/S/C to receive report. Bro. Bob Dickey, Executive Board member, was given time to give a verbal report on progress of the effort being made to establish a Home Mission work, within the bounds of the Central Western Missouri Association, in towns where there is no Free Will Baptist church. He discussed some of the problems encountered, in making a decision on the location, and also the selection of the right man for the work.

Report of the Treasurer was read. M/S/C to receive report. Report of the Statistician read. M/S/C to receive report. Business session was adjourned at this time for worship.

# Wednesday Morning Worship, 11:00 A. M.

The congregation joined in singing "Oh Happy Day," and "Victory in Jesus," led by Roger Phillips, with Jan Cross at the piano. The Moderator asked that an offering be taken for expenses of the association, as the congregation sang "Near to the Heart of God." \$39.90 was received.

A beautiful number "Just Suppose," was sung by Patricia Pitts. Bro. Russell Johnson, speaker, took the stand and brought a soul searching message, using passages from the book of Rev., as a basis for his thoughts. He challenged, and encouraged the Church to more dedicated and zealous living in the face of all the satanic influences of this present day.

At the conclusion of the message, the Moderator made some announcements, then called for the benediction and blessing on the noon meal.

# Ministers Conference, Wednesday, 1:30 P. M., July 31, 1974

"To God Be the Glory," was sung, led by Roger Phillips, with Jan Cross at the piano. Bro. Steve Burton read from Romans 8:35-37 as a basis for the subject to be discussed in the hour to follow.

The importance of perseverance, as a convincing testimony to the world, was stressed as the following ministers discussed the different aspects of suffering for Christ: Revs. Bob Dickey, Thayne Fast, Morgan Walker, Hollis Walker, Russell Johnson, Steve Burton, and Lowell Martin.

Rev. Bob Dickey discussed the necessity of our being able to persevere, and undergo tribulation in a way that would prove the undergirding strength Christ can provide. He sighted Romans 5 and

Acts 14 as Scriptures which can provide sustaining grace. Rev. Thayne Fast emphasized the importance of the Christian

remaining faithful through distress, as a confirming testimony to the keeping power of the Holy Spirit.

Rev. Lowell Martin used the life of Paul as an example of the possibility of triumphing over persecution, through the abundant mercy and grace offered. God provides all the grace necessary to help us overcome. She quoted Scripture to prove the necessity of our suffering for Him, if we expect to reign with Him.

She gave a suggestion she once heard, as a way to help the Christian prevail over the perplexing problems of life. "To help minimize our adversities, we should magnify our glorious hope of

the future."

Rev. Morgan Walker discussed the element of famine, with re-

gard to our Christian growth. He pointed out the fact that our lives are nurtured by God, thus making it impossible for us to be completely vulnerable to the onslaughts of the enemy of the soul, either physically or spiritually. He is the sustenance of life.

Rev. Hollis Walker used Gen. 2, as a clarification of the word nakedness, as the subject is being considered. The word might be dealt with, both as the consequence of misfortune, and also as a condition, contrary to Christian beliefs, found in our society today.

The element of nakedness, both physically and spiritually, as dealt with in Genesis, brought out the fact that we were created in a perfect condition, in the Garden of Eden, and our nakedness was no cause for shame. Through the influence of satan our foreparents fell prey, and thus inherited the Adamic nature, which makes it necessary for us to have a covering for our nakedness both physically and spiritually.

Rev. Russell Johnson spoke on perils, as a condition the Christian may expect to face, even more as time goes on, in the light of warning God gives in 2 Tim. 3. He recalled incidents and related many passages of Scripture to substantiate the fact that God's grace will always be available to His people to escape the judgement, that God has told us will most certainly come on earth.

Rev. Steve Burton discussed the sword, as a condition the Christian will face symbolically, if not literally. He sighted Scriptures which may be applied to our life as a fortification against militant onslaughts of satanic forces.

The endurance of the Apostle Paul was referred to again as an example of one who lived a victorious life, over threats of the sword. Also Paul offered a new outlook on life for the child of God, in that he brought out the fact that for one to live is Christ but to die is gain.

At the conclusion of the Ministers Conference, a recess was declared by the Moderator, before the Sunday School and C. T. S. Convention.

# Wednesday Afternoon, 3:00 P. M., July 31, 1974 SUNDAY SCHOOL and C. T. S.

The Convention was convened, and Becky York sang a beautiful number, "The King is Coming," accompanied by Ramona York.

The President, Bro. Bob Dickey, took charge and called three Sunday School teachers, Bro. Dale Pitts, Roger Phillips, and Hazel Fleeman, to the pulpit to discuss different teaching techniques they use, or might think helpful in getting the lesson across, and help hold the attention of the class.

## PETITIONARY LETTER

Greetings, in the name of the Lord Jesus:

We, of the Evangel Free Will Baptist Church of Webb City, Missouri formally organized as a Free Will Baptist Church on July 21, 1974, in accordance with the rules set forth in the TREATISE OF FAITH AND PRACTICES OF THE ORIGINAL FREE WILL BAPTISTS.

We adopted the Bible as our rule of faith and practice and adopted the Free Will Baptist Church Covenant. Brother and Sister Charlie Hoover, Brother and Sister Russell Johnson, and Brother Roger Phillips extended the right hand of fellowship to us.

We organized with 17 members on July 21, 1974, but have 13 other Christians worshiping with us regularly who will join our fellowship within the month. Some are on vacation and some have been out with illness.

We have adopted the Missouri State Cooperative Plan of giving to the world wide ministry of Free Will Baptists, by designating 10% of our general fund offerings for that purpose and feel keenly the responsibility that is ours to evangelize our community with the Gospel of the Lord Jesus Christ.

We now formally petition the Central Western Association of Free Will Baptists for membership, with the desire to fellowship with our Free Will Baptist brethren in your churches and to aid you in your projects of world evangelism.

# CONSTITUTION

Article 1—Name and Composition.—This organization shall be known as the Central Western Missouri Association of Free Will Baptists, and shall be composed of such consistent, well-regulated Free Will Baptist churches as shall from time to time unite with the organization and agree to this constitution.

Article 2—Purpose.—The purpose of this organization shall be to unify the work of the various churches of which it is composed, and to promote plans for the extension of the Kingdom of God.

Article 3—Representation.—Representation to this Association shall be those who are chosen by the churches of which it is composed; each church to be entitled to one delegate, and each church having twenty-five resident members, two delegates, with one delegate for each additional twenty-five members or major part thereof,

together with all ordained deacons, ordained or licensed ministers and their companions who are members in good standing with the Free Will Baptist church and the church clerks of the churches in this Association, and one delegate from each church represented in a Quarterly Meeting from the Central Western Missouri Association.

Section 2.—A resident member shall be one in good standing who, if able, discharges his or her obligations to the church. All other

members shall be considered non-resident.

Article 4—Discipline.—Should a grievance arise which cannot be properly and satisfactorily settled in the local church, a request may be made to the Association that a council be appointed to advise or arbitrate; the decision of that council to be accepted as final.

Article 5—Officers.—The officers of this Association shall be a Moderator, an Assistant Moderator, a Clerk, an Assistant Clerk, a Treasurer, and a Statistician; all said officers shall be elected annually at the regular session of the Association; and shall hold office

until their successors are elected and qualified.

Article 6—Boards.—This Association shall elect a Board of five members of which two shall be ministers, to be elected as follows: The first named for a period of one year, the second for a term of two years, and the fifth for a term of five years. After the first election one member shall be elected each year for a term of five years or until his successor is elected. This Board shall be called the Home Mission and Executive Board of the Central Western Missouri Association, shall act as Trustee of any property of the Association, and shall be the examining council of the Association.

Article 7—Meetings.—This Association shall meet annually on Tuesday night following the 4th Sunday in July, and it shall be the duty of the churches composing it to represent themselves by letter

and delegate.

Article 8—Program.—It shall be the duty of the Executive Board

to plan and carry out the program of the Association.

Article 9—Amendments.—This Constitution may be altered or amended at any regular session of this Association by a two-thirds vote of members present, provided notice of proposed alteration or amendments has been given to the church clerks of the member churches by the Executive Board 30 days prior to Association meeting.

#### **BY-LAWS**

Article 1.—Each annual session of this Association shall be called to order by the Clerk or the Assistant Clerk, or in his or her absence the standing member having seniority in years of service. After the clerk or the one calling the assembly to order shall declare a quorum he or she shall call the Moderator to the chair, or in his or her absence the standing member having seniority in years of service.

Article 2.—Each session of this Association shall be open and

closed with prayer.

Article 3.—Delegates equal in number to the number of active churches and representing at least a simple majority of active churches shall constitute a quorum to transact business for the Association, but any less number shall adjourn.

Article 4.—Regular Parliamentary procedure as set forth in "Robert's Rules of Order" shall be followed. The method of voting shall be determined by the Moderator unless one-third of the voters

present dissent. No one shall be allowed to speak more than five minutes nor more than twice on the same subject without the consent of the Conference.

Article 5—Section 1.—The first item of business of the Association shall be to receive the church letters and seat the delegates. However, business shall not be suspended to wait for late or delayed letters. Such letters shall be received upon their arrival and their delegates seated.

Section 2—Item 1.—The election of the officers of this Association shall be held at the closing business session of the regular session of the Association. They shall hold office until their successors are elected.

Section 2—Item 2.—The Clerk-Treasurer shall supervise the printing of the minutes for the year of which they were Clerk-Treasurer.

Section 3.—The second item of business of the Association shall be the report of the Executive Board,

Article 6.—All committees or a Committee on Committees shall be

appointed by the Moderator.

Article 7.—It shall be the right of each church of the Association to determine its own pastoral year. We urge that each church have its business year end on June 30th.

Article 8.—A committee of five lay members, qualified delegates to the Association, shall be chosen to look into the standing of the ministry of the Association and shall report to the Association for approval before adjournment.

Article 9—Section 1.—It shall be the duty of the churches of the Association to accompany their church letter with five dollars (\$5.00) per church plus fifty cents (50c) per resident member for the Central Western Missouri Association fund to be allocated thus: 15 per cent for honorarium for Associational Clerk, and 85 per cent for the Central Western Missouri Associational expense.

Section 2.—The Associational Clerk is to reimburse our general board member from this Association to the State Association for gas,

lodging and food per receipts.

Article 10—Section 1.—No one shall be ordained to the ministry in the Association until they have carried a license two years, or should they be called to pastor a church they may be ordained in

one year.

Section 2.—Examination for ordination to the ministry may be carried out at the regular session of the Association, or as otherwise directed by the Association. Examination for license or for ordination (both ministers and deacons) to be done at a time and place agreeable to both candidates and examining council. Ordination may be carried out in the local church (if desired) subsequent to examination and favorable action of the examining council.

Article 11.—No one shall be licensed or ordained in this Association who is a user of tobacco, alcohol, or who cannot qualify accord-

ing to I Timothy 3:1-12 and Titus 1:6-9.

Article 12—Section 1.—It shall be required of the ministry of this Association to adhere to sound doctrine in both preaching and practice as embraced in our Treatise of Faith and Practice. It shall further be the duty of the active ministries to report each year by letter and at least once in three years in person. Ministers in the Armed

Forces shall not be required to report in person during their term of service. All ministers meeting these requirements shall be granted a Certificate of Ministerial Standing when and if approved by the appointed Committee on Ministerial Standing.

Section 2.—All aged or afflicted ministers, who so desire, may be enrolled on the superannuated list, not being required to report to

the Association in order to have a Certificate.

Article 13.—These By-Laws may be altered or amended at any session of the Association by a two-thirds vote of members present, providing that a notice of proposed change has been given to the church clerks of the member churches by the Executive Board 30 days prior to the Association meeting.

#### CHURCH CONVENANT

Having given ourselves to God, by faith in Jesus Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We promise by His grace to love and obey Him in all things, to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to provide things honest in the sight of all men.

We agree faithfully to discharge our obligations in reference to study of the Scriptures, secret prayer, family devotions, and social worship and by self-denial, faith, and good works endeavor to grow in grace and in the knowledge of our Lord and Savior Jesus Christ.

We will not forsake the assembling of ourselves together for church conferences, public worship, and the observance of the ordinances of the gospel, nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able, promote the success of the church and of the Gospel.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influences of Christ in society; constantly praying and toiling that the Kingdom of God may come, and His will be done on earth as it is in Heaven.

To this end we agree to labor for the promotion of education and denominational enterprises, the support of missions, the success of Sunday schools, and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.
