REPORT OF EXECUTIVE BOARD FROM MARCH 27, 1981 TO APRIL 2, 1982

Moderator - Charlie Hoover; Assistant Chairman - John Bough; Secretary-Treasurer - Phillip Munn; Assistant Secretary-Treasurer - Roger Phillips.

March 27, 1981: First F.W.B. Church at ElDorado. The meeting was held during the Association to except the resignation of Rev. John McClure and to give him a vote of confidence. There was a discussion of the financial status of the Mission with the possibility of reversing the obligations.

March 28, 1981: After the Association closed the Board met to organize for the following year. The officers named above were nominated, and voted in for the coming year. The program committee will be Charlie Hoover and Phillip Munn.

April 11, 1981: Stockton F.W.B. Church. A special meeting was called to discuss the operation of the Mission. The Board decided to pay the up-keep on the Mission and allow the Mission to pay for the Pastor. When the Associations account reaches an excess of \$500.00 all over that amount will be given to the Mission for debt retirement.

May 16, 1981: Stockton F.W.B. Church. A special meeting was held to officially recognize Rev. Fidell Bridges as the new Pastor of the Mission. It was voted to pay Rev. John McClure 2 weeks vacation pay which would pay him thru the end of May and to have Rev. Bridges to start on May 24th.

Rev. Bridges presented a plan for the operation of the Mission: There will be 3 types of funds (1) Operating (2) Debt Retirement and (3) Surplus. His salary will be a maximum of \$100.00 weekly and \$250.00 a month for housing allowance. If the offering of the Mission does not meet the above criteria, he may draw from the Surplus Fund which is deposited to when there is an excess in the Sunday offering.

The weekly Sunday offering is deposited to the Operating Fund and distributed as follows:

10% to Home Missions

5% to Operating Expense

Maximum of \$100.00 salary & \$57.69 for housing to the Pastor weekly. Remainder goes to the Surplus Fund.

The Debt Retirement Fund is paid into by the Executive Board to be used to pay the monthly bills of the Mission.

June 6, 1981: Verdella F.W.B. Church. The Board met at the conclusion of the Quarterly meeting. Rev. Steve Shaw from the Evangel F.W.B. Church ask the Board to set a time to examine Bro. Brent Thompson and Bro. Bob Gilman.

September 5, 1981: Bethel F.W.B. Church. The Board met at the conclusion of the quarterly meeting. The Board examined Rev. Bill Swearingen from the Bethel F.W.B. Church and issued him a card of standing with our Association. The Board also examined and voted to except Brothers Brent Thompson and Bob Gilman as Deacons in the Evangel F.W.B. Church.

Rev. Fidell Bridges gave a report on the Mission and a discussion followed on organizing the Mission into a Church.

December 5, 1981: Evangel F.W.B. Church. The Board met at the conclusion of the quarterly meeting. A special meeting was set for January 9, 1982 at 7:00 p.m. at Hannon to plan the Annual Association Program.

The Youth Camp cabin was discussed either to expand the boy's cabin or a possibility of purchasing the adjoining cabin.

January 9, 1982: Hannon Free Will Baptist Church. This meeting was held to plan the program for the yearly Association, when it convenes April 2 & 3 of 1982. Reports were read, approved and accepted. Bethel submitted a letter for Rev. Swearingen to finish out the term as their member of the Executive Board.

Rev. Bridges reported that the Stockton Mission is now 77% self supporting and will be paid off December 10, 1986. A vote was taken to let Stockton organize into a church.

The Youth Camp Cabin Project was discussed and also insurance for the cabins. The program was planned for the Annual Association Meeting, with Friday night services to start at 7:00 p.m. and Saturday night services to start at 6:30 p.m. The offerings taken on Friday and Saturday night will go the speakers. The Churches are to be notified of a by-law change on Article 9: Section 1:

It shall be the duty of the churches of the Association to accompany their church letter with twenty dollars (\$20.00) per church plus fifty cents (50¢) per resident member for the Central Western Missouri Association. Funds to allocated thus: five dollars (\$5.00) to the Missouri State Association of Free Will Baptist; ten dollars (\$10.00) to the National Association of Free Will Baptist; with the remaining amount, 15% for honorarium for Associational Clerk, and 85% for the Central Western Missouri Association expense.

However the additional amount will have to paid this year in order that the churches in our Association will be seated at the State & National Association Meetings. At the conclusion of the business meeting refreshments were served, and a time of fellowship was enjoyed by all.

# CONSTITUTION

Article 1: Name and Composition. This organization shall be known as the Central Western Missouri Association of Free Will Baptists, and shall be composed of such consistent, well-regulated Free Will Baptist churches as shall ifrom time to time unite with the organization and agree to this constitution.

Article 2: Purpose. The purpose of this organization shall be to unify the work of the various churches of which it is composed, and to promote plans for the extension of the Kingdom of God.

Article 3: Representation. Representation to this Association shall be those who are chosen by the churches of which it is composed; each church to be entitled to one delegate, and each church having twenty-five resident members, two delegates, with one delegate for each additional twenty-five members or major part thereof, together with all ordained deacons, ordained or licensed ministers and their companions who are members in good standing with the Free Will Baptist Church and the church clerks of the churches in this Association, and one delegate from each church represented in a Quarterly Meeting from the Central Western Missouri Association.

Section 2: A resident member shall be one in good standing who, if able, discharges his or her obligations to the church. All other member shall be considered non-resident.

Article 4: Discipline. Should a grievance arise which cannot be properly and satisfactorily settled in the local church, a request may be made to the Association that a council be appointed to advise or arbitrate; the decision of that council to be accepted as final.

Article 5: Officer. The officers of this Association shall be a Moderator, an Assistant Moderator, a Clerk, an Assistant Cler, a Treasurer, and Statistician; all said officers shall be elected annually at the regular session of the Association; and shall hold office until their successors are elected and qualified.

Article 6: Boards. This Association shall maintain a Board, to be known as the Home Mission and Executive Board of the Central Western Missouri Association. This Board shall be made up of one ordained person from each church. If an ordained representative is not available, a church may recommend a nonordained person, who otherwise meets the qualifications for ordination stated in these By-Laws. Such members shall be elected by the Association, with consideration given to the nominees submitted by their churches.

One third of the members of this board shall be elected each year, for a three year term of office. (The churches shall be listed alphabetically with the first third and fraction, if any, elected for a one year term; the second third and fraction, if any, elected for a two year term; and the third elected for a three year term.

The duties of this board shall be: to serve as trustees of any, and all, property belonging to the association; to serve as the examining council of the Association; to promote, and oversee Home Mission work within the Association; to act upon any expedient business of the Association that may arise between meetings of the Association. The board must have at least a simple majority present to officially conduct business.

Article 7: This Association shall meet annually on Friday, following the fourth Sunday in March, and continue through Saturday night. It shall be the duty of the churches composing it to represent themselves by letter and delegate.

Article 8: Program. It shall be the duty of the Executive Board to plan and carry out the program of the Association.

Article 9: Amendments. This Constitution may be altered or amended at any regular session of this Association by a two-thirds vote of members present, provided notice of proposed alteration of amendments has been given to the church clerks of the member churches by the Executive Board 30 days prior to Association meeting.

#### BY-LAWS

Article 1: Each annual session of this Association shall be called to order by the Clerk or the Assistant Clerk, or in his or her absence the standing member having seniority in years of service. After the clerk of the one calling the assembly to order shall declare a quorum, he or she shall call the Moderator to the chair, or in his or her absence the standing member having seniority in years of service.

Article 2: Each session of this Association shall be open and closed with prayer.

Article 3: Delegates equal in number to the number of active churches and representing at least a simple majority of active churches shall constitute a quorum to transact business for the Association, but any less number shall adjourn.

Article 4: Regular Parliamentary procedure as set forth in "Robert's Rules of Order" shall be followed. The method of voting shall be determined by the Moderator unless one-third of the voters present dissent. No one shall be allowed to speak more than five minutes nor more than twice on the same subject without the consent of the Conference.

Article 5: Section 1: The first item of business of the Association shall be to receive the church letters and seat the delegates. However, business shall not be suspended to wait for late or delayed letters. Such letters shall be received upon their arrival and their delegated seated.

Section 2: Item 1: The election of the officers of this Association shall be held at the closing business session of the regular session of the Association. They shall hold office until their successors are elected.

Section 2: Item 2: The Cler-Treasurer shall supervise the printing of the minutes for the year of which they were Clerk-Treasurer.

Section 3: The second item of business of the Association shall be the report of the Executive Board.

Article 6: All committees or a Committee on Committees shall be apointed by the Moderator.

Article 7: It shall be the right of each church in the Association to determine its own fiscal year. We suggest March 1st to February 20 or 29.

Article 8: A committee of five lay members, qualified delegates to the Association, shall be chosen to look into the standing of the ministry of the Association and shall report to the Association for approval before adjournment.

Article 9: Section 1: It shall be the duty of the churches of the Association to accompany their church letter with five dollars (\$5.00) per church plus fifty cents (50¢) per resident member for the Central Western Missouri Association fund to be allocated thus: 15 per cent for honorarium for Associational expense.

Section 2: The Associational Clerk is to reimburse our general board member from this Association to the State Association for gas, lodging and food, per receipts.

Article 10: Section 1: No one shall be ordained to the ministry in the Association until they have carried a license two years, or should they be called to pastor a church, they may be ordained in one year.

Section 2: Examination for ordination to the ministry may be carried out at the regular session of the Association, or as otherwise directed by the Association. Examination for license of for ordination (both ministers and deacons) to be done at a time and place agreeable to both candidates and examining council. Ordination may be carried out in the local church (if desired) subsequent to examination and favorable action of the examining council.

Article ll: No one shall be licensed or ordained in this Association who is a user of Tobacco, alcohol, or who cannot qualify according to 1 Timothy 33:1-12 and Titus 1:6-9.

Article 12: Section 1: It shall be required of the ministry of this Association to adhere to sound doctrine in both preaching and practice as embraced in our Threatise of Faith and Practice. It shall further be the duty of the active ministries to report each year by letter and at least once in three years in person. Ministers in the Armed Forces shall not be required to report in person during their term of service. All ministers meeting these requirements shall be granted a Certificate of Ministerial Standing when and if approved by the appointed Committee on Ministerial Standing.

Section 2: All aged or afflicted ministers, who so desire, may be enrolled on the superannuated list, not being required to report to the Association in order to have a Certificate.

Article 13: These By-Laws may be altered or amended at any session of the Association by a two-thirds vote of members present, providing that a notice of proposed change has been given to the church clerks of the member churches by the Executive Board 30 days prior to the Association meeting.

# CHURCH COVENANT

Having given ourselves to God, by faith in Jesus Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We promise by His grace to love and obey Him in all things, to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to provide things honest in the sight of all men.

We agree faithfully to discharge our obligations in reference to study of the Scriptures, secret prayer, family devotions, and social worship and by self-denial, faith, and good works endeavor to grow in grace and in the knowledge of our Lord and Savior Jesus Christ.

We will not forsake the assembling of ourselves together for church conferences, public worship, and the observance of the ordinances of the gospel, nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicated, admonish the erring, and as far as we are able, promote the success of the church and of the Gospel.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influences of Christ in society; constantly praying and toiling that the Kingdom of God may come, and His will be done on earth as it is in Heaven.

To this end we agree to labor for the promotion of education and denominational enterprises, the support of missions, the success of Sunday schools, and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.
