FIFTH ANNUAL MEETING OF THE COASTAL ASSOCIATION

The Annual meeting of the Coastal Association of Free Will Baptists convened with the Five Points Free Will Baptists Church, Pinetown, N. C., on September 16-17, 1966. There was good attendance at the opening session, a good representation of Delegates present from the Seventeen Churches represented. The Association was opened with a devotional service led by Bro. Roger Tripp of the Union Chapel Church. The Clerk declared the Session opened for the transaction of business, and read the By-Laws of the Association. Following this he introduced the Moderator for the Session, Rev. T. O. Terry.

The Moderator gave his message to the Association, and then declared it ready for the transaction of business. The Clerk read the list of Delegates from the various Churches represented, and on motion and second these were seated. The Moderator then recognized the following as visitors to this meeting of the Association, Bro. Bobby Aycock from Brazil, Bro. Freeman Edwards from Ahoskie, Bro. Johnny Eason from Davis, Bro. Roger Russell from Columbia, Bro. Ronald Creech from Durham, and Bro. Charles Keith from Durham. Following this the Moderator appointed the following to serve on the Committee on Committees, Bro. Billy Gene Outland Chairman, Bro. Joseph Haley, and Bro. Romain Gaskill.

The Moderator then called for Petitionary letters from Churches and Ministers who were seeking membership in the Association. The Clerk read a letter from the Sunset Park Mission in Wilmington, N. C., requesting membership in the Coastal on a Fraternal basis until such time as they were organized into a Church. On motion and second this request was granted. Requests from Brother Roger Russell and Frank H. Dunn for membership in the Coastal were turned over to the Examining Board for further action. The Clerk read a request from the First District Quarterly Meeting of South Carolina requesting a letter for Bro. Tommy Godley who had taken membership with their Union. On motion and second this request was granted.

The Committee on Committees then gave a partial report at this time. On motion and second this partial report was adopted. On motion and second the Digest Committee was instructed to bring back before the body a general report on the Condition of the Churches in the Association rather than a detail report which involved many figures of finance which would be published in the statistical report in the Minutes. It was brought to the attention of the Body that Bro. Roger Anderson had left the Denomination and took membership in another body. On motion and second his name was dropped from the roll of Ministers in the Association.

The Examining Board then gave their report, and on motion and second this report was adopted. The following were recommended by the Board to be placed on the roll of Ministers: Bro. Perry Ham, Bro. Danny F. Padgett, and Bro. Hillary Gaskins for License; Bro. Freeman Edwards, Bro. J. V. Johnson, and Bro. Johnny Eason as Ordained Ministers. Bro. Eldon J. Hollowell having surrendered his Credentials, it was ordered that he be dropped from the roll of Ministers.

The Moderator then declared that the business session was closed and the Association entered into the Worship Hour. Bro. Gene Parisher brought the message at the Worship Service and his very inspiring message challenged our hearts. Following the close of the Worship Service the Moderator declared the session adjourned until 1:15 P.M. The host Church served a delicious picnic lunch which was enjoyed by all.

The Afternoon session was opened with a devotional service led by Bro. M. E. Cox of Hamlet. Following this service business was resumed and the Digest Committee gave their report. On motion and second this

report was adopted. The superannuation Committee then gave their report, on Motion and second this report was adopted. Mrs. Galen Dunbar brought a report from the Women's Auxiliary Convention of the Coastal Association. On motion and second this report was received for informational purposes. The Treasurer gave his report for the Year, on motion and second this report was adopted. The Mission Board then gave their report for the Year. On motion and second this report was adopted.

The Committee on Committees then gave their full report to the Body. On motion and second this report was adopted. The Sunday School Committee gave their report. On motion and second this report was adopted. The Christian Education Committee gave their report; on motion and second this report was adopted. The Finance Committee gave their report; on motion and second this report was adopted. The Church Training Service and Youth Relations Board gave a partial report at this time; on motion and second this partial report was adopted. On motion and second the Clerk was instructed to send a donation of \$50.00 to the next State Association convening in Cramerton in 1967.

Motion and second that we extend a rising vote of thanks to the host Church for their fine hospitality and very enjoyable lunch at the Noon hour. The Moderator then called on some of the visiting Brethren for remarks. Bro. Ronald Creech brought greetings from the State Association and the Free Will Baptist Witness, and encouraged everyone to support the State paper with their news items and subscriptions. Bro. Bobby Aycock brought greetings from the Mission field in Brazil, and Bro. Carl Johnson from the mission field in Alaska. Bro. Thomas Johnson brought greetings from the new Mission in Wilmington, N. C. He told of the work there that had been started recently, and of the plan to purchase a Church in the City of Wilmington, N. C. There being no further business to come before the session, the meeting was closed with Prayer by Bro. Galen Dunbar, with special prayer for the Service Men in Viet Nam.

The Night Session convened at 7:30 P. M. and this was a Missionary Service conducted by the Mission Board of the Coastal Association. Bro. Harold Stevens was the visiting Missionary and brought the message for this service. An offering in the amount of \$135.00 was taken in the service for the Harold Stevens Aircraft Fund.

On Saturday morning the Association reconvened at 9:30 A.M. with a Devotional Service led by Bro. Albert Rollins of Vanceboro. Following this the Moderator declared the Session in order for the transaction of its business. The Clerk read the Minutes of the previous day's session, these were declared approved as read by the Moderator. Delegates were properly seated from two Churches who were not present at the previous day.

The Examining Board then gave their final report. On motion and second this report was adopted. The Resolutions Committee gave their report. Motion and second this report was adopted. The next item of business was the selection of the site for the 1967 Associational Meeting. A request came from the Cove City Free Will Baptist Church to host the meeting in 1967. On motion and second this request was accepted by the Association. The Publications Committee then gave their report. Motion and second this report was adopted.

A recommendation came from the Union Meeting to the Association pertaining to Ministers appearing before the Examining Board of the Association. On motion and second this was tabled until the request could be put in writing by the Committee from the Union Meeting. The Church Training Service and Youth Relations Board then gave their final report. This report consisted of several recommendations. These were acted on separately and all were adopted as recommended except one which dealt with the Camp Registration Fees for 1967. On Motion and second the fees were raised to \$15.00 per camper instead of \$14.00.

The Nominating Committee then gave their report. On Motion and second this report was received. The Association then proceeded to elect its officers for the new year. Bro. Galen Dunbar was elected Moderator, Bro. Billy Gene Outland, Asst. Moderator, and E. A. Mallard, Clerk-Treasurer. Bro. Bobby Potter was elected to a Four Year term on the Executive Board. On motion and second the Clerk was instructed to add a page to the Minutes listing the Ministers of the Association and listing the standing Boards with each member's year of retirement from the board.

On motion and second the recommendation from the Union Meeting was brought from the table to be acted upon. The recommendation was that each new Minister coming into the Coastal Association would be contacted by the Examining Board and notified of a date to appear before the Board for approval. This to be done within Two (2) Months after his arrival in the Coastal Association. On Motion and second this was adopted. Motion and second that this be added to the By-Laws of the Association and was to become part of By-Law No. 17. The By-Laws have been changed accordingly.

On request from the Mission Board and on motion and second a donation of \$100.00 was given to the Sunset Park Mission in Wilmington, N. C. Delegates to the State Association meeting in Cramerton, N. C. in 1967 were selected. Mrs. Luther Reed, and Mrs. Joe Haley. Bro. T. O. Terry was selected to bring the message at the opening day session of the Association in 1967, and the Executive Board was to select an alternate.

There being no further business to come before the session on motion and second the business session was closed, and the Worship Service began. Bro. Freeman Edwards brought a very inspiring message at this service, which was enjoyed by all. Following this the 1966 Session of the Coastal Association was officially closed with prayer by Mrs. Alexander.

REPORT OF THE EXAMINING COMMITTEE

Your Examining Committee of the Coastal Association, composed of T. O. Terry, Chairman, Adam Scott and Luther Reed, members, have held three meetings this church year.

On Friday Night, December 17, 1965 we met at Cardinal Village Church. The meeting was opened with prayer by Luther Reed. Brother Perry Ham, from Emanuel F. W. B. Church and brother Danny F. Padgett, from Calvary F. W. B. Church appeared before us to be examined for license.

We examined them thoroughly about their moral convictions and their doctrinal beliefs. We found their answers to be satisfactory. We recommended that their churches grant them a license to preach the gospel.

The Examining Committee of The Coastal Association met at Sherwood Forest Church, May 19, 1966 for the purpose of examining the following men for acceptance into our Association, brother Freeman Edwards, brother J. V. Johnson and brother Johnny Eason. We examined all in regard to their moral attitudes, doctrinal views and general support of the denominational work.

Their answers were satisfactory and we did approve and recommend that they be accepted into the Coastal Association as ministers of the Gospel. The meeting was opened and closed with prayer.

All the regular elected members were present at this meeting.

The Examining Committee of the Coastal Association met at Cove City Free Will Baptist Church, July 23, 1966. The purpose of this meeting

was to examine brother Hilary Gaskins to be licensed to preach the gospel.

After a thorough examination we felt him to be sound in doctrine moral character and Christian practice. We unanimously recommended that his church grant him a license to preach the gospel.

Brother Adam Scott who is a regular member of this committee was not present at this meeting, so brother Gene Outland served in his place.

At the Quarterly Meeting of the Coastal Association, held at Union Chapel Church, April 23, 1966 it was reported that Eldon J. Hollowell was surrendering his credentials. We now recommend that he be dropped from our roll of ordained ministers.

The Examining Board of the Coastal Association met at the Five Points FWB Church, September 17, 1966; while the Association was in regular session. Brothers Roger Russell and Frankie Dunn came before us requesting membership in our Association. We examined them and recommend that they be accepted.

REPORT OF YOUTH ACTIVITIES AND CHURCH TRAINING SERVICE COMMITTEE

We your Committee submit the following report:

PART I-

We are happy to report that our Youth work in the Coastal Association has been most successful during the past year. We held three Associational Church Training Service Rallies during the past year. Each of these rallies were very successful. Our first rally was held October 16, 1965 at the First Free Will Baptist Church in Morehead City, N. C. Young people of the Association directed the service, which featured the Gospel Film "Goal to Go."

Our second rally was held February 12, 1966 at Ruth's Chapel F. W. B. Church, New Bern, N. C. There were various competitive activities to determine winners in the different age groups who would represent our Association at the State Contest. Also at this rally, offerings from the various youth groups across our Association were given enabling us to go over our goal for our Mission's Project in our Association Youth work this past year. An amount in excess of \$550.00 was given to the Mission's Project of "Pews For Panama."

Our third rally was held June 18, 1966 at the First Free Will Baptist Church of Washington, N. C. Emphasis at this rally was on Christian Education. Rev. Charles Thigpen, dean of our Free Will Baptist Bible College, was our speaker and he brought a very challenging message. All of these rallies were well attended with a good representation from most of our churches.

PART II-

In that this committee was charged with the responsibility of directing the Coastal Association Youth Camp, we submit the following report: Brother Gene Outland served as Camp Supervisor for the two weeks of Youth Camp held at the Presbyterian Camp on Bogue Sound. Brother T. O. Terry served as director for Junior-age week, and Brother Galen Dun-

bar served as director for Teen-age week.

During the first week of camp, August 8-13, 1966, 76 junior attended youth camp. Brothers, Albert Rollins, Joe Hailey, Lewis Campbell, Charles Heuser, Luther Reed, Chester Phillips and Mrs. Lewis Campbell, Mrs. Chester Phillips, Mrs. Joe Hailey, Mrs. Charles Heuser along with the director and supervisor composed the staff.

During the second week at camp, August 15-20, 1966, 70 teen-agers attended Youth Camp. Brothers, Freeman Edwards, Ronald Creech, Roger Tripp, Fred Hawkins, Lewis Campbell, Mrs. Roger Tripp, Mrs. Freeman Edwards, Mrs. Lewis Campbell, Miss Kathy Tippet, along with director and supervisor composed the staff.

Mrs. Annie Heath was dietician, assisted by Mrs. Luther Reed, Mrs. Hillary Gaskins, Mrs. Lewis Campbell, Mrs. Tippet and several ladies from some of our churches. We had a most successful camp each week with approximately 20 young people accepting Christ as Saviour and many rededicating their life to Christ.

Part III-

In the light of this past year's work and accomplishments and as a result of consideration and much prayer we offer the following recommendations:

1. We recommend, that our churches order their Church Training Service Material and Youth Program material from our National Church Training Service Department.
2. We recommend, that we encourage the people of our churches to use the devotional guide "Depth" and that where-in it is possible that the C.T.S. in each local Church make these devotional guides available to the people of the church.
3. We recommend that each church endeavor to become acquainted with the material setting forth the competitive Youth activities, which is available through our National C.T.S. Department.
4. We recommend that each church, organize if necessary or exert all effort necessary to maintain an active Church Training Service Program with special emphasis given to teaching and reaching our Young People.
5. We recommend, that three Association-wide C. T. S. Rallies be held during the coming church year, the rallies being held on the third Saturday night in the months of October, February, and June.
6. We recommend that the Coastal Association sponsor, under the direction of this committee two weeks of youth camp next summer, and that we endeavor to rent the Presbyterian Camp for our Youth Camp.
7. We recommend that the Camp Fee be \$14.00 per camper.
8. Whereas there are several individuals in our Association who have expressed an interest in Camp Jubilee; we recommend that we recognize the work of Camp Jubilee and that we give our endorsement to those working with the Camp, and to those who wish to attend.
9. We recommend that the Association allocate \$100.00 from the Youth Camp Fund to be used in promoting Youth Work in our Association for the next year.

REPORT OF THE SUNDAY SCHOOL COMMITTEE

We your Sunday School Committee submit the following report.

1. We recommend that all the Pastors in the Coastal Association hold several teacher training courses in their Churches during 1967, including a study of Free Will Baptist Treatise, Free Will Baptist Doctrine, and other related subjects. Our reason for this is as follows:

(a) Teachers in the Public Schools are trained to teach, and so must the teacher that teaches the Word of God.

(b) Teachers must be trained in order to help the Child of God to grow properly in wisdom, in order that they might be able to refute certain things found in their text books in school, such as evolution, etc.

(c) Because North Carolina Free Will Baptists are having such a great controversy over Free Will Baptist Church Government.

(d) Every teacher needs to know clearly the plan of salvation,

and how to lead their lost pupils to Christ.

2. We recommend that Pastors and Teachers put special emphasis on family devotions in our homes.

3. We recommend that Pastors emphasize teacher visitation and contact with the members of their class.

4. We recommend that Pastor hold monthly teacher meetings in their Churches, working out their problems together in order to help the growth of the Sunday School.

5. We recommend that all Sunday Schools in the Coastal Association order their literature from the National Sunday School Board of the National Association of Free Will Baptists.

CONSTITUTION

PREAMBLE:

From long experience we, the Original Free Will Baptist Churches, are convinced of the advantages of cooperative programs and united efforts for advancing the cause of our Lord; do propose to establish and maintain an association of churches for the purpose of spiritual fellowship, united efforts in missions, Christian education and church extension upon the following plan:

I. This association shall be named the Coastal Association of Original F. W. B. churches of N. Carolina and shall be composed of such well regulated F. W. B. Churches as may embody themselves under this constitution.

II. The acting members of this association shall be five (5) delegates from each organized church, chosen by the members of the respective churches while in session, together with all ordained and licensed ministers who appear on the roll of Ministers of the association, belonging to any church composing this body, and associational officers.

III. The officers of this association shall be a moderator, an assistant moderator, a clerk who shall be treasurer and shall superintend the printing of the minutes. These officers shall be elected annually, and shall hold their offices until their successors are elected; an Executive Board of four (4) members elected from the laity, whose duty shall be to transact all the business of the Association when this body is not in session, and whose term of office shall be as follows; one elected for one year; one elected for two years, one elected for three years, and one elected for four years; and at the expiration of each of these terms, one shall be elected for four years; And further if any vacancies occur between sessions of the Association the board shall fill such vacancies until the next session of the Association; all of whom shall perform such duties as usually devolve upon such officers, or directed by the Association in setting. The Officers of this Association, namely Moderator, Asst. Moderator, Clerk-Treasurer shall also be members of the Executive Board, and shall meet with the Board and shall have a vote on any and all matters that shall come before the Executive Board.

IV. Any regular organized F.W.B. church maintaining gospel order, agreeing with the denomination in doctrine and practice as set forth in the Treatise of Faith and Practice of the National Association, in favor of benevolent enterprises such as S.S., Missions, Temperance, Christian education etc., may be received into this body by presenting a Petitionary letter requesting membership and upon examination and recommendation of the Examining Committee, and by a majority vote of the body in session. Moreover, any church holding membership in this Association reserves the right to participate, or refrain from participating in any of all programs of the body, or may withdraw from the Association at her own pleasure.

V. This Association shall have power to discipline it's churches, exclude them for disorderly conduct, if labor proves unsuccessful; to license and ordain ministers as they are requested to do so by the churches, (such as give evidence of qualification); to settle questions of doctrine and discipline as the churches may refer to it; to make any rules and by-laws necessary to its regulation and not inconsistent with it's constitution, but in no case shall this association reverse a decision of one of it's churches, nor in any way interfere with it's internal regulations, nor exert any ecclesiastical authority over the churches composing this association. (see National Treatise)

VI. The sessions of this association shall convene annually at 9:30 o'clock on Friday and Saturday before the third Sunday in September; and it shall be the duty of the churches composing the association to represent themselves by delegates, and send written reports. The churches shall report their spiritual standing, benevolent work, names and addresses of ministers and clerks, names of their deacons, meeting days and statistics; at which time the association shall act upon questions and topics as may be referred to them through their committees, and trans-

act such other business not repugnant to this constitution, nor to the usages of the denomination, as in their judgment may promote the cause of Christ and the interest of the churches within the limits of the Association.

VII. It is the duty of this association to provide for general union of churches, to point out their interests and to aid them in securing pastors when requested to put evangelists and other ministers in places where the gospel is most needed, and require an annual written report from each minister belonging to this association.

VIII. This constitution may be altered or amended by a two-thirds majority of all members voting at any regular session of the association, written notice having been given at the last previous session.

BY-LAWS

1. At every setting of the Association, business shall be opened and concluded with prayer by the moderator or whomever he may request.
2. These by-laws shall be distinctly read by the clerk immediately after the organization of the association and a copy in the hands of all delegates, both standing and elected.
3. The moderator shall call his assistant to fill the chair when he wishes to speak or otherwise vacate his place.
4. The moderator shall declare out of order any speaker who fails to speak on the subject before the body, or who makes use of unkind personalities.
5. The moderator shall not succeed himself more than once within a period of five (5) years.
6. All committees shall be elected by the body unless otherwise provided for by the association.
7. While the association is in session no member shall absent himself without permission from the moderator.
8. Any one wishing to speak shall arise and address the moderator and be recognized by him before speaking.
9. All visiting brethren may have the privilege to speak on any subject before the body, but not to vote unless ruled otherwise by the body.
10. No person shall speak more than twice on the same subject without leave of the association and not longer than five (5) minutes.
11. No subject shall be discussed without a motion and a second and the question stated by the moderator.
12. When a motion has been made and seconded, and stated by the chair, and any member opposes its discussion, the moderator shall put the question "Shall it be discussed," if negative, the question shall be dismissed.
13. A motion shall be put in writing if any member of the body requests it.
14. No report shall be adopted except by motion and second and a vote to that effect.
15. Any member of the association violating any of these rules shall subject himself to the forfeiting of voting privileges for the remainder of the day.
16. A motion shall always be in order to adjourn, but shall not be discussed unless it is necessary to do so.
17. A Minister seeking membership in the Association shall present a petitionary letter to the Association, and after he has been recommended and approved by the Examining Board, and upon a majority vote of the Body in session, his name shall be placed on the roll of Ministers of the Association. Each new Minister coming into the Coastal Association shall be contacted by the Examining Board and notified of a date to appear before the Board for approval. This shall be done within Two (2) Months after he has arrived and began his Pastorate in the Association.

18. No one shall be ordained to gospel ministry who uses tobacco, alcoholic beverage, narcotics, or has a tolerant attitude toward liberalism, modernism, communism, catholicism, etc. Each candidate must carry license for at least one year. Then if request comes from the church to which he belongs and he be found worthy, he may be ordained, provided the candidate has been called to some definite work. All ministers called to pastor churches in this association shall be required to hold certificates of Ministerial Standing in force during their term of service as pastors. This certificate shall be issued upon request of the church in which they hold membership.

19. The associational year shall end in the same month in all our churches, and that month shall be in August.

20. These rules and the order of business may be temporarily suspended or permanently altered by a two-thirds vote of the members present at any regular meeting of the body.

April 14, 1966

ORGANIZATIONAL MEETING OF THE COASTAL ASSOCIATION OF ORIGINAL FREE WILL BAPTIST

November 30, 1961

On Thursday Night at 7:30 P.M. at the Ruth's Chapel Free Will Baptist Church, the following Churches met to organize the Coastal Association of Original Free Will Baptist Churches. Union Chapel FWB Church, Palmetto Chapel FWB Church, Ruth's Chapel FWB Church, Fellowship Chapel FWB Church, and First Free Will Baptist Church at Beaufort. The meeting was presided over by Bros. A. L. Hines and Randy Cox. E. A. Mallard was appointed to serve as temporary clerk until such time as one could be duly elected by the body. After a short devotional service, Bro. Cecil Campbell brought an inspiring message for the meeting. There were seven churches represented at the meeting, and sixteen ministers were recognized. Bro. Frank Davenport of Goldsboro, N. C. brought greetings from the National Association of Free Will Baptists.

An examining council of the following members met, Bro. Milton Hollifield, Frank Davenport, Roy Rikard, Sherman Branch, and W. L. Kell, Jr. After meeting with the five churches seeking membership in the Association; they reported back that they find that they are in good standing and should be admitted. They recognized these Churches and also their delegates, and they were properly seated. The following ministers were also seated: Revs. Cecil Campbell, A. L. Hines, Gordon Sebastian, Randy Cox, Milton Worthington, C. M. Dixon, and Melvin Worthington.

After all delegates were seated the following business matters were taken care of. The following were elected to serve as Officers of the Association, Rev. Cecil Campbell, Moderator, Rev. A. L. Hines, Asst. Moderator, and E. A. Mallard, Clerk and Treasurer. The Constitution and by-laws that had been previously passed out for study were adopted. A copy of these are on file with the Clerk of the Association.

Two resolutions were adopted by the Association, they are as follows:
No. 1. Whereas the National Association of Original Free Will Baptists, during its 1961 session at Norfolk, Va., asked the State Convention of Original Free Will Baptists of N. C. "to repudiate any and all forms of Connectional Church Government and reaffirm its position in our historic and established form of Church Government"; and whereas the N. C. State Convention of Free Will Baptists, during its 1961 session at Mount Olive, N. C., refused to comply with the above mentioned request of the National Association; therefore be it resolved that we of the Coastal Association of Original FWB of N. C. hereby comply with the request of the National Association of FWB and hereby repudiate any and all forms of Connectional Church Government wherever it may be found among FWB and do hereby reaffirm our belief in Congregational Church Government.

No. 2. Whereas a sworn statement to the contrary gained its basis through a treatise revision of 1899, corrupted with Holiness Doctrines, being changed to read "The annual Conference being the highest tribunal shall have final jurisdiction over the Local Churches", be it resolved; that the Coastal Association of Original FWB of N. C. recognize the historic position of Original FWB Churches, in the area of their autonomy as related to their Association affiliation, as being that set forth in the Treatise of 1883, (in harmony with the treatise of 1812) which states, "But to these Conferences are granted No jurisdictional or appellate powers conflicting with the independence of the local Churches."

On motion and second it was decided to call another meeting of the Association at an early date. This was decided on for Tuesday Night, January 23, 1962, place to be announced at a later date. There being no further business to come before the body, and on motion and second to adjourn, the meeting was closed with the singing of Bless Be the Tie, followed by prayer by Bro. Lee Purifoy.
