SIXTH ANNUAL MEETING OF THE COASTAL ASSOCIATION

The annual meeting of the Coastal Association of Free Will Baptists convened with the Cove City Free Will Baptist Church on September 15-16, 1967. There was a good attendance at the opening session, a good representation of delegates present from the eighteen churches representing. The Association was opened with a short devotional service led by Bros. Charles Holton and Hillary Gaskins of the host church. Following this the clerk read the by-laws of the Association and declared the sixth annual session open for the transaction of its business. Brother Galen Dunbar served as moderator for the session, and called on Brother Tommy Godley to open the business session with prayer. Following this, the moderator gave his message to the Association, and declared the body ready to transact business.

The clerk read the list of delegates from the member churches, and on motion and second, these delegates were properly seated. The moderator then appointed two committees as follows: Committee on Committees, Brother Adam Scott, Chairman, Brother Hillary Gaskins, Brother J. V. Johnson and Brother Don Eubanks. Digest Committee, Brother Roger Russell, Chairman, Betty Piner and Brother Earl Griffin. The report of the Executive Committee was given by Brother Galen Dunbar and on motion and second this report was adopted. On motion and second, Brothers Lee Whaley and Herbert Bryan were dropped from the minister's roll, it being understood that they had taken membership in other organizations.

The moderator welcomed and recognized all visitors who were attending the opening session and extended to them an invitation to sit with the body during the transaction of its business. A petitionary letter from Brother Osborne was presented to the Association for membership. On motion and second this was referred to the Examining Board. The report of the Woman's Auxiliary was given by Mrs. Galen Dunbar. On motion and second, this report was accepted by the Association. The Committee on Committees then gave a partial report to the Association. On motion and second, this partial report was adopted. The moderator then adjourned the business session for ten minutes. Following this, we entered into the worship hour of the morning session. Brother T. O. Terry brought an inspiring message which challenged the hearts of all present. At the close of the worship service the session was adjourned for lunch with prayer by Brother Fred Hawkins.

The afternoon session was opened with a devotional service led by Bros. Johnny Eason and Bobby Potter. Following this service business was resumed and the Committee on Committees gave another partial report. Motion and second to adopt this partial report. Brother Roger Russell, Chairman of the Digest Committee, gave their report. On motion and second, this report was adopted. The treasurer then gave his report to the Association, and on motion and second this report was adopted. Brother Gene Parisher gave a report for the Superannuation Committee. On motion and second, this report was received by the Association. The report of the Christian Education Committee was given by Mrs. Joyce Daniels. On motion and second, this report was adopted. Mrs. Ruby Barker gave the report of the Publications Committee, and on motion and second, this report was adopted.

The Finance Committee report was given by Brother Bobby Potter and on motion and second, this report was referred back to the Committee to make some necessary changes in the report. The Sunday School Committee report was given by Brother Johnny Eason, and on motion and second this report was adopted. The final report from the Committee on Committees was given by Brother Scott, Chm., and motion and sec-

ond, this final report was adopted. Brother Adam Scott read the report of the Examining Board, and on motion and second this report was adopted. Bros. Henry Hagen, Alvis Harris and Ralph Osborne were recommended in this report for membership in the Coastal Association, and they are hereby added to the Minister's Roll of the Coastal Association. Motion and second that a committee be appointed by the moderator to study the structure of our organization, including the quarterly meeting, and report back to the Association at its annual session in 1968. Motion carried. And on motion and second the moderator was instructed to name three members on this committee. The Finance Committee then gave their amended report and on motion and second, this report was adopted as read. The report of The Church Training and Youth's Relation Board was given by Brother Gene Outland. This report contained several recommendations for the body to act upon. On motion and second the recommendation concerning the youth camp for the summer session of 1968 was amended to read "that we hold two weeks or more of Youth Camp next summer if the plans could be worked out." On motion and second the full report and the recommendations, as amended, were adopted by the body.

There being no further business to come before the body and on motion and second to adjourn, the afternoon session was closed with prayer by Brother Thomas Johnson.

On Saturday morning September 16, 1967, the Association reconvened at 9:30 a.m. with a short devotional service led by Bros. Roger Russell and Rodger Tripp. Following this the moderator declared the session in order for the transaction of its business. Delegates from the Union Chapel Church were properly seated, they not being present at the previous day's session. The clerk read the minutes of the previous day's session, these were declared approved by the moderator. On motion and second, the following delegates to the State Association were named: Mrs. Lewis Campbell, Mrs. Bobbie Smyer, and Mrs. Hillary Gaskins, alternate. The moderator then welcomed the visitors from other bodies who were attending this session.

Brother Thomas Johnson gave a detailed report on the Mission work in Wilmington. He stated that as of January 1, 1967, they had changed the name of the Mission to The Friendship F. W. B. Church. They were not, as yet, organized into a church, but were still operating as a Mission. The work was growing and they were now occupying their new church building which they recently bought for which they expressed their thanks to God, mainly, and to all of the others who had helped in any way in the work.

The moderator then enquired if there were any requests for the 1968 Associational Meeting from any church. Brother Rodger Tripp extended an invitation for the Association to meet with the Union Chapel Church in 1968. On motion and second, the invitation was accepted. Brother Fred Hawkins then gave the report of the Resolutions Committee. On motion and second, this report was adopted. The moderator then appointed the committee which he was instructed to appoint at the preceding days session to study the structure of our organization. The following were appointed: Brother T. O. Terry, chairman, Brother Fred Hawkins, and Brother Gene Parisher.

Brother Gene Parisher then gave the Missions Board report, and on motion and second, this report was adopted. The Nominating Committee was then called on for their report. On motion and second this report was adopted and those nominated to the various positions by the committee were duly elected to serve. Brother Fred Hawkins was selected to bring the morning worship hour message at the 1968 Association con-

vening with Union Chapel Church. On motion and second, the clerk was instructed to prepare and have published the minutes of this Association for distribution to the member churches.

There being no further business to come before the body, on motion and second to adjourn, the business session was properly adjourned until the next regular meeting in 1968. Following a ten minute recess the worship hour was entered into and turned over to the Mission Board to conduct a special missionary service. Brother Bronco West was introduced and brought an inspiring message to the congregation. He soon will be moving to Winston-Salem, N. C. to begin a work of establishing a Mission in that area. An offering for this cause was taken at the close of the service which amounted to \$48.50. At the close of the worship service the 1967 Coastal Association meeting officially ended.

REPORT OF THE EXAMINING COMMITTEE

On Saturday, October 22, 1966 we met at Sherwood Forest Church, while the quarterly meeting was in session, for the purpose of examining Brother James Bell for ordination. The meeting was opened and closed with a prayer. All of the regular members were present. We gave him a thorough examination as to his morals, beliefs and general qualifications and found him to be sound in every way. We recommended him for ordination, the recommendation was passed upon and he has since been ordained.

The Examining Committee of the Coastal Association held its second meeting of the Associational year at the First Free Will Baptist Church in Washington, N. C., January 21, 1967. The purpose for this meeting was to examine Brothers Henry Hagen and Alvis Harris, who came from the General Conference, requesting admission into the Coastal Association. After due examination we recommended them for membership into the Quarterly Meeting of the Coastal Association. Our recommendation was adopted, the quarterly meeting being in session that day. The meeting was opened and closed with prayer. All the regular members were present for this meeting.

The Examining Committee held its third meeting at the First Free Will Baptist Church in Beaufort, N. C., while the Quarterly Meeting was in session, on July 22, 1967. The purpose of this meeting was to examine Brother Wiley Lewis for license. After a careful examination we decided to recommend that his church, which is the Beaufort Church, license him. Brother Ralph Osbern came before us requesting membership into the Quarterly Meeting of the Coastal Association. After examining him, we voted to recommend his acceptance into our body. The report of your committee was not given that day so we recommended that this vote be taken at this time, following this report. Brother T. O. Terry, who is chairman of this committee was not able to be present for this meeting because of the illness of his daughter. Brother Gene Outland served as proxy for him. The meeting was opened and closed with prayer.

REPORT OF CHURCH TRAINING AND YOUTH RELATIONS BOARD

We, your Board submit the following report:

PART I

We are happy to report that our Youth work in the Coastal Association has been most successful during the past year. We held three Association Church Training Service Rallies during the past year. Each of these rallies were very successful. Our first rally was held October 15, 1966 at the First Free Will Baptist Church in Jacksonville, N. C.

Our second rally was held February 18, 1967 at Ruth's Chapel Free Will Baptist Church in New Bern, N. C. There were various competitive activities to determine winners in the different age groups who would represent our Association at the State Contest. Also at this rally, offerings from various youth groups across our Association were given to our Project in our Coastal Association Youth work this past year. An approximate amount of \$400.00 was given to the expansion program of Free Will Baptist Bible College.

Our third rally was held June 17, 1967 at the Sherwood Forest Free Will Baptist Church in New Bern, N. C. Emphasis at this rally was on Christian Education. Jack Paramore, director of the Expansion Program of the Free Will Baptist Bible College, was our speaker and he brought a very challenging message. All of these rallies were well attended with a good representation from our churches. We take this opportunity to commend the members and the sponsors of the Sherwood Forest Free Will Baptist Church Bible Tic-Tac-Toe team for winning first place in the National Competition.

PART II

In that this committee was charged with the responsibility of directing the Coastal Association Youth Camp, we submit the following report:

Brother Gene Outland served as Camp Supervisor for the two weeks of Youth Camp held at the Presbyterian Camp on Bogue Sound. Brother T. O. Terry served as director for the Junior-age week, and Brother Galen Dunbar served as director for the Teen-age week.

During the first week of camp, July 31-August 4, 1967, 88 juniors attended Youth Camp. Brother Albert Rollins, Mr. and Mrs. Jim McLain, Mr. and Mrs. Roger Tripp, Mr. and Mrs. Lee Gurganus, Mr. Richard Hines, along with the director and supervisor composed the staff.

During the second week at camp, August 14-19, 1967, 40 teen-agers attended Youth Camp. Mr. and Mrs. Roger Russell, Miss Mary E. Rice, Mr. and Mrs. Alvis Harris, Mr. Johnny Eason. Mr. and Mrs. Fred Hawkins, Mr. and Mrs. Al Davis along with the director and supervisor composed the staff.

Mrs. Annie Heath was dietician, assisted by Mrs. Mary E. Blackman, Mrs. Sidney Smyer, Mrs. Al McElmon, Miss Sandra McElmon, Miss Janet McElmon, also ladies from various churches. We had a most successful camp each week with many young people accepting Christ as their Saviour and others rededicating their lives to Christ.

PART III

In the light of this past year's work and accomplishments as a result of consideration and much prayer we offer the following recommendations:

1. We recommend, that we encourage the people of our churches to use the devotional guide "Depth" and that where-in it is possible that the C.T.S. in each local church make these devotional guides available to the people of the church.
2. We recommend, that our churches order their Church Training Material and Youth Program Material from our National Church Training Service Department.
3. We recommend, that each church endeavor to become acquainted with

the material setting forth the competitive Youth activities, which is available through our National C.T.S. Department.

4. We recommend, that each church, organize if necessary or exert all effort necessary to maintain an active Church Training Service Program with special emphasis given to teaching and reaching our Young People.

5. We recommend, that three Association-wide C.T.S. Rallies be held during the coming Church year, the rallies being held on the third Saturday night in the months of October, February, and June.

6. We recommend, that the Coastal Association sponsor under the direction of this Board two weeks or months of Youth Camp next summer, and that we endeavor to rent the Presbyterian Camp for our Youth Camp.

7. We recommend, that the Camp Fee be \$15.00 per camper.

8. We recommend, that the Association allocate \$100.00 from the Youth Camp Fund to be used in promoting Youth Work in our Association for the next year.

CONSTITUTION

PREAMBLE:

From long experience we, the Original Free Will Baptist Churches, are convinced of the advantages of cooperative programs and united efforts for advancing the cause of our Lord; do propose to establish and maintain an association of churches for the purpose of spiritual fellowship, united efforts in missions, Christian education and church extension upon the following plan:

I. This association shall be named the Coastal Association of Original F. W. B. churches of N. Carolina and shall be composed of such well regulated F. W. B. Churches as may embody themselves under this constitution.

II. The acting members of this association shall be five (5) delegates from each organized church, chosen by the members of the respective churches while in session, together with all ordained and licensed ministers who appear on the roll of Ministers of the association, belonging to any church composing this body, and associational officers.

III. The officers of this association shall be a moderator, an assistant moderator, a clerk who shall be treasurer and shall superintend the printing of the minutes. These officers shall be elected annually, and shall hold their offices until their successors are elected; an Executive Board of four (4) members elected from the laity, whose duty shall be to transact all the business of the Association when this body is not in session, and whose term of office shall be as follows; one elected for one year; one elected for two years, one elected for three years, and one elected for four years; and at the expiration of each of these terms, one shall be elected for four years; And further if any vacancies occur between sessions of the Association the board shall fill such vacancies until the next session of the Association; all of whom shall perform such duties as usually devolve upon such officers, or directed by the Association in setting. The Officers of this Association, namely Moderator, Asst. Moderator, Clerk-Treasurer shall also be members of the Executive Board, and shall meet with the Board and shall have a vote on any and all matters that shall come before the Executive Board.

IV. Any regular organized F.W.B. church maintaining gospel order, agreeing with the denomination in doctrine and practice as set forth in the Treatise of Faith and Practice of the National Association, in favor of benevolent enterprises such as S.S., Missions, Temperance, Christian education etc., may be received into this body by presenting a Petitionary letter requesting membership and upon examination and recommendation of the Examining Committee, and by a majority vote of the body in session. Moreover, any church holding membership in this Association reserves the right to participate, or refrain from participating in any of all programs of the body, or may withdraw from the Association at her own pleasure.

V. This Association shall have power to discipline it's churches, exclude them for disorderly conduct, if labor proves unsuccessful; to license and ordain ministers as, they are requested to do so by the churches, (such as give evidence of qualification); to settle questions of doctrine and discipline as the churches may refer to it; to make any rules and by-laws necessary to its regulation and not inconsistent with it's constitution, but in no case shall this association reverse a decision of one of it's churches, nor in any way interfere with it's internal regulations, nor exert any ecclesiastical authority over the churches composing this association. (see National Treatise)

VI. The sessions of this association shall convene annually at 9:30 o'clock on Friday and Saturday before the third Sunday in September; and it shall be the duty of the churches composing the association to represent themselves by delegates, and send written reports. The churches shall report their spiritual standing, benevolent work, names and addresses of ministers and clerks, names of their deacons, meeting days and statistics; at which time the association shall act upon questions and topics as may be referred to them through their committees, and trans-

act such other business not repugnant to this constitution, nor to the usages of the denomination, as in their judgment may promote the cause of Christ and the interest of the churches within the limits of the Association.

VII. It is the duty of this association to provide for general union of churches, to point out their interests and to aid them in securing pastors when requested to put evangelists and other ministers in places where the gospel is most needed, and require an annual written report from each minister belonging to this association.

VIII. This constitution may be altered or amended by a two-thirds majority of all members voting at any regular session of the association, written notice having been given at the last previous session.

BY-LAWS

1. At every setting of the Association, business shall be opened and concluded with prayer by the moderator or whomever he may request.
2. These by-laws shall be distinctly read by the clerk immediately after the organization of the association and a copy in the hands of all delegates, both standing and elected.
3. The moderator shall call his assistant to fill the chair when he wishes to speak or otherwise vacate his place.
4. The moderator shall declare out of order any speaker who fails to speak on the subject before the body, or who makes use of unkind personalities.
5. The moderator shall not succeed himself more than once within a period of five (5) years.
6. All committees shall be elected by the body unless otherwise provided for by the association.
7. While the association is in session no member shall absent himself without permission from the moderator.
8. Any one wishing to speak shall arise and address the moderator and be recognized by him before speaking.
9. All visiting brethren may have the privilege to speak on any subject before the body, but not to vote unless ruled otherwise by the body.
10. No person shall speak more than twice on the same subject without leave of the association and not longer than five (5) minutes.
11. No subject shall be discussed without a motion and a second and the question stated by the moderator.
12. When a motion has been made and seconded, and stated by the chair, and any member opposes its discussion, the moderator shall put the question "Shall it be discussed," if negative, the question shall be dismissed.
13. A motion shall be put in writing if any member of the body requests it.
14. No report shall be adopted except by motion and second and a vote to that effect.
15. Any member of the association violating any of these rules shall subject himself to the forfeiting of voting privileges for the remainder of the day.
16. A motion shall always be in order to adjourn, but shall not be discussed unless it is necessary to do so.
17. A Minister seeking membership in the Association shall present a petitionary letter to the Association, and after he has been recommended and approved by the Examining Board, and upon a majority vote of the Body in session, his name shall be placed on the roll of Ministers of the Association. Each new Minister coming into the Coastal Association shall be contacted by the Examining Board and notified of a date to appear before the Board for approval. This shall be done within Two (2) Months after he has arrived and began his Pastorate in the Association.

18. No one shall be ordained to gospel ministry who uses tobacco, alcoholic beverages, narcotics, or has a tolerant attitude toward liberalism, modernism, communism, catholicism, etc. Each candidate must carry license for at least one year. Then if request comes from the church to which he belongs and he be found worthy, he may be ordained, provided the candidate has been called to some definite work. All ministers called to pastor churches in this association shall be required to hold certificates of Ministerial Standing in force during their term of service as pastors. This certificate shall be issued upon request of the church in which they hold membership.

19. The associational year shall end in the same month in all our churches, and that month shall be in August.

20. These rules and the order of business may be temporarily suspended or permanently altered by a two-thirds vote of the members present at any regular meeting of the body.

ORGANIZATIONAL MEETING OF THE COASTAL ASSOCIATION OF ORIGINAL FREE WILL BAPTIST

November 30, 1961

On Thursday Night at 7:30 P.M. at the Ruth's Chapel Free Will Baptist Church, the following Churches met to organize the Coastal Association of Original Free Will Baptist Churches. Union Chapel FWB Church, Palmetto Chapel FWB Church, Ruth's Chapel FWB Church, Fellowship Chapel FWB Church, and First Free Will Baptist Church at Beaufort. The meeting was presided over by Bros. A. L. Hines and Randy Cox. E. A. Mallard was appointed to serve as temporary clerk until such time as one could be duly elected by the body. After a short devotional service, Bro. Cecil Campbell brought an inspiring message for the meeting. There were seven churches represented at the meeting, and sixteen ministers were recognized. Bro. Frank Davenport of Goldsboro, N. C. brought greetings from the National Association of Free Will Baptists.

An examining council of the following members met, Bro. Milton Hollifield, Frank Davenport, Roy Rikard, Sherman Branch, and W. L. Kell, Jr. After meeting with the five churches seeking membership in the Association; they reported back that they find that they are in good standing and should be admitted. They recognized these Churches and also their delegates, and they were properly seated. The following ministers were also seated; Revs. Cecil Campbell, A. L. Hines, Gordon Sebastian, Randy Cox, Milton Worthington, C. M. Dixon, and Melvin Worthington.

After all delegates were seated the following business matters were taken care of. The following were elected to serve as Officers of the Association, Rev. Cecil Campbell, Moderator, Rev. A. L. Hines, Asst. Moderator, and E. A. Mallard, Clerk and Treasurer. The Constitution and by-laws that had been previously passed out for study were adopted. A copy of these are on file with the Clerk of the Association.

Two resolutions were adopted by the Association, they are as follows: No. 1. Whereas the National Association of Original Free Will Baptists, during its 1961 session at Norfolk, Va., asked the State Convention of Original Free Will Baptists of N. C. "to repudiate any and all forms of Connectional Church Government and reaffirm its position in our historic and established form of Church Government"; and whereas the N. C. State Convention of Free Will Baptists, during its 1961 session at Mount Olive, N. C., refused to comply with the above mentioned request of the National Association; therefore be it resolved that we of the Coastal Association of Original FWB of N. C. hereby comply with the request of the National Association of FWB and hereby repudiate any and all forms of Connectional Church Government wherever it may be found among FWB and do hereby reaffirm our belief in Congregational Church Government.

No. 2. Whereas a sworn statement to the contrary gained its basis through a treatise revision of 1899, corrupted with Holiness Doctrines, being changed to read "The annual Conference being the highest tribunal shall have final jurisdiction over the Local Churches", be it resolved; that the Coastal Association of Original FWB of N. C. recognize the historic position of Original FWB Churches, in the area of their autonomy as related to their Association affiliation, as being that set forth in the Treatise of 1883, (in harmony with the treatise of 1812) which states, "But to these Conferences are granted No jurisdictional or appellate powers conflicting with the independence of the local Churches."

On motion and second it was decided to call another meeting of the Association at an early date. This was decided on for Tuesday Night, January 23, 1962, place to be announced at a later date. There being no further business to come before the body, and on motion and second to adjourn, the meeting was closed with the singing of Bless Be the Tie, followed by prayer by Bro. Lee Purifoy.
