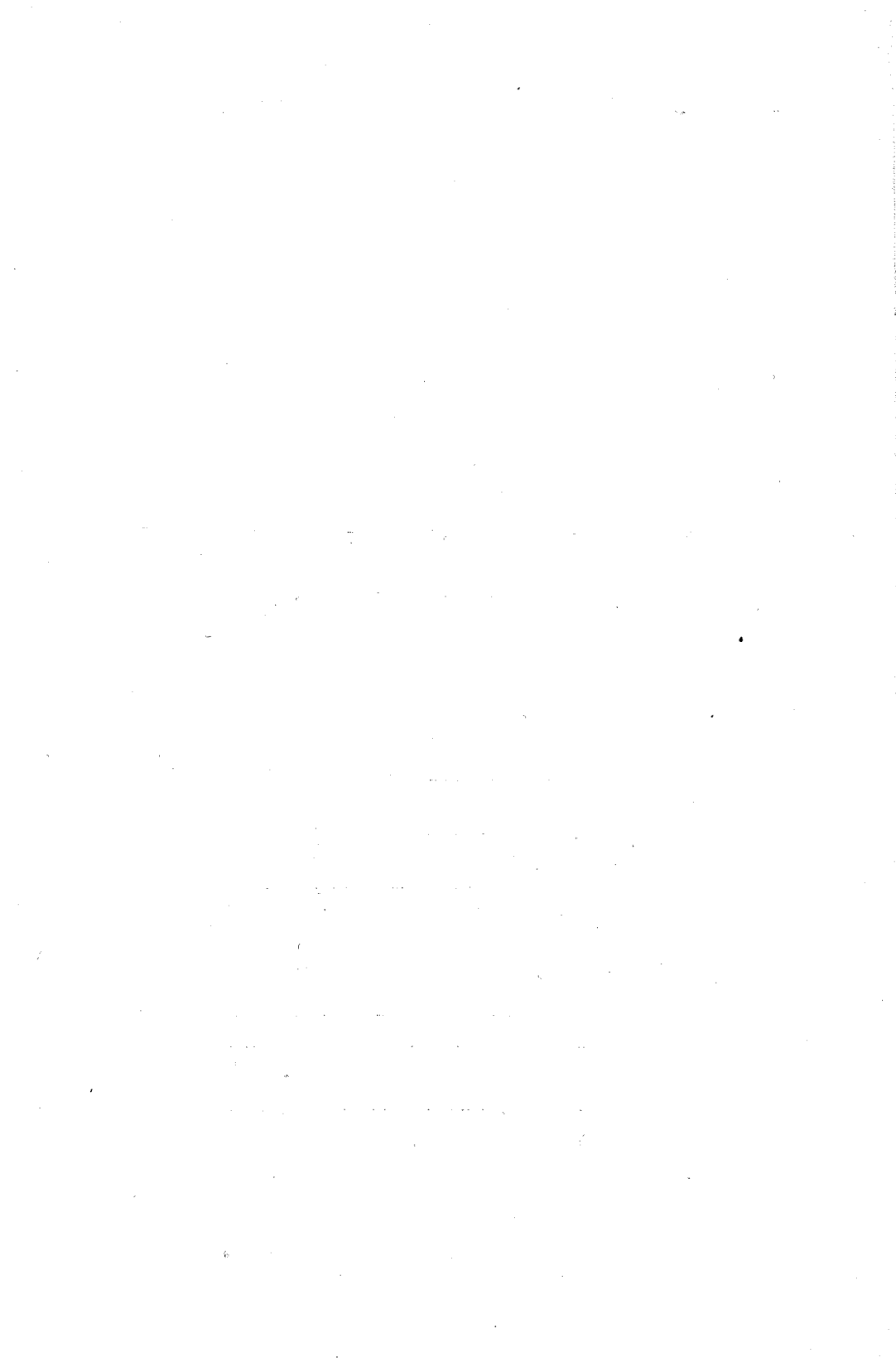

## SEVENTH ANNUAL MEETING OF THE COASTAL ASSOCIATION

The annual meeting of the Coastal Association of Free Will Baptists convened with the Union Chapel Free Will Baptist Church on September 13-14, 1968. The Association was opened with a devotional service conducted by Brother Billy Gene Outland with Brother Ralph Osborne leading the singing. Following this the clerk read the by-laws of the Association and then announced that the seventh annual session of the Coastal Association was open for the transaction of business. The Reverend Galen Dunbar was introduced as the Moderator for this session. The moderator gave his message taking his Scripture Lesson from I Peter 3:15. He emphasized the importance of a study of the Word of God and then led us in prayer.

The clerk read the list of delegates from the member churches and on motion and second, these delegates were properly seated. The moderator then appointed two committees as follows: Committee on Committees: Brother Gene Parisher, Chairman; Brother Julius Willis and Brother Alvis Harris; and the Digest Committee composed of Brother Gene Outland, Chairman, Mrs. Joyce Daniels and Mrs. Roger Russell.

Brother Roger Tripp brought a word of greeting from the local church in which he extended a cordial welcome to all delegates and visitors.

A petitionary letter was presented by the Faith Free Will Baptist Mission of Maysville. On motion and second the mission was received into the fellowship of the association and the delegates were seated. A partial report of the Examining Board was given in which recommendations were made to add Brothers Bob Breeden, Irvin Hyman and Hillary M. Gaskins to the roll of ordained ministers. On motion and second the report was adopted. On motion and second, Brother Adam Scott was granted a letter of recommendation to the Second Quarterly Meeting of the South Carolina Conference.

The report of the Executive Committee was given by the clerk and on motion and second the report was adopted. The special committee on the Organizational Structure of our Association made their report and on motion and second this report was adopted. At this time a motion was offered for the amending of Article VI of the Constitution. On motion and second the constitutional change was laid on the table. The Committee on Committees gave a partial report and on motion and second, this partial report was adopted. Brother Roger Russell declined to serve on the Nominating Committee because of other committee duties. Motion was carried for the chair to appoint a replacement. Brothers Bob Breeden and Gordan Boyd were elected to serve on the Sunday School Committee.

The business meeting was adjourned for the worship hour. Brother C. M. Dixon challenged our hearts with a message on spiritual growth. The moderator appointed Brother T. O. Terry as chairman of the Nominating Committee. We were dismissed for lunch with a prayer by Brother Allison Robinson.

The afternoon session was opened with a devotional service conducted by Brother Freeman Edwards with Brother Roger Tripp leading the singing. The business was resumed and the Committee on Committees gave their final report. On motion and second this report was adopted. The Treasurer gave his report and on motion and second the same was adopted. The report of the District Woman's Auxiliary Convention was given by the president, Mrs. Barbara Dunbar. On motion and second this report was received as information. The report of the Sunday School Committee was given by Brother Bob Breeden. On motion and second this report was adopted.

Brother L. D. Creech, Treasurer of the State Mission Board, reported on the work of the Board. He reported encouraging progress among the missions sponsored by our State Mission Board and other associated missions. The report of the Christian Education Committee was given by Brother Roger Russell and on motion and second, the report was adopted. Mrs. J. K. Rhodes gave the report for the Publications Committee. On motion and second this report was adopted.

Brother Ronald Creech, State Evangelist, was recognized to give a report on the State Program of work. He urged greater support for the various departments of this work.

The Finance Committee report was given by Mrs. Joyce Daniels and on motion and second, the report was adopted. Brother Billy Gene Outland reported for the Church Training Service and Youth Relations Board. Motion was made to receive the report and to adopt items one through three and that items four through seven be considered separately. Motion was carried. On motion and second item 4 of the report was adopted. On motion and second item 5 was adopted. On motion and second item 6 was adopted. On motion and second item 7 was adopted.

There being no further business the afternoon session was adjourned. Brother Alton Hines prayed the benediction.

On Saturday morning the Association reconvened at 9:30 a.m. with a devotional service conducted by Brother L. D. Creech. The singing was led by Brother Roger Russell. Following this the moderator declared the meeting open for the transaction of business.

The report of the Superannuation Committee was given by Brother Alvis Harris and the same was adopted by the body. Brother Ralph Osborne gave the report for the Resolutions Committee and this report was also adopted. Motion was made to amend item 19 of the by-laws by substitution: "Each member church shall be required to make an annual report to the association. Any church failing to report for two consecutive years shall be declared out of fellowship with the association until such time as report is made." A motion was made to amend the amendment to the by-laws by addition of the following clause: "and the clerk shall notify such churches of this action. The amendment to the amendment was adopted. The body then voted to adopt the amendment as amended. Motion was made that churches affected by this action be notified by the clerk or a visit by the General Officers of the Association and given one month to report. Those failing to comply shall be notified that they are out of fellowship until such time as they report. A motion was made to amend the motion by deleting the words, "or a visit by the General Officers," and the addition of the following statement after the first sentence of the motion: "If the church fails to respond, a visit will be made by the General Officers to the pastor." The motion to amend was adopted. The motion as amended was then adopted and reads as follows: "Churches affected by this action shall be notified by the clerk and given one month to report. If the church fails to respond, a visit will be made by the General Officers to the pastor. Those churches then failing to comply shall be notified that they are out of fellowship until such time as they report."

The report of the Nominating Committee was given by Brother Freeman Edwards. Motion was carried to receive the report and to vote on each office separately. Since there were no nominations from the floor for any office, all those proposed by the Nominating Committee were elected by acclamation.

An invitation was extended by the Five Points Church for the 1969 annual session of the association to meet with them. Motion was carried to accept their invitation. Brother T. O. Terry gave the report for the Mission Board and the same was adopted by the body. The report of the Digest Committee was presented by Brother Billy Gene Outland and on motion and second this report was adopted. The following delegates were elected to the State Association: Mrs. Ralph Osborne, Mrs. Roger Russell and Mrs. Freeman Edwards with Mrs. Johnny Floyd and Mrs. Galen Dunbar to serve as alternates. Motion was carried to send \$30.00 with the report to the State Association.

Brothers T. O. Terry and Roger Russell were nominated to bring the message on the opening day of the next annual meeting. Brother Terry was selected to bring the message and Brother Russell was chosen to serve as the alternate. On motion and second it was directed that the Moderator appoint a Layman's Committee to work on plans for a Layman's Rally. The moderator appointed Brother Robert Potter, chairman, Brother Roger Russell and Brother Mack Styron.

There being no further business to come before the body, the business session was adjourned for the worship hour. The worship service was under the direction of the Mission Board. An inspiring message was brought by Brother Alvis Harris on our missionary responsibilities. A mission offering was received in the amount of 43.47. At the close of the worship service the 1968 Coastal Association meeting officially ended.

1. That the laymen and laywomen of the Coastal churches purchase basic Bible study aids such as Bible Dictionary, Bible Concordance, a good one volume commentary, etc. Bible correspondence courses are available from the Free Will Baptist Bible College as outlined in the college catalog.

2. Where possible, we recommend that Bible Clubs be held for the youth of our churches.

3. As young people become college age that they be encouraged to get part or all of their education at the Free Will Baptist Bible College, Nashville, Tennessee.

## REPORT OF SUNDAY SCHOOL COMMITTEE

We your Sunday School Committee submit the following report:

1. We recommend that the Advisory or Nominating Committee of each Sunday School be more cautious in recommending new Sunday School teachers and officers to their churches, and that they recommend such teachers on the basis of their ability, separation, consecration, faithfulness, character, and example.

2. We recommend that each teacher be able to give Biblical evidence of their salvation. We feel that this is essential in order for them to tell their students how to be saved.

3. We recommend that each Sunday School have an active Teacher Training Program.

4. We recommend that pastors continue to emphasize teacher visitation and especially contact their absences.

5. We recommend that where it is not possible for pastors to hold monthly teacher meetings that such meetings be held quarterly in their churches.

6. We recommend that each teacher realize their major goal in teaching is "To win the lost for Christ" and in turn teach their students to be soul winners also.

## REPORT OF THE EXAMINING BOARD

Upon the approval of the examination and his presentation of a petitionary letter, we recommend that he be added to the roll of ordained ministers.

The Examining Board of the Coastal Association met on June 11, 1968 at Pleasant Acres Church to examine Brother James Dixon for ordination. Brother Billy Gene Outland served as proxy for Brother Terry. Brother Dixon passed the examination satisfactorily and was recommended for ordination.

## **REPORT OF CHURCH TRAINING & YOUTH RELATIONS BOARD**

We, your Board, submit the following report:

### **PART I**

The outstanding rally of the year was the February Rally at which we conducted the competitive activities, which are designed for the various groups of our Church Training Service Department. Winners were declared at this Rally that represented our Association at the State Meeting. The number of contestants entering the competitive activities was much greater than last year. We appreciate the fine work done by the teams, individuals, and their sponsors. We take this opportunity to give special recognition to the Sherwood Forest Church who not only won top honors in most of the competitive activities in the Associational Rally, but for the second year in a row took the Bible Tic-Tac-Toe team all the way to National competition.

### **PART II**

In that this committee was charged with the responsibility of directing the Coastal Association Youth Camp, we submit the following report:

Both weeks of our Youth Camp were held at the Presbyterian Camp on Bogue Sound. During these two weeks the Lord really poured out His blessings. We thank the Lord for every accomplishment during our Youth Camp this past summer.

During the first week of camp, August 5-10, ninety Juniors attended camp. Brother Gene Outland served as director assisted by a fine staff. Alvis Harris, Fred Hawkins, Kenneth Wilson, Gary L. 4. We recommend that two Association-wide C. T. S. rallies be held during the coming year, and that the rallies be held on November 23, 1968 and March 1, 1969.

5. We recommend that the Coastal Association sponsor, under the direction of this board, two weeks of Youth Camp next summer, and that we endeavor to rent the Presbyterian Camp for our Youth Camp.

6. We recommend that the Camp fee be \$15.00 per camper.

7. We recommend that the Association allocate 50.00 from the Youth Fund to be used in promoting Youth Work in our Association next year.

## SPECIAL COMMITTEES ON ORGANIZATIONAL STRUCTURE

We, the Committee on Organizational Structure, beg leave to submit the following information taken from a suggested revision of the Practices Section of the Treatise of the National Association of Free Will Baptists which was distributed at the National Association in Oklahoma City this year. We feel that this provides an informative preface for our recommendations.

"Chapter Three: Associations of Churches"  
"Section 2: Their Organizational Structure"

There is considerable variety within the denomination as to the exact number and nature of associational organizations.

A. The plan which seems to work best calls for four levels of organization which can be diagrammed thus:

Level 1 — The Local Church

Level 2 — The District Association

Level 3 — The State Association

Level 4 — The National Association

(3) The district association, in this plan, is the body which deals directly with the local church and would be the first level of appeal from the local church. It is also the body to which the local church delegates its authority to ordain and discipline ministers (See Chapter Two: The Minister).

(4) In this plan, the district association may meet quarterly. Some district associations cover such large geographical areas, however, that it is found preferable to subdivide voluntarily into smaller groupings for three quarterly meetings between the annual meetings of the entire association each fourth quarter. In this case, these smaller quarterly meetings are mostly devoted to fellowship and inspiration. While the local churches are expected to report to these smaller quarterly meetings, their main annual reports are presented directly to the annual meeting of the association.

B. Another plan of structure followed in some areas calls for five levels of organization which can be diagrammed thus:

Level 1—The Local Church

Level 2—The Quarterly Meeting

Level 3—The Yearly Meeting

Level 4—The State Association

Level 5—The National Association

This plan works much like the four-level plan outlined above, except for the fact that the Quarterly Meeting is given considerably greater status in the associational structure and stands between the local church and the Yearly Meeting (equivalent to the District Association). Here, the churches form and report only to the Quarterly Meeting; Quarterly Meetings form and make all reports to the Yearly Meeting. In other particulars the two plans are identical."

### Recommendations

1. Due to the limited number of churches which we have in the Coastal Association, we feel it unwise at this time to divide into two Quarterly Meetings. Therefore we recommend that we follow the four-level plan of organization which will dispense with the Quarterly Meeting as a separate organization.

2. We further recommend that the Coastal Association meet quarterly; the first three meetings of the year would be primarily for fellowship and inspiration and the fourth meeting of the year would be the annual business meeting of the Association.

3. We recommend that the dates of meeting be the fourth Saturday in January, April, July and the annual meeting be on the fourth Friday and Saturday in October.

### Suggested Constitutional Change

ARTICLE VI — This association shall convene quarterly at 9:30 a.m. on the fourth Saturday in January, April and July for fellowship and the conducting of such business as may be deemed necessary. The annual business meeting shall be on the fourth Friday and Saturday of October beginning at 9:30 a.m., at which time the association shall act upon ques-

tions and topics as may be referred to it through its committees, and transact such other business not repugnant to this constitution, nor to the usages of the denomination, as in their judgment may promote the cause of Christ and the interest of the churches within the limits of the Association. The churches shall make such reports of their works as required by the Association.

## CONSTITUTION

### PREAMBLE:

From long experience we, the Original Free Will Baptist Churches, are convinced of the advantages of cooperative programs and united efforts for advancing the cause of our Lord; do propose to establish and maintain an association of churches for the purpose of spiritual fellowship, united efforts in missions, Christian education and church extension upon the following plan:

I. This association shall be named the Coastal Association of Original F. W. B. churches of N. Carolina and shall be composed of such well regulated F. W. B. Churches as may embody themselves under this constitution.

II. The acting members of this association shall be five (5) delegates from each organized church, chosen by the members of the respective churches while in session, together with all ordained and licensed ministers who appear on the roll of Ministers of the association, belonging to any church composing this body, and associational officers.

III. The officers of this association shall be a moderator, an assistant moderator, a clerk who shall be treasurer and shall superintend the printing of the minutes. These officers shall be elected annually, and shall hold their offices until their successors are elected; an Executive Board of four (4) members elected from the laity, whose duty shall be to transact all the business of the Association when this body is not in session, and whose term of office shall be as follows; one elected for one year; one elected for two years, one elected for three years, and one elected for four years; and at the expiration of each of these terms, one shall be elected for four years; And further if any vacancies occur between sessions of the Association the board shall fill such vacancies until the next session of the Association; all of whom shall perform such duties as usually devolve upon such officers, or directed by the Association in setting. The Officers of this Association, namely Moderator, Asst. Moderator, Clerk-Treasurer shall also be members of the Executive Board, and shall meet with the Board and shall have a vote on any and all matters that shall come before the Executive Board.

IV. Any regular organized F.W.B. church maintaining gospel order, agreeing with the denomination in doctrine and practice as set forth in the Treatise of Faith and Practice of the National Association, in favor of benevolent enterprises such as S.S., Missions, Temperance, Christian education etc., may be received into this body by presenting a Petitionary letter requesting membership and upon examination and recommendation of the Examining Committee, and by a majority vote of the body in session. Moreover, any church holding membership in this Association reserves the right to participate, or refrain from participating in any of all programs of the body, or may withdraw from the Association at her own pleasure.

V. This Association shall have power to discipline it's churches, exclude them for disorderly conduct, if labor proves unsuccessful; to license and ordain ministers as they are requested to do so by the churches, (such as give evidence of qualification); to settle questions of doctrine and discipline as the churches may refer to it; to make any rules and by-laws necessary to its regulation and not inconsistent with it's constitution, but in no case shall this association reverse a decision of one of it's churches, nor in any way interfere with it's internal regulations, nor exert any ecclesiastical authority over the churches composing this association. (see National Treatise)

VI. The sessions of this association shall convene annually at 9:30 o'clock on Friday and Saturday before the third Sunday in September; and it shall be the duty of the churches composing the association to represent themselves by delegates, and send written reports. The churches shall report their spiritual standing, benevolent work, names and addresses of ministers and clerks, names of their deacons, meeting days and statistics; at which time the association shall act upon questions and topics as may be referred to them through their committees, and trans-

act such other business not repugnant to this constitution, nor to the usages of the denomination, as in their judgment may promote the cause of Christ and the interest of the churches within the limits of the Association.

VII. It is the duty of this association to provide for general union of churches, to point out their interests and to aid them in securing pastors when requested to put evangelists and other ministers in places where the gospel is most needed, and require an annual written report from each minister belonging to this association.

VIII. This constitution may be altered or amended by a two-thirds majority of all members voting at any regular session of the association, written notice having been given at the last previous session.

### BY-LAWS

1. At every setting of the Association, business shall be opened and concluded with prayer by the moderator or whomever he may request.
2. These by-laws shall be distinctly read by the clerk immediately after the organization of the association and a copy in the hands of all delegates, both standing and elected.
3. The moderator shall call his assistant to fill the chair when he wishes to speak or otherwise vacate his place.
4. The moderator shall declare out of order any speaker who fails to speak on the subject before the body, or who makes use of unkind personalities.
5. The moderator shall not succeed himself more than once within a period of five (5) years.
6. All committees shall be elected by the body unless otherwise provided for by the association.
7. While the association is in session no member shall absent himself without permission from the moderator.
8. Any one wishing to speak shall arise and address the moderator and be recognized by him before speaking.
9. All visiting brethren may have the privilege to speak on any subject before the body, but not to vote unless ruled otherwise by the body.
10. No person shall speak more than twice on the same subject without leave of the association and not longer than five (5) minutes.
11. No subject shall be discussed without a motion and a second and the question stated by the moderator.
12. When a motion has been made and seconded, and stated by the chair, and any member opposes its discussion, the moderator shall put the question "Shall it be discussed," if negative, the question shall be dismissed.
13. A motion shall be put in writing if any member of the body requests it.
14. No report shall be adopted except by motion and second and a vote to that effect.
15. Any member of the association violating any of these rules shall subject himself to the forfeiting of voting privileges for the remainder of the day.
16. A motion shall always be in order to adjourn, but shall not be discussed unless it is necessary to do so.
17. A Minister seeking membership in the Association shall present a petitionary letter to the Association, and after he has been recommended and approved by the Examining Board, and upon a majority vote of the Body in session, his name shall be placed on the roll of Ministers of the Association. Each new Minister coming into the Coastal Association shall be contacted by the Examining Board and notified of a date to appear before the Board for approval. This shall be done within Two (2) Months after he has arrived and began his Pastorate in the Association.

18. No one shall be ordained to gospel ministry who uses tobacco, alcoholic beverages, narcotics, or has a tolerant attitude toward liberalism, modernism, communism, catholicism, etc. Each candidate must carry license for at least one year. Then if request comes from the church to which he belongs and he be found worthy, he may be ordained, provided the candidate has been called to some definite work. All ministers called to pastor churches in this association shall be required to hold certificates of Ministerial Standing in force during their term of service as pastors. This certificate shall be issued upon request of the church in which they hold membership.

19. Each member church shall be required to make an annual report to the association. Any church failing to report for two consecutive years shall be declared out of fellowship with the association until such time as report is made. Churches affected by this action shall be notified by the clerk and given one month to report. If the church fails to respond, a visit will be made by the General Officers to the pastor. Those churches then failing to comply shall be notified that they are out of fellowship until such time as they report.

20. These rules and the order of business may be temporarily suspended or permanently altered by a two-thirds vote of the members present at any regular meeting of the body.
