

#### CONSTITUTION

#### **Preamble:**

Į

From long experience we, the Original Free Will Baptist Churches, are convinced of the advantages of co-operative programs and united efforts for advancing the cause of our Lord; do propose to establish and maintain an association of churches for the purpose of spiritual fellowship, united efforts in missions, Christian education and church extension upon the following plan:

I. This association shall be named the Coastal Association of Original F.W.B. Churches of North Carolina and shall be composed of such well regulated F.W.B. Churches as may embody themselves under this constitution.

II. The acting members of this association shall be five (5) delegates from each organized church, chosen by the members of the respective churches while in session, together with all ordained and licensed ministers who appear on the roll of Ministers of the association, belonging to any church composing this body, and associational officers.

The officers of this association shall be a moderator, an III. assistant moderator, a clerk who shall superintend the printing of the minutes, an assistant clerk, a treasurer who shall be in charge of all monies, and an assistant treasurer. These officers shall be elected annually, and shall hold their offices until their successors are elected: an Executive Board of four (4) members elected from the laity, whose duty shall be to transact all the business of the Association when this body is not in session, and whose term of office shall be as follows; one elected for one year: one elected for two years, one elected for three years, and one elected for four years; and at the expiration of each of these terms, one shall be elected for four years; And further, if any vacancies occur between sessions of the Association the board shall fill such vacancies until the next session of the Association: All of whom shall perform such duties as usually devolve upon such officers, or as directed by the Association in setting. The officers of this Association, namely Moderator, Assistant Moderator, Clerk, Assistant Clerk, Treasurer, Assistant Treasurer shall also be members of the Executive Board, and shall meet with the Board and shall have a vote on any and all matters that shall come before the Executive Board. Any regular organized F.W.B. church maintaining gospel IV. order, agreeing with the denomination in doctrine and practice as set forth in the Treatise of Faith and Practice of the National Association, in favor of benevolent enterprises such as S.S.. Missions, Temperance, Christian Education, etc., may be received into this body by presenting a Petitionary letter requesting membership and upon examination and recommendation of the Examining Committee, and by a maj-

ority vote of the body in session. Moreover, any church holding membership in this Association reserves the right to participate, or refrain from participating in any of all programs of the body, or may withdraw from the Association at her own pleasure.

V. This Association shall have power to discipline its churches, exclude them for disorderly conduct, if labor proves unsuccessful; to license and ordain ministers as they are requested to do so by the churches, (such as give evidence of qualification); to settle questions of doctrine and discipline as the churches may refer to it; to make any rules and by-laws necessary to its regulation and inconsistent with its constitution, but in no case shall this association reverse a decision of one of its churches, nor in any way interfere with its internal regulations, nor exert any ecclesiastical authority over the churches composing this association. (See National Treatise)

VI. This association shall convene quarterly at 10:00 a.m. on the fourth Saturday in January, April, and July for fellowship and the conducting of such business as may be deemed necessary. The annual business meeting shall be on the fourth Friday and Saturday of October beginning at 9:30 a.m. at which time the association shall act upon questions and topics as may be referred to it through its committees, and transact such other business not repugnant to this constitution, nor to the usages of the denomination as in their judgement may promote the cause of Christ and the interest of the churches within the limits of the association. The churches shall make such reports of their works as required by the association.

VII. It is the duty of this association to provide for general union of churches, to point out their interests and to aid them in securing pastors when requested to put evangelists and other ministers in places where the gospel is most needed, and require an annual written report from each minister belonging to this association.

VIII. This constitution may be altered or amended by a twothirds majority of all members voting at any regular session of the association, written notice having been given at the last previous session.

1. At every setting of the Association, business shall be opened and concluded with prayer by the moderator or whomever he may request.

2. These by-laws shall be distinctly read by the clerk immediately after the organization of the association and a copy in the hands of all delegates, both standing and elected.

3. The moderator shall call his assistant to fill the chair when he wishes to speak or otherwise vacate his place.

4. The moderator shall declare out of order any speaker who fails to speak on the subject before the body, or who makes use of unkind personalities.

5. The moderator shall not succeed himself more than once within a period of five (5) years.

6. All committees shall be elected by the body unless otherwise provided for by the association.

7. While the association is in session no member shall absent himself without permission from the moderator.

8. Any one wishing to speak shall arise and address the moderator and be recognized by him before speaking.

9. All visiting brethren may have the privilege to speak on any subject before the body, but not to vote unless otherwise ruled by the body.

10. No person shall speak more than twice on the same subject without leave of the association and not longer than five (5) minutes.

11. No subject shall be discussed without a motion and a second and the question stated by the moderator.

12. When a motion has been made and seconded, and stated by the chair, and any member opposes its discussion, the moderator shall put the question "Shall it be discussed?" If negative, the question shall be dismissed.

13. A motion shall be put in writing if any member of the body request it.

14. No report shall be adopted except by motion and second and a vote to that effect.

15. Any member of the association violating any of these rules shall subject himself to the forfeiting of voting privileges for the remainder of the day.

16. A motion shall always be in order to adjourn, but shall not be discussed unless it is necessary to do so.

17. A minister seeking membership in the association shall present a petitionary letter to the association, and after he has been recommended and approved by the Examining Board, and upon a majority vote of the Body in session, his name shall be placed on the roll of Ministers of the Association. Each new Minister coming into the Coastal Association shall be contacted

the the Examining Board and notified of a date to appear before the Board for approval. This shall be done within two (2) months after he has arrived and begun his Pastorate in the Association.

18. No one shall be ordained to gospel ministry who is divorced and remarried, who uses tobacco, alcoholic beverages, narcotics or has a tolerant attitude toward liberalism, modernism, communism, catholicism, etc. Each candidate must carry license for at least one year. Then if! request comes from the church to which he belongs and he be found worthy, he may be ordained, provided the candidate has been called to some definite work. All ministers called to pastor churches in this association shall be required to hold certificates of Ministerial Standing in force during their term of service as pastors. This certificate shall be issued upon request of the church in which they hold membership.

19. Each member church shall be required to make an annual report to the association. Any church failing to report for two consecutive years shall be declared out of fellowship with the association until such time as report is made. Churches affected by this action shall be notified by the clerk and given one month to report. If the church fails to respond, a visit will be made by the General Officers to the pastor. Those churches then failing to comply shall be notified that they are out of fellowship until such time as they report.

20. These rules and the order of business may be temporarily suspended or permanently altered by a two-thirds vote of the members present at any regular meeting of the body. The annual meeting of the Coastal Association met October 27-28, 1972, at Richlands Free Will Baptist Church, Richlands, N.C. The session opened with the singing of "At the Cross" led by Rev. Roger Russell. Evangelist Vann Dell Hudson led in prayer. Rev. Robert Burke, of the Five Points Free Will Baptist Church, brought the morning devotion from Psalm 60:1-4.

Rev. Danny Padgett, pastor of the host church, gave the Association a warm welcome.

The business session was called to order by the Clerk. The by-laws governing the Association were read. A motion was made and carried to seat the delegates.

The Moderator recognized and welcomed all visitors to the Association. There were five visiting Ministers recognized: Rev. Bob King, Rev. Vann Dell Hudson, Rev. Robert Burke, Rev. Ronald Creech, and Rev. Bob Breeden.

A motion was made and carried that the program be altered as necessary. Upon consent of the body, the Moderator appointed the following committees to function during this session of the Associaton:

Committee on Committees: Rev. Sigbee Dilda, Rev. Glenn Thomas, Rev. Billy Jackson

Digest Committee: Rev. Jerry Rackley, Rev. Roger Russell, Rev. J.V. Johnson

Finance Committee: Rev. Gene Outland, Rev. Danny Padgett, Rev. Johnny Floyd

The Clerk called the roll of Ministers and Churches. There were 17 Ministers and 20 Churches responding.

Bro. Bob King gave a report on the progress being made in the state on behalf of the special Bible College Project.

The report of the Executive Committee was given and adopted. A motion was made and carried to receive the report of the Committee on Committees, and vote on them item by item.

A motion made and carried to adopt the Nominating Committee as recommended by the Committee on Committees.

A motion made and carried to adopt the resolutions Committee as recommended by the Committee of Committees.

A motion made and carried to delete the following committees as recommended by the Committee on Committees: Super-annuation, Christian Education, Sunday School, and Publications Committee.

Rev. Ronald Creech gave a report on the State Work.

The morning Worship Service with Rev. Roger Russell leading in the singing and testimonies. Rev. William Reagan brought an inspiring message from John 1:43 on "Being A Disciple of Jesus", after which we were adjourned for the noon meal.

Friday Afternoon October 27, 1972

The afternoon session opened with a devotion by Rev. Bob Breeden, pastor of Sandy Acres F.W.B. Church of Columbia, N.C., on "Boldness" from Acts 4:12.

A motion was made and carried to grant letters of recommendation to Rev. Irvin Hyman and Edward Turnage to their respective Associations.

A motion was made and carried that the Clerk send reporting forms to both the Church Clerks and the Pastors.

The report of the C.T.S. and Youth Relations Board was given by Rev. Gene Outland. A Motion was made, seconded, and carried to receive the report and to give Committee a rising vote of appreciation for their work.

A motion was made and carried to adopt the new reporting forms as suggested by the National Association. A motion was made and carried to receive the partial report of the Digest Committee. The Treasurer gave his report and on a Motion and second it was received.

The report of the Resolutions Committee was given to be voted on item by item. The first resolution, concerning the printing of resolutions, was, upon a motion and second, defeated. The remaining resolutions were, on motion and second, carried.

There being no further reports or business at that time, the meeting was adjourned with prayer until the next morning.

> Saturday Morning October 28, 1972

The session was opened with Bro. Lee Zeiglien leading in the singing of "Victory in Jesus" and "There Is Power In The Blood". Rev. Eustis Riggs who was visiting with us led in prayer.

Rev. Danny Padgett brought the morning devotion from Luke 24:44-53 on "Praising God".

The Moderator called the session to order. The Clerk read the minutes of the previous day. The Moderator extended a welcome to those who were visiting with us. The report of the Examining Board was given and accepted after a motion and second. The report of the Woman's Audiliary was given and also approved.

A motion was made, seconded, and carried to receive the report of the Nominating Committee and to consider it office by office. The entire slate was elected as suggested by the Nominating Committee.

Upon a motion and second the report of the Finance Committee was adopted. The session recessed 10 minutes before the Worship hour. Rev. Freeman Edwards brought an inspiring message to us from Eph. 6 on the Spiritual Warfare. Session adjourned with prayer.

# **ITEMS PASSED - FIRST THREE QUARTERLY SESSIONS**

The Quarterly Meeting of the Coastal Association of Free Will Baptists met with the Pleasant Acres F.W.B. Church, Saturday, January 22, 1972.

A motion was made and carried to take from the table the proposed constitution change dealing with section III of the constitution, which read as follows: "The officers of this association shall be a moderator, an assistant moderator, a clerk who shall superintend the printing of the minutes, an assistant clerk, a treasurer who shall be in charge of all monies, and an assistant treasurer." The Association voted unanimously for the constitutional change.

The following resolutions were passed:

- 1. Whereas sex-education in the public schools seem to follow the liberal thinking of today's society, we resolve to ask our denomination, first from the pulpit, second in its teaching materials to stress the spiritual aspects of sex-education, and, to speak out in the press and all publications and communications with society, our opposition to the methods being used today in our public schools.
- 2. We further resolve that letters of protest be sent to major networks, speaking out against the deplorable situation that exists on many so-called talk shows in which people express extreme liberal views on sex and request that some discretion be used when this subject is discussed, as T.V. is a guest in every American home.
- 3. We resolve, whereas there are many revised versions of the Bible being promoted today. We highly recommend the Authorized King James Version be used in our pulpits, in the publication of our literature, as this is an old foundation stone upon which our denomination has been built.

A motion was made and carried to receive the report of the Examining Committee as follows: Rev. Billy Jackson, who is an ordained F.W.B. Minister, has been called as pastor of Cove City F.W.B. Church. He has requested membership in the Coastal Association. We have properly examined him and recommend that he be accepted into our Association, pending a letter from his previous Association in Augusta, Georgia.

**Part I** We praise the Lord for His blessings upon the Church Training Service and Youth Camp work during the past year. We are thankful for the cooperation of all who have contributed to or assisted in any way to our work. It has been our desire to see improvements in our Church Training Service Program and especially to do more to reach our youth. We recognize the importance of young people coming to Christ for salvation and getting involved in serving our Lord.

It is our privilege to report that a Youth Rally is being held monthly at the various churches within our Association. Every three months the Rally convenes at 10:00 A.M. and most of the program consists of competitive activities among the contestants from the various churches participating. We are glad to report that the winners in the competitive activities did a fine job in representing us at the State level, and two of our contestants winning at the State Rally, did a great job representing our State at the National level. **Part II** Our Youth Camp Program was a great success. God's blessings flowed in abundance during both the Junior and Teenage weeks of camp. We witnessed many decisions for Christ as young people were saved and many rededicated their lives to the Lord.

The first week of camp, one-hundred-twenty (120) attended. The staff which consisted of Roger Russell, Billy Jackson, Dennis Wiggs, Billy Hill, Glenn Thomas, Larry Inscoe, Albert Rollins, Gene Outland, Mary Etta Hill, Opal Boyd, Priscilla Inscoe, Ruth Russell, Cathy Severs, Pam Gillen, Debbie Hargett, and Barbara Hodges did a very commendable job working with the Juniors.

The second week of camp, fifty-seven (57) teen-agers attended. The staff consisted of Sigbee Dilda, Gene Outland, Danny Thomas, Roger Tripp, Richard Hines, Randy Eubanks, Tom Johnson, Jonathan Thigpen, Ada Johnson, Sybil Tripp, Bobbie Thomas, Mary Dilda, Estelle Parker, Brenda Hines, and Arlene Davidson did an excellent job.

Peggy Outland, Mary E. Blackman, Virginia Waller, Virginia Hart, Marie McElmon with other ladies from various churches, assisting on different days did an outstanding job preparing meals for the two weeks of camp.

**Part III** In that we desire to see our Church Training Service doing an effective job in all our churches and we certainly want to provide an excellent camp program for our young people we would like to offer the following recommendations:

1. We recommend that each church exert every effort necessary to maintain an active Church Training Service Program with special emphasis given to reaching our youth. We offer our service to help in organizing youth work in your church or area.

2. We recommend the devotional guide, **Depth**, available through our National office, and that our people use if as an aid to devotional time in the home.

3. We recommend that our churches order their Church Training Service materials from our National Church Training Service Department.

4. We recommend that monthly rallies be held with emphasis toward reaching young people for Christ.

5. We recommend that all our churches endeavor to have entries in all youth Competitive Activities and that the time for the district run-offs for the Competitive Activities be announced by the Youth Committee at a later date.

6. We recommend that the Coastal Association sponsor, under the direction of the Board, two weeks of Youth Camp for our young people next summer, and that we endeavor to rent the Presbyterian Camp at Bogue Sound.

7. We recommend that the camp fee be \$18.00 per camper.

8. We recommend that each church in our Association make a contribution of \$25.00 or more to the Youth Work of our Association.
