The General Co-operative Association met with the Denison Church in its Seventh Tri-ennial Session, Nov. 6th to 9th, at Denison, Fexas. The clerk was absent, and Elder J.L. We also agree to accept the name National Assembly of Free Will Baptist Organizations which may be eligible to membership, and shall have jurisdiction over such matters as pertain to an organic union.

We are witnessing an unusal number of young ministers answering the call to preach the gospel, and several new churches are being organized and buildings erected over the state. While there are some things in a small way which is always true pertaining to the progress or the cause, yet we can truthfully say that the prospects for the Missouri State work looks unusually bright and encouraging Plans are now being laid for the erection of a tabernacle centrally located for a permanent meeting place each year. The State meeting is almost entirely out of debt. May the Heavenly Father make this one of the greatest sessions we have ever had and may much and lasting good be accomplished is our prayer.
