#### RULES OF ORDER

- 1. At every sitting of the Association, business shall be opened and concluded by prayer by the Moderator or whomsoever he may request.
- 2. Ministers, deacons, church clerks, Associational clerks and elected delegates, present are invited to seats, allowed to take part in debates on all subjects and vote.

3. Those who speak shall arise and address the Moderator. Personal reflection shall be avoided in all debates.

- 4. No motion shall be discussed without a second.
  5. When a motion has been made and seconded, and a member opposes its discussion, the Moderator shall put the question, "Shall it be discussed?" If negative, the question shall be dismissed.
- 6. If any proposition or motion under debate contains two or more points it shall be divided at the request of any member, and the vote taken separately.

7. Motions made and lost shall not be recorded.

8. No one shall speak more than twice on the same subject without special leave of the Moderator.

9. All questions shall be decided by a majority vote of

all members present.

10. No member shall absent himself without special leave of the Moderator.

11. Minutes shall be leisurely read and corrected before

the close of the Association if necessary.

12. At all future sessions of the Association arrangements shall be made to insure two sermons or other devotional exercises equivalent thereto, during each day of the session and the chair shall announce, just before adjournment, who shall fill the stand at the next meeting.

13. Rules of order shall be distinctly read from the chair immediately after organization of the association.

14. Alternations may be made in these rules at any regular session of the Association.

#### **PROCEEDINGS**

The Dibble Association met at the Camp Grounds Thursday evening, September 5, 1968.

THURSDAY EVENING: The first meeting was opened at 7:30 P.M. with congregational singing of "When I See the Blood" led by Brother Clarence Hearron with Linda Bagwell at the piano. Other congregational selections were "At Calvary" and "I am Thine 'O Lord." A special was brought by the Chickasha trio, "What a Day that Will Be" followed by another congregational number "Stepping In the Light." A special was rendered by Linda Bagwell, "Until You've Known the Lord God."

Prayer was led by Bro. Chester Bailey preceding the introduction of the speaker of the evening, Rev. E. A. O'Donnell, by the Moderator Rev. J. C. Morgan. Rev. E. A. O'Donnell brought a stirring message from Matthew 16:15-19, "WILL THE CHURCH SURVIVE?" Announcement that churches should turn in letters and that starting time the following morning, September 6, would be 9:30 A.M.

FRIDAY MORNING, September 6, 1968: Meeting called to order by Moderator, Rev. J. C. Morgan. Prayer was led by Bro. Bill Davoult.

Congregational singing of "Won't it Be Wonderful There" and "Oh, I Want to See Him" was led by Rev. E. A. O'Donnell with Patricia Bailey at the piano.

Romans 12:9-13 was used by Rev. J. C. Morgan in the mornings devotion-"We need to be about the Father's Business", prayer by Brother Sherman Webb.

Patricia Bailey was appointed Assistant Clerk by the Moderator in the absence of the Associational Assistant Clerk.

Minutes of 7 churches read. Motion made to accept letters and seat delegates approved. Rev. Don Smith appointed to assist the Moderator in the Assistant Moderator's absence and the hand of fellowship was given to each delegate present from the churches. St Clair petitionary letter read and motion made and approved to receive the church into the Dibble Association. St. Clair representatives were given hand of fellowship. Rules of order read by Moderator. Invitation made to visiting Brothers to sit with us today. Rev. Webb of Stigler, Oklahoma was welcomed.

Appointment of Committees (listed elsewhere) by Moderator. After naming Divine Service Committee, permission granted to complete appointment of committees after reading of Iron Chapel letter just received. Letter from Iron Chapel Church read and delegates welcomed. Other committees named, Divine Service Committee xcused for deliberation.

Divine Service Committee reported that Rev. Sherman Webb would be our speaker for the morning worship services.

Letter read from Rev. E. E. Jenkins requesting a letter of recommendation. Motion made and unanimous approval given to send letter of recommendation to Rev. Jenkins who is now pastoring in the South Grand River Association.

The matter of insurance for the Camp Grounds was discussed. Dismissed for short recess before worship service. Business dismissed until 1:15 P.M.

MORNING WORSHIP service opened with congregation singing of "From the Cross to the Crown," and "Farther Along," led by Rev. E. A. O'Donnell with Sister Maggie Roberts at the piano. A special song, "No Tears in Heaven" was rendered by Bro. Luther Hudson, Sister Corley, Sis Roberts and Rev. O'Donnell, with Patricia Bailey at the piano. The speaker of the hour Rev. Sherman Webb, was introduced by Rev. J. C. Morgan. Special song was given by Bro. Webb and Sis Roberts, "Precious Memories" with Patricia Bailey at the piano. Rev. Webb brought the message from Hebrews 11:1-6 and other scriptures on FAITH, exhorting the congregation to exercise their faith or lose it. stating that when we come before God ours should be a good report (Heb. 11:2) and that we should come boldly before the Lord knowing

that He is the Greatest and He is Holy, keeping faith alive in our hearts through prayer and showing others that we've been with Jesus. WHLL OUR FAITH SURVIVE?

Prayer of dismissal and blessings on the food by Sister Juanita Hearron.

FRIDAY AFTERNOON services opened with congregational singing "I'm going That Way" led by Rev. E. A. O'Donnell with Sister Maggie Roberts at the piano. Second congregational song "I Will Meet You in the Morning."

Afternoon devotion was given by Rev. Don Smith from 2 Kings, Chapter 22. "We need to find and read the Book of the Lord and find His will for our lives". Prayerby Rev. O'Donnell.

Treasurer's Report given by Bro. Dormie Mills and approved as read. C.T.S. Report given by Bro. Dale Lane and approved as read. Motion that Rev. G. Gardner be the 1969 evangelist for Youth Camp. Seconded and approved. Building Committee report given by Bro. Dale Lane. Bro. Lane also reported that letters of appreciation have been prepared to be sent donors contributing material to the camp grounds. Report received as read. Obituary report read and approved by standing for prayer by Bro. Dunn. Temperance Committee report accepted as read.

Divine Service Committe Chairman, Bro. John Kirkpatrick, reported that Rev. Clarence Hearron was selected to bring the evening message, Sept. 6.

Motion made that Association clean up (i.e level, remove some trees, etc.) the camp ground was approved. The following Executive Committee recommendation for rental of camp grounds (with requirement that rental be only to Christian Organizations) was submitted as a motion and approved by the Association.

"We the Exec. Board wish to report the following: first, that the Ass'n, adopt rules pertaining to the rental of Camp Ground to activities outside the Dibble Assn. We recommend that the Camp Ground set a Minimum rate of a \$50.00 fee for the use of the grounds and facilities if less than two days, or \$25.00 per day for an indefinite number of days, or \$100.00 per week. Also, that additional \$50.00 fee be charged to insure that the buildings and grounds will be left in the same shape and condition as when they were rented. All fees be paid in advance of the use of the camp ground with other temporary use being granted as determined by the property manager. The grounds will be rented only to Christian Organizations. Rev. E. A. O'Donnell, Chairman.

Motion made that Moderator appoint a Committee to investigate the water supply conditions at the Camp Ground and report to the association was seconded and carried.

The Moderator appointed as this committee: Bro's Bill Davoult, Dormie Mills and Dale Lane.

Motion that Youth Camp begin the last Sunday in July. Seconded, and approved. The 1969 Youth Camp will begin 27 July 1969.

A prayer request was made for a soul in the hospital at Chikasha. The Moderator announced that Brother Shockey will be at the Chickasha Church on Thursday and Friday nights following the State Association meeting prior to dismissal. Prayer by Bro. John Kirkpatrick.

SATURDAY MORNING, September 7, 1968: Meeting opened by Rev. J. C. Morgan, Moderator. "Joy Unseakable," was first congregational song led by Rev. Clarence Hearron, with Stephen Koonce at the piano.

Rev. Morgan introduced Rev. Gillentine who gave the morning devotion from the scripture Acts 1:8, 'Witness unto the Lost,' prayer by Rev. Gillentine. Church letters from Hawkins and Lindsay churches read and hand of fellowship extended to delegates. Rev. Ronnie Liles introduced visiting minister, Rev. Shelby.

Credential report given by Rev. J. C. Morgan, followed by Executive Board report. Mission Board Report given by Rev. Elmer Steelman. Divine Service Committee dismissed for deliberation. Bro. Gale Gardner welcomed to the meeting. Divine Service Committee reported that Rev. Ronnie Liles was selected to speak at the morning service.

Election of Board members and Election of Officers (Treas-Dormie Mills, Asst-Clerk-Pat Bailey, Clerk-Martha Langford, Assnt-Moderator-Clarence Hearron and Moderator-J. C. Morgan) (Boards-Executive, 5 yr-J. C. Morgan and 3 yr-Clarence Hearron; Credential, 5 yr-Clarence Hearron, 4 yr-Clyde Gillentine, 2 yr-E. A. O'Donnell; Sunday School 3 yr-John Kirkpatrick; CTS, 3 yr-Ronnie Liles and 1 yr-Bro. Townsend; Mission Board 3 yr-Leon Koonce.) The 1969 State Board Member, elected by acclamation. Motion made that Bro. Dormie Mills be Custodian of the Camp Grounds.

Motion made that Executive Board serve as a program committee for the quarterly and annual meetings, including selecting of the speakers. Recessed the assembly after prayer by Rev. Gale Gardner.

A.M. worship service opened with congregational singing of "Have you Really Been a friend to Him" led by Rev. Elmer Steelman with Sister Gale Gardner at the piano. Special song "Without Him," by Pat Bailey, Judy and Donna Cook from Brockland with Rev. Ronnie Liles at the piano. Congregational song "I'd Like to Talk it Over with Him". Special song by the Gale Gardner children with Mrs. Gardner at the piano "It will be Worth It Just to See My Lord". Special song by the young people of the St Clair church "Mansion Over the Hilltop" with Stephen Koonce at the piano. The Moderator introduced the speaker. Rev. Ronnie Liles who brought the morning message on the theme that no man can serve two masters from scriptural references including Matthew 6:24, Gal 1:10 and others. "Love the Lord with all thy heart with all thy might and all thy Soul-Let Jesus Come In." Song of invitation "Jesus, Jesus How I Trust Him" by Rev. Steelman with Mrs. Gardner at the piano. Announcements followed by dismissal prayer by Sister Gardner.

Afternoon service opened with singing of the song "He Loves Me". Afternoon devotion given from St Luke 21:27-36, "Must live our lives the way we want to die."

Credential report read and accepted. List of State Delegates named on church letters read and motion made that delegates be approved. Pledges for support of the association taken. Announcements. Motion to adjourn. Prayer by Bro. Dormie Mills,

Campers will be present in all classes and services unless dismissed by Director.

The Association will acquire insurance on all children. The \$5.00 registration fee will cover this item.

Meals served to anyone not registered at the camp will be charged 50 cents.

From long experience, we the members of the Church of God (denominated Free Will Baptist) being regularly baptized upon a profession of our faith in our Lord Jesus Christ and being convinced of the necessity of a combination of churches to perpetuate a union among us, and to preserve and maintain correspondence with each other, do therefore ordain this constitution for our better church government.

Article 1. Membership This Association shall be composed of members chosen by the churches or Quarterly Meetings of our union, not exceeding three messengers from each church and upon producing letters they shall be entitled to seats. All ordained ministers and deacons of said union shall be

regular members when presented by virtue of their office.

Article 2. Name. The members thus chosen and convened in the yearly meeting or Association of the Church of God, denominated Free Will Baptist, being composed of sundry churches in Dibble Association, the Association having no power to Lord it over God's heritage, nor have any ecclesiastical power over the churches; reserving the right of withdrawing

from any church becoming disorderly.

Article 3. Letters Letters from the different churches representing are to express their number in fellowship including the names and addresses of ordained and licensed ministers, the number of members received upon profession of faith, by letter or recommendation, by restoration, or denominational choice; the number dismissed by letter, excluded and those having died since last Association. Churches sending their letters may send obituaries of any who died during the year that we may keep up the memorial of our dead.

Article 4. Officers. The Association shall have a Moderator, Assistant Moderator, a clerk, an assistant clerk, a treasurer, and an Executive Board which shall be composed of 5 members serving terms of 5, 4, 3, 2, and 1 years.

Article 5. New Churches Newly constituted churches may be admitted to the Association which are to petition by letter and delegates and, if upon examination, they are found to be orthodox and orderly, that they may be received into the Association, the Moderator giving the right hand of fellow-

Article 6. Questions. No questions from any church shall come under the

consideration unless it has been first considered in its own church.

Article 7. Motions Every motion made and seconded shall come under the consideration of the Association, except it be withdrawn by the members who made it.

Article 8. Minutes The Association is to endeavor to furnish the churches

with minutes of the Association.

Article 9. Clerk. It shall be the duty of the Clerk to keep a regular file of the minutes of the Association in a book to be kept by the Association for that purpose.

Article 10. Signatures. The minutes of the Association shall be read and corrected if needed, signed by the Moderator and Clerk before the end of

the association.

Article 11. Amendments. Amendments to this Constitution may be made when necessary by a two-thirds vote of the members present at any regular session.

Article 12. Be it resolved that our Quarterly Meeting begin Friday nights before the Second (2nd) Sunday in the given months December, March and

June.

Article 13. Be it resolved that the Dibble Association pay co-operatively of all monies taken in except those ear-marked otherwise. Allocate 50 percent District, 50 percent State, this to be put in the constitution and carried from year to year.

#### ARTICLES OF FAITH

1. The Bible. The Scriptures of the Old and New Testaments were given by inspiration of God, and are our infallible rule of faith and practice.

2. God. There is one living and true God, revealed in nature as the Creator, Preserver, and Righteous Governor of the universe; and in the Scriptures as Father, Son, and Holy Ghost; yet as one God, infinitely wise and good, whom all intelligent creatures are supremely to love, adore, and obey.

3. Christ. Christ is God manfest in the flesh; in His divine nature truly God in His human nature truly man. The mediator between God and man, once crucified, He is now risen and glorified, and is our ever present Saviour

and Lord.

4. The Holy Spirit. The Scriptures assign to the Hoyl Spirit all the attri-

tributes of God.

5. The Government of God. God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts, not otherwise provided for, as the highest welfare of men requires.

6. The Sinfulness of Man. Man was created innocent, but by disobedience fell into a state of sin and condemnation. His posterity therefore, inherit a a fallen nature of such tendencies that all who come to years of accounta-

bility, sin and become guilty before God-

7. The Work of Christ. The Son of God by His incarnation, life, sufferings, death, and resurrection effected for all a redemption from sin that is

full and free, and is the ground of salvation by faith.

8. The Terms of Salvation. The conditions of salvation are: 1. Repentance or sincere sorrow for sin and hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Saviour and Lord with purpose to love and obey him in all things. In the exercise of saving faith, the soul is renewed by the Holy Spirit, freed from the dominion of sin, and becomes a child of God. 3. Continuance in faith and obedience until death.

9. Election. God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ men be-

come His elect.

10. Freedom of the Will. The human will is free and self-controlled, having power to yield to the influence of the truth and the Spirit, or to resist them

and perish.

11. Salvation Free. God desires the salvation of all, the Gospel invites all, The Holy Spirit strives with all, and whosoever will may come and take of the water of life freely.

12. Perserverance. All believers in Christ, who through grace perservere in

holiness to the end of life, have promise of eternal salvation.

13. Gospel Ordinances. BAPTISM, or the immersion of believers in water, and the LORD'S SUPPER, are ordinances to be perpetuated under the Gospel. FEET WASHING, an ordinance teaching humility of universal obligation, and to be ministered to all true believers.

14. Tithing. God commanded tithes and offerings in the Old Testament; Jesus Christ endorsed it in the Gospel (Matt 23:23), and the apostle Paul said, "Upon the first day of the week let every one of you lay by him in

store, as God hath prospered him" (1Cor. 16:2a.).

15. The Christian Sabbath. The divine law requires that one day in seven be set apart from secular employments and amusements, for rest, worship, holy works, and activities, and for personal communion with God.

16. Resurrection, Judgment, and Final Retribution. The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done evil unto resurrection of damnation; then the wicked will "go away into eternal punishment, but the righteous into eternal life."

Having given ourselves to God, by faith in Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another the will of God in this solemn covenant.

We promise, by His grace, to love and obey Him in all things, to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to provide things honest in the sight of all men."

We agree faithfully discharge our obligations in reference to the study of the Scriptures secret prayer, family devotions, and social worship; and by self-denial, faith, and good works endeavor to "grow in garce and the knowledge of our Lord and Saviour Jesus Christ."

We will not forsake the assembling of ourselves together for church conferences, public worship, and the observances of the ordinances of the Gospel nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bonds of peace. To be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able, promote the success of the church and of the Gospel.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society constantly praying and toiling that the Kingdom of God may come, and His will be done on earth as it is in heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday schools, and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.

#### DUTIES OF STANDING BOARDS

MISSION BOARD: It shall be the duty of htsi board to work to promote an active missionary program in and for the Dibble Association. They shall plan the annual Missionary Conference for the association and shall present a report to each quarterly and annual meeting of the association.
