Children's Home Report: The home currently has 17 children; 11 girls and 8 boys. The home hooked up with the city water line, at a cost of about \$1,160. This will probably save on the repair of the well pump, etc. The home is currently averaging paying out about \$14,500 per month and the average receipts are about \$8,500 per month. (Signed, Rev. Rodger Milling) Received as information. General Board Report: (1) We recommend that we find our piano and 50 chairs and bring them home for Rev. Mickey Kirkland to use at the new mission in Montgomery. This was moved, seconded, carried. (2) We recommend that we accept Weems Road Free Will Baptist Church as a mission church, and that we pledge \$50.00 per week for one quarter to supplement the pastor's salary out of the East Alabama Mission Fund. Moved, seconded, carried. (3) We understand that Leroy Forlines is teaching false doctrine at the F W B Bible College by making statements to the effect that Jesus made and drank alcoholic or fermented wine. We hereby let it be known that we do not approve and we suggest that the East Alabama Association write to the college and recommend that they take whatever measure necessary to

correct this problem if it exists. Moved, seconded, carried. It was moved, seconded, and carried that we send the \$10.00 extra per church to the State Association as they voted at the State Meeting. It was moved, seconded, and carried to extend the right hand of fellowship to the Weems Road Free Will Baptist Church.

CHURCH DECORUM

- 1. The church may choose a pastor annually or as determined necessary by the church, or if they prefer they may call a pastor for an indefinite length of time.
- 2. The pastor, if he is an ordained Free Will Baptist minister, shall be moderator of all church conferences. When he is absent or does not serve, the Chariman of the Board of Deacons shall serve in his place, and in his absence some other suitable brother may be selected by majority vote of the congregation.
- 3. There shall be one or more deacons in the church whose duty it shall be to assist the pastor in the administration of the Lord's Supper.
- 4. Some suitable member shall be appointed clerk and it shall be his duty to do all the recording and other writing pertaining to the business of the church and to preserve a file of minutes of the church.
- When a new clerk is appointed, all books, etc. belonging to the clerk shall be immediately delivered to him by his predecessor.
- 6. It shall be the duty of every member, male and female, to attend each conference meeting if they can, for on that day the pastor is expected to instruct the church in spiritual manner by giving plain and pointed lessons on doctrine, discipline and the rule of holy living.
- 7. Conference shall be opened and conducted as follows:
 1. Prayer (unless divine service has been conducted.) 2. Invite
 visiting brethren to sit with us. 3. Open door of church for reception of members. 4. Acknowledgements. 5. References or
 deferred business. 6. Matters of dealing which are in order to
 come before the church. 7. Miscellaneous business. 8. Adjournment.
- 8. Visiting brethren who are called in as helpers from sister churches shall be allowed to speak and make motions or second motions, but will not be allowed to vote.
- 9. Any orderly member of another church who does hold this church in membership, may be received into the church without a letter, when it is made apparent that his Christian character is unimpeachable, and that he has applied for a letter and could not obtain it because he desired to join this or some sister church. All other members must join by letter or baptism.
- 10. No member shall be received without the majority of the members present, but unreasonable objections shall not be valid and unless withdrawn the member who makes them shall be liable to be taken under dealing by the church.
- 11. No member shall be expelled unless he has been cited verbally or in writing to attend this trial provided his residence be known to the church.
- 12. The evidence in every case of dealing and acknowledgement shall be recorded in the minutes in the church books.
- 13. Members dismissed from the church by letter, who become disorderly or continue to hold their letter without a good reason, shall be cited to the conference to answer for their conduct.
- 14. Expelled members may be restored to fellowship on their petition, if their walk since expulsion has convinced the church that they have sincerely repented of their former evil.

- 15. A vote shall not be taken on any question without being moved and seconded and all important questions must be moved and seconded and the vote taken by members rising to their feet, and all votes taken by count.
- 16. No other motion shall be considered while a previous motion and second is before the conference.
- 17. It shall be considered disorderly for a member to be absent from conference when an important question is to be decided; but a member, upon his request, may be excused by the church from voting on either side in particular cases.
- 18. No member shall leave the house during conference without a sufficient cause nor engage in conversation or whispering without being subject to being subject to being called by the moderator.
- 19. All discussion in conference must be conducted with calmness and good faith; those who speak must rise to their feet and address the moderator, and keep to the point in debate.
- 20. No one shall speak more than three times on the motion without permission of the moderator, nor shall the remarks of anyone be unreasonably long.
- 21. When the moderator speaks he must nominate some other brother in his stead.
- 22. No one shall be interrupted while speaking unless it is necessary to call the speaker to order.
- 22. No one shall be interrupted while speaking unless it is necessary to call the speaker to order.
- 23. It shall be the rule of the church to attend to the administration of the Lord's Supper and feet washing at least once a year and the expenses are to be paid by the church.
- 24. Members not in good standing shall not commune, but the administration shall not be deferred on account of any.
- 25. Public fasting, humiliation and prayer shall be ob-'served on proper occasions.
- 26. This Decorum may be amended or altered by the vote of two thirds of the members present at any two succesive monthly conferences.
- 27. Any member who is absent from his church for six months shall be placed on inactive roll until he returns and proves himself to the satisfaction of the church.

BY-LAWS

- The East Alabama Association of Free Will Baptist and its members adopt the treatise of the national association of Free Will Baptists in faith and practice.
- The clerk and assistant clerk, or in their absence, the senior minister in years shall call the association into conference, and if a quorum is present the moderator or in his absence, the assistant moderator shall take charge; and if neither

of these is present, the senior minister in years shall act as moderator.

- 3. It shall be the duty of the clerk to enroll the delegates to the association. These delegates shall present themselves with proper evidence of their rights to their seats therein, and those enrolled by the clerk shall compose the association. In case of questionable representation, however, the case under question shall be referred to the credential committee.
- 4. It shall be the duty of every body belonging to this association to send a letter to every annual session of this association reporting in the same spiritual condition, benevolent work and statistics. Any body belonging to this association which fails to report itself for two successive sessions may be dismissed from the association by a two thirds vote of all members present.
- 5. Each meeting shall be opened by reading a portion of the Bible and with prayer and shall be closed with prayer.
- 6. By a two thirds vote of all members present a ruling of the moderator can be overruled.
- 7. This association may correspond by messenger or otherwise with other religious bodies.
- 8. This association shall sit with open doors except when it shall go in a committee as a whole.
- 9. Any person not a member of this association may be allowed to take part in its discussion by obtaining permission from the moderator.
- 10. It shall be the duty of all members of the association to be present at the time appointed for each meeting.
- Il. No member shall absent himself from the association during its meeting without first obtaining permission from the moderator.
- 12. No person shall be allowed to nominate more than one member of any committee, provided the person nominated be elected.
- 13. The moderator shall not allow discussion when not carried on in a Christian spirit or when he thinks it will cause discord or division.
- 14. Anyone desiring to speak shall rise to his feet and address the moderator by the appellation "Brother Moderator", but shall not speak further until recognized by the moderator.
- 15. The "yeas" and "nays" may be counted on any question by request of one fifth of the members present.
- 16. No member of this Association shall be allowed to speak more than five minutes nor twice on the same subject without permission from the moderator.
- 17. It shall be the duty of the moderator to seat delegates in a designated section of the assembly room at the beginning of the business section.
- 18. These By-Laws may be altered or amended at any regular or adjourned session of the Association by a two-thirds vote of the

members present.

- 19. Minutes of the last Association meeting shall be read and adopted at the beginning of each session.
- 20. Licenced Free Will Baptist preachers may be ordained after having been licensed for one year. The only exception shall be when a properly licensed preacher (FWB) is called to pastor a Free Will Baptist Church then he may be ordained before the year is completed.
- 21. Any church desiring the service of the Ordaining Council between conferences must bear the expenses of the council.
- 22. Any minister coming to this association bring letter of recommendation from his association.
- 23. This association shall not consider for ordination any man who does not pay tithes, or any man who has been divorced and remarried, if first wife is still living.
- 24. Each pastor shall be accepted by the ordination council before being placed on any board of permanent committee.
- 25. A minister coming to this association for the first time shall being a photostatic copy of his ordination papers, or some proof of his having been ordained as a Free Will Baptist. Such papers shall be kept by the clerk.

A minister coming from a local church not a member of an association be examined by the ordination council.

- 26. (passed August, 1962) We recommend that each church enclose with their letter a list of ministers and deasons to receive certificates of standing and that each church have 6 delegates for the first 100 members and one delegate for each 50 added members.

GENERAL RECOMMENDATIONS:

 That the By-Laws be amended to include the following governmental statement: No officer, board, committee, or council has any authority over any other officer, board, committee, or council except that which has been specifically described by the associational body in its By-Laws.

All officers, boards, and committes, and councils of equal authority, and are servants of the body of the association. Hence they are answerable to the body for their performance of duties and conduct.

No officer, board, committee, or council shall assume any responsibilities other than that which has been expressly assigned to it by the body. Any officer, board, committee, or council which does not abide by the above stated by-law shall be subject to dismissal and any appropriate discipline decided by the body.

 That the List of officers and their job descriptions be included as part of the By-Laws of the East Alabama Association of Free Will Baptists.

JOB DESCRIPTIONS:

- Moderator: The moderator will be responsible to conduct the business meetings of the association according to Roberts Rules of Order. The moderator is an ex-officio member of all boards committees and councils. The moderator will be responsible to know the Treatise of the National Association of Free WIII Baptists. The Church Decorum and the By-Laws of the East Alabama Association of Free Will Baptists.
- Assistant Moderator: The assistant moderator willbe equally qualified in his knowledge of Free Will Baptists as the Moderator. He will be responsible to do the job of the moderator in his absence.
- 3. Clerk: It will be the duty of the clerk to keep accurate minutes of all associational meetings. Also keep all records orderly and up-to-date. It is also the duty of the clerk to handle all correspondence reports, and letters to all other levels in the denomination. It will also be the duty of the clerk to keep accurate and honest account of the associations' general fund and disburse the money according to the will of the association.
- 4. Assistant Clerk: It will be the responsibility of the assistant clerk to work closely enough with the clerk's duties that she may efficiently take her place when unable to perform said duties.
- 5. East Alabama Mission Fund Treasurer: It will be the responsibility of the mission fund treasurer to receive all contributions to the mission fund, keep accurate and honest account of them and disburse them at the will of the body.
- of the Trustee to the Children's Home to attend all meetings of the board of trustees for the Children's Home. While there he will take notes of the meetings and give brief but accurate reports of said meetings to the body. It will be the duty of the trustee to reflect the opinion of the body when voting on all matters concerning the Home when said opinion has been expressly stated. Otherwise he will vote appropriately.

- 7. Board of Christian Educatoin: It will be the responsibility of the Board of Christian Education to act in an advisory capacity concerning the educational activities of the association. They will be responsible to recommend the structure of youth camp(s) and recommend qualified directors for the camps. It will be the responsibility of the board to set dates, times and places for associational youth rallies. It will be the responsibility of the board to recommend whatever steps and activities they deem beneficial and practical to the association for the furtherment of our association.
- 8. Ordination Council: The Ordination council will act as the credentials committee when needed. The ordination council will be responsible for the thorough examination of all candidates for ordination to the office of deacon or preacher in the association. The council shall not recommend any candidate who does not meet the requirements of the association as reflected in our minutes (most recent) This includes any who have never been ordained, as well as those who come from another demonation or association. Only ordained men can serve on this council.
- be made up of the pastors of the East Alabama Association, who are in good standing. The General Board may meet, and if they desire, elect an Executive Board out of the General Board. The Executive Board shall act in an advisory capacity in cases of church disputes and/or associational disputes. The Executive Board will act in an advisory capacity in regards to the disbursements of the assets of the Home Mission Fund. The Executive Board shall act as the association's representative in the organization of new churches (when requested), and in the commissioning of home missionaries under the association's support. (Only ordained men can serve on either Board).
- 10. Business and Finance Committee: It will be the responsibility of the Business and Finance Committed to consider and examine all major items of business that will come upon the floor of any business session. The committee will make known all items of business which come before it whether they recommend them or not. The business and finance committee may refine or alter any item of business that is presented before it to make it more practical.
- 11. Resolutions Committee: (Be it recommended that the "Temperance, Sabbath Day Observance, and Deceased Committee be dissolved and consolidated into this one committee for the sake of convenience and efficiency.) It will be the responsibility of this committee to formulate and present resolutions concerning important moral and doctrinal issues when instructed to do so by the body. It is also the responsibility of the resolutions committee to give a report in the form of a resolution concerning those in our churches who have died during the previous year. This committee will be appointed and function only during the yearly meeting in February.

STATEMENT OF PURPOSE:

It is not my purpose by presenting these recommendations to

interefere where I am not wanted. But to help accomplish a duty that has been assigned to the executive committee six months ago. These recommendations are not meant to be exhaustive by any means but are presented as merely guidelines for the executive committee to go by in presenting their recommendations to the association. May God bless you in your work and if I can be of any future help in this matter please call on me.

ARTICLES OF FAITH

- The Holy Bible. The Scriptures of the Old Testament were given by inspiration of God, and are our infallible rules of faith and practice. 2 Peter 1:18-21,2 Tim. 3:16-17.
- 2. God. There is one living and true God, revealed in nature as the Creator, Preserver, and Righteous Governor of the Universe; and the Scripture as Father, Son and Holy Ghost, yet as one God infinitely wise and good, whom all intelligent creatures are supremely to love, adore, and obey. Deut. 6-4;1 Cor. 8:4, Jer. 10:10, Jun. 7:28;2 Cor. 1:19;1 Tim. 6:17.
- 3. Christ. Christ is God manifest in the flesh; in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified. He is now risen and glorified, and is our everpresent savior and Lord. Isa. 45:21; Jn. 4:42; Rev. 22:13; 1 Jn. 5:20; I Tim. 3:16.
- 4. The Holy Spirit. The Scriptures assign to the Holy Spirit all the attributes of God. He is the Reprover, Comforter, Guide and Sanctifier of men. Jn. 16:13; I Cor. 2:11; Acts 13:2; Jn. 16:8.
- 5. The Government of God. God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts of grace not otherwise provided for as the highest welfare of man requires. Ps. 19:12; Psa. 145:10; Acts 1:28; Psa. 22:28.
- 6. The Sinfullness of Man. Man created innocent, but in disobedience fell into a state of sin and condemnation. His posterity, therefore, inherit a fallen nature of tendencies that all who come to years of accountability, sin and become guilty before God. Deut. 30:19; Ezek. 33:11; Jer. 44:4; Psa. 5:15; Jn. 6:44.
- 7. The Work of Christ. The son of God by His incarnation, life, sufferings death and resurrection effected for all a redemption from sin that is full, free and is the ground of salvation by faith. 2 Col. 2:8-10; Jn. 3:3; Col. 2:8-10; Jn. 16:30; Jn. 3:13; Isa. 9:6.
- 8. The Terms of Salvation. The conditions of salvation are:
 1. Repentance or sincere sorrow for sin and hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Savior and Lord with purpose to love and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit, freed from the dominion of sin and becomes a child of God.
 3. Continuance in faith and obedience until death. Rom. 10:10; Acts 16:31; Heb. 11:16; Rev. 2:10; Jn. 15:9.
- 9. Election. God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ men become His elect. Rom. 11:5-7, 28; Rom. 9:11.
- 10. Freedom of the Will. Human will is free and self controlled, having power to yield to the influence of the truth and the spirit or to resist them and perish. Rev. 22:17; Jn. 11, 12.
- 11. Salvation Free. God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all and whosoever will may come and take of the water of life freely. 2 Col. 13:14; Matt. 11:28; Isa. 45:22; Rev. 22:17; I Tim. 2:4.

- 12. Gospel Ordinances. BAPTISM, or the immersion of believers in water, and the LORD'S SUPPER are ordinances to be perpetuated under the Gospel; Feet Washing, is an ordinance teaching humility of universal obligation, and is to be administered to all true believers. Matt 28:19; Col. 2:12; Acts 8:36-39; M. 1:5; Rom. 6:4; Matt. 26:26-28; I Cor. 10:16-21; John 13: 1-17.
- 13. Tithing. God commanded tithes and offerings in the Old Testament. Jesus Christ endorsed it in the Gospel (Matt. 23:23,) and the Apostle Paul said, "Upon the first day of the week let every one of you lay by him in store as God hath prospered him." (I Cor. 16:2.)
- 14. The Christian Sabbath. The divine law requires that one day in seven be set apart from the secular employments and amusements for rest, worship, holy works and activities, and for personal communion with God. Gen 2:3; Mk. 2:27; Ex. 20:8-11; Neh. 9:14; Luke 24:1-6.
- 15. Resurrection. Judgment and Final Retribution. The Scripture teaches the resurrection of all men at the last day. They that have done good will come forth to all the resurrection of life, and they that have done evil unto the resurrection of damnation; then the wicked will "go away into eternal punishment, but the righteous into eternal life." Eccl. 12:7; Phil. 1:23; Lk. 23:43; Matt. 17:3; Matt. 10:28; Acts 1:11; Matt. 28:6; Jn. 5: 28, 29; Acts 25:15; I Cor. 15:22; Rev. 20:12; Rom. 2:16; Matt. 25: 46; II Thess. 1:8-10; Rom. 2:23; II Pet. 1:11; Mk. 3:29; Matt. 13: 41-43; Rom. 2:6-10; Acts 17:31.

FROM: Requirements for ordination into the offices or acceptance into the offices of Deacon and Preacher

We, the Ordination Council for the East Alabama Association of Free-Will Baptists wish to make the following requirements necessary for the ordination of any individual to the offices of deacon or preacher. We do not wish to impose any of the following requirements on any ordained individual who presently holds credentials, but we do encourage our presently ordained men to abide by the requirements for the sake of consistency. We feel that all of the following requirements are based on scriptural precept or principle. Please pray about this and voice your opinion by exercising your right to vote at the next quarterly meeting of our association.

REQUIREMENTS:

- 1. Cannot have but one living wife.
- 2. Must tithe. (10% of their income)
- 3. Must attend all services of their local church faithfully.
- 4. Cannot use or handle alcohol or tobacco.
- 5. Must read his Bible faithfully.
- 6. Must pray faithfully.
- Cannot use off-color language.
- 8. Must have a good reputation concerning his financial obligations.
