The meeting opened with a song, Standing On The Promises, led by Brother Scott Porter, with Sister Debbie Woolbright at the piano. Brother David Burgess led prayer.

A welcome devotion was given by Brother Travis Penn using I Samuel 4:3-11, titled, "Putting Our Trust in the Wrong Things". This was a stirring devotion reminding us not to just go through the motions in our Christian activity. After the devotion, Brother Travis closed in prayer.

Brother David Shores was recognized and asked to give a report. He stated that he would like to see others give reports about Operation

Brother Mark Shores informed the body that he has been called to be a home missionary to Albuquerque, NM. His duties as pastor at Johnson City FWB will end as of the end of October. At that time, he will begin itinerate work to prepare his upcoming ministry. He asked for our prayers and asked for the pastors present to set up services with him for a presentation of the work.

Brother Lyle and Sister Marie Rutger went to Chicago. Sister Marie said they handed out over 4,000 pieces of literature. Brother Lyle reported that there were two telephone calls asking for more information even before the group had finished their work and returned to the church.

Brother Mike Robertson reported that 19 people from Effingham made the trip to Springfield to help Brother Doggett there.

Another day is planned for the last weekend in September next year.

Recessed was called to allow the committees time to complete their work.

The meeting was called back into session by Brother Ernie Lewis.

Brother Ernie Lewis gave a report for Camp Hope. The Oak Valley church had made a challenge to the other churches in the district to fund new chairs for the camp. Brother Ernie reported that they already had about \$700 toward that project. He also stated that the camp board had looked into the price of the chairs they would like to buy. One cost \$16, the other cost \$17 each. The board would like to purchase about 100 new chairs. Brother Ernie again challenged the district churches to meet this need. He spoke of many other projects that the camp board would like to undertake and the possibility of challenging the other districts in the state to match what the East Central Quarterly has done.

The all-purpose building is still having problems with the roof. The roof is "sliding off" on one side of the building. It is now starting to leak. Estimates to fix the problem range from \$20K to \$50K.

A few years ago, it was decided by the board to replace the beds in each of the dorms one cabin at time. Unfortunately, they have only been able to replace beds in one cabin at this time.

Brother Ernie stated that any designated money that an individual or group would like to give for any of these needs can be mailed to Brother Ronnie Mitchell, camp board treasurer. He also stated that the money could be given through state channels by sending it Brother Tim Hayes.

A report of activities at the Pleasant View FWB church was given by Sister Paula Hayes. Their pastor, Brother Clifton Buchanan, has resigned and moved to southern Georgia. They appreciate all of those speakers who have filled in while they look for a new pastor. They recently had a service conducted by the youth of the church. They were excited to see how eager the youth were to take over the various duties. She encouraged all of the churches to involve the youth as much as possible. They had a hailstorm last spring that damaged the roof and siding of the church. They have now replaced the roof and hope to replace the siding soon. They have also finished the handicap access ramp and bathrooms.

A report on activities at the Salem FWB church was given by Brother Dale Braddock. He also mentioned that they were without a pastor, for nearly two years now, and they have really appreciated those who have filled the pulpit. Even though this is a tough time for a church, he mentioned that several have really grown in their spiritual relationship during this time. Their Wednesday night prayer meeting has grown in number as well.

The Youth Committee report was given by Brother Kent Waller as follows:

Item 1: Blue Point FWB church will host a youth rally this quarter. A letter will be sent at a later date outlining the arrangements.

Item 2: Encourage all high school aged youth of our churches to attend Welcome Days at FWBBC in Nashville.
