MINUTES OF THE JANUARY 30, 2010 MEETING

BUSINESS SESSION

Moderator David Burgess welcomed everyone to the meeting and directed the clerk to call the meeting to order. Standing delegates were recognized. The clerk read the reports from each church. MSC to accept the reports and seat the delegates. The minutes from the October meeting were available in typed form. MSC to accept the accept the minutes.

Kathy Hayes gave the treasurer's report. We began the quarter with \$823.40. Dues were received \$315 and an offering of \$178 made available \$1316.40 to work with. Disbursements made include \$75 to Bud Porter for a new briefcase for the Examining Committee, \$20 Tyler Penn (speaker), \$50 Paula Hayes (clerk), and \$150 to the State Association for our designated giving. MISSIONS--Bro. Ernie Lewis added that the Josh Bennett and Jeff Goodman families are leaving ministries in Homerville, Georgia and going to Arizona as the Marana Project. Ashley Bennett and Jeff Goodman are both from Illinois. Shane Davison, former international missionary may be coming back to help them on the field. The Detherages are in language study. They have been attending the ELIC winter meetings. Stephen Gray in Collinsville, fell and broke an ankle and had to have surgery. Discovery's average attendance was 91. They are excited about that. Becky Ham is here today and will tell us about her work. We haven't heard much from

Tim Lewis. Darren Portell may be coming home this summer. Dennis Teague continues working with youth in France. Jason Taylor is praising the Lord that they had 190 in services. In two services they saw four saved then the next week, they had 242 in service and saw 7 saved. Continue to pray for each of theses missionaries and their families as they serve. Then Bro. Each item was made a motion, a second was received and each item carried by majority vote. Furthermore, a motion and second to receive a special offering for Becky Ham at the end of the service was carried.

Moderator David Burgess called for a motion to bring the Constitution and By-Laws addition off the table to be dealt with. MSC to bring that motion off the table. Article IX, Paragraph D would state: "Ordained deacons in good standing that become inactive in Free Will Baptist Church(s) in the state of Illinois, would be recognized as ordained authority in the district. A confirmation of good standing by letter from the deacon's home church would be expected." There was some discussion about this proposed change. Ernie Lewis and David Shores voiced their opposition to this proposal. The terms "inactive" and "in good standing" could be misleading. Mike Crabtree, member of the committee, said that this could bring about the possibility of deacons going before the examining committee. It was pointed out by Bro. Ernie Lewis that examining the deacon is the

local church's business. Since the Examining Committee was still out, Moderator David Burgess suspended the discussion until they returned to the full body.

LOCAL CHURCH REPORTS

OAK VALLEY CHURCH--Bro. Craig Smith updated us on what the Oak Valley Church has been doing. They distributed food baskets and visited shut-ins at the nursing home. Oak Valley also continues to support the food pantry and hold a service in connection with the Hope Center. They are in the planning stages for a building program. The youth meet every Sunday evening. They had a Thanksgiving social, as well as a Christmas sing-along. Pray for Oak Valley and they will continue to pray for you.


- 3. We met with Bro. Luther Ganieany. We will issue a certificate of recognition of ordination today. He has completed his required meetings and reports.

Secondly, David pointed out that neglecting strongholds become roadblocks. Joash was not willing to get rid of pagan practices. Are you ready to surrender every place in your heart to God or are you hanging on to something that doesn't belong?

Verses 17 & 18 tell us how Joash surrendered things that should have never been surrendered—sacred things. When push comes to shove in our lives, what gives way? If we are earnestly seeking a closer walk with the Lord, we should not surrender to anything or anyone but the Lord.

Ignoring the call to repentance can also be a roadblock. Joash did not like the message, so he killed the messenger. You can chose to ignore God's call to repentance or you can chose to answer. The choice is up to you. Before closing in prayer Bro. David left us with this thought, "genuine sorrow leads to repentance." A motion to give Bro. John Hollis \$200 to help with expenses was seconded and approved by the body present. Bro. Ernie Lewis closed the meeting in prayer with a blessing on the food.
