- 1) Believing abortion to be the taking of human life (Ex. 21:22-25) and believing in the sanctity of all human life (Ex. 20:13), we recommend that we as indivudial believers, take an active role in pushing for the enactment of both "The Post Viable Child Protection Act" (S. 343/HB 2204), which would prohibit abortion after the unborn child is viable and "The Parental Consent Bill" which would require parental consent for minors seeking abortions while still dependent upon their parents by praying, circulating petitions requesting our legislators to pass these statutes, and by personally contacting our representatives, and
- 2) Whereas, we believe the current bills to put parimutual gambling and a state lottery on the November ballot promote self gain at our neighbors expense which is inconsistent with Matthew 22: 36-40, we recommend that we do not let down under the weight of our opposition but continue to take an active role individually, locally, and as a district in seeking to defeat these bills through prayer, petitions, and personal contact with our legislators.
