We the Public Morals Committee feel that we as Christians need to be aware of a serious and dangerous demonic worship called "The Witches of Oz," which has recently met in Lawrence, Kansas. They meet four times a year.

Here are a few of their viewpoints: 1) We are kept secret because people on the outside don't understand, they think all witches are bad. 2) Most all say how they came from religious backgrounds (Galatians 5:19-20) 3) They use the elements - water, wind, and fire (Deut. 18:10) 4) They don't associate with Satanism or Christians - both have stole rituals from them (example: The Christians stole their fertility egg "The Easter Egg").

They don't say a lot about Satanism for being a form of Satanism themselves. This secret is so well kept here in the mid-west that it could be your neighbor, teacher, or mailman.

We feel that we as Christians should be aware of this demonic worship as much as we are aware of abortion, drugs, abuse, etc. (Rev.21:8)


