Public Morals Committee Report

Who is Harry Potter? He is the main character of a best-selling children's fantasy book series (with a movie and sequel in the works). An orphaned boy who discovers he's a wizard with magic powers. The story centers on "good" magic (Harry, parents, friends represent) versus "evil" magic.

Why are these stories so popular? They give kids a sense of a supernatural world that is bigger than themselves—one that allows them to access power that will change their lives. Why should we as Christians be concerned? The major concern is that the books trivialize the biblical admonitions against witchcraft and sorcery. Even though the spells and magic are not actual incantations, may feel that the stories legitimize the idea of practicing witchcraft. They make it seem like the only way to combat evil is through "good" magic rather than the power of God.

What does the Bible actually say about witchcraft and the occult? The clearest admonition is found in Deuteronomy 18:10-12, Isaiah 47:9-16, and also in II Chronicles 33.

Why are kids fascinated by the occult these days...because they have a deep spiritual hunger that is longing to be satisfied.

How can the church reach out to our children? We need to show them that while the fellowship and empowerment that Harry Potter found in a school of witchcraft is counterfeit, that there is real power and true fellowship to be found in God. Genesis 1:1 tells of the power of the one true living God.
