PROCEEDINGS OF THE EASTERN CONFERENCE

The nineteenth annual session of the Eastern Conference of the Original Free Will Baptist of North Carolina, met with the church at Friendship, Jones County, N. C., on Oct. 22, 1914.

Eld. J. W. Alford, who was appointed to preach the introductory sermon, attended and preached. Text: I. Cor. 16:13.

On motion Eld. E. L. Swain be referred to the committee on Ministerial Character.

On motion Eld. J. W. Salter be referred to the same committee.

On motion Eld. B. W. Wells be referred to the same committee.

Devotional committee reported as follows: For tonight, Eld. W. W. Lewis, open; Eld. M. C. Prescott preach. At Trenton, Eld. S. H. Styron preach. At Maple Grove, Eld. G. W. Kennedy preach. For tomorrow at the same stand, Eld. S. H. Styron open; Eld. W. B. Everett preach.

On motion conference close until tomorrow morning 9 o'clock, to be opened by Eld. R. C. Kennedy with a 30 minutes' prayer service.

Closing exercises by Eld. A. E. Rouse.

FRIDAY MORNING

Conference met at 9 o'clock, and opened with a 30 minutes' prayer service conducted by Eld. R. C. Kennedy.

On motion the minutes of yesterday were read and approved.

On motion we send to Eld. L. C. Garner the sum of \$25.00. Motion amended by sending him \$50.00.

On motion the list of churches be called. (See table.)

On motion Eld. E. T. Phillips of the Western Conference be invited to a seat with us.

FRIDAY AFTERNOON

Eld. E. T. Phillips, Editor of the Baptist, was given time, and he addressed the conference on the need of the paper, and the people supporting the same.

Devotional committee reported as follows: This afternoon Eld. Luke Wetherington open; Eld. J. W. Sewall preach. Tonight Eld. W. J. Moore open; Eld. M. C. Prescott preach. Tomorrow, Eld. D. B. Garner open; Prof. J. E. Sawyer preach.

The following private pledges made at last conference for Educational work were paid:

Daugherty, \$5.00; A. E. Rouse, \$5.00; J. E. Sawyer, \$6.25; J. W. Alford, \$5.00; M. C. Prescott, \$5.00; W. W. Lewis, \$5.00; W. B. Lewis, \$5.00.

On motion B. G. Prescott be appointed Treasurer Pro. Tem.

On motion the Finance Committee retire, settle with the Treasurer; the Treasurer make his report, and the committee be discharged.

The various committees reported as follows:

"We, your committee on education beg leave to make the following report: In view of the fact that this conference has accepted the duty of raising \$3,000.00 to meet Ayden's offer, be it resolved,

"1st, That we put forth a stronger effort the coming year than we have the past year toward raising this amount.

"2nd, That this conference appoint a committee of fifteen representative men, (that is, men who know what the general condition of the churches are,) from the different sections of the conference, to make an apportionment between the different churches, of the balance due.

"3rd, That we discontinue the Financial Agent, with its accompanying expense, and ask the pastors, assisted by appointees of their own choice from their churches, to put forth every effort they can toward getting their respective churches to raise this amount, or as much of it as possible, during the coming year.

"4th, We recommend that the churches adopt the principle of setting aside their Sunday morning offerings on this educational apportionment. By the committee."

On motion the report be adopted.

Committee required by above resolution appointed as follows: J. W. Alford, J. E. Sawyer, M. C. Prescott, A. E. Rouse, R. F. Daugherty, G. W. Kennedy, T. L. Hardy, W. W. Lewis, J. T. Caton, J. Y. Sawyer, J. G. Paul, Luke Wetherington, D. B. Garner, L. A. Foy, S. H. Styron.

Meeting of above committee called for 8 o'clock Saturday morning.

A report from the State Convention concerning an Orphanage was read. On motion it be tabled.

On motion we adjourn until Saturday morning 9 o'clock. Conference to be opened with a 30 minutes' prayer service conducted by Eld. J. W. Sewall.

Closing exercises by Eld. H. Cunningham.

SATURDAY MORNING

Conference met at 9 o'clock, and Eld. Sewall being absent, Eld. Everett opened the session with a 30 minutes' prayer service, at the conclusion of which special prayers were offered for those who had requested the same by Eld. A. E. Rouse.

On motion the minutes of yesterday were read and approved.

The Treasurer made report as follows:

The Mission committee reported as follows:

"As we look over the Eastern conference, and seeing so much need of mission work, and realizing that the commission of our Saviour to His disciples to go into all the world and preach the gospel to every creature cannot be done without the aid of mission funds, therefore, be it resolved,

"Ist, That every pastor take up offerings once every three months for this work.

"2nd, That each union meeting in this conference take a collection for missions at each session. By the committee."

On motion it be adopted.

Sunday School committee reported as follows:

"Resolved, 1. That our members be more diligent in attending Sabbath Schools.

"2, That our pastors endeavor to have a good Sabbath School in every church for which they care.

"3, That our schools use F. W. B. literature in full. By the committee."

On motion it be adopted.

Temperance committee made report as follows:

"We your committee on Temperance, seeing the great evil causes by intemperance, resolve,

"1st, That our ministers be total abstainers from all intemperance, and furthermore preach temperance in every church they hold the care of during the year.

"2, We ask every child of God to use his influence against intemperance. By the committee."

On motion it be adopted.

Special committee to apportion the balance due the school among the churches, made report as follows:

"We respectfully ask the churches to make a diligent effort to raise and send to the next conference the amount following their names, as a fund to settle the balance due the school:

On motion the pastors' work in the Eastern Conference begin on January 1st, to come in effect January 1, 1915.

On motion the conference go on record as favoring the suggestion that we endeavor to bring the various conferences together under one discipline, as proposed by the State Convention.

Committee on Ministerial character reported as follows:

"We, your committee on Ministerial Character beg to make the following report:

"We recommend that you excuse Eld. E. L. Swain for not coming to this conference for reasons he sent you by Eld. Sewall.

"We find that Eld. B. W. Wells stands charged with certain things, which, if true, would impeach him from his ministerial functions. We recommend that he be silenced until next conference, and his church be notified of this action, and they shall give him trial as required by Sec. 5 of the Discipline, and he be required to come to the next conference to answer the charges against him, and failing to come, he shall be excommunicated from this conference.

"We also find that Eld. J. W. Salter stands charged with things that would impeach his ministerial character, if found true. We therefore recommend that he be silenced until next conference, and that his church give him a trial according to the Book of Discipline Sec 5, and he be demanded to come to the next conference to answer these charges, and upon his failure, he shall be excommunicated from this conference. By the committee."

On motion the report be adopted.

Committee to apportion the Retired Ministers' funds made report as follows:

"Eld. J. Bennett, \$75.00; Eld. I. H. Pipkin, \$20.00; Eld. W. G. Jones, \$10.50; widow of Eld. Slaughter,

On motion it be adopted.

On motion this conference empower the Executive committee to dispose of the property at Edwards as they see fit, and report to the next conference.

M. C. Prescott, Financial agent, presented bill of \$12.00

On motion it be allowed.

On motion we send to Eld. L. C. Garner the Mission money on hand at this session (\$26.78.)

Petitions for the next conference were taken up and two were found. Macedonia and Arapahoe. By vote it was ordered held with the church at Macedonia.

On motion the Executive committee correspond with the Treasurer and find out our financial standing, and if there is a balance found, an order be drawn and honored in favor of Bro. L. C. Garner for the balance due him of the \$50.00 voted him by this body.

On motion, Eld. A. E. Rouse preach the Introductory sermon at the next conference, and J. W. Alford be his alternate.

Devotional committee reported as follows:—This afternoon, Eld. J. W. Sewall preach. Tonight, Eld. J. E. Sawyer preach. Sunday, Elds. A. E. Rouse and M. C. Prescott preach.

On motion the clerk prepare the minutes for the press, and he be allowed \$12.50 for his services.

On motion the F. W. Baptist Pub. Co., be instructed to publish the minutes, and distribute them as heretofore, and draw on the Treasure for the expense of same.

On motion the Trustees of the Belhaven church be

empowered to make such a deal as they see proper for their church.
