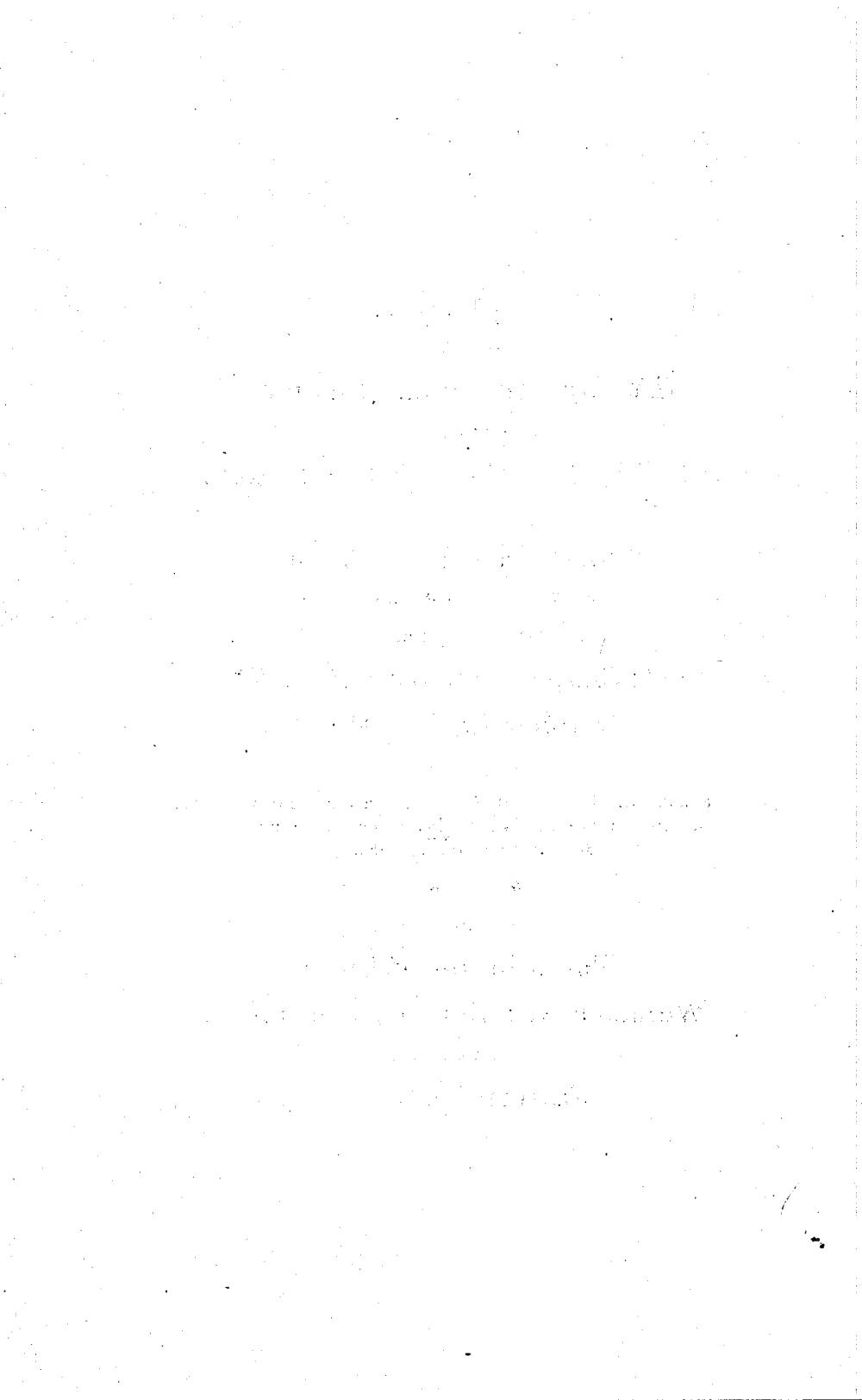

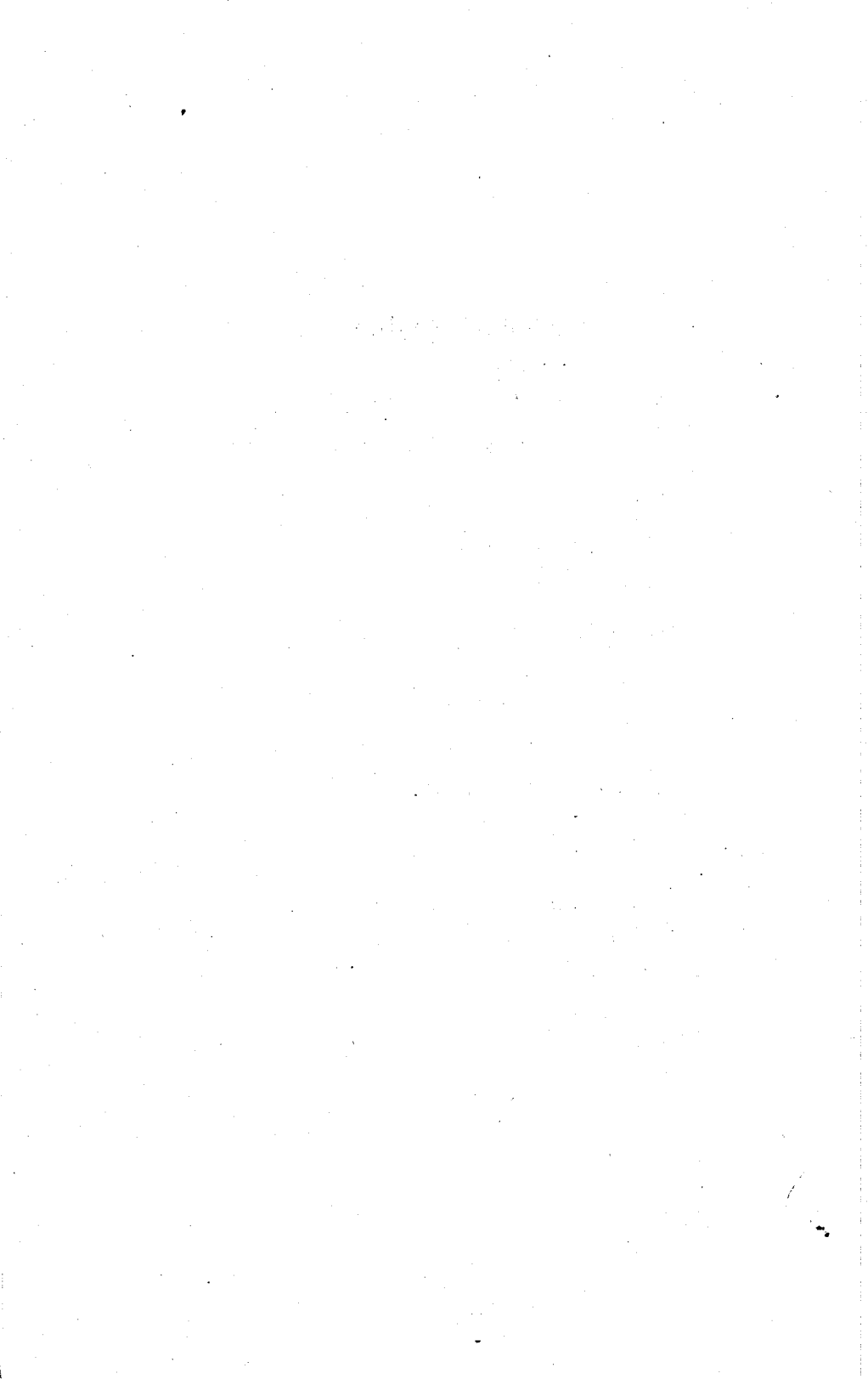

PROCEEDINGS

The Fifty-Fourth Annual Session of the Eastern Conference of the Original Free Will Baptists of North Carolina, convened with the church at Dailey's Chapel, Lenoir county, North Carolina, at 10 o'clock A. M., on October 19, 1949.

Proper devotions were conducted by Rev. Sam Kennedy.

The following officers were present: Rev. S. A. Smith, Moderator; Rev. Clinton Lupton, Assistant Moderator; H. M. Mallard, Treasurer; J. W. Alford, Clerk.

The Minutes of the Executive Committee were read as follows:

The Executive Committee of the Eastern Conference of the Original Free Will Baptists of North Carolina met at Bridgeton, N. C., on November 2nd, 1948. Present S. A. Smith, Chairman; J. W. Alford, Secretary; Lloyd Vernon. Visitors, J. R. Bennett, Sam Kennedy.

Bro. W. R. Millard who asked for a letter at the last session of the Conference came before us and asked to be reinstated as a licensed minister.

On motion Bro. Millard was reinstated as requested.

On motion we adjourn.

The Chairman, later on the same date, called the Executive Committee back in session, and a motion was made to rescind the motion by which Bro. Millard was reinstated, this motion being at his request.

On motion the Committee adjourned.

The Executive Committee of the Eastern Conference met at Kinston, N. C., on December 29, 1948.

Present: S. A. Smith, Chairman; H. M. Mallard, Treasurer; J. W. Alford, Secretary; Lloyd Vernon, J. C. Griffin.

Prayer was offered by Bro. Mallard.

Bro. W. R. Millard appeared before us, and made the contention that in spite of the action of the Executive Committee on November 2nd, 1948, he is entitled to the letter of commendation ordered by the Conference.

By vote it was agreed that the letter ordered by the Conference was voided by his re-instatement on November 2, 1948.

On motion we give to Bro. W. R. Millard the following Certificate:

This is to certify that the name of W. Russell Millard was dropped from the list of licensed ministers of the Eastern Conference, at his request, on October 20, 1948, and affirmed by the Executive Committee of the Conference on November 2, 1948, and further re-affirmed by the Executive Committee of the Conference on December 29, 1948, and the said Eastern Conference has no further claim on him.

The minutes were read and approved.

On motion we adjourned.

Dismissed by Rev. J. C. Griffin.

On motion the Minutes of the Executive Committee were adopted.

On motion the name of Judy Caro be dropped from the list of Licensed ministers.

At this time a special prayer was offered for several ministers who were reported sick.

Rev. M. L. Johnson gave a report of the Church Finance Association, Inc., and on motion it was received as information.

Rev. M. L. Johnson gave a report on Superannuation as follows:

Your Churches are asked to raise \$1,100.00 during this Fall, as their part of the \$7,500.00 budget for the next year.

On motion the report was adopted.

At 11:15 o'clock, Rev. J. C. Griffin preached the introductory sermon. Subject: Pentecost. A very good message was delivered, after which we were dismissed for dinner.

Wednesday Afternoon

After a bountiful dinner, we re-assembled at 1 o'clock P. M. for business. Devotions by Rev. W. E. Stilley.

On motion the list of churches was called.

On motion the name of Rev. L. J. Potter was placed on list of Retired Ministers.

The Temperance Committee reported as follows:

We recognize the whiskey and the desecration of God's laws by those who profess His name to be hindering the program of the church in a great way. Therefore we recommend to all our people.

1st—To abstain from the very appearance of evil.

2nd—That we follow more closely the teachings of God's Word in relation to keeping the Sabbath Day holy.

3rd—That our people live such spiritual lives that the world might be drawn nearer to our Lord and Savior Jesus Christ.

On motion the report was adopted.

The Committee on Devotions reported: For tonight, Rev. D. W. Hansley preach. Tomorrow at 11 o'clock, Rev. Clifton Rice preach.

Rev. D. W. Hansley spoke to us about our National Educational program, and encouraged our support of the same.

On motion we adjourn until tomorrow A. M., 9:30 o'clock.

Rev. Albert Harris was appointed to open the session tomorrow with proper devotions.

Closed by singing "Blest be the tie," and prayer by Mrs. L. E. Ballard, remembering the sick.

Thursday Morning

Conference was opened at 9:30 o'clock A. M., with proper devotions.

The minutes of yesterday were read and approved.

The committee on Sabbath Schools reported as follows:

Never before in the history of our church has there been a greater need for Sabbath Schools. We therefore plead prayerfully for this cooperation.

1st—That all the ministers use their power, time, energy and prayers to help us make the Sunday School of our denomination as strong as any.

2nd—That the Superintendents try at all times to live a life beyond reproach, so that they will be a guide to help others find Christ.

3rd—That our teachers study the Bible, as well as the quarterly, so as to give the pupils the best training possible.

4th—We ask and plead with parents that you go to Sunday School with your children. Please don't send them, and you stay at home.

On motion it was adopted.

Petitions for the next Conference were from Antioch and Moseley's Creek, each in Craven county.

By vote it was ordered to be held at Antioch.

J. W. Alford was selected to preach the introductory sermon; Rev. Lloyd Vernon alternate.

Rev. R. B. Spencer spoke to us about the progress of the Press. In his remarks he assured us that the product of the Press is "growing by leaps and bounds."

Rev. J. A. Evans, Field Director-Treasurer of the Orphanage, spoke about the work of the Home, and stated that the Eastern Conference last year went over the top for the budget assigned us. He also assured us that there is a good, substantial growth in building, and improvement in the present holdings.

At 11 o'clock Rev. Clifton Rice preached. Text: Rev. 1:5-6. Subject: *The Blood of Christ*. A very good message was delivered, and at the end of the sermon, an offering was made for the orphanage, which amounted to \$68.54.

Thursday Afternoon

After a very good dinner, we reassembled for the closing session. Devotions were led by Rev. Alton Hill; prayer by Rev. A. L. Reynolds.

The Finance Committee retired and settled with the Treasurer, who reported as follows:

The Examining Board reported as follows:

The Examining Board of the Eastern Conference met at Kinston on December 29th, 1948, and examined Bro. Herbert Turner Tripp, and recommend that he further apply himself to study, and come another year for re-examination.

Members present: J. W. Alford, D. W. Hansley, Lloyd Vernon, S. A. Smith proxy for J. R. Bennett. Bro. J. W. Alford served as Chairman pro tem.

The Examining Board met at Dailey's Chapel church during the session of the Eastern Conference October 19-20, 1949, and examined Bros. Herbert Tripp, Charlie Robinson and Clifton Styron, and recommend the ordination of Bro. Clifton Styron at such time and place as agreed on by the Examining Board and Bro. Styron.

We further recommend that Bros. Tripp and Robinson continue under license, and further prepare themselves.

On motion the report was adopted.

The committee on nominations reported as follows: Rev. S. A. Smith, Moderator; Clinton Lupton, Assistant Moderator; J. W. Alford, Clerk; H. M. Mallard, Treasurer.

Elective members of Executive Committee: J. C. Griffin, Lloyd Vernon.

To represent this Conference in the Annual meetings of the Press: D. W. Hansley, J. W. Alford.

On motion it was adopted.

The committee on Ministerial Character made a verbal report that "all ministers are in good standing."

On motion the report was adopted.

Rev. A. B. Chandler requested a letter to the Albemarle Conference, and by motion it was granted.

Rev. M. L. Tyndall requested his name be dropped from the list, as he has united with the Western Conference.

The following resolutions, approved by the committee on Resolutions were offered: Whereas Time is a precious entrustment, and we are responsible for its proper use, and we are obligated for wise planning, so as to assure proper use of the time God has given us; be it Therefore Resolved:

1st—That a Digest committee, consisting of three members, be appointed

at the opening of each session of the Eastern Conference of Free Will Baptists, whose duty it shall be to receive all letters from churches bearing statistical reports, compile and compare same with statistical table in the minutes of the previous session, and make report to the conference before the close of the session; in order that the Conference may be informed of gains and losses for the year.

2nd—That a program committee, consisting of the Executive Committee of this Conference, be empowered with authority to plan the program for our annual sessions, providing for inspiration, information, and necessary business periods, together with a plan which will lay proper emphasis on our denominational program as a whole.

On motion the resolution was adopted.

Resolved that this Conference instruct the Examining Board not to examine and pass an applicant for ordination, unless said applicant has been graduated from some accredited high school, or his educational qualification is equivalent to same.

On motion the resolution was adopted.

Whereas we have no Constitution and By-Laws of the Eastern Conference which provide for the rotation of the Examining Board, we present the following Resolution:

Resolved, That the Examining Board rotate every five years. Beginning at this session of the Conference: The oldest member, as to time of service, going off each year, and a new member be elected to fill the vacancy.

On motion the resolution was adopted.

Inasmuch as the Dailey's Chapel church, together with its pastor and friends, have so graciously and efficiently entertained the 1949 session of the Eastern Conference of the Original Free Will Baptists, and

Inasmuch as the Holy Spirit has so guided as to give us a glorious session of this Conference through the official staff, the committees and others who have made their contributions for a constructive session, be it therefore resolved:

1st, That we extend a rising vote of thanks to this church, its pastor and friends, for the splendid entertainment rendered during this session.

2nd, That we extend due thanks to the official staff of the Conference for the efficient way in which the business has been conducted. Also to every committee and individual having served our Lord in relationship to this session.

3rd, That we bow our heads in a deep sense of thanksgiving for the guidance of the Holy Spirit during this session, while the Moderator designates someone to lead us in a prayer of gratitude.

A Sketch of the Life of Rev. W. B. Everett

According to our information, Rev. W. B. Everett, was born July 31, 1876, and passed to his eternal reward May the 1st, 1948. He was born near Conetoe, N. C., near the county line of Pitt and Edgecombe counties. At the time of entering the ministry he was living in Clayton, N. C. About the year of 1910 the writer of this sketch met with Rev. W. B. Everett in a revival meeting at White Oak Hill, Nash county, and we were the closest of friends throughout the life of the deceased. We were in school together in the old Seminary at Ayden, during the years 1912-1913, and class mates. We had many quiet hours together. During the Summer of the above mentioned dates we held revival meetings in several churches in the eastern part of the state. A strange connective fellowship existed between us. When Everett, left the pastorate at Sound Side, Tyrrell County, I was his successor. When he resigned the pastorate of St. Mary's in New Bern, during World War I to enter the Y. M. C. A., I was his successor. He went from the Y. M. C. A. to Davis church, Davis, N. C., and when Brother Everett left Davis, I followed him there and from Davis Brother Everett went to Goldsboro, where I was his successor again. And in all these places where I followed this man of God I found a very constructive work and a people who loved and esteemed this man of God, Rev. W. B. Everett. He was not only loved by the members of the congregation that he serviced, but by many of those who had no religious fellowship. His last work was done in New Bern. For years before the end came it was his highest ambition to see and to be used in the construction of a modern Church and Sunday School administration building. He did not live to see the work constructed, but laid a foundation which has matured and as a result of his prayers and admonition the church at St. Mary's, has erected a very modern Educational building, which is a great memorial to the untiring efforts of the deceased.

Rev. W. B. Everett was a great advocate of Christian Education and worked hard for the support of the old Seminary and the Eureka College, and later joined in for the erection and the ongoing of the Free Will Baptist Bible College in Nashville, Tenn. One of his greatest messages on Christian Education was delivered at Smithville, Miss., in behalf of the work in a session of the Eastern General Conference of Free Will Baptist, when in the midst of his message, he said, "I know very little about "Hogology" but I know that the nose has been taken off the "Piney woods rooster" through the knowledge of better breeding, and this being true, I am sure that a better trained and educated leadership in our churches, can be accomplished, through education."

Among the last papers that Rev. W. B. Everett signed, was a circular letter which was sent out by the Board of Education of the North Carolina State Convention of which he was a member. This letter was an appeal to the churches to put on a drive during the month of June for funds for the Free Will Baptist Bible College, in Nashville, Tenn.

Rev. W. B. Everett was loved by the majority of all the people who ever met him. He had a word for all and could speak so as to gain the friendship of newly acquainted people.

He left a wife, Mrs. Fannie Everette and one son Stanley and a host of friends who mourned the loss of this faithful worker for his Christ, but we all can say, "Thy will be done O Lord."
