

CONSTITUTION AND BY-LAWS OF THE EASTERN CONFERENCE

Constitution

PREAMBLE: From long experience, we, the members of the Eastern Conference of the Original Free Will Baptist Denomination of North Carolina, being regularly baptized upon a profession of our faith in Jesus Christ, and realizing the necessity of a bond of union and fellowship among us as a Church or Conference; and to preserve and maintain correspondence and co-ordination with us, do therefore ordain this Constitution for our better conference government.

ARTICLE I

Name-This organization shall be known as the EASTERN CONFER-ENCE OF THE ORIGINAL FREE WILL BAPTIST OF NORTH CARO-LINA.

ARTICLE II

Purpose—The object and purpose of this organization shall be to unify the work of this body which is made up of the various churches composing the Eastern Conference, and to devise and execute measures for the extension of the Kingdom of God in connection with the various Churches of this Conference district, or that may hereafter be represented therein.

ARTICLE III

Composition—This Conference shall consist of delegates duly appointed or elected by the Church they represent, and of all ordained Free Will Baptist Ministers who are of good repute in the Free Will Baptist Church in the district embracing the Eastern Conference.

ARTICLE IV

Representation—Representation to Eastern Conference is to be by the Churches composing the Conference district, and each Church in said district shall be entitled to two delegates.

Sec. 2. This Eastern Conference shall have no power to fill vacancies in the delegation from any church representing, except it be a regular member from the said Church being in attendance at the said session, and that in the absence of the regularly appointed delegate.

ARTICLE V

Finance—Each church representing in this body shall make their donations as liberal as they can, and if possible conform to the custom established some years ago of contributing .50c per member of the Church membership.

See. 2. The Secretary is to be paid the sum of \$35.00 annually and the Treasurer to be paid the sum of \$20.00 annually, all other expenditures not specified herein shall be made at the discretion of the body.

ARTICLE VI

Discipline—This Eastern Conference shall have the right to settle any question of discipline, doctrine or practice that may properly come before it from any of the churches composing said Conference, or act on any special appeal that may be made by any Church belonging to this Conference Said appeal shall have been written and properly signed by the constituent body or bodies, and its decision shall be final.

Sec. 2. All appeals coming before the Eastern Conference may be settled in either of the following ways: (1) By the Conference when sitting in a committee of the whole. (2) By a special committee, whose report shall be voted on without discussion.

ARTICLE VII

Officers—The Officers of the Eastern Conference shall consist of a Moderator, an Assistant Moderator, a Clerk, an Assistant Clerk, and η Treasurer, each of whom shall be elected at the close of each two years regular session.

Sec. 2. Committees as necessary shall be appointed by the Moderator, unless otherwise provided for, and shall hold office until their work is completed, or until their successors are elected.

ARTICLE VIII

Boards—All standing Boards shall be composed of five members, exclusive of the Executive Committee. Standing Boards exclusive of the Executive Committee shall be an Examining Board, Grievance Committee, Trustees, and two representatives of the Conference for meetings of the Printing Press. The personnel of each of the foregoing, exclusive of the Executive Committee, shall be elected as follows: The first named for a term of one year, the second for a term of two years, the third for a term of three years, the fourth for a term of four years, and the fifth for a term of five years. Succession to office thereafter shall be determined as order requires.

Sec. 2. The Excentive Committee shall have the power to act in behalf of and for the Eastern Conference from one regular session to another, and shall also have power to elect such officers as may be necessary for its own government, and to carry out the plans and undertakings of the Eastern Conference.

Sec. 3. The Executive Committee shall be composed of the Moderator, Assistant Moderator, Clerk, Assistant Clerk, Treasurer, and two members to be elected same as the other officers. These shall have the power to fill any vacancies that may occur between sessions of the annual conference, same to be approved or rejected by the following session of the annual Conference. And it shall be the duty of this committee to make written reports of its work to each annual session of the Conference.

ARTICLE IX

The Eastern Conference shall hold its regular meetings arnually begin-

ning on Wednesday before the Fourth Sunday in October and remaining in session until the business has been finished. The place of meeting shall be agreed upon in regular session; however, where a necessity may arise the Executive Committee may at its discretion change the place of meeting.

ARTICLE X

Should necessity arise, from war, pestilence, or any cause which prevents a regular session, whether such condition is of local or general condition then the Executive Committee shall be privileged to call and act with full authority in all matters pertaining to the general welfare of the Eastern Conference and the Church as a whole, provided that every transaction passed shall be by a two-thirds vote of the full membership of the said Executive Committee, provided such transactions shall not conflict with the purpose and edicts of the Constitution as set forth in the preceeding articles.

ARTICLE XI

This Constitution may be amended or altered at any regular session of the Eastern Conference by a two-thirds vote of members or representatives present, provided proposed amendment or alteration be presented in writing to the body one day in advance.

By-Laws

1. The Clerk or Assistant Clerk, or in their absence the senior minister in years, shall call the conference into session, and, if a quorum is present, the Moderator, or in his absence the Assistant Moderator, shall take charge; and if neither of them is present, the senior minister in years shall act as Moderator.

2. It shall be the duty of the Clerk to enroll the delegates to the Conference, who shall present themselves with the proper evidence of their rights to seats therein, and those enrolled by the Clerk shall compose the Conference. In case of a questionable representation, however, the cases under question shall be referred to the credential committee.

3. It shall be the duty of every church belonging to this Conference to send a letter to every annual session of the Conference, reporting in the same its spiritual condition, benevolent work, and its statistics. Any church belonging to this conference which shall fail to report itself for two successive sessions may be dismissed from the conference by a twothirds vote of all members present.

4. Each meeting shall be opened by the reading of a portion of the Bible and with prayer, and shall be closed with prayer.

5. By a two-thirds vote of all members present a ruling of the Moderator can be overruled.

6. This Conference may correspond by messenger or otherwise with other religious bodies.

7. This Conference shall sit with open doors except when it shall go into a committee as a whole.

8. Any person not a member of this conference may be allowed to take part in its discussions by obtaining permission from the Moderator.

9. It shall be the duty of all the members of this conference to be present at the time appointed for each meeting, and anyone wishing to retire shall first obtain permission of the Moderator.

10. No member shall absent himself from the Conference during its meetings without first obtaining permission from the Moderator.

11. No person shall be allowed to nominate more than one member of any committee provided the person nominated be elected.

12. The Moderator shall not allow discussions when not carried on in a Christian spirit, or when he thinks it will cause discord or diversion.

13. Anyone desiring to speak shall rise to his feet and address the Moderator by the appellation "Brother Moderator," but shall not speak further until recognized by the Moderator.

14. The "yeas" and "nays" may be counted on any question by request of one-fifth of the members present.

15. No member of this conference shall be allowed to speak more than ten minutes nor twice on the same subject without permission from the Moderator.

16. It shall be the duty of the Moderator to seat delegates in a body in a designated section of the assembly room at the beginning of each business session,

17: These By-Laws may be altered or amended at any regular or adjourned session of this Conference by a two-thirds vote of the members present.

18. All other By-Laws in conflict with the above By-Laws are hereby repealed.

19. These By-Laws shall be in force from and after they are ratified.

The following resolution was offered and by motion was adopted:

RESOLUTION

Be it resolved by the Eastern Conference of Free Will Baptists of North Carolina, in conference assembled, that we go on record as follows:

First, that we unite our voices with other Protestant groups throughout the United States of America in protesting against the appointment by the President of the United States of a representative to the Vatican, or headquarters of the Roman Catholic Church, in the City of Rome, Italy, it being our conviction that such an appointment would violate the principle of the separation of church and state—a cherished heritage of our nation.

Second, that copies of this resolution be sent to the Presidtnt of the United States, and also to the Congress of the United States when it convenes.

On motion Rev. L. E. Ballard was appointed to edit the above resolution, and mail it to the proper and designated parties.

On motion this Conference approve the ministers licensed during the past year, and we hereafter license all applicants according to the requirements of the Treatise.

On motion any church calling for the Board in the matter of issuing a license to a minister, that church shall bear the expense of the Board.

On motion we adjourn until tomorrow A. M. 9:30 o'clock. Rev. R. N. Hinnant was requested to sing a special number for us, and he very graciously sang .'Leave It There."

THURSDAY A. M.

Conference met at 9.30 o'clock, and was opened with devotions conducted by Rev. T. O. Terry who read Rom. 1:13-15, after which he made appropriate remarks for the opening of the session.

The minutes of yesterday were read and approved.

Bro. C. K. Dunn, the Business Manager of the Press, was called forward, and he made a very interesting report of the work of the Press.

On motion we allow the Clerk to work with the Examining Board in the absence of Bro. Bennett, the Chairman.

Rev. F. B. Cherry, Editor-in-Chief elect of the Press was recognized and he solicited cooperation and counsel on the part of the brethren. The Temperance Committee reported as follows:

REPORT OF TEMPERANCE COMMITTEE

Realizing that only a casual observation reveals to any open-minded person the fact that the cause of temperance is on the losing side in our society, with a constant increase in its ravages as a result of the popularizing of the use of alcoholic beverages by their legalization, and illicit commerce in their distribution, and, of various substances which threaten the very fabric of Christan and moral character, we wish to recommend:

That strict adherence be given to the second paragraph in our Church Covenant on the part of our entire membership. We quote the paragraph:

"We promise by His grace to love and obey Him in all things, to avoid all appearance of evil, to abstain from all sinful amusements and unholy conformity to the world, from all sanction of the use and sale of intoxicating beverages, and to provide things honest in the sight of all men."

Failure on the part of any member of our churches to comply with

the agreement in the above paragraph should be considered as just cause for disciplinary measures being taken by the church.

That our people be urged to stir up a sense of consciousness of the dangers of becoming passive relative to the handling of liquor, beer or wine cartons for any conveniences, and, alert themselves relative to the influence of their personal appearance about places of business which deal in these substances.

Finally, that our young people, and. especially our youth in the high schools be alerted relative to the dangers lurking about those who smoke cigarets, lest they be swept into the use of narcotics which may call upon our virtuous girls to sell their bodies in order to carry out the acquired desires of the flesh.

Minutes of the Eastern Auxiliary Convention March 22, 1951

The Eastern Auxiliary Convention met with Long Ridge Church on March 22, 1951. The devotions were given by Mrs. J. R. Davidson. The Theme for the day was "The Vision of Testimony." Mrs. Davidson spoke on some of the experiences of Paul in his life as a missionary and as a true witness of the gospel of Christ. She said that Paul was a model of obedience, having turned his back on all luxuries he might have had, for a life of suffering, and hardships and labor in the cause of Christ.

The report of the fifth Vice President was given, after which the Superintendent of the Orphanage, Mr. Walter Croom brought interesting news regarding the progress and needs of the institution. In his remarks he stressed the need for a larger amount for clothing, suggesting that Ten Dollars be added to the \$30.00 that had been sent heretofore if possible, since the cost of clothing had advanced in accordance with other living costs.

There was congregational singing, "Help Somebody Today", at which time an offering was taken for the Orphanage, amounting to \$67.65. Mrs. Ballard exhibited a plate, or plaque of the new College Building, at Nashville, Tennessee, stating that they are on sale and may be obtained from her.

She also had Vacation Bible School literature on hand, and where it could '→ be obtained.

Mrs. Smith, the President. presented the speaker at this time, Mrs. Bruce Barrow, who brought an inspiring message on "The Vision of Testimony", basing her remarks on Acts 18:9,10, and using the apostle Paul as an example of service and suffering, of faithfulness and sacrifice and of his final victory when he said, "I have fought a good fight, I have kept the faith." She brought out in vivid description the life and purpose of Christ and His death on the cross, and urged that we make a personal application as Christians. that the Lord enlarge our vision to the extent that we shall make an absolute surrender of our lives to Him in order that our service to Him become more like that of Paul and others who laid themselves and their all on the altar. She closed with a poem, "Out of Touch With the Lord."

The afternoon session opened with devotions by Mrs. Murphy. The first business taken up was the reading the minutes of the A. M. session. Reports were given by the Second. Davidson, who not only brought news, but gave some valuable information relative to the new work being done, new property acquired with an estimated cost of same. He said the total assets with the land and the new building are \$90,314.98. Number of graduates to date are 91. Information was also given relative to the four year courses, number enrolled at present and the number of pupils enrolled during the entire period since the first opening. Mr. Davidson gave as his conviction that Education and Missions must go hand in hand, that we needed a medium through which we can go forward in the Lord, and that this can be done through our Bible College. There were a few remarks by the President and Mrs. Ballard, who suggested that several Bible students were ready to go out in Vacation Bible Schools during the summer.

The Secretary made her report, and gave some information relative to how the Report blanks should be filled out.

Mrs. J. C. Griffin, State Field Worker, made a statement that Auxiliary work throughout the State is very encouraging, that interest is growing and progress is being made.

Mrs. Ballard made a short talk on our Cragmont Assembly, Inc., and closed with a little enactment of "All Aboard for Cragmont!" She had all who had ever been to Cragmont. to sit together on the rostrum and pretend we were on a bus, journeying toward Cragmont and our annual Woman's Conference, while she gave excerpts of conversations and choruses on the way. There was a special selection by Rev. Davidson, "No One Ever Cared For Me Like Jesus."

A rising vote of appreciation for the splendid manner in which the Convention has been entertained, together with the fine spirit of fellowship and co-operation, was tendered the local church, after which the closing hymn "Blest Be The Tie That Binds", was sung. The President recognized the State Auxiliary President, Mrs. J. C. Moye, delegates from other districts and the Ministers present. Mrs. Moye made a short talk, and urged that we stress the need of meeting our obligations in the payment of our per capita dues. Mrs. J. R. Greetings and news from the Orphanage was given by the Superintendent, Mr. Walter Croom. He said in part that he had two reasons for beirg glad to be present; one, that he was always glad to speak in behalf of the Orphanage, the second, that this would be the last time he would appear before the Convention in the capacity of Superintendent. He made a good report of the work as a whole, with details regarding the part this Auxiliary district has had in the support of the Home. He stressed the need for a greater overall view of the situation and condition of the Home with a hope for greater progress based on three things; 1st, the Home as a real home for our children as we would provide for our own homes, 2nd. the great need to cultivate and train the inner lives of the children, rot artificially, but in reality, that they may know God and be qualified to serve Him in every possible way, 3rd, Certain types of vocational training; this pertains to the care of the buildings, stock, farm and other items needed at the home for the well-being of the children in preparing them for their life's work.

Report of the 5th Vice-President was given, after which an offering was taken for the Orphanage amounting to \$85.15. Offertory by Rev. J. C. Griffin. Ballard. Adjournment for lunch and recreation.

Report of 3rd Vice-President was given, after which minutes of the A. M. session were read and approved. Reports of 1st and 6th Vice-Presidents were given, followed by a duct, "Come Unto Me", Shelby Sutton and Naney Lou Dawson.

Mrs. L. E. Ballard gave a talk on the Woman's Conference at Craemont. also urged a greater effort on the part of the Auxiliaries in behalf of the Anna Phillips Loan Fund, stressing the need, and also the great good this Fund is doing for some of our Young People who are trying to prepare themselves for more efficient Christian service, by attending Bible College. She called and received several testimonies from those who attended the Woman's Conference, and closed her remarks with the Conference Chorus, "All My Sins Are Gone."
