



CONSTITUTION AND BY-LAWS Of the Eastern Conference

CONSTITUTION

PREAMBLE: From long experience, we, the members of the Eastern Conference of the Original Free Will Baptist Denomination of North Carolina, being regularly baptized upon a profession of our faith in Jesus Christ, and realizing the necessity of a bond of union and fellowship among us as a Church or Conference; and to preserve and maintain correspondence and co-ordination, with us, do therefore ordain this Constitution for our better conference government.

ARTICLE I

Name-This organization shall be known as the EASTERN CONFERENCE OF THE ORIGINAL FREE WILL BAPTISTS OF NORTH CAROLINA.

ARTICLE II

Purpose—The object and purpose of this organization shall be to unify the work of this body which is made up of the various churches composing the Eastern Conference, and to devise and execute measures for the extension of the Kingdom of God in connection with the various Churches of this Conference district, or that may hereafter be represented therein.

ARTICLE III

Composition-This Conference shall consist of delegates duly appointed or elected by the Church they represent, and of all ordained Free Will Baptist Ministers who are of good repute in the Free Will Baptist Church in the district embracing the Eastern Conference.

ARTICLE IV

Representation—Representation to Eastern Conference is to be by the Churches composing the Conference district, and each Church in said district shall be entitled to two delegates.

SECTION 2. This Eastern Conference shall have no power to fill vacancies in the delegation from any church representing, except it be a regular member from the said Church being in attendance at the said session, and that in the absence of the regularly appointed delegate.

ARTICLE V

Finance—Each church representing in this body shall make their donations as liberal as they can, and if possible conform to the custom established some years ago of contributing 50c per member of the church membership.

SECTION 2. The Secretary is to be paid the sum of \$35.00 annually and the Treasurer to be paid the sum of \$20.00 annually, all other expenditures not specified herein shall be made at the discretion of the body.

ARTICLE VI

Discipline-This Eastern Conference shall have the right to settle any question of discipline, doctrine or practice that may properly come before it from any of the Churches composing said Conference, or act on any special appeal that may be made by any Church belonging to this Conference. Said appeal shall have been written and properly signed by the constituent body or bodies, and its decision shall be final.

SECTION 2. All appeals coming before the Eastern Conference may be settled in either of the following ways: (1) By the Conference when sitting in a committee of the whole. (2) By a special committee, whose report shall be voted on without discussion.

ARTICLE VII

Officers—The Officers of the Eastern Conference shall consist of a Moderator, an Assistant Moderator, a Clerk, an Assistant Clerk, and a Treasurer, each of whom shall be elected at the close of each two years regular session.

SECTION 2. Committees as necessary shall be appointed by the Moderator, unless otherwise provided for, and shall hold office until their work is completed, or until their successors are elected.

ARTICLE VIII

Boards-All standing Boards shall be composed of five members, exclusive of the Executive Committee. Standing Boards exclusive of the Executive Committee shall be an Examining Board, Grievance Committee, Trustees, and two representatives of the Conference for meetings of the Printing Press. The personnel of each of the foregoing, exclusive of the Executive Committee, shall be elected as follows: The first named for a term of one year, the second for a term of two years, the third for a term of three years, the fourth for a term of four years, and the fifth for a term of five years. Succession to office thereafter shall be determined as order requires.

SECTION 2. The Executive Committee shall have the power to act in behalf of and for the Eastern Conference from one regular session to another, and shall also have power to elect such officers as may be necessary for its own government, and to carry out the plans and undertakings of the Eastern Conference.

SECTION 3. The Executive Committee shall be composed of the Moderator, Assistant Moderator, Clerk, Assistant Clerk, Treasurer, and two members to be elected same as the other officers. These shall have the power to fill any vacancies that may occur between sessions of the annual conference, same to be approved or rejected by the following session of the annual Conference. And it shall be the duty of this committee to make written reports of its work to each annual session of the Conference.

ARTICLE IX

The Eastern Conference shall hold its regular meetings annually beginning on Wednesday before the Fourth Sunday in October and remaining in session until the business has been finished. The place of meeting shall be agreed upon in regular session; however, where a necessity may arise the Executive Committee may at its discretion change the place of meeting.

ARTICLE X

Should necessity arise, from war, pestilence, or any cause which prevents a regular session, whether such condition is of local or general condition then the

Executive Committee shall be privileged to call and act with full authority on all matters pertaining to the general welfare of the Eastern Conference and the Church as a whole, provided that every transaction passed shall be by a two-thirds vote of the full membership of the said Executive Committee, provided such transactions shall not conflict with the purpose and edicts of the Constitution as set forth in the preceeding articles.

ARTICLE XI

This Constitution may be amended or altered at any regular session of the Eastern Conference by a two-thirds vote of members or representatives present, provided proposed amendment or alteration be presented in writing to the body one day in advance.

BY-LAWS

1. The Clerk or Assistant Clerk, or in their absence the senior minister in years, shall call the conference into session, and, if a quorum is present, the Moderator, or in his absence, the Assistant Moderator, shall take charge; and if neither of them is present, the senior minister in years shall act as Moderator.

2. It shall be the duty of the Clerk to enroll the delegates to the Conference, who shall present themselves with the proper evidence of their rights to seats therein, and those enrolled by the Clerk shall compose the Conference. In case of a questionable representation, however, the cases under question shall be referred to the credential committee.

3. It shall be the duty of every Church belonging to this Conference to send a letter to every annual session of the Conference, reporting in the same its spiritual condition, benevolent work, and its statistics. Any church belonging to this conference which shall fail to report itself for two successive sessions may be dismissed from the conference by a two-thirds vote of all members present.

4. Each meeting shall be opened by the reading of a portion of the Bible and with prayer, and shall be closed with prayer.

5. By a two-thirds vote of all members present a ruling of the Moderator can be overruled.

6. This Conference may correspond by messenger or otherwise with other religious bodies.

7. This Conference shall sit with open doors, except when it shall go into a committee as a whole.

8. Any person not a member of this conference may be allowed to take part in its discussions by obtaining permission from the Moderator.

9. It shall be the duty of all the members of this conference to be present at the time appointed for each meeting, and anyone wishing to retire shall first obtain permission of the Moderator.

10. No member shall absent himself from the Conference during its meetings without first obtaining permission from the Moderator.

11. No person shall be allowed to nominate more than one member of any committee provided the person nominated be elected.

12. The Moderator shall not allow discussions when not carried on in a Christian spirit, or when he thinks it will cause discord or diversion.

13. Anyone desiring to speak shall rise to his feet and address the Moderator by the appellation "Brother Moderator," but shall not speak further until recognized by the Moderator.

14. The "yeas" and "nays" may be counted on any question by request of one-fifth of the members present.

15. No member of this conference shall be allowed to speak more than ten minutes nor twice on the same subject without permission from the Moderator.

16. It shall be the duty of the Moderator to seat delegates in a body in a designated section of the assembly room at the beginning of each business session.

17. These By-Laws may be altered or amended at any regular or adjourned session of this Conference by a two-thirds vote of the members present.

18. All other By-Laws in conflict with the above By-Laws are hereby repealed.

19. These By-Laws shall be in force from and after they are ratified.

The organization being completed, prayer was offered by Rev. R. C. Kennedy. The minutes of the Executive Committee were read as follows:

The Executive Committee of the Eastern Conference of the Original Free Will Baptists of N. C. met in session at St. Mary's Church, New Bern, N. C., on November 28, 1951.

Present: Revs. Clifton Rice, Chairman; J. C. Griffin, J. W. Alford, Secretary; H. M. Mallard, Treasurer.

Prayer by Brother Griffin.

Bros. John Grimesly and James E. Howard who were requested to be present presented themselves, and the Chairman explained to them that they, as licensed ministers, were requested to be present for counselling together as to their privilege as a licensed minister.

On motion Bros. Grimesley and Howard explained to the churches to which they have been called as pastor, that the church must have a regularly ordained minister as their pastor, and that the Conference will endorse and sustain Bros. Grimesley and Howard in their work as helpers to these pastors.

At this time we called off for the introductory sermon which was delivered by Rev. Sam R. Kennedy, who used Matthew 27:45 as a text. After the sermon we called off for dinner.

A very beautiful dinner was served by the ladies of the church.

Devotions were conducted by Rev. N. D. Wiggs, Jr. Prayer by Bro. Lonnie Mallard.

The meeting was called to order by the chairman.

Minutes of the Eastern Auxiliary Convention

IN SESSION WITH THE KINSTON CHURCH

Thursday, March 20, 1952

The Convention opened with devotions by Mrs. Chambers, who stressed the need of living up to the theme selected for the day-The Hour Is Come that the Son of Man should be Glorified.

Prayer was offered by Mrs. J. C. Griffin.

The welcome address was given by Mrs. Nina Grace Register, and response by Mrs. Nelson Simpson of Bridgeton.

The new President, Mrs. J. K. Bryan, Jr., addressed the Convention and gave some timely remarks on the business of the day, with instructions to the delegates as to their duties.

It was moved and carried that the minutes of the previous convention not be read for information, as formerly. The Secretary asked permission to read the Resolution adopted at the last meeting, which was granted.

Mrs. J. C. Griffin, first vice president, made her report, after which Rev. Burkett Raper led a prayer for the good of the Convention, its officers, delegates and visitors.

Mrs. Clara Jones, second vice president, made report of work done among the youth and urged the Auxiliaries to make preparations for Vacation Bible Schools during the summer, preferably in June.

Mrs. L. E. Ballard announced that literature for Bible Schools was ready for use, and recommended that students from the Bible College be given special opportunities to conduct vacation Bible Schools during their vacation months. She also said that Bible School Clinics are planned for the summer, times and places to be announced later.

The fourth and fith vice presidents made their reports. Mrs. Blizzard, the fifth, reminded us that last September at our annual Convention, she asked for \$5.00 from each Auxiliary to help furnish the boys' cottage at the Orphanage, which has now been completed. She thanked each one for their support, and stated she would have another request later in the day.

News from the Orphanage, with report was made by the new Superintendent, Rev. S. A. Smith. He gave as his objectives for the Home that they know the Lord first of all. From a material standpoint he named three others. The first need is Pay the bills, second, the girls' building completed, third, finish the chapel. He quoted from Paul in I Tim. 5:8 "But if any provide not for his own, and specially for those of his own house, he hath denied the faith, and is worse than an infidel." He also brought the good news that the adopted boy of this Convention, Richard Little, is a Christian. He solicited a continuance of the interest and support for the Institution. Mrs. Blizzard made her request at this time for \$5.00 from each auxiliary with which to buy rugs for the Albemarle Cottage, after which an offering was taken for the Orphanage, which totaled \$108.22.

Mrs. Albert Coats brought greetings from the Cape Fear District Convention,

also Mrs. M. A. Woodard, State Treasurer of the State Convention made a few remarks about the work in the Central District. A bus load of delegates and visitors from Davis was asked by the President to stand for recognition, also she recognized the Ministers present and called for remarks, to which several responded. There were nine from the Eastern District, three Western, two Central and one from the French Broad.

"We've a Story to Tell," was sung by the congregation, after which a special selection was rendered, "He Leads."

At this time the Rev. F. B. Cherry was presented by Mrs. J. C. Griffin as the speaker for the Convention message. After giving some data on "News from the Press," Mr. Cherry spoke on "Revival Fires-1st, *The World's Fire*, 2nd. *Christ's Fire*, and 3rd. *The Revival Fire*. The message was inspirational and illuminating throughout.

The following committees were appointed: Resolutions, Mrs. Marie Gaskins, Mrs. D. F. Chambers, Mrs. Carl Ivey; Petitions, Mrs. Roy Kennedy, Mrs. Sam Howard, Mrs. Katherine Wood. The Finance Committee, which is a standing one, was called as follows: Mrs. Harold Mallard, Mrs. Jonnie Jones, Mrs. J. W. Stilley, with Mrs. Rhom Mallard, Treasurer.

Mrs. Griffin made an announcement relative to sending names to the Secretary of the State Convention, also cards for registration, and urged all auxiliaries to obesrve the Pre-Easter Week of Prayer, and to use the little booklet, "Foot-prints of Jesus in His Last Week."

Announcement was made by the pastor, Rev. Narron, relative to refreshments and rest during the noon recess. A blessing was asked on the food by Rev. Evans and thanksgiving for all favours of the day.

Noon-Adjourned for lunch.

AFTERNOON SESSION

The Convention opened the afternoon session at 1:15 with a Memorial service for deceased members, by Mrs. J. H. Oglesby, which was very impressive.

The business session opened with a report from the field, by Mrs. Griffin. She said this had been the greatest year in her experience as State Field Worker.

Rev. Terry spoke in behalf of the Bible College at Nashville, Tenn. He urged that we give it our whole-hearted support, as conditions there were congested as to space, and that North Carolina has about 42 students. He also urged the use of young Ministerial students during the summer for supply pastors, youth revivals, Vacation Bible Schools, etc.

Rev. J. R. Davidson, one of the Trustees of the College made some timely remarks on the prospects of attaining a piece of property next to the college, which is much needed, and that the national program is being-put in force as fast as possible. He asked for prayer for the program as a whole.

Reports were given by the third and sixth vice presidents.

A talk on Christian Education was made by Rev. David Hansley. He said, in part, that plans were in the making for a junior college to be opened at Cragmont Assembly, Inc., in September, this year.

Mrs. L. E. Ballard gave a report on the Woman's Conference last year, to-

gether with plans for the two separate weeks this year, the first one to be June 8-16, the other August 18-25. There was a motion that Mrs. Ballard sing the Gragmont Chorus, which was carried and the Chorus was sung.

/Rev. Evans arose to say "Amen" to all that had been said about Cragmont, and a double "Amen" for all we hope to do.

The Secretary made her report with some recommendations. Adopted.

Report of Finance Committee was given and on motion received.

The Treasurer gave her report, and on motion was received as read.

The Resolution Committee reported that three Resolutions were presented. These were taken up one by one and after discussion on two of them, were adopted by motion.

The Petition Committee reported petitions from five Auxiliaries, namely, Jacksonville, Snow Hill, Davis, Folkstone and Holly Springs. On motion the next Convention will be held with the Jacksonville Church. A vote of appreciation was given the other petitioners. By motion a rising vote of thanks was tendered Mrs. Raper and Mrs. Mallard for the printing of the program. Delegates to the following Conventions were named by the president: Central, Mrs. D. W. Hansley; Western, Mrs. Bryan (president); Cape Dear, Mrs. Griffin; Albemarle, Mrs. Ballard; Pee Dee, Mrs. Ben Sutton; French Broad, Mrs. Griffin; Piedmont, Mrs. I. W. Swindell; State Convention, which will convene with Bridgeton Church in May, Mrs. Walter Rhodes, delegate.

A delicious lunch was served at the noon hour by the ladies of the Church, which was much enjoyed. A large five tiered cake was presented to Mrs. Alice E. Lupton, honoring her as the founder and promoter of the Woman's work in the denomination. (She acknowledged her appreciation of the favour and was kept busy for some time, cutting and presenting to others generous slices of the cake.)

The Convention adjourned, after a rising vote of thanks was given the local church, with its pastor, for the fine spirit of co-operation during the day, and for the delicious refreshments and other favours.
