PROCEEDINGS

The fifty-ninth annual session of the Eastern Conference of the Original Free Will Baptists of North Carolina convened with Free Union Church, Carteret County, Sea Level, North Carolina, on October 27, 1954, at 10 o'clock a. m. (The session was held one week late, because of the hurricane one week before the regular time having carried away the North River bridge, and it was impossible for the delegates and ministers to get to the church.)

The session was begun by 15 minutes devotional service conducted by Rev. J. O. Fort, editor of the Free-Will Baptist publications, after which the Moderator took charge, and the following officers were seated: Rev. Clifton Rice, Mod., Rev. K. W. Gaskill, Asst. Mod. pro tem, J. W. Alford, Clerk, Rev. Lloyd Vernon, Asst. Clerk, H. M. Mallard, Treasurer.

RECORD OF JOINT SESSION OF EASTERN CONFERENCE AND PIEDMONT ASSOCIATION

Members present at this session were as follows:

Brother Lloyd Vernon presided over the meeting by mutual consent of both bodies.

The grievance was over the ordination of two ministers by the Piedmont Association who were members of the Eastern Conference. The following motion was passed.

"Beginning as of this date, December 15, 1953, We, the members of the Executive Committee of the Eastern Conference and Piedmont Association of North Carolina, mutually agree and pledge ourselves not to infringe on the rights or jurisdiction of our fellow conference or association mentioned above."

"By this we mean, not to ordain any person not previously known to us to be in good standing with his conference or association."

"The same pledge and agreement applies to church membership in conference or association."

A motion was made to adjourn. The benediction was by Wade Calvert.

The Executive Committee of the Eastern Conference met at Whaley's Chapel Parsonage on March 2, 1954, at 7 o'clock p. m. All members were present except Bro. J. C. Griffin, who had given his proxy to Bro. Clifton Rice. Prayer was offered by J. W. Alford.

The secretary of the Examining Board submitted the following report:

As agreed, the Examining Board of the Eastern N. C. Free Will Baptist conference continued the meeting of February 22, 1954 at Bridgeton Church February 25, 1954, 9 a. m.

All members were present.

Prayer by Bro. K. W. Gaskill.

Bro. C. M. Dixon was examined for ordination and made a passing grade.

The ordination of Bro. Dixon was left in the hands of Bro. Clifton Rice, who is to make arrangements for and carry out the ordination.

Bros. Alton Mason and E. M. Goodwin, who were ordained by the Piedmont Association, came before us bearing letters of transfer and asking for membership in the Eastern Conference. They were given the usual examination by the board and each made a satisfactory grade.

These brethren had been silenced at the last session of the Eastern Conference until they satisfied the Examining Board and the Conference.

They having come in all humility, making proper apology, we therefore recommended to the Executive Committee of the Conference that their confessions and apologies be accepted by the Executive Committee and the order of silence, imposed by the Conference, be lifted and that they be admitted to ministerial membership in the Conference.

We further ask Bro. Mason to sever all connection with the churches formerly asking his services, due to the division in them.

We further recommend that Bros. Mason and Goodwin be on probation to the Examining Board of this Conference for a period of three years.

Bros. Mason and Goodwin agreed to the above conditions.

The Executive Committee of the Eastern Conference met at the home of Mrs. Rosa Styron, Otway, N. C., on August 4, 1954, at 7:30 p. m.

After a song, prayer was offered by Rev. John Grimesley, Bridgeton, N. C.

The Chairman spoke several minutes on building on Christ if we are to build a church that will stand and prosper.

After much discussion about the conditions that has existed in the past, giving rise to this request for the organization of a new church, the group as a body, at the suggestion of Rev. Wingate Hansley who has been working with them, stated that if they have in any way offended the Conference, they ask forgiveness of the Conference.

On motion the Chairman was instructed to contact the other members of this committee, and arrange a date during the latter half of September, for the entire committee to meet for a final decision.

The Minutes were read and approved.

On motion we adjourned.

The Executive Committee of the Eastern Conference met in Welcome Home Church on September 4, 1954 at 7 p. m.

All members were present except Bro. H. M. Mallard, and he had placed his proxy in the hands of the Secretary, thus making all votes present.

Prayer was offered by Bro. Griffin.

The Chairman stated that we want the group of Welcome Home Church to help us by giving us such information as they have, bearing on the matter of a new church at Otway, N. C., and that will enable us to make a right decision about organizing the Otway group into a church.

Bro. Ralph Wilkins acted as spokesman for the Welcome Home Church, and he gave us the information that the Welcome Home group has all the time stood loyally by the Eastern Conference, and will always have open hearts and doors for the group that withdrew.

The church group was dismissed with a prayer by Bro. Vernon, and the Executive Committee went into executive session.

The committee discussed the situation for several minutes, and then the following decision and motion was dictated to the committee by Bro. Griffin: After careful study of the information from both sides, we deem it unwise to authorize a new church at Otway from the group that withdrew from Welcome Home Church, and on motion the Chairman is instructed to notify the Group at Otway of our decision.

We further recommend that, in keeping with 1st and 3rd chapters of 1st. Corinthians, the aggrieved group follow the instructions laid down by the Apostle Paul.

The above decision and recommendation was unanimous by the Executive Committee.

IN MEMORY OF REVEREND R. C. KENNEDY

Rev. R. C. Kennedy was 73 years and eight days old when the Lord called him to his reward last March. He had been an active minister 50 years, and served faithfully as pastor, also doing much revival work during these years. He organized eight churches during his ministry, and gave much assistance to several others in their undertakings.

Mine is a tribute to "one we all loved." I can say just a few things about Uncle Robert Kennedy, but a big book could be written about the Christian life he lived.

He was one of the most consecrated men I ever knew. He was the head of a Christian home and family, and lived a daily life of prayer. He taught and practiced the family altar in the home, and always encouraged and comforted those with whom he came in contact to live for Christ. His good deeds were too many to mention. His presence and prayers at any kind of service was uplifting in spirit. I can truthfully say that in his absence our services don't seem the same as when he lived. He would not agree in the last years of his life, even after afflictions came upon him, to be placed on the retired list, and it is the honest opinion of the writer that he ministered to those who came to see him, even on the last day of his life.

His was a life of happy service, and did not allow discouragement to hinder him, because he took his troubles to the Lord in prayer, and he knew He would hear and answer his prayers.

How many souls he led to Christ while living, only the Lord knows, and many there are who mourn his passing.

He is gone, but not forgotten.

MRS. WALTER RHODES

A Sketch of the Life of Jesse Randall Bennett

The subject of this sketch was born at Grantsboro, in Pamlico County, July 1, 1902. The parents, Elder Calvin L. and Emma Caton Bennett said he was named for the father of Calvin L. Bennett and Benjamin Randall. Jesse Randall Bennett was educated in the public schools of Pamlico County, and attended Elon College and Eureka College, also, took summer courses in the State schools for teachers. He taught school in connection with his ministry for several years, was principal of the Ernul school for years, this writer knows not how long.

He was ordained to the gospel ministry, at Core Creek Church, in the month of October, 1925, at the sitting of the Annual Eastern Conference. The ordaining council was composed of Elders Duff Toler, Wilson Lupton, and John Sewell, with Brother Toler preaching the sermon.

Brother Bennett was married to Miss Mabel Oglesby, daughter of Mr. and Mrs. J. H. Oglesby of Bridgeton, North Carolina, August 23, 1927. To this union two daughters were born both living at this time, namely Mrs. Milton B. Langston, New Bern, North Carolina, and Miss Peggy Bennett, a student at the Free Will Baptist Bible College, Nashville, Tennessee.

Brother Bennett, was Superintendent of the Free Will Baptist Orphanage, at Middlesex, North Carolina, 1929-1934, during a very hard financial depression, but by hard work, close economy and perseverance, he made a go of the work, and held things together until a better day dawned. He was President of the North Carolina State Convention of Free Will Baptist from 1944-1945. He was on the Eastern Conference Board of Examiners to examine candidates for the ministry for several years and had the privilege and pleasure of seeing and helping to ordain his father, Brother C. L. Bennett. He was a member of this Board at the time of

death and Chairman of the Board, but during the last months of life he was not physically able to serve.

He did much evangelistic work in the state of North Carolina, and also some of the other southern states. We are giving a list of part of the churches that he preached for and served as pastor, Rock of Zion (his home church), Mt. Zion, Trent, Warden's Grove, Oriental, Arapahoe, and all the churches in Pamlico County, and near the birth place of Brother Bennett. In Craven County, he served, Antioch, Macedonia, Moseley's Creek, St. Mary's in New Bern, and was serving Bridgeton as pastor up until death, however, he did no active preaching during the last month of life.

He pastored the Free Will Baptist Church in Goldsboro, the church in Smithfield, Johnston County, Shiloh in Beaufort County and Malachi's Chapel and Gum Neck in Tyrrell County. He was the first president of the North Carolina Minister's Conference which had its birth at Cragmont Assembly, Inc., Black Mountain, North Carolina, and was a friend to the Cragmont move from its beginning.

He served on the Board of Education of the National Association of Free Will Baptist and was a member at the time the first real concrete move was made to raise funds toward establishing the Bible School. It was a small beginning in its infancy, but it is written "Some men's work go before them and others follow after to the judgment." He was always a strong advocate of better education for the ministry. He often spoke of "Raising the Standard." The last sermon delivered by Jesse Randall Bennett, was the Dedictory sermon of the chapel at the Free Will Baptist Orphanage, Thanksgiving day, 1953. Even though he was so weak that he had to sit in a chair to deliver the message, he put much of his former earnestness and expression into the message. He finished his preaching that day, and passed to his reward on the 17th day of January 1954. Truly it can be said, that, Jesse Randall Bennett, "Fought a good fight," he kept the faith, as declared by his denomination, which he loved and gave himself for in a great way until the end.

Written by one who worked with him a great deal, and saw much of him from his first ministerial labours.
