WEDNESDAY MORNING, OCTOBER 24

The sixty-first annual session of the Eastern Conference of the Original Free Will Baptists of North Carolina convened with the church at Friendship, Jones County, North Carolina, on October 24, 1956, at 10 o'clock a. m.

The session was begun with 15 minutes devotional service conducted by Rev. L. J. Lupton, after which the moderator took charge, and the following officers were seated:

A prayer for guidance was offered by Rev. Lloyd Vernon.

The minutes of the executive committee were read as follows:

The Executive Committee of the Eastern Conference of the Original Free Will Baptists of North Carolina met at the proposed new church named Calvary, in Onslow County, North Carolina, on May 2, 1956, at 7:30 o'clock p. m.

Present: Rev. D. W. Hansley, chairman; J. W. Alford, secretary; J. C. Griffin, Lloyd Vernon.

After a song by the congregation, J. W. Alford offered prayer.

The chairman then stated that the purpose of the meeting was to organize the group into a church of the Free Will Baptist faith.

After several questions by the committee, officers for the new church were elected. (The list of officers is listed in the church register.)

Rev. J. C. Griffin then presented the Holy Bible to the group, as their rule and guide in their work.

Rev. J. W. Alford read the Statement of Faith contained in the Treatise.

Rev. D. W. Hansley read the rules of Government and Discipline from the Treatise.

Rev. Lloyd Vernon read and explained the Church Covenant.

The group, by vote, signified their acceptance of all the above.

The prayer of consecration was offered by Rev. D. L. Whaley, pastor of the Jacksonville Church, after which the hand of fellowship was given by the committee.

On motion this group be declared organized as a Free Will Baptist church, and recommended for membership in the Eastern Conference; also notice of same published in the Baptist paper.

The new church then officially elected Rev. P. D. Jenkins for pastor.

The minutes were read and approved.

On motion we adjourn.

Dismissed by Rev. Lloyd Vernon.

The Executive Committee of the Eastern Conference met at Bridgeton Church, Bridgeton, North Carolina, on August 14, 1956, at 10 o'clock a. m., with all members present.

The chairman called on Rev. J. R. Forest to lead the prayer.

The chairman stated that we were called together to consider a controversy between the pastor, Rev. J. R. Forest and some of the deacons of Holly Springs Church, as to the time of the beginning of the new pastoral year; also any possible irregularity in the election of the pastor and the work assigned to the pastoral committee.

Several questions were asked the group from Holly Springs Church by the executive committee, in order to get a clear understanding of the situation.

After much discussion of the matter, the group from Holly Springs and the pastor, Rev. J. R. Forest, were excused, and after due deliberation, a motion was made by Rev. Lloyd Vernon to instruct Holly Springs Church to abide by the date set by the conference, August 31, for the close of the pastoral year. We also approve the action of the pastoral committee in the hiring of a pastor, except that part of their action in which they contacted another party after having made a contract previously with someone clse.

The minutes were read and approved.

On motion we adjourned.

Dismissed by Rev. J. C. Griffin.

The Executive Committee of the Eastern Conference of North Carolina met in session in the Morehead City Church on October 4, 1956, at 10 o'clock a. m., with all members present.

Prayer was offered by Rev. Lloyd Vernon.

The chairman stated that we were called together to consider the Otway and West End Missions in Carteret County, and determine what is best to do in these cases. After discussing the Otway situation, and in view of the action of the Welcome Home Church which is recorded as follows:

August 26, 1956

There was a business meeting called at the church by the pastor, Brother James Lupton, for the purpose of discussing the Otway Mission being recognized as a mission in the Eastern Conference. There was a lengthy discussion with every one privileged to speak as they wished. Brother Lupton asked for a motion which was made and seconded, and the church voted unanimously for the Otway Mission to be taken in. Brother Harry Gillikin and Brother Ralph Wilkins were appointed as delegates to the Eastern Conference, with Brother Nelson as alternate, and that the delegates be given authority to present before the Conference that Welcome Home Free Will Baptist Church go on record as recommending that Otway Mission be received as a Free Will Baptist mission.

A motion was made to adjourn.

Closing prayer by Brother Lupton.

We recommend that the conference recognize the group at Otway as a mission, and the executive committee be authorized to organize them into a regular Free Will Baptist church, at the request of the mission, if the executive committee finds them qualified.

The question of the West End Mission was considered, and after due consideration the following motion was passed: On motion we recommend that the conference recognize the group at West End, Morehead City, North Carolina, as a mission, and the conference authorize the executive committee to proceed to organize them into a regular Free Will Baptist church, at the request of the mission, if the executive committee finds them qualified.

On motion we request the conference that from the date of this conference, the executive committee be instructed not to organize any mission into a church, unless it is recommended by the mission board of the conference, and having been in existence one year. This does not affect the missions already existing.

The minutes were read and approved.

On motion we adjourn.

Dismissed by Brother Griffin.

The Executive Committee of the Eastern Conference met in session at

Cabin Church, at 11 o'clock, on October 12, 1956. All members were present except Brother J. C. Griffin who made J. W. Alford his proxy.

Prayer was offered by Brother H. M. Mallard.

The chairman stated that we were called together here by the Third Union Meeting to investigate a dispute between the pastor of the Cabin Church and certain members of the church.

After hearing several statements from both sides, the committee went into executive session and made the decision that the dispute seems to be a local and internal matter, and we recommend that they definitely settle the matter between themselves.

The minutes were read and approved.

Dismissed by Brother Lloyd Vernon.

On motion these minutes were adopted.

The minutes of the examining board were read as follows:

The Examining Board of the Eastern Conference met at Bridgeton Church December 14, 1955, at ten o'clock a. m., to investigate matters left to us by the ministerial character committee.

Brother Roger C. Reeds presented his letter of recommendation from the Cumberland Association of Tennessee, this placing him in full fellowship with our conference.

Moved that Brother Lloyd Vernon take care of the ordination of Brother Melvin Everington.

Moved that Brother Boyce Wallace be cited to appear before this board at our February meeting to answer to reports of departing from our doctrine.

Since certain matters were referred to us without proper proof or witnesses, therefore we were unable to proceed.

Moved that we adjourn.

The resolutions committee reported as follows:

REPORT OF RESOLUTIONS COMMITTEE

We, the resolutions committee, submit the following report:

Be it resolved that the Executive Committee of the Eastern Conference shall not enter into internal problems affecting the local church unless requested by a majority vote of the active membership of the congregation, or in case a hearing is desired by a minority group, the request must be by a vote of at least one third of the active membership of the local church.

On motion the report was adopted.

The committee on ministerial character reported all ministers are in good standing, and by vote the report was adopted.

Petitions for the next session of the conference were from Beaufort, Folkstone and the Third Union Meeting Assembly, and by vote, the next session will be held at Beaufort.

Rev. Lloyd Vernon was selected to preach the introductory sermon; Rev. J. C. Griffin, alternate.

Rev. R. H. Jackson, retiring superintendent of the Children's Home, was recognized, and he spoke to us about his retirement, and appealed to us to loyally support Rev. S. A. Smith and the home.

On motion this conference extend to Brother Jackson a rising vote of thanks for his work at the Children's Home.

Revs. Walter Carter of the Piedmont Association, Willie Renfrow and Boyd Shook of the Western Conference, were recognized as visiting Ministers.

Rev. W. B. Raper, president of Mt. Olive College, spoke to us about the need of Christian education. After his remarks, a motion was made that an offering be received, and it be equally divided between the college and the Children's Home.

On motion the executive committee be instructed to consider the form of the Church Letter, and make any change in it necessary.

The temperance committee reported as follows:

Realizing that our youth is facing the most perilous time in history, we recommend the following:

1. That we cooperate in every possible way with the temperance forces of our state, to impress on the 1957 legislature the need of a liquor referendum at an early date.

2. That because the breweries are doing everything possible to seduce our youth, we recommend that our pastors be requested to preach, at least quarterly, one sermon on the evil of strong drink, and that our Sunday school teachers place more emphasis on the fearful results of alcoholic beverages and other intemperate habits.

3. We further recommend that family altars be established in our homes, and we discourage the use of alcoholic beverages in the home, and do all we can to encourage and support our youth in their efforts to become dependable Christians.

On motion the report was adopted.

Minutes of the Eastern Auxiliary Convention March, 21, 22, 1956, at St. Mary's Free Will Baptist Church

Mrs. J. C. Griffin rendered a good report on membership and promotion, stressing the need of wholesome literature in the home.

Mrs. R. H. Jackson brought news from the orphanage, with some of their needs. She asked that we help with the purchase of a piano for the chapel, which is much needed, also for coupons that mean so much to the home. Mrs. J. J. Blizzard, orphanage chairman, made her report and asked for an offering, for the institution. The congregation sang, "Give of Your Best to the Master," while the offering was taken; amount taken being \$108.71

The declamation contest on "Missions" was heard and Sara Lou Gaskins and Judith Campbell were judged winners in the district and were cited to appear with other contestants at the State Auxiliary Convention which convenes in May.

"God's Purpose for Our Future in the Mission Field," by Mrs. Ben Sutton, was impressive and to the point.

Mrs. Swindell spoke on "God's Purpose Revealed to Us Through the Stewardship of Prayer" which was very uplifting.

Announcements were made regarding lunch and the benediction was given, together with a blessing on the food, by the Pastor, Rev. Cecil Campbell.

THURSDAY AFTERNOON

Opening hymn, "Trust and Obey." The devotions were given by the vice-president, Mrs. J. K. Rhodes, on "Obedient to the Call."

A foreign mission playlet, "Make it a Matter of Prayer," in three scenes, was given by local talent, and made a very good impression, it being very informative and inspirational.

Rev. R. B. Crawford, of Greenville, made a very impressive talk on our Nashville Bible School. In part, he said, "Education, to mean anything, must be based on the Bible, the Living Word. When you open your heart to the Bible, it opens to you." He gave several Bible quotation, such as Proverbs 6:20-22; Psalm 119:105; and others. He gave the auxiliary women credit for being first in teaching and promoting the Bible College at Nashville, first in missions, and in Christian teaching and training of our youth. "Our needs are many," he said, "one is that we are needing a Christian's day school." He said he hoped the day was drawing near when we can move into a theological seminary.

Rev. S. A. Smith spoke in behalf of Mt. Olive Junior College, after announcing the physical condition of its president, Rev. Burkette Raper, who has been quite ill, but who is now improving. He stated present conditions and needs of the college. His indictment that the Eastern Conference had given less and had shown less interest in the support of the school than any other conference was, in a way, astounding, as he said he did not know why, and, naturally, we wonder why. He made an earnest appeal to the auxiliaries of the district to take up the matter with their pastor's and make every effort to enlist their interest in behalf of better support. He asked for a short season of silent prayer for Brother Raper, and that Rev. J. W. Alford close the prayer, which was done.

Mrs. J. C. Moye, from the Central Auxiliary Convention, was welcomed, and she spoke in behalf of Mt. Olive College, giving some of its aims and its needs.

Rev. J. W. Alford made a touching plea in behalf of missions, and suggested that this auxiliary convention underwrite Tommy and Emma Ruth Willey as missionaries to Cuba. There was a motion made with a second that we adopt these young people and become responsible for their salaries, amounting to a total of \$150.00 per month, and that this hold good for one year.

Reports were heard from Mrs. Patty Rhodes, finance committee, and the treasurer, and were recorded as read.

It was moved and carried that we make a donation of \$10.00 to Cragmont Assembly.

An offering was taken for Mt. Olive College amounting to \$120.50. It was moved and carried that we draw on the treasury for enough to make our contribution \$200.00. Mooneyham, Raymond Riggs (the last two were from the National Association; Rev. Riggs being the foreign mission secretary and Rev. Mooneyham promotional secretary).

Mrs. D. W. Hancock brought a very inspiring talk on our first foreign missionary, Miss Laura Belle Barnard; after which prayer was offered by Rev. Cecil Campbell.

Greetings were heard from the Children's Home, by the superintendent, Rev. R. H. Jackson. The hymn, "Send the Light," was sung and an offering was taken amounting to \$93.77 for the home.

A panel discussion, conducted by Mrs. W. J. Gaskins, was very imformative and impressive, especially the emphasis that was given the Anna Phillips Loan Fund.

A solo was given by a local young lady, Miss Jo Ann Heath.

Rev. Roger Reed brought a very inspirational message on "Jesus, the Light of the World," basing his remarks on John 8:12, "Then spake Jesus again unto them, saying, I am the light of the world: he that followeth me shall not walk in darkness, but shall have the light of life." He brought out the fact that we are witnesses of that light, as was John the Baptist and other great Biblical characters. He said that the Bible itself is a light, for the psalmist said, "Thy word is a lamp unto my feet and a light unto my path." He admonished that we follow 1 Corinthians 15:58, ". . . be ye steadfast, unmoveable, always abounding in the work of the Lord, . . ."

Remarks were made by Rev. Riggs about the mission work, and an announcement by Rev. J. W. Alford that he is now treasurer of the State Mission Board, and urged us to rally to the support of the mission cause.

Announcements were made by Rev. Terry, pastor of the local church, relative to the lunch to be served, with other information, after which he pronounced the benediction.

AFTERNOON SESSION

A picture of the convention was made at the lunch hour by a representative from the Wooten—Moulton Studio of New Bern, North Carolina.

A memorial service was conducted by Mrs. W. E. Baldree for seven deceased members who had passed during the year, which was very impressive. Miss Julia Ann Pate closed the service with the hymn, "Beyond the Sunset."

The president called the convention to order for business at this time.

The state president, Mrs. Carl Dudley, was recognized, who made some timely remarks and gave some overall information relative to the state work, especially the goal for 1957, which will be the fiftieth anniversary of the woman's work in our denomination. It will be recognized as Founder's Day, and the goal of \$1,000 is set for Cragmont Assembly, Inc. She also told of the Life Membership Plan, and that Mrs. Lupton had already been given a life membership in the State Auxiliary Convention, that each membership will cost \$25.00, and for the year, 1957, funds from this source will be used on the \$1,000 goal. She urged the women to single out some outstanding member of their auxiliaries and confer upon them a life membership. She said also that we could even honor our pastors in like manner.

Mrs. Rom Mallard spoke on, "Turning the Light on Our Missionaries," and on Tommy and Emma Ruth Willey in particular. She was followed by Rev. Riggs, our national mission director, who urged that we remember our missionaries, not only financially, but in earnest prayer, and by writing to them, by sending birthday greetings, good reading matter, such as Moody's Monthly, our own publications and other Christian literature.

Rev. Mooneyham, the national promotional secretary, was recognized and spoke on letting our light shine in the selection of our own reading matter, urging us to be sure to subscribe to our own denominational papers.

Mrs. Cecil Campbell gave a very informative talk on our Nashville Bible College, with its Christian attainments and influence. She said there were 169 students enrolled this year with 47 from North Carolina.

Rev. Burkette Raper, president of Mt. Olive Junior College, spoke in behalf of the expansion work being done there and was very appreciative of the part this convention has had in its progress. They have 63 full-time students, with enough night students to bring it to 95. He told of a new purchase of property one-fourth of a mile from the present site, costing \$40,- 000, with payments being \$8,000 per year. It was moved and carried that \$125.00 be allocated, plus the freewill offering for the maps needed at the college, according to Rev. Raper's announcements of the need. Motion carried.

The offering taken was \$68.80.

Rev. J. C. Griffin announced that the tract of Evangelism, by Rev. Floyd Cherry, was useful, not only for personal use, but would be good in study courses and otherwise. He recommended that we take advantage of this tract in every way possible.

Mrs. Bertha Thompson, one of the courtesy committee, made a verbal report, expressing the appreciation of the convention on the fine spirit of cooperation given us, together with the delicious dinner.

Mrs. S. A. Smith asked each auxiliary to contribute \$10.00 on the new laundry at the orphanage, or at least to help equip it which is now in the way of construction.

Mrs. R. B. Crawford gave some timely information regarding the East Carolina College Youth Center at Greenville. She is youth chairman of the State Auxiliary Convention, and announced that the YPA and GTA contest will be held at Mount Olive College next spring, the date to be announced later. She gave some interesting facts on the work of the Free Will Baptist students at East Carolina College, and of how the women of the Greenville Free Will Baptist churches, together with the pastors and families, are working with the youth, many times furnishing refreshments and encouraging good fellowship.

Mrs. Ballard spoke on "Keeping Our Lights Turned on Cragmont," and of its needs and possibilities. She thanked all who responded to the apron or repair fund drive. She said Cragmont is a mission point of our conferences.

Mrs. Cecil Campbell gave some information from the National Auxiliary Convention, stating that they planned to buy a tent for home mission work, and that \$350.00 had been allocated to North Carolina. She hoped we would accept the challenge and do our best to raise our part.

Mrs. M. D. Fulcher made a brief report on the state convention, and closed by urging that we study to become A-1 Christians as well as A-1 auxiliaries.

The finance committee made its report and on motion was adopted.

It was moved and carried that the reading of the minutes of the executive session be omitted.

The treasurer made her report and on motion was adopted. (See report.)

The secretary made a report of blanks mailed out, number responding, and the amount of funds sent in. (This was for information.)

The petition committee reported invitation from the following churches for the March convention: Beaufort, Folkstone, Sarecta and Pilgrim's Home. It was decided by a standing vote that we meet with the Beaufort Church,
