

The Sixty-Seventh Annual Session of the Eastern Conference of Original Free Will Baptists of North Carolina convened at the Assembly Grounds, Duplin County, North Carolina, October 24, 1962, at 10:00 a.m.

The session opened by singing "There Is Power in the Blood." After the devotional by the Reverend Albert Keech, the Reverend Robert M. Fader welcomed the ministers, delegates, and visitors.

The Reverend C. B. Hansley, moderator, expressed appreciation for the confidence placed in him, and he pledged to stand by Original Free Will Baptist faith and practices. He also reminded the delegation of the crisis our nation is facing during the quarantine of Cuba relative to the buildup of nuclear weapons by the Russians. He asked that the whole delegation pause for prayer, and the Reverend R. N. Hinnant led the prayer.

By motion, second, and vote the program was adopted with the stipulation that the moderator have the privilege of making any necessary changes.

Resolutions: Clifton Rice, W. A. Jones, and J. B. Starnes.

Memorial: J. C. Grffin, Lloyd Vernon, and O. B. Everette.

Nominating: Graham Lane, J. R. Davenport, and Clifton Styron.

At this juncture, Ralph Lightsey gave the report of the Free Will Baptist Press. By motion, second, and vote the report was received as information.

The Reverend David W. Hansley reported for the North Carolina State Ministerial Association. That report was also received as information.

The report of the Children's Home was given by the Reverend M. L. Johnson. By motion, second, and vote the report was accepted as information. An offering in the amount of \$156.96 was received for the Home.

The business session was recessed at this time for the worship service. The Reverend Llovd Vernon preached a stirring message from Matthew 24: 13: "But he that shall endure unto the end, the same shall be saved." Following this service, lunch was served.

# AFTERNOON SESSION

The afternoon session opened with the singing of "I Will Sing the Wondrous Story," and the Reverend L. L. Parker led in the devotional.

The Credentials Committee made a partial report at this time. A motion was carried to accept the report and seat the delegates and ministers present. See report.

A motion was passed to revise the list of ministers before the minutes are published.

The Executive Committee made its report at this time; and by motion, second, and vote, the entire report was adopted. (See report.)

The Examining Board made its report. By motion, second, and vote, it was adopted in its entirety; but the motion was amended to vote on the item dealing with requirements for ordination separately. By motion, second, and vote this part of the report was tabled.

The Reverend Walter Reynolds made the Superannuation report; and by motion, second, and vote, the report was received as information. (See report.)

The conference mission report was given by the Reverend A. G. Lane; and by motion, second, and vote it was adopted. (See report.)

At this point, the congregation sang "Amazing Grace." The benediction was pronounced by the Reverend Ralph Lightsey.

#### THURSDAY MORNING

The session opened by singing "When We All Get to Heaven." The Reverend Kenneth Grubbs led the devotional.

The minutes of the previous day were read and approved.

Reports of the following organizations and enterprises were given and received as information: Cragmont Assembly, Church Finance Association, State Mission Board, State Woman's Auxiliary Convention, State Convention, and Mount Olive College.

An offering of \$82.48 was received for Mount Olive College.

At this juncture, the business session recessed for the worship service. The Reverend J. B. Starnes preached a stirring message, after which Lynwood Boyette, Pat Corbett, and Robert Earl O'Quinn were ordained to the gospel ministry.

A motion was passed that their names, together with the others who were ordained, licensed, or received into the conference this year, be placed on the ministerial list.

# AFTERNOON SESSION

The congregation sang "The Way of the Cross Leads Home," and the Reverend Kemery Ard led the devotional.

The Reverend M. L. Johnson reported on the progress of the Edgemont case pending before the Supreme Court, and it was received as information.

The Examining Board made a further report; and by motion, second, and vote it was adopted.

The Credentials Committee made its final report; and by motion, second, and vote it was adopted.

The Temperance Committee report was made and adopted.

The report of the Sunday School Committee was made and adopted.

The treasurer made his report and it was adopted.

The Nominating Committee's report was given and adopted.

The Allocation Committee's report was given and adopted.

A motion was carried to include the J. W. Alford Scholarship Fund in the church letter.

The Digest Committee's report was made and adopted.

The Resolution Committee reported at this time, and a motion was passed to vote on each item separately. All the items were adopted by vote except item 4 which was tabled.

The Memorial Committee report was made and adopted.

Hansley, Mrs. James Lupton, and Mrs. R. W. Mallard.

The following were appointed as delegates to the various conferences: A. G. Lane, Western; Lloyd Vernon, Cape Fear; S. A. Smith, Central; J. B. Starnes, Piedmont; A. B. Bryan, Pee Dee; David W. Hansley, Albemarle.

A motion was passed to give a rising vote of thanks to the Third Union Meeting and those responsible for our entertainment during this session.

The minutes were read and approved by vote.

A motion was carried to adjourn; and after the congregation sang "Blest Be the Tie," F. E. Jones pronounced the benediction.

# EXECUTIVE COMMITTEE REPORT

The Executive Committee met at Kinston, North Carolina, November 1, 1961. All members were present.

The meeting was called in keeping with the action of the Eastern Conference while in session October 18, 19, 1961, relative to Seldon Bullard, Gordon Sebastian, and Melvin Worthington and their pastorates.

A motion was made, seconded, and passed that these ministers and churches be declared out of fellowship with the conference and that the ministers be silenced. The Executive Committee met again at Mount Olive November 27, 1961, to discuss the National Association's entry into the Edgemont lawsuit. A motion was made, seconded, and passed that since the National Association had entered the case that we employ a lawyer to represent the Eastern Conference in the lawsuit on behalf of the Western Conference. The moderator and clerk were instructed to work with Attorney Art Vann in employing a lawyer.

The next meeting was on February 19, 1962, concerning the situation at the Davis Free Will Baptist Church, Davis, North Carolina. After hearing reports from the representatives of the church, it was decided to meet with the church to further explore the situation.

Approved recommendations of Examining Board regarding Richard Mabe.

At the meeting, March 13, 1962, at the Davis Community Building, the committee looked further into the situation; and after studying the reports, a motion was made, seconded, and passed to recognize the group standing true to the Eastern Conference and State Convention as the true Davis Original Free Will Baptist Church. (See Resolution below.) The other group, by their own choice, voted previous to this date to leave the Eastern Conference and State Convention and affiliate with other groups not recognized by the Eastern Conference.

#### RESOLUTION

Whereas, the Davis Original Free Will Baptist Church of Davis, North Carolina, Carteret County, has been a member of the Eastern Conference of Original Free Will Baptists of North Carolina since it was formed in 1896 and was, prior to that, a member of the General Conference, and

Whereas, the said church has actively participated in the proceedings, ministry, and provisions of the Eastern Conference of Original Free Will Baptists of North Carolina and has elected to be governed by the *Statement* of *Faith and Discipline for Original Free Will Baptists of North Carolina*, and

Whereas, the pastor of Davis Original Free Will Baptist Church, together with the following officers: Clinton Piner, deacon; Lloyd Davis, deacon; Julius Willis, deacon; Ralph Lowrimore, superintendent of Sunday School; Mrs. Louise Bedsworth, president of Woman's Auxiliary; Virginia Willis, president of leagues; and others (number undetermined) have agreed by vote, voice, and attitude that they do not wish to remain members of, and in fellowship with, the Eastern Conference of Original Free Will Baptists of North Carolina, and

Whereas, this group has rejected and refused to be governed by the Statement of Faith and Discipline for Original Free Will Baptists of North Carolina which constitutes a departure from the doctrine, customs, practices, and usages of Original Free Will Baptists, and

Whereas, the following officers of Davis Original Free Will Baptist Church of Davis, North Carolina: Charlie Paul, chairman of the board of deacons; J. B. Williams, deacon; Milton Styron; Reginald Styron, treasurer; and Leslie Styron, clerk, and others (the number undetermined) who are members of said church did oppose the action taken by the pastor and his followers, and

Whereas, Charlic Paul, J. E. Williams, Milton Styron, Reginald Styron, Leslie Styron, and those affiliated with them in this action did, and do hereby, reaffirm their loyalty to Original Free Will Baptists of North Carolina, and especially the Eastern Conference of Original Free Will Baptists of North Carolina of which they have been members, and therefore wish to remain as such, and

Whereas, this loyal group does hereby endorse and reaffirm faith in the Statement of Faith and Discipline for Original Free Will Baptists of North Carolina, and

Whereas, the Executive Committee of the Eastern Conference of Original Free Will Baptists of North Carolina has investigated alleged statements and charges against the pastor and the seceding group, and

Whereas, it is our opinion that the minutes recording the action of the seceding group show clearly that the pastor and the seceding group have departed from the customs, practices, and usages of Original Free Will Baptists of North Carolina,

Be it resolved that we declare that Charlie Paul, J. E. Williams, Milton Styron, Reginald Styron, Leslie Styron, and those affiliated with them do constitute, and are therefore recognized and accepted as, the Davis Original Free Will Baptist Church and that all rights and privileges belonging to said church shall be maintained, exercised, enjoyed ,and perpetuated by them.

Be it further resolved that their membership in the Eastern Conference of Original Free Will Baptists of North Carolina has not been questioned nor terminated by the aforesaid action.

The Executive Committee met again on September 18, 1962, at Ayden. All members, except H. M. Mallard, were present; and D. W. Hansley was his proxy.

A motion was made, seconded, and carried that we make application to file a brief *Amicus Curiae* with the North Carolina Supreme Court in support of the position of the Western Conference and the J. G. It has always been the intention of this conference to abide by, be governed and bound by, and to practice the form of church government as developed and established by the Original Free Will Baptists of North Carolina (Palmer Movement). It has in fact been the understanding of this conference, during the entire time of our affiliation with the National Association of Free Will Baptists, that the spirit and stated principles upon which the National Association was formed, and subsequently upon the PROVISION AND CLAIM on page 39 of the National Treatise, this conference, as well as other state and district organizations, has been and is still free to continue to operate under our own established usages, customs, and practices. Therefore this conference has at all times considered and understood that it was bound and governed, and we do still consider, understand, and intend to be bound and governed by, and remain loyal to the doctrines, usages, customs, practices, rules and regulations of Original Free Will Baptists of North Carolina in general and the Eastern Conference of Original Free Will Baptists in particular.

2. Whereas, some of our ministers have been asked to surrender their ordination papers for having departed from the faith and having failed to surrender them therefore be it resolved:

That all ministers of the Eastern Conference, in good standing, be issued a new certificate of ordination that has been revised with proper wording in keeping with regulations of the Eastern Conference and that all other certificates of ordination be declared null and void after the 1963 session (annual) of the Eastern Conference. That all ministers who are members of the Eastern Conference, in good standing, forward to the secretary of the

3. Being very familiar with the report entitled "Edgemont Church," and the action taken by the Western Conference of Original Free Will Baptists of North Carolina on January 18, 1961, relative to Edgemont Free Will Baptist Church, Durham, North Carolina, and finding said action to be in complete accord with the usages, customs, and practices of Original Free Will Baptists of North Carolina, we do hereby enter the following in our official minutes as our official position relative thereto:

- 1. It is the judgment of this Eastern Conference of Original Free Will Baptists of North Carolina that the action taken by the Western Conference of Original Free Will Baptists of North Carolina on January 18, 1961, wherein it recognized the J. G. Teasley Faction as the true congregation of Edgemont Original Free Will Baptist Church, was within the authority and jurisdiction of the Western Conference; and that the Western Conference did act within its authority, jurisdiction, forms, and rules in so recognizing the J. G. Teasley Faction as the true congregation on January 18, 1961.
- 2. It is further the judgment of this Eastern Conference of Original Free Will Baptists of North Carolina that the Western Conference not only had the right to take the action it did on January 18, 1961, but that it also had a duty, in view of the findings of facts and the usages, customs, and practices of Original Free Will Baptists of North Carolina and the Western Conference, to take such action.
- 3. We further instruct the Executive Committee of this Eastern Conference to make application to file a brief *Amicus Curiae* with the North Carolina State Supreme Court in support of the position of the Western Conference and the J. G. Teasley Faction of Edgemont in the litigations now on appeal to the Supreme Court from the Superior Court of Durham County.
- 4. We further instruct the Executive Committee of this Eastern Conference to furnish any necessary affidavits, briefs, or statements, properly giving verification to any previous action or expression by this Eastern Conference in support of the Western Conference and the J. G. Teasley Faction of Edgemont relative to any litigation now pending which is related to the Edgemont dispute and Ronald Creech.

4. Whereas, the Original Free Will Baptist denomination of North Carolina has suffered through the years by invasion of other denominations; forces, doctrines and church polities contrary to what the Original Free Will Baptists of North Carolina believe, and whereas, the Original Free Will Baptists of North Carolina have found it necessary to withdraw from the National Association, because it has been invaded by individuals who are not true Original Free Will Baptists;

Vy acreas, because of these past experiences, we should be cautious of any further invasions and should elect only men and women to office and members of boards in the State Convention, conferences, and union meetings who are known to be members of the Original Free Will Baptist denomination in good standing with his or her local church, conference, State Convention, and who subscribe to the Statement of Faith and Discipline for Original , Free Will Baptists of North Carolina;

Whereas, on September 13, 1962, during the regular annual session of the North Carolina State Convention of Original Free Will Baptists, a report from Mount Olive College offered a recommendation that two members of the Board of Directors be elected from the locality in which the college resides and who are not members of the Original Free Will Baptist denomination; and, whereas, this action has caused some embarrassment and mistrust among some of the most ardent supporters of the college; and, whereas, if this action is followed through in the future it could cause the same experience to the denomination as that which happened in the past by allowing outsiders to help set policies for one of our main educational institutions.

Therefore, be it resolved: That this Eastern Conference of Original Free Will Baptists of North Carolina during this regular session October 24 and 25, 1962, protest this action and ask that the Executive Committee of the North Carolina State Convention of Original Free Will Baptists, together with the Board of Directors and the president of the college, hold this matter in obeyance until each conference belonging to the State Convention is allowed to express itself by vote.

5. Whereas, It is observed that during recent months many absolutely false, misleading, and deceiving reports and items of information relative to Original Free Will Baptist institutions, organizations, programs, and individuals, including those of the Eastern Conference and those endorsed and supported by the Eastern Conference, have been circulated through the United States mail and otherwise, and,

Whereas, We have reasons to believe that at least a part of the above constitutes criminal action and the illegal use of the United States mail for the purpose of fraud, in that there appears to have been the willful intent to deprive the above-mentioned institutions, organizations, programs, and individuals of their good name and reputation and the confidence of those to whom knowledge of the false, misleading, and deceiving reports and items of information have come, and,

Whereas, It appears to us that the above publication and circulation constitutes criminal action and illegal use of the United States mail for the purpose of fraud in that there appears to have been present the intent to use deception, deceit, trickery, artifice, and the intentional perversion of truth and fact in efforts to induce the readers and those to whom knowledge of such publications should come to believe that the institutions, organizations, programs, and individuals mentioned above are not worthy of their good name and reputation and the confidence of the public, thereby depriving said institutions, organizations, programs, and individuals of their civil and constitutional rights.

#### THEREFORE BE IT RESOLVED,

- 1. That the officers and Executive Committee of this Eastern Conference be, and are hereby, authorized and instructed to join with other organizations, institutions, programs and/or individuals which may be involved, interested, or have a mutual interest, in calling upon proper authorities to fully investigate these matters and things,
- 2. That the officers and Executive Committee of this Eastern Conference be, and are hereby, authorized and instructed to furnish any information and/or evidence that may be in their possession or the possession of this Eastern Conference which would be useful in the investigation called for above.

6. Be it resolved that this conference urge all candidates for the ministry to get at least two years of college training. Be it further resolved that those who cannot conveniently take regular college training be strongly urged and encouraged to take advantage of the courses offered in the Palmer Institute of Mount Olive College.

# MACEDONIA FREE WILL BAPTIST CHURCH, ERNUL, N. C. SEPTEMBER 20, 1962

The Eastern District Woman's Auxiliary Convention held its semiannual session, September 20, 1962, at Macedonia Free Will Baptist Church, Ernul, North Carolina. The theme for the day was "Unity in Christ" (Romans 12:5).

The meeting was called to order by congregational singing of "The Church's One Foundation," with music being directed by Mrs. W. S. Burns.
