PROCEEDINGS

The fifteenth annual session of the Eastern Conference of the Original Free Will Baptist of South Carolina convened with the Poplar Hill Church, Williamsburg County, S. C., on October 30, 31 and November 1, 1930.

Introductory Sermon by Elder R. C. Williams. Text: St. John 14:2. "In my Father's house are many mansions: if it were not so, I would have told you. I go to prepare a place for you." After which Elder J. W. Moore, the assistant moderator, proceeds to organize by electing the following committees:

Board of Presbytery—Elders J. L. Smith, M. C. Powell, J. W. Moore, James Powell and N. N. Davis.

By motion of Bro. W. C. Williams, we invite all visiting Brethren to a seat and voice with us during this session.

Conference called off until Friday morning, 9 o'clock.

On motion of Bro. W. V. Cooper, Bro. N. N. Davis and delegates from Little Lamb Church was excused from these sessions as other matters claimed their attention.

By motion of Bro. B. G. Miller, Elder R. C. Williams was chosen as delegate to represent this body in the S. C. Conference.

By motion of Bro. J. W. Moore, Bro. A. E. Perrott was excused.

By motion of Bro. B. G. Miller, the delegates from Greelyville Church were excused.

Saturday Morning Session

Conference reassembled with devotional services by Elder R. C. Williams.

We further recommend that our preachers keep the true idea of Temperance before our people at all times, by practice and precept.

Mission and Education—We, your committee submit the following report: Seeing the great need of a greater mission spirit among our people, we ask that this conference pass a resolution, viz., that each church set up a mission standard of not less than 10 cents per capita of each member, and that each preacher take a special mission offering at least once each month. Aside from this, that, our conference try to raise not less than fifty dollars for mission in the coming conference year and that each preacher pay at least one dollar per year for mission.

As to education, we ask that our preachers and churches advocate more earnestly the cause of Christian Education among our children, and more especially, our ministry, that we may have still a greater oneness in doctrine and discipline with preachers and churches.
