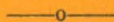


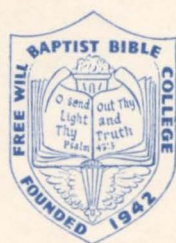

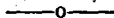

# PROCEEDINGS

Minutes of the twenty-ninth annual session of the Eastern Conference of the Original Free Will Baptist of South Carolina which convened with New Hope Church, in Florence County, November 2-4, 1944.

Song: "We're Marching to Zion," by congregation. Prayer by moderator. Scripture lesson: Hebrews, 9th chapter, verses 11-28 was read by moderator, T. A. Williams, who after an impressive comment, declared the conference was opened for business which was duly entered into as follows:

## ORGANIZATION

After which the conference was called off for preaching and refreshments. Preaching at 12:00 o'clock by Elder M. F. Howell—text: Mark, the eighth chapter and thirty-eighth verse. After an inspiring message dinner was served on the grounds.

## THURSDAY EVENING

Conference re-assembled at 2:00 o'clock P. M., with singing by the congregation and prayer by Elder M. S. Todd, then business of the conference was resumed as follows:

Little Lamb—Troy Pope was the representative. Deaths none; received none; received 3; baptized 4; dismissed none; excommunicated none. Numbers in church, males 24, females 33, total 57. Number of members in Sunday School 35; number of members that belong to the church 30. Incidental fund \$10.25.

New Hope—represented by Sisters Matthews, Edith Ard, Sister Hughes, and Sister Thomas. Died, three; received none; baptized none; dismissed none and excommunicated none. Number of males 7, number of females 37, total 44. Number of members in Sunday School 50, number of members that belong to the church 20. Incidental fund \$11.40.

New Prospect—Hubert Creel and Liston Poston. Incidental fund \$10.

New Zion—Gary Powers. Died, none; received 12; baptized 8; and dismissed none. Number of members, males 11, females 9, total 20. Number of members in Sunday School 27; number of members that belong to the church 18. Incidental fund, \$4.50.

**Little Bethel**—Z. B. Eaddy, B. E. Thompson, and W. L. Benton. Died, none; received 3; baptized 4; dismissed none; excommunicated none. Number of males in church 20, number of females 34, total 54. Number of members in Sunday School 82, number of Sunday School members that belong to the church 75%. Incidental fund \$2.00.

**Spring Pond**—not represented.

**Williams Hill**—J. M. Williams and T. B. Williams. Died, 2; received 4; baptized 1; dismissed 3; excommunicated none. Number of members in Sunday School 80; number of Sunday School members that belong to the church 40. Incidental fund \$10. Total members 85.

**Gethsemane**—John Skipper and C. R. Roberts. Died, none; received 10; baptized 8; dismissed none; excommunicated none. Number of members, males 22, females 34, total 56. Sunday School members that belong to the church 30. Incidental fund \$7.30. Turned in Orphanage work 1 quilt and \$27.

**Saint John**—W. A. Powell and H. B. Wise. Died, none; received 9; baptized 5; dismissed none; excommunicated none. Number of members, males 14, females 49, total 63. Number of members in Sunday School 61; number of Sunday School members that belong to the church 16. Incidental fund, \$10.

By motion petitions were considered for the next conference agreed it goes to Gethsemane Free Will Baptist Church in Horry County. It was then motioned we adjourn until Friday morning at 9:30 o'clock. After song, "God Be With You Till We Meet Again," benediction by Moderator.

#### FRIDAY MORNING, 9:30—November 3, 1944

Conference re-assembled. After singing by congregation a scripture lesson was read by Brother B. E. Wise, Psalm 56. Prayer by Elder J. L. Smith, then we entered into business as follows:

It was motioned we excuse Elder S. J. Player for non-attendance by reason of ill health. Motion names of churches not represented yesterday (Thursday) were called again and their report was heard and accepted. Elder J. L. Smith made report on Antioch Church and whereas Brother Smith was appointed in our last conference to secure clear deed to property of said church; reported that he had done so and on motion we reimburse him for his expenses involved in this matter. Motion we give him \$5.00 and extend to him our heartfelt thanks for his kindness in rendering this service. On motion, St. John's Free Will Baptist Church was received into our conference by extending to her delegates the right hand of Christian fellowship which was done by a spirit of "heartfelt welcome" to them in our midst.

It was motioned all committees make their report. Reports were accepted, committees were released (except investigation committee which was retained until next conference.)

### New Business

Requests by Elds. M. S. Todd and T. D. Lyerly for a letter of dismissal from the Conference was debated. On motion we grant Brother Lyerly a Letter of recommendation "To Whom It May Concern" but on account of Brother Todd's absence at the time his request was deferred until later. As we could not legally grant his request in his absence on motion by request of Brother E. J. Moore (licentiate) We grant him a letter of recommendation to whom it may concern.

Motion by request of Delegate of Little Bethel, we grant a letter of recommendation to whom it may concern, to said church.

On motion, we returned our heart-felt thanks to the good and generous people of this vicinity for their kindness and hospitality shown us during the sitting of this Conference. On motion we adjourned to meet at our regular time in course, Thursday morning at 9:30 o'clock, before the first Sunday in November, 1945, with Contentnea Free Will Baptist Church in Horry County.
