CHURCH COVENANT

And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.

EASTERN CONFERENCE OF THE
ORIGINAL FREE WILL BAPTISTS OF SOUTH CAROLINA

The fifty-seventh annual session of the Eastern Conference of the Original Free Will Baptists of South Carolina convened Saturday, October 28, 1972, at 10:00 A.M. with the New Prospect Church, Route 2, Pamplico, S. C.

The meeting was called in session by Moderator, Rev. Joseph Cagle. Brother Cagle led the congregation in song number 21, "Standing On The Promises", followed with prayer by Brother LeWayne Poston. Brother Mancy Noles gave the morning devotion, scripture Ecclesiastes 1:4-7.

Business:

Brother Wendell Ard, Reading Clerk, read the rules of decorum.

The Moderator gave his address, recognized the delegates, welcomed all visitors and invited them to sit with us in this meeting and extended them all rights except voting.

The minutes of the fifty-sixth meeting were approved as read.

There was a motion that the chair appoint the various committees. M.S.C. Finance Committee: Brothers G.F. Hayes, Wallace Stone, and Rutledge Alford. Sunday School and Temperance: Brothers Wayne Watson, Myrlee Benton, and William Wise. Mission and Education: Brothers Frank Woodbury, Tommy Poston, and LeWayne Poston. Investigation Committee: Brothers T. C. Farmer, James Powell, and Carlisle Jones.

The roll call of ministers was called with fifteen present, three absent. There was an invitation given to any minister who may wish to unite with this body.

There was a motion that only the name of the church pastor and delegate be read from the church report. M.S.C.

The Treasurer reported a balance on hand of \$645.84.

The Moderator asked for a short recess. Dismissed in prayer by Brother Hoyt Powell.

The morning worship service began with the congregation singing song number 113, "At the Cross". Rev. Paul Clayton brought the morning message, scripture Galations 2:16-20. His subject was "I am Crucified with Christ". The worship service was closed with the congregation singing "God Be With You".

Brother Joseph Cagle made the announcement concerning the noon meal. Dismissed in prayer by Brother Jack Evans. Brother Wayne Watson asked God's blessings on the food and partakers.

SATURDAY AFTERNOON

The afternoon service began with the congregation singing song number 361, "Leaning on the Everlasting Arm". Brother James Powell gave the afternoon devotion, Daniel 6:26.

Business:

The Moderator asked for the reports.

The Finance Committee Report was read. There was a motion that we accept the report and release the Committee. M.S.C. (See Report)

The Mission and Education Report was read and it was adopted. M.S.C. (See Report)

The Sunday School and Temperance Report was read. There was a motion to accept the report. M.S.C. (See Report)

There was a motion that Article III of the constitution of this conference be changed to read: "Any Brother desiring to be licensed or ordained must have a letter of recommendation from the church of which he is a member. Said church must be a member of the Eastern Conference of the Original Free Will Baptists of South Carolina." M.S.C.

There was a motion that Numbers 1 and 2 of the bylaws of this conference be changed to read: Number 1—"No minister of the Eastern Conference shall pastor a church that is not in fellowship with the Original Free Will Baptist denomination." Number 2 - "No brother shall receive credentials except he has been a member of a church in the Original Free Will Baptist denomination in said conference for a period of twelve (12) consecutive months or more, preceding his recommendation for licenses. He must be licensed twelve (12) consecutive months before he can be ordained."

There was a motion that we proceed to purchase four lots in the Goose Creek area. M.S.C.

Brother Carlisle Jones was elected to represent the Conference at the State Association.

The following were nominated from the floor: Moderator, Rev. Joseph Cagle; Assistant Moderator, Rev. Paul Clayton; Secretary and Treasurer, Carlisle Jones; Reading Clerk, Wendell Ard; Ordaining Council, Rev. Joseph Cagle. These were elected.

A rising vote of thanks was given to the host church for their hospitality.

A motion was carried to adjourn this meeting to meet again September 29, 1973 with the Mill Branch church, Route 1, Johnsonville, S. C.

CONSTITUTION OF THE EASTERN CONFERENCE
OF ORIGINAL FREE WILL BAPTISTS

ARTICLE I

This conference shall be called the Eastern Conference of the Original Free Will Baptists.

ARTICLE II

The officers of this conference shall be: a moderator, a clerk, reading clerk, treasurer, and an Ordaining Council consisting of three (3) duly ordained ministers to be elected or re-elected yearly.

ARTICLE III

Any brother desiring to be licensed or ordained must have a letter of recommendation from the church of which he is a member. Said church must be a member of the Eastern Conference of the Original Free Will Baptists of South Carolina.

ARTICLE IV

A minister coming from another conference or association must come by letter from his former conference or association.

ARTICLE V

Each minister duly licensed or ordained of said conference may have the privilege to vote.

ARTICLE VI

This constitution shall be revised at any annual conference by a vote of two-thirds majority.

BYLAWS

1. No minister of the Eastern Conference shall pastor a church that is not in fellowship with the Original Free Will Baptist denomination.
2. No brother shall receive credentials except he has been a member of a church in the Original Free Will Baptist denomination in said conference for a period of twelve (12) consecutive months or more preceding his recommendation for licenses. He must be licensed for twelve (12) consecutive months before he can be ordained.
3. He that desires to be licensed must come with a letter of recommendation stating whether or not he has tithed during said period, signed by his pastor and church treasurer. Also bringing a personal record of his work to be presented to the ordaining council. The same applies to his ordination.

4. Any minister who makes a shipwreck of his life or brings a reproach upon himself or conference, the accuser shall present a written charge properly signed to the Ordaining Council, if proven guilty shall surrender his credentials for a period of six (6) months on first offense. The penalty for second offense is the surrender of credentials for two (2) years.
5. From this, The Lord's Day—December 7, 1963, the Ordaining Council shall not license, ordain, or accept anyone who has two (2) living wives, or if wife has two (2) living husbands. Scripture: Titus 1:6; I Timothy 3:1-2.
6. Each minister of the said conference must report in person or by letter to each union or conference. All ministers who fail to conform to this ruling will have to surrender his credentials and go before the Ordaining Council before they can be reinstated. But, in case of an emergency, a minister has one week from date of the conference to send in his excuse.
7. These bylaws may be amended by two-thirds (2/3) majority vote at any regular conference.
8. All visiting ministers will be given a seat in our conference with this restriction—they will not be privileged to vote.
9. The dues of this conference are one dollar (\$1.00) per quarter; payable each quarter at the regular conference.
10. The clerk is to inform the Ordaining Council of all ministers of said conference who do not conform to rule number six of these bylaws.
11. The minutes of all ministers' meetings are to be published in the Association minutes rather than just the minutes of the annual meeting as has been done in previous years.
12. A committee is to be appointed to judge whether or not the excuse of absent ministers is to be accepted. The committee shall consist of the clerk and two ministers of our conference. If any excuse is rejected, the sender is to be notified and more information is to be asked for.

RULES OF DECORUM

1. The Association shall be opened and closed with prayer.
2. There shall be no conversation by the members, one with another so as to interrupt business while in session.
3. Every member speaking shall first rise and address the moderator.
4. No member shall interrupt another member while they are speaking.
5. We shall admit no other title while in session but that of "Brother."
6. Every member speaking shall attend to the subject under consideration.
7. No member shall speak more than twice on any one subject.
8. Every motion made and seconded shall be attended unless withdrawn by the person who made it.
9. No member shall absent himself from the body without leave of the moderator.
10. On motion made where the vote of the body is taken a majority shall prevail.
11. The moderator shall have the same privilege to speak as any other member, provided the chair is filled.
12. Any members transgressing the above rules shall be admonished by the moderator.
13. Not less than nine members shall constitute a quorum.
